#### Galore of errors in inter first year paper in Telangana

Hyderabad: A day after printing inconsistency was reported in English paper-II question paper, errors galore, ranging from improper grammar to misprints, were detected in the question papers of the first-year intermediate public examination, conducted on Tuesday. A total of six such errors were identified in the question papers of Botany, Mathematics and Political Science, causing confusion and concerns among students. According to an official on exam duty, question No. 13 in Botany Telugu medium, question No.5 in Botany paper – I English medium, question Nos. 32 and 20 in Political Science paper – I English and Telugu mediums respectively, and questions Nos. 4 and 9 in Mathematics paper-IA Telugu medium had errors.

#### TGPSC releases Group - II general ranking list; Men bag top 10 ranks

Hyderabad: Men walked away with top ranks in the Group – II services recruitment examination, for which the Telangana Public Service Commission (TGPSC) released the general ranking list (GRL) on Tuesday. Men secured top 10 ranks with Naru Venkata Haravardhan from multizone-I who scored 447.088 out of 600 marks topping the list. Vadlakonda Sachin of multi-zone-I and B Manohar Rao of multi-zone-II secured second and third ranks.Lakkireddy Vinisha Reddy of multi-zone-II who secured 408.713 marks was the highest-ranking woman with 32nd rank followed by Baikadi Susmitha of multi-zone-I with 41st rank.

Following the Commission's meeting chaired by TGPSC Chairman Burra Venkatesham, the TGPSC declared the GRL of 2,36,649 candidates, along with the final key, which has been made available on the website https:/ /www.tspsc.gov.in/. Candidates' OMR sheet images have also been released. A total of 5,51,855 candidates registered for the Group - II services recruitment and 2,49,964 appeared for the examination, which was conducted on December 15 and 16, 2024. 

#### Rajiv Yuva Vikasam For **Unemployed Youth: Bhatti** Announces New Scheme



Hyderabad, March 11 (NSS): Deputy Chief Minister Bhatti Vikramarka has announced a new initiative called 'Rajiv Yuva Vikasam' aimed at assisting unemployed youth in Telangana. He announced that this scheme will support self-employment opportunities for five lakh youth, allocating a budget of Rs. 6,000 crores for unemployed youth from SC, ST, BC, and minority groups in the State. During a media interaction at Veera Vanitha Chakali Ilamma Women's University on Tuesday, the Deputy Chief Minister disclosed the government's plan to offer financial aid of Rs. 3 lakh to each beneficiary through the Rajiv Yuva Vikasam scheme via the SC, ST, BC, and Minority Corporations. He informed that a notification regarding the self-employment initiative for 5 lakh unemployed youth will be issued on March 15."Applications for the self-employment scheme must be submitted online by April 5. The review of these applications will take place from April 6 to May 31, during which beneficiaries will be chosen. The selected beneficiaries will receive their sanction letters on June 2, coinciding with Telangana Formation Day," disclosed Bhatti VikrThe Deputy Chief Minister noted that the authorities are developing suitable guidelines for selecting beneficiaries, and comprehensive information about the scheme will be provided in the forthcoming notification. Bhatti Vikramarka also shared that the State government has earmarked Rs. 540 crore for the establishment of Veera Vanitha Chakali Ilamma University.A master plan has been created to construct outstanding facilities, aiming to make it the premier university in the nation. Plans are also in place to renovate the heritage buildings on campus. In addition to this, the State government is releasing Rs 15.5 crore for the renovation of heritage buildings on the university premises and Rs 100 crore for the construction of new buildings immediately," he added. #### Pay Remunerative Price To Turmeric Farmers: Brs Mlc Kavitha

Nizamabad, March 11 (NSS): BRS party MLC Kalvakuntla Kavitha has made crucial comments on the turmeric farmers' agitation. Living up to all the hype, Team India emerged worhy winners of the Champions Trophy. The squad, ably ed by Rohit Sharma, just had too much firepower at its lisposal. No wonder the resilient Kiwis, known for punchng well above their weight, finished second best. Starting he tournament as firm favourites, the Indian team had a emarkable unbeaten run. However, the superb achievenent was soured by allegations that India had been given referential treatment, thanks to its financial muscle and clout in the International Cricket Council. The team staved but in Dubai throughout the event, even as some of the thers shuttled between Pakistan and the UAE. The biarre rescheduling was necessitated by India's refusal to play in the neighbouring country, citing security concerns.

For hosts Pakistan, the tournament was a disaster n more ways than one. The home team got knocked out at the group stage itself, while India's relentless march enied the Pakistan Cricket Board the honour of hosting he final. The contrast between the fortunes of the two sides ouldn't have been starker

India's emphatic victory would have been all the more ratifying had it happened on Pakistani soil. Pakistan had rossed the border to take part in the ODI World Cup in 023, but India chose not to reciprocate the gesture. A olden opportunity to initiate a thaw in bilateral ties was hus lost. But it's never too late to make amends and mend ences. Prime Minister Modi needs to take a leaf out of his nentor Atal Bihari Vajpayee's book. The latter didn't let he Kargil War cast a long shadow on cricket relations. An ndian team toured Pakistan in March-April 2004 and went on to win both the Test and ODI series. Efforts to revive a reat rivalry through reciprocal tours can help in easing order tensions. India, which calls the shots in the cricket vorld today, must take the lead on this front.

### Ai-Powered Fraud Detection Must: Sajjanar

Hyderabad, March 11 (NSS): The Federation of Telangana Chambers of Commerce and Industry (FTCCI) organised a Conference on "Navigating Corporate Failure and Digital Fraud: Pathways to Success" at FTCCI Surana Auditorium, Federation House, here on Monday evening The program was organised to explore how good governance practices can help companies prevent fraud and corruption. It also covered the consequences of failing to do so. Giving his opening remarks, Dr Suresh Kumar Singhal, President of FTCCI, said the program was a platform for dialogues, learning and collaboration to prevent digital frauds. Naresh Chandra and Dr Tasneem Shariff, Chair and Cochair of the Corporate Laws, IBC & ADR Committee set the tone for the meeting, introduced speakers. V C Sajjanar, IPS, Vice Chairman & Managing Director, Telangana State Road Transport Corporation was the chief guest. Addressing the audience, Sajjanar said he was a hardcore police officer, then tasked to manage TGRTC as MD. "I didn't know business. When I took over, the Corporation was not doing well and it was loss-making. The total turnover of the corporation in September 2021, when he took over, was Rs 3800 crore. We turned it around now in four years. Today, it is a billion-dollar company. The turnover next year is likely to reach Rs 10,000 crore. The historical transformation happened because of passion, commitment, determination and hard work of our 50,000 employees, he said. This was also possible due to the strong government support, without which we couldn't have navigated the scenario. You need to have strong internal controls, and transparency. We have been paying TGRTC employees without defaulting salaries and paid salaries on the first of the month due to a bit of financial engineering", he said. Speaking about digital frauds, Sajjanar said "we have reached a stage, we can do without technology. We depend heavily on it. The rise of Al and Big Data also increased the scope of digital fraud. Digital frauds have been rising at an alarming pace. The cyber criminals are exploiting the increasing reliance on online platforms to steal personal information, money, and disrupt businesses. Hence, digital frauds have to be boardroom priorities of all the corporate houses. Sajjanar, a former top cop, suggested that Al-powered fraud detection must be used to analyze data and identify suspicious activity. Use Blockchain technology to secure financial transactions, which ensures tamper-proof and resistant to alteration. Training the staff on cyber security is important to prevent digital frauds, and focus on educating them about basic security practices. ### 53% surveyed experience sleep-related disorders without a consistent bedtime routine: YouGov and Amazon Alexa Study

Top activities that are a part of bedtime routines amongst all respondents include watching video content (63%), connecting with family and friends (59%), listening to podcasts, music, or audiobooks (58%), and scrolling through social media apps (57%). Households with only couples rank highest in following these activities as part of their bedtime routine, amongst all other house-

One in two respondents use voice assistants to setup their sleep routines—with more people between 35-45 years using voice assistants compared to those aged between 25-34 years.

"Sleep routines are gaining popularity, and what's noteworthy is that smart technologies, especially voice assistants like Alexa, are increasingly becoming a valuable aid in helping people follow their bedtime routines. Personalised voice AI experiences are emerging as practical alternatives to handheld screen devices before bedtime. Whether it's playing meditation sessions or relaxing sounds, listening to audiobooks or music, setting reminders and alarms, or controlling smart devices to adjust the room's sleep environment, people are finding innovative ways to use Alexa as part of their bedtime routines. Alexa users can easily set up their bedtime routine through the Alexa app, customizing it to their specific needs and preferences," says Teena Sidana, Country Manager, Alexa India.

Households with couples and kids use voice assistants to set up sleep routines more than household types

Households with couples and kids rank higher in taking help of voice assistants to follow routines, followed by other household types\*. Across all respondents, 45% take help of voice assistants in smart devices for listening to music, podcasts, meditation playlists, ambient sounds, movies, and audiobooks. About 23% use voice assistants to set up reminders and alarms, and 22% use it for controlling smart home appliances such as smart lights in the bedroom or baby room, automated curtains, smart ACs, etc.

Listening to meditation playlists and journaling before bedtime see increased interest among adults.

#### 66,961 sanitation workers validated under NAMASTEscheme: Govt tells Parliament

New Delhi: The Centre on Tuesday told Parliament that a total of 66,961 sewer and septic tank workers (SSWs) have been validated under the National Action Plan for Mechanised Sanitation Ecosystem (NAMASTE) scheme as of March 2025, marking a 22.7% increase compared to December 2024, when the figure stood at 54,574. The scheme was launched in 2023-24 with an aim to address the persistent issues in sanitation work by promoting mechanised solutions and providing rehabilitation support to workers. According to the government, 425 deaths were reported between 2019 and 2024 due to hazardous sanitation work, particularly related to cleaning sewers and septic tanks. To be sure, under the scheme—the workers are "profiled" and then "validated" according to the guidelines. The Social Justice and Empowerment Ministry had included "Waste pickers engaged in Solid Waste Management" under NAMASTE in 2024. The Centre reported that 45,292 personal protective euipment (PPE) kits were distributed by March 2025, a rise of 170% from the 16,791 PPE kits distributed by December 2024. Additionally, 43 safety devices kits for emergency response sanitation units (ERSUs) were provided by December 2024, with this number remaining unchanged by March 2025. The government released Rs. 17.23 crore in capital subsidies to 599 sanitation workers by March 2025, marking an increase of 23% in capital subsidies from ?13.96 crore, which benefited 503 workers by December 2024. The number of workshops focused on preventing hazardous sewer and septic tank cleaning also saw growth, with 1,837 workshops conducted by March 2025, up from 837 workshops by December 2024. Despite the legal ban on manual scavenging under the "Prohibition of Employment as Manual Scavengers and their Rehabilitation Act, 2013," the practice persists in some areas. No reports of manual scavenging have been received from Indian Railways or other districts in the past five years. However, two surveys conducted in 2013 and 2018 identified 58,098 manual scavengers across the country. The government has been working to assist these individuals by offering one-time cash assistance, skill development training, and capital subsidies for self-employment.

## DU prepares for first 4-yr batch under NEP 2020, student-teacher ratio, infra, timetable among key concerns



GNS News Agency, March 11

It's a race against time for Delhi University as it prepares for the fourth year under the Undergraduate Curriculum Framework 2022 (UGCF-2022). This is the first time that students will undertake a four-year undergraduate course under the National Education Policy 2020.It, however, is not the first time that DU will implement a four-year undergraduate programme. The Four Year Undergraduate Programme or FYUP was first introduced in 2013 and scrapped a year later following widespread protests by teachers and students. Meanwhile, students and teachers at the university can now look forward to longer days, with the varsity and colleges planning to offer classes till late in the evening, officials said. This is being done to make sure that the extra batch of students can be managed with the existing infrastructure. While the new framework, aligned with NEP 2020, allows greater flexibility and research-oriented learning, the lack of clarity regarding faculty, infrastructure, and student interest continues to divide the stake-

Under the NEP 2020, the fourth year offers students three specialisation tracks — Dissertation Writing, Academic Projects, and Entrepreneurship. The first is designed for those considering academic research, the second focuses on applied research, and the third aims to guide students through market research, business development, and financial planning. Under the new framework, a student can earn a certificate after completing one year of college, a diploma on completing two years, bachelors (honours) in one core subject or a bachelor (multidisciplinary) in different subjects. The fourth year will earn students bachelors (honours with research) or bachelors (honours in multidisciplinary courses). For students who want to pursue a dissertation in the fourth year (Honours with Research), Research Methodology as a General Elective (GE) course must be taken in either Semester VI or VII. This

CELLPHONES stolen from Metro stations, public buses, and crowded marketplaces across Delhi, swiftly transported out of the city to leave no trail and then smuggled to Bangladesh — this is how an international syndicate, which has now been busted, operated, the police said on Sunday. As the Delhi Police's Crime Branch busted the syndicate, a West Bengal-based "smuggler" was arrested, and 48 high-end mobile phones worth approximately Rs 20 lakh were recovered, officials said

Identified as Abdush, 24, the alleged smuggler was intercepted near Salimgarh Bypass in North Delhi's Kotwali while attempting to flee with a consignment of stolen phones. Officers said that Abdush is allegedly a key operative in the bigger network responsible for large-scale theft, smuggling, and illegal sale of mobile phones across international borders. The Crime Branch was recently tipped off about several mobile theft syndicates operating in Delhi that target commuters at Metro stations, public buses, and crowded marketplaces across the city and smuggle the phones across the border to Nepal or Bangladesh, said police.

"The syndicate, which has been busted, ensured that stolen mobile phones are swiftly moved out of Delhi-NCR, making it difficult for law enforcement agencies to trace them. Once stolen, the mobile phones were never sold or used locally to avoid detection. Instead, they were immediately collected by smugglers, who purchased them at a nominal price of Rs 2,000-3,000 per device," said DCP (Crime



Gautam. These smugglers then transported bulk consignments to West Bengal, where the phones underwent modification before being dispatched to Bangladesh.

These phones were then sold for Rs 8,000-10,000 each in the illegal markets across borders," he added.Investigators used a combination of human intelligence, surveillance footage, and digital tracking to trace the key players in the syndicate. After weeks of monitoring, police received intelligence that Abdush was attempting to transport a large consignment of stolen phones to West Bengal, said officials. Acting swiftly, a team laid a trap at Salimgarh Bypass. When Abdush allegedly sensed police presence and tried to escape, he was swiftly overpowered, according to police. Upon searching his backpack, officials recovered 48 stolen mobile phones. He was immediately taken into custody, and the mobile phones were seized as evidence. During interrogation, Abdush allegedly admitted to being involved in smuggling stolen mobile phones for the past 1.5 years.

"(Abdush) revealed that he was struggling with financial difficulties. In search of easy earnings, he got involved in illegal activities in 2023. Initially, he was engaged in the scrap trading of mobile phone parts and during this period, he came in contact with Sameer and Salim, thekey players in the stolen mobile phone trade," said DCP Gautam. "Seeing an opportunity for quick profits, he started purchasing stolen mobile phones from them at significantly low prices. He then sold these devices in the local markets of West Bengal and smuggled them into Bangladesh. He further admitted to having smuggled more than 800 stolen phones from Delhi to West Bengal in the past one-and-a-half years," he added. Following Abdush's arrest, police are now focusing on identifying his associates, including the key players Sameer and Salim, and tracking down the larger network involved in this illegal trade, said officials.

would provide a foundation, however, students choosing any of the other two specialisation tracks in the fourth year need not take this. There are also Discipline-Specific Elective (DSE) requirements, as per the UGCF framework. The university has also revised its definition of Generic Electives (GEs), expanding course selection flexibility. "From Semester 5, all students of BA (Programme) can opt for GEs from the open pool other than that of the core disciplines they are studying," a university notification states.

Special provisions have been introduced for students who did not study Hindi up to Class 8. The amendment specifies: "Students of BA (P)/ B Com (P) with two nonlanguage core disciplines, and who have not studied Hindi up to class 8, shall be allowed to opt for GE from the open pool if he/she cannot be provided GE (L) of their mother tongue. However, the principal of the college shall have to seek permission for the same." A similar provision "may be made for students from South India or the Northeast who do not have the proficiency to study the GE (L) Hindi prescribed for those who have studied Hindi up to Class 8. Further, those who have not studied Hindi/Modern Indian Language up to Class 8 may also be exempted from studying the second language of GE(L)," the document outlining the framework states. To accommodate the increased academic load, the university plans to implement longer class hours as suggested by the University Grants Commission (UGC). A senior DU official told The Indian Express, "We are going to implement the optimum utilisation of infrastructure as suggested by the UGC from 8 am to 8 pm. The labs might be an issue as they function only till 4 pm, but their timings will also be extended. Every student will have a mixed timetable, holding classes in the evening too on several days of the week to make sure that all credits are covered in the timetable." Ajay Arora, Principal, Ramjas College, said, "There was a misconception among students that they need a CGPA of more than 7.5 to enter the fourth year but that's not the case. The promotion criteria remain the same from the third year to fourth year, as it was from first to second and second to third. We cannot ascertain the number of students who will opt for the fourth year but the university will offer this to any eligible student... Some universities are already running the fourth year of their courses." Talking about the challenges, he said, "The college infrastructure is designed for a three-year program. Extending to a fourth year would require significant adjustments, including increased utilisation of resources like classrooms. This will change the college's working culture..."Arora added that this would result in reduced flexibility in student schedules, as timetables would need to be adjusted to accommodate increased academic requirements. Meanwhile, Anju Srivastava, Principal, Hindu College, said, "There's a degree of uncertainty surrounding the fourth year, and we've done a round of queries, but there's still room for clarification. The response so far from the students has been lukewarm, partly due to the timings.""Students in social sciences seem to be showing more interest... with at least sixty or more per cent of students wanting to continue to fourth year because of the research methodology aspect being offered...But the science students are preparing for their Master's programmes and are unsure whether to continue or prepare for IIT." Meanwhile, Delhi University Teachers' Association president AK Bhagi said research project requirements at the undergraduate level would be unmet because of a lack of UGC special grants. "Currently, DU doesn't seem to be prepared for the fourth year," he said, adding, "There are no teachers for the fourth year who are sanctioned to date. DU colleges have not been given teaching positions in lieu of EWS expansion of student strength in 2019." According to Bhagi, there should be a comprehensive review of the batch to make the fourth year relevant. Karuna Singh, a third-year BA Political Science (Hons.) student at DU, spoke about divided student opinions, stemming from a lack of clarity on syllabus, as well as guidelines. "The complete syllabus is still not available, and we've only been told that a research subject in the fifth semester is necessary for a foundation," said Singh. "Some of my batchmates plan to take competitive exams after the third year, while others will prepare for CUET PG. I'm part of a third category of students — fascinated by the idea of doing research with graduation...but we're apprehensive about whether the syllabus will match the MA

Talking of the prevailing uncertainty, she said, "We are the first NEP batch until we experience this ourselves...we can't say anything. This one year could be problematic or innovative - only time will tell."For students considering postgraduate studies abroad, uncertainty is even greater. Some universities, particularly in the US and UK, have started accepting students with a three-year UG degree. "I was planning to apply for a Master's abroad, but now I don't know if staying for the fourth year will help or delay my chances," said a student. To accommodate the fourth-year students, the Hindu College Principal said, special arrangements are being made. "By April-end, we'll start preparing the timetable that will require speculative planning and calculated risks. We need to make arrangements for varying student numbers, adopting a more open-minded approach. Considering the 13 to 14-week semester duration, we will face challenges with teacher-student ratios, requiring innovative solutions under NEP framework," she said.

## Sacked 3 yrs ago, Anganwadi workers in Delhi say: 'Will not give up now... were never at fault'

Most of them dressed in red, more than a hundred Anganwadi workers and helpers, terminated from service by the Women and Child Welfare Department three years ago over a protest, gathered at Ambedkar Bhavan in Jhandewalan on Sunday afternoon to participate in an event titled 'The Festival of Struggle'.

Video messages from around the world, including from England, Pakistan and New Zealand, expressing solidarity with the Delhi State Anganwadi Workers and Helpers Union (DSAWHU) played on a large screen as the women, some accompanied by young children, watched keenly. On March 13, 2022, 884 Anganwadi workers and helpers were terminated from their jobs following more than a month-long protest to press for better wages. This was after the Essential Services Maintenance Act was imposed, following a protest by the women in front of the Delhi Secretariat under the banner of 'Anganwadi Stree Adhikar Rally' on March 8. While around 750 of the women have been reinstated since then, the matter has reached the Delhi High Court, which will hear the case next on March 21.

One of the women, who is yet to be reinstated by the department, said, "The exploitation continues... While we have not backed down, we are afraid. A large group of workers has been reinstated, but a small section has been left behind. I was told that I was not reinstated, as I was outspoken. I don't even expect a wage increase... how could I, when they didn't even pay us on time?" Savita Yadav (53), also yet to be reinstated, is a single mother. She had worked as an Anganwadi worker since 2007 in Karawal Nagar. "They are not allowing Anganwadi workers to live. Everybody is threatened by the department. Those who have rejoined work are constantly under pressure. They did not pay me my salary for January 2023," she said, adding that while she use to be paid Rs 9,741 every month, helpers received a honorarium of Rs 4,739. "My husband has passed away... I worked as a tailor and as a cook in house-



holds to survive. My elder daughter was forced to start work because we could not make ends meet. With the union's help, we have fought for three years, and we will not give up now. I am confident that we will win this case. We were never at fault."Priyambada Sharma, the DSAWHU convenor, said a representation will soon be sent to the newly-formed BJP government in Delhi seeking reinstatement of the remaining workers and helpers.

"Today, we mark three years of the struggle... Many women are afraid... Their families are suffering. They have not even been guaranteed minimum wages, which should be their basic right... instead they are being overburdened and exploited." As part of Sunday's event, a documentary titled When They Painted The City Red - produced by the Progressive Artists League - was screened. The film chronicles the 2022 protest. A play, Kahani Ek Anganwadi Aurat Ki, inspired by famous playwright Safdar Hashmi's work, was also presented by the Anganwadi workers' theatre group Aparajita. A book stall featuring literature on women's and children's issues was set up, along with a dedicated children's corner filled with toys and paintings. The festival concluded with a rally, as the workers took to the streets in protest. One of the attendees was Supreme Court advocate Colin Gonsalves

# 'Delhi's vastness makes it a world unto itself... a microcosm of India's unity in diversity': Ambassador of France to India

A career diplomat and a scholar specialised in Asian studies, Dr Thierry Mathou, Ambassador of France to India, came to Delhi in September 2023. Since then, he has discovered multiple places in the city where he and his wife, Cécile, "enjoy getting lost". Counted among French diplomacy's foremost experts on Asia. Dr Mathou has served in the continent for more than 25 years. He was Consul General in Shanghai and Ambassador to Myanmar, then to the Philippines, and more recently to Thailand. He is fluent in several Asian languages, including Chinese. As a scholar, Dr Mathou's main focus is on India-China relations and Himalavan studies. A specialist in Bhutan studies, he has written several articles and books on Bhutan in French and English and has been involved in many academic projects in this country. His wife too is involved in Bhutanese studies. The couple has three children: Alexandra, François, and Charles. Dr Mathou speaks to The Indian Express as part of a series of interviews with Ambassadors about Delhi their home. I joined my post in 2023 in Delhi, a city that never ceases to amaze me with its great diversity and richness, both architecturally and socially. There are many places in the city where my wife and I enjoy "getting lost": Old Delhi with its labyrinths of narrow streets, markets, havelis and lively atmosphere, and New Delhi for its treelined avenues and parks. My favourite area, however, is Humayun's Tomb at dusk – and its magnificent museum,

the vast wilderness of Sunder Nursery, and Hazrat Nizamuddin Auliya Dargah, which exudes deep spirituality and a sense of harmony, and offers the magic of qawwali. This combination makes Delhi an eternal city. Another area that I really like because it reminds me of cherished places in the Himalayas is Majnu ka Tila - Little Tibet. Three words come to mind spontaneously when I think of Delhi: diversity, vastness, and pollution. Delhi's diversity reflects that of India - we could speak of "Delhis" in the plural as the city is a microcosm of India's unity in diversity. There's the Old Delhi-New Delhi duality, but really, the diversity is more encompassing - culturally, socially, and economically. You hear Hindi, Punjabi, Urdu, Bengali, and many other languages, and, English, of course. Not enough French indeed, except if you go to the lively Alliance Française de Delhi, near Lodhi Gardens, to learn my mother tongue and discover French culture. Delhi is a city of immigration whose traditions and way of life have been influenced by the cultures of neighbouring regions. Its cuisines and architectural styles contain elements spanning South to North India. That's why I am proud that France is contributing to shaping the Yuga Yugeen Bharat National Museum. Delhi's vastness makes it a world unto itself. This feeling comes from both the size of its population - roughly half that of France and the expanse of its territory, which is over ten times that of Paris, plus the sprawl of Delhi-NCR. Delhi's dynamism attracts people.

## Brace for warm days ahead in Delhi, rain likely on Holi



t's a race against time for Delhi University as it prepares for the fourth year under the Undergraduate Curriculum Framework 2022 (UGCF-2022). This is the first time that students will undertake a four-year undergraduate course under the National Education Policy 2020.

Delhi is expected to see light rain on Holi on Friday, preceded by a warm week, the India Meteorological Department (IMD) said on Sunday. The maximum temperature on Sunday was recorded at 32.8 degrees Celsius, 4.4 degrees above what is normal for this time of the year. The minimum, at 13.5 degrees Celsius, was half a degree below normal. The warmest place in Delhi-NCR was Noida, with a maximum temperature of 33.1 degrees Celsius.

The temperature is expected to rise till Thursday – the maximum is expected to be around 32 degrees Celsius on all days except Tuesday, when it is expected to touch 33 degrees Celsius. The highest-ever maximum temperature in March was recorded at 40.6 degrees Celsius, on 31st in 1945. Strong winds, meanwhile, are expected on Tuesday and Wednesday. Light rain is expected on Friday, when the minimum is forecast to be 30 degrees Celsius and the minimum is likely to rise to 16 degrees Celsius.

The air quality index (AQI), meanwhile, dipped to poor, at 209, on Sunday. The primary pollutants were Ozone and PM 10. The overall AQI in the warmer months, however, is better than that in winter months, as low temperatures and calm winds aid the accumulation of particulate matter. The IMD forecast for Tuesday and Wednesday - strong surface winds - is expected to bring improvement in the AQI, from poor to moderate. "The predominant surface wind (on Tuesday) will likely be from the northwest direction with a wind speed of less than 18 kmph during morning hours. The wind speed will gradually increase thereafter becoming 20-22 kmph from the northwest direction during the afternoon. It will decrease to less than 8 kmph, coming from northwest direction, during evening and night on Wednesday," the forecast from the Air Quality Early Warning System for Delhi, Ministry of Earth Sciences, said.

#### Wife approaches Delhi Police, UP MLA Raja Bhaiya booked for domestic abuse

Uttar Pradesh MLA Raghuraj Pratap Singh, also known as Raja Bhaiya, was booked by the Delhi Police on Friday on charges of domestic abuse following a complaint filed by his wife Bhanvi Kumari Singh. According to the FIR lodged under Section 498A (husband or relative of husband of a woman subjecting her to cruelty) of the Indian Penal Code, Bhanvi Kumari has accused her husband of prolonged domestic abuse spanning nearly three decades, citing severe physical assaults, and emotional trauma. She has also alleged numerous instances of violence, including an attack in 2015 that left her with fractured ribs and internal injuries. Further, the Kunda MLA has been accused of making death threats against his wife. In 2023, Bhanvi Kumari had approached the National Commission for Women and the Delhi State Legal Services Authority but withdrew her case, hoping for reconciliation. In her complaint, she has written that in November 2022, her husband filed for divorce, which remains pending in a district court in Delhi. As per her complaint, continued abuse and alleged death threats have compelled her to seek legal action.

#### Medak Mp Raghunandan Gets Relief In Hc

Hyderabad, March 11 (NSS): Medak MP Raghunandan Rao had got relief from the Telangana High Court. The High Court has dismissed an electoral offence case registered against Raghunandan Rao in Nagarjuna Sagar Police station limits. An FIR was registered against Raghunandan Rao in connection with the Nagarjuna Sagar by-election campaign in the year 2021. It was complained that he campaigned without permission while the Model Code of conduct was in force. He participated in the election campaign in Utlapalli and Pulicherla villages. A case was registered against Raghunandan on the basis of a complaint of MPDO Dubba Satyam. This case was now dismissed by the High Court.Meanwhile, it is known that when the previous BRS government was in power, its MLA Nomula Narsimhayya died untimely. Due to this, the byelection was held in Nagarjuna Sagar assembly seat in 2021. The BRS party won the by-election. The people of Sagar gave victory to BRS party candidate and the son of Narasimhaiah Nomula Bhagat, who won with a majority of 18,872 votes. (NSS)

### Man buried with excavator, kin face endless wait — for body, death certificate

In the end, closure — or some sense of it — came in the form of a five-foot-something cast made of atta and a garlanded photograph of Rakesh Yadav placed on a bamboo frame. Months after 35-year-old Rakesh and his excavator were buried under 60 feet of mud and rubble at the site of a water supply project in Palghar's Navghar area, over 1,600 kilometers away, at Azamgarh in Uttar Pradesh, Rakesh's family carried out his last rites.

"The pandit said since the body was never found, we can get a cast made to roughly match Rakesh's height. We made one with atta, put his photograph on it and carried out the cremation," says Rakesh's father Balchandra, 62.But for the family, the wait continues — this time, for a death certificate. Though the administration called off the search operations four months after the accident, the authorities are yet to officially declare Rakesh dead. Rakesh's brotherin-law, Santosh Yadav, says, "When we came to Vasai (in Palghar, soon after the accident), we spoke to several authorities there, but at that time, we were told that since the body had not been found, no one could issue a death certifi-

Man buried with excavator, kin face endless wait for body, death certificate The site in Palghar, Maharashtra, where Rakesh Yadav was buried after a mishap in May 2024. "Rakesh had invested some money in LIC policies, and his wife and three children need the money for their future, which is why his death certificate is very important for us. We will need the certificate in the future too, for other formalities," he added. When contacted on the matter of Rakesh's death certificate, Collector and District Magistrate Govind Bodke directed The Indian Express to Resident Deputy Collector Subhash Bhagade, who said that Rakesh has "not been officially declared dead". "I will understand the procedure and get back," he added. On May 29, 2024, Rakesh and his eight-tonne excavator were buried when one of the concrete walls of a trench he was working in collapsed on him. He was part of a team working to excavate a tunnel to lay a pipeline for a water supply project under the Mumbai Metropolitan Region Development Authority's (MMRDA) Surva Regional Water Supply Scheme. Excavator The trench inside which Rakesh Yadav (inset) and his excavator lie buried.

Soon after the accident, a team of the National Disaster Relief Force, firemen from the Vasai Virar Municipal Corporation and personnel of the Indian Army's Pune-based 269 Engineer Regiment launched an operation to locate Rakesh. As the news reached his family in Azamgarh, on May 30, Rakesh's elderly parents, wife, three children, and other family members packed a few sets of clothes and boarded a train to Mumbai. The family of nine, including Rakesh's parents, his wife Sushila and their three children, besides other relatives, camped under a bridge, metres away from where the 35-year-old and the excavator lay buried under 60 feet of mud. "We stayed at the site under the bridge for two months, hoping to see him, even if for the last time," says Rakesh's wife Sushila. Rakesh's brotherin-law Santosh claims that the authorities forced them to leave Palghar. "While we were there, we could follow-up with the authorities. So the search operations went on, even when the conditions were difficult and when it started to rain. But our presence at the site was adding to the pressure on the authorities since various politicians would visit us. So the authorities booked our tickets and asked us to leave by the end of July. They promised us that they would start the process of retrieving the body once the monsoon got over. But then they stopped looking for the body," he says. "Then chief minister Eknath Shinde and other politicians and authorities had promised us that Rakesh's body, in whatever form, would be recovered and handed over to us," says Rakesh's father Balchandra, a farmer and small-time grocery shop owner. "But now nobody is answering our calls."

Collector Bodke said, "We did everything in our capacity. We conducted the rescue operation for over four months before calling it off. It was difficult to recover his body because the creek near the site caused instability in the soil. One of the pillar walls (weighing over 900 tonnes) collapsed, and the remaining three pillars were shaking heavily. ### Indian Railways: Women staff crosses 1.1 lakh-mark

New Delhi: The number of women employees in Indian Railways has been steadily rising over the last 10 years, with the total crossing 1.13 lakh, which constitutes 8.2 per cent of the total workforce, up from 6.6 per cent in 2014, according to official figures. Women are playing a bigger role in key operational jobs in the railway network. According to an official statement, 2,162 women are currently working as loco pilots, while 794 women have taken up the role of train managers (guards). Additionally, 1,699 female station masters are stationed across India. The number of women loco pilots and station masters in Indian Railways has jumped fivefold over the past 10 years, a senior official said. Apart from operational roles, women are making a significant impact in the administrative and maintenance sectors as well. Indian Railways has 12,362 women office staff and 2,360 women supervisors. In track maintenance, a traditionally male-dominated field, 7,756 women are now working to ensure the safe running of trains. Women are also actively involved in passenger services, with 4,446 serving as ticket checkers and 4,430 working as 'pointsmen' at railway stations across the country. Besides, Indian Railways has operationalised several railway stations with all-women teams to enhance confidence in gender inclusivity. These stations include Matunga, New Amravati, Ajni and Gandhinagar railway stations. Indian Railways, which is one of the world's largest employers, with over 12.3 lakh employees working on its vast network, is also playing a key role in empowering women, a senior official said. "Irrespective of gender, all the candidates fulfilling the prescribed eligibility criteria are eligible for recruitment," Railway Minister Ashwini Vaishnaw said in an answer to a question in Parliament recently. The government has prioritised transforming Indian Railways into a world-class entity, which ferries on an average 2.3 crore Indians every day from one part of the country to the other at an affordable cost, and women are playing an increasing role in this endeavour, a senior official added.

### 10 days before Hampi rape, accused made chain snatching attempt: Police

The three accused in the alleged gang rape of two women, including an Israeli tourist, near Hampi, the UNESCO World Heritage Site in northern Karnataka, were allegedly involved in a chain-snatching bid about 10 days before the incident, a police officer "The attempt failed but their target did not complain to police. If police had been informed, maybe this incident (gang rape) could have been averted," the officer said. From preliminary investigations in the alleged gang rape, the officer said, police suspect that "the accused, who are construction workers from the Gangavathi region nearby, were under the influence of illegal substances" at the time.According to a repesentative of local homestay owners, "the incident was first reported as a robbery before the women informed police of the gang rape". Police have nabbed all the three accused, identifying two of them as Sai Chetan and Mallesh, both hailing from the Gangavathi region in Koppal district where the tourist hotspot is located. While Chetan and Mallesh were arrested Saturday and sent to two-day police custody, the third accused was apprehended

Sunday. "There was only one way to exit the site and the victims had run the other way. After going through CCTV footage on that route, police found that a bike had travelled in that direction at 11.17 pm that night," the officer said about the key clue that led arrests. According to police, the three accused allegedly assaulted a group of five at around 10.30 pm near Sanapura Lake on March 6, pushing three men into a canal leading to the death of one and gangraping the two women. The victims of the alleged gang rape included a homestay owner who had taken the group out for "star gazing", police said.Hampi rape case: As shaken tourists pack up, owners of homestays brace for crackdown Police investigate the gang rape and murder in Hampi. Police have identified the deceased as Odisha native Bhibas Nayak (30) and the two other men as US national Daniel (23) and Maharashtra resident Pankaj.Gangavathi Rural Police have registered a case under BNS sections 309(6) (robbery and voluntarily causing hurt), 311 (dacoity), 64(L) (committing rape causing grievous bodily harm or maiming or disfiguring or endangering the life of a woman), 70 (1) (gang rape). "We are inves-

tigating the case," the officer said. The homestay owner hails from a neighbouring state and has been running the guest house for several years, according to Ravi Sanapur, who represents accommodation owners in the region."I received a call around 11.30 pm on March 6 from the resort where Daniel and Pankaj had rushed to after the incident. They informed me that they had been robbed while they were star-gazing near a canal close to the Sanapur lake, about 3 km from their accommodation. I immediinformed the Gangavathi rural police inspector and rushed to the spot. When we reached the spot, the women said they had been robbed, and that Daniel, Pankaj and Bhibas had been pushed into the canal. While Daniel and Pankaj had managed to swim ashore, Bhibas was missing," Sanapur said."I called about 20 locals to search in the night but there was no result. It was only the next day we found his (Bhibas) body. The other four others had left with the police. On Saturday morning, we came to know that the women were gang raped," he said. On Saturday, police retrieved the body of Bhibas. "He had a head injury, possibly caused by a stone, leading to his death," said the officer. According to Mallikarjuna, an elderly local resident, "The village had not heard of such a crime after an Indian and a foreign national were murdered in the 1990s."Homestay and guesthouse owners said they have been cautioning foreign nationals against

Days after the special court allowed an application to add an accused in the abetment of suicide case of Dr Payal Tadvi, filed by special public prosecutor Pradip Gharat, the state government has removed him from the case A notification has been issued by the law and judiciary department stating that Gharat's appointment has been cancelled with immediate effect. The notification dated March 7 does not give any reasons for the decision. It states that a new special public prosecutor,

Mahesh Mule, has been

now appointed for the case.

On February 28, the

special court hearing the abetment to suicide case, had allowed an application filed by Gharat to add as accused Dr Yi Ching Ling, the then unit head of the gynecology department, at the T N Topiwala National Medical College and BYL Nair Hospital where Tadvi was studying in 2019."I have not been informed about the cancellation of my appointment. I am an officer of the court first and I had filed the application to add an accused based on evidence, which the court has accepted,' Gharat said.On May 22, 2019, Tadvi died by suicide in her hostel room. The police arrested three of her seniors, Dr Bhakti Mehare, Dr Ankita Khandelwal and Dr Hema Ahuja on allegations that they had harassed Tadvi, including on the basis of her caste, as she belonged to the Tadvi Bhil community, a Scheduled Tribe, and based on a suicide note left by Tadvi naming the three. The case is currently at the stage of framing of charges against the three, with them currently out on bail.Gharat had made an application under Section 319 of the Criminal Procedure Code (power to proceed against other persons appearing to be guilty of offence). It said there is a prima facie case against the professor as she turned a 'deaf ear' to complaints that

Tadvi was facing harass-



ment from her three seniors.

"The impleaded/added Accused Dr Yi Ling Chung Chiang be tried together with trio charge-sheeted accused," the court said directing that summons be issued to her and directed the investigating officer to submit a report by next date on March 20. Tadvi's husband, Salman, said that the state's decision to cancel Gharat's appointment

Saudi Arabia is set to host talks on Tuesday (March 11, 2025) between the United States and Ukraine after an argument erupted during President Volodymyr Zelenskyy's February 28 visit to the White House. Riyadh, the capital of the oil-rich kingdom, may seem like an unusual venue for talks aimed at smoothing over relations after the blow-up. But Saudi Arabia under its assertive Crown Prince Mohammed bin Salman has been positioning itself as an ideal location for possible peace negotiations between Kyiv and Moscow and even the first face-to-face talks between Russian President Vladimir Putin and U.S. President Donald Trump. Here's what to know about why this meeting is taking place and Saudi Arabia's role:

Why are these talks happening?

U.S. and Ukrainian officials will meet after the Oval Office meeting between Mr. Zelenskyy, Mr. Trump and U.S. Vice-President J.D. Vance descended into an extraordinary 10-minute argument before journalists. Trump-Zelenskyy open spat in the Oval OfficeMr. Trump at one point admonished Mr. Zelenskyy by angrily saying, "You're gambling with World War III, and what you're doing is very disrespectful to the country." Mr. Zelenskyy ended up leaving the White House without signing a deal that included granting the U.S. access to Ukraine's rare earth minerals. Kyiv hoped that deal would ensure the continued flow of U.S. military support that Ukraine urgently needs as it battles Russia in the war that began after Moscow's full-scale invasion in February 2022.

Where will these talks take place?

Saudi Arabia's Foreign Ministry in a statement on Friday (March 7) identified the location for the talks as Jeddah, a port city on the Red Sea. It's not clear why the kingdom picked Jeddah as opposed to Riyadh, Saudi Arabia's capital city where the initial Russia-U.S. talks took place on February 18. However, Jeddah has hosted other diplomatic engagements in the past and is home to royal palaces.

Saudi Arabia's Foreign Ministry said the kingdom would continue to pursue "a lasting peace to end the Ukrainian crisis". "The kingdom has continued these efforts over the

The fallout extends beyond Washington and Kyiv. A fractured NATO could shift global power balances, affecting US-China-Russia dynamics. For India, while the immediate impact is limited, the crisis risks diverting US attention from key agreements and Indo-Pacific priorities. However, closer US-Russia ties could ease pressure on India's relationship with Moscow, and a ceasefire could help stabilize food, fuel, and

Mr. Zelenskyy plans to visit Saudi Arabia on Monday (March 10) ahead of the talks. He earlier delayed a trip to the kingdom after travelling to the neighbouring United Arab Emirates, which also has been considered as a possible venue for peace talks between Kyiv and Moscow.

"We continue working on the relevant steps with our partners who want peace, who want it just as much as we do," Mr. Zelenskyy said "There will be a lot of work here in Europe, with America in Saudi Arabia - we are preparing a meeting to accelerate peace and strengthen the foundations of security." Mr. Zelenskyy wrote online that a team including his Chief of Staff Andriy Yermak, Foreign Minister Andriy Sybiha and Defence Minister Rustem Umerov travelling with him to Saudi Arabia will take part in the talks.

U.S. Secretary of State Marco Rubio will lead the American team for the Ukrainian talks and meet with Prince Mohammed.Mr. Sybiha also spoke Friday (March 7) with Mr. Rubio ahead of the talks. Mr. Sybiha described it as a "constructive call". A two-sentence readout from the State Department said Mr. Rubio "underscored President Trump is determined to end the war as soon as possible and emphasised that all sides must take steps to secure a sustainable peace". Trump accuses Zelenskyy of 'overplaying his hand,' demands immediate Ukraine ceasefire

The high-stakes meeting between President Trump and President Zelenskyy was expected to focus on U.S. aid and Ukraine's strategy in the war against Russia. But tensions flared as Trump reportedly told Zelenskyy to 'make a deal' with Russia or risk losing U.S. support. Vice President J.D. Vance also criticized Zelenskyy, calling his stance 'unreasonable. After the meeting, U.S. President Donald Trump said visiting Ukrainian leader Volodymyr Zelenskyy "overplayed his hand" Friday during their extraordinary Oval Office clash and insisted, I want a ceasefire now." Mr. Trump, who spoke to reporters while departing the White House for his Florida estate, also said he wanted fighting in Ukraine to end "immediately" and accused Mr. Zelenskyy of opposing a truce. | Video Credit: The Hindu

Why are these talks in Saudi Arabia?

Since assuming power in Saudi Arabia, Prince Mohammed took an aggressive posture both at home and abroad. His public image reached its nadir with the 2018 slaying of Washington Post columnist Jamal Khashoggi at the Saudi Consulate in Istanbul, believed by the United States and others to be at the Prince's orders. In the last two years. however, Prince Mohammed instead has reached a détente with Iran, hosted Mr. Zelenskyy for an Arab League summit and been involved in negotiations over the wars in Sudan

Rivadh also maintained ties to Russia through the OPEC+ oil cartel while Western nations levied sanctions against it. That's reasserted the role the kingdom long has perceived itself as having — being the leader of the Sunni Muslim world and a dominant force in the Middle East. Hosting Russia-U.S. talks, possibly drawing Mr. Trump to the kingdom for his first foreign trip in this term through investments and other possible meetings only raise Saudi Arabia's profile further as a neutral territory for highstakes negotiations. Mr. Trump remains focused on reaching some kind of peace deal to stop the war. While conciliatory toward Mr. Putin, Mr. Trump recently also threatened new sanctions against Russia over its ceaseless attacks on Ukrainian cities. If Ukraine and the U.S. reach some sort of understanding acceptable to Mr. Trump, that could accelerate his administration's push to talks. However, the rest of Europe remains sceptical as they've been sidelined from the talks. The European Union last week agreed to boost the continent's defences and to free up hundreds of billions

## Mahmoud Khalil arrest: U.S. immigration agents arrest Palestinian activist who helped lead Columbia University protests

authorities arrested a Palestinian activist on Saturday (March 9, 2025) who played a prominent role in Columbia University's protests against Israel, a significant escalation in the Trump administration's pledge to detain and deport student activists. Mahmoud Khalil, a graduate student at Columbia until this past December, was inside his universityowned apartment Saturday night when several Immigration and Customs Enforcement agents entered and took him into custody, his attorney, Amy Greer, told Associated Press.Greer said she spoke by phone with one of the ICE agents during the arrest, who said they were acting on State Department orders to revoke Khalil's student visa. Informed by the attorney that Khalil was in the United States as a permanent resident with a green card, the agent said they were revoking that instead, according to the lawyer.Students at Columbia University painted a response during their protest last year to a message written by Palestinians in Rafah thanking students for their

University painted a response during their protest last year to a message written by Palestinians in Rafah thanking students for their support A spokesperson for the Department of Homeland Security, Tricia McLaughlin, confirmed Khalil's arrest in a statement Sunday, describing it as being "in support of President Trump's executive orders prohibiting anti-Semitism."

Khalil's arrest is the first publicly known deportation effort under Trump's promised crackdown on students who joined protests against the war in Gaza that swept college campuses last spring. The administration has claimed participants forfeited their rights to remain



in the country by supporting Hamas.McLaughlin signaled the arrest was directly connected to Khalil's role in the protests, alleging he "led activities aligned to Hamas. a designated terrorist organization."As ICE agents arrived at Khalil's Manhattan residence Saturday night, they also threatened to arrest Khalil's wife, an American citizen who is eight months pregnant, Greer said Khalil's attorney said they were initially informed that he was being held at an immigration detention facility in Elizabeth, New Jersey. But when his wife tried to visit Sunday, she learned he was not there. Greer said she still did not know Khalil's whereabouts as of Sunday night."We have not been able to get any more details about why he is being detained," Greer told the AP. "This is a clear escalation. The administration is following through on its threats."Columbia University protest on Gaza war

A Columbia University spokesperson said law enforcement agents must produce a warrant before entering university property, but declined to say if the school had received one ahead of Khalil's arrest. The spokesperson declined to comment on Khalil's detention.

In a message shared on X Sunday evening, Secretary of State Marco Rubio said the administration "will be revoking the visas and/ or green cards of Hamas supporters in America so they can be deported."The Department of Homeland Security can initiate deportation proceedings against green card holders for a

broad range of alleged criminal activity, including supporting a terror group. But the detention of a legal permanent resident who has not been charged with a crime marked an extraordinary move with an uncertain legal foundation, according to immigration experts. "This has the appearance of a retaliatory action against someone who expressed an opinion the Trump administration didn't like," said Camille Mackler, founder of Immigrant ARC, a coalition of legal service providers in

New York. Khalil, who received his master's degree from Columbia's school of international affairs last semester, served as a negotiator for students as they bargained with university officials over an end to the tent encampment erected on campus last spring. The role made him one of the most visible activists in support of the movement, prompting calls from pro-Israel activists in recent weeks for the Trump administration to be-

against him.Khalil was also among those under investigation by a new Columbia University office that has brought disciplinary charges against dozens of students for their pro-Palestinian activism, according to records shared with the AP.

fund cutThe investigations come as the Trump administration has followed through on its threat to cut hundreds of millions of dollars in funding to Columbia because of what the government describes as the Ivy League school's failure to squelch antisemitism on campus. The university's allegations against Khalil focused on his involvement in the Columbia University Apartheid Divest group. He faced sanctions for potentially helping to organize an "unauthorized marching event" in which participants glorified Hamas' Oct. 7, 2023, attack and playing a "substantial role" in the circulation of social media posts criticizing Zionism, among other acts of alleged discrimination.

"I have around 13 allegations against me, most of them are social media posts that I had nothing to do with," Khalil told the AP last week."They just want to show Congress and rightwing politicians that they're doing something, regardless of the stakes for students,' he added. "It's mainly an office to chill pro-Palestine

Such obscenity in the name of tourism promotion will not be tolerated in Kashmir," the Mirwaiz said.J&K CM Abdullah, replying to Mirwaiz's statement, said the shock and anger were totally understandable. "The images I have seen show a complete disregard for local sensitivities and that too during this holy month. My office has been in touch with the local authorities and I've asked for a report to be submitted within the next 24 hours. Further action, as appropriate, will follow from this report," CM Abdullah said. Ruling National Conference (NC) Member of Parliament Syed Aga Ruhullah Mehdi too expressed shock. "This is what cultural invasion in the disguise of tourism looks like. They show an utter disregard for Kashmiri sentiments. The Tourism department officials involved should be immediately taken to task, as well as the organisers," MP Mehdi said.J&K Peoples Conference chief Sajad Lone said the fashion show in Gulmarg was "an eminently avoidable event in the holy month of Ramadan". "I consider myself to be a person of liberal orientation, and believe in dignified and mutually respectful coexistence. But this was not the best time to host such an event." Mr. Lone said.

#### India, Mauritius and a visit to deepen long-standing ties

In our current era of geopolitical churn and uncertainty, Prime Minister Narendra Modi' visit to Mauritius (March 11-12, 2025), will be a celebration of the deep and long-standing ties between the two countries. Mr. Modi had last visited the island country in 2015, but on this occasion. he will be the guest of honour at its Independence Day celebrations on March 12. India-Mauritius relations have enjoyed political consensus, irrespective of the party in power in either country. Mauritius has a new government in power led by Navinchandra Ramgoolam of the Labour Party, whose coalition won a landslide victory in the elections held in November last year. While India-Mauritius relations will continue to be positive and stable, the visit provides an opportunity for Mr. Modi to establish a personal connect with Mr. Ramgoolam and reassure him of India's continuing support to the island's security and prosperity. It was during the latter half of my tenure as India's High Commissioner to Mauritius (1992-97) that Mr. Ramgoolam was Prime Minister. India-Mauritius relations saw significant growth under his leadership and he was particularly sensitive to India's security concerns. I have no doubt that he will prove to be a trusted partner for India and will open new vistas for our cooperation.

Mr. Ramgoolam's father, Sir Seewosagur Ramgoolam,

had led the struggle for his country's independence and was its first Prime Minister. Not many people know that Sir Seewosagur worked closely with Netaji Subhas Chandra Bose during Bose's stay in Britain between 1919-21. They were part of the Indian students' movement in London working for Indian independence. Ramgoolam did the proof-reading for Bose's famous work, The Indian Struggle, and received an autographed copy in appreciation. There are strong people-to-people ties between the two countries. Nearly 70% of the population of Mauritius is of Indian origin, being the descendants of Indian indentured labour who were brought by the colonial rulers to work on sugar plantations. About 50% trace their ancestry to Bihar and Uttar Pradesh and still speak the Bhoipuri dialect. There are smaller communities of Tamil-, Telugu-, and Marathi-speaking communities who have preserved their languages and traditional culture. Mauritius appears like a microcosm of India. However, the country is home to other ethnic groups including African and mixed populations, which create its proud rainbow culture. Though only 2% of the population, the island's French population is wealthy and influential, still owning its large sugar plantations, dominating its banking and financial sector and other commercial business. The challenge for India's diplomats lies in maintaining links with all segments of the Mauritian population, even while celebrating the kinship and cultural ties that exist with its Indiaorigin population. India has done much to nourish the linguistic and cultural heritage of the Indian-origin population. In 1976, it inaugurated the Mahatma Gandhi Institute as a premier institution for promoting Indian languages and culture. The Indian Cultural Centre in Mauritius is the largest of anywhere in the world and is one of the most active. The island hosts the World Hindi Secretariat that is supported by India. India-Mauritius bilateral trade has expanded rapidly over the past few years, reaching \$554 million in 2022-23. Mauritius is a part of the African Union and has preferential trade agreements with African countries. It is bilingual, with most of its citizens being fluent in English and French. With its well-developed finance and banking sector and reliable laws and regulations, Mauritius has become a preferred platform for doing business with Africa particularly Francophone Africa. Thanks to a favourable Double Taxation Avoidance Agreement (DTAA) with Indi.

In New South Wales, Essential Energy said repairs were underway across the storm-hit region, with "significant vegetation work to remove trees from power lines, re-standing power poles, replacing electrical assets and restringing power lines". "The weather pattern is still somewhat unpredictable. We're expecting some increased rainfalls over the next 24 hours," New South Wales Premier Chris Minns told a news conference. ## Netherlands starts bird flu vaccination program at hen farm

The Netherlands, one of the world's largest egg exporters, has launched a pilot program on a laying-hen farm to vaccinate poultry against bird flu with the aim of achieving large-scale vaccination, the government said on Monday. The highly pathogenic avian influenza, commonly called bird flu, has killed or led to the culling of hundreds of millions of poultry globally in recent years, most of them laying hens, which sent egg prices rocketing. It can also spread to humans and other animals, raising fears of a new nandemic

The Dutch pilot follows field tests that demonstrated the effectiveness of two vaccines last year. It will be conducted at one farm initially, and then potentially expanded to others, the government said in a statement. "The aim is to investigate how the market responds to the sale of products (from vaccinated poultry) and to gain experience with the implementation of the surveillance program," it said.

The Netherlands opted for a gradual introduction because large-scale vaccination requires adjustments in veterinary infrastructure and can have trade consequences, the government said, without naming them. Bird flu vaccination programs can sometimes trigger export bans, on concern that vaccinated birds not showing signs of infection could pose risks to healthy birds in the export countries. France's country-wide vaccination program in 2023 of ducks prompted several countries to ban French poultry on such concerns. Chicks will be vaccinated at Dutch hatcheries before being moved to laying farms, with eggs sold only within the Netherlands. The program will run until early 2027."I am pleased that the poultry sector wants to take this step with me. Vaccination offers a huge opportunity to better control bird flu," said Agriculture Minister Femke Wiersma. #### Congo ex-president Kabila's allies to be questioned by military prosecutor



GNS News Agency, March 11 Officials from the party of Democratic Republic of Congo's former President Joseph Kabila have been invited to appear before a military prosecutor on Monday in a sign of political tensions over Rwanda-backed rebels' advances in the east.

The exact reason for the invitations was not clear. said Jean Mbuyu, a lawyer for the officials and former security advisor to Kabila. But President Felix Tshisekedi, who once formed an awkward power-sharing deal with Kabila, has recently accused him of sponsoring the M23 rebels who have seized east Congo's two biggest cities since January. Kabila has also reached out to opposition politicians and civil society members to discuss the country's political future, amid criticism of Tshisekedi's response to M23's military campaign. The military prosecutor's office sent about 10 invitation letters to members of Kabila's People's Party for Reconstruction and Democracy, though only three people were expected to appear for questioning in the capital Kinshasa on Monday, Mbuyu said. They included Aubin Minaku, vice president of the party and former president of the National Assembly, and Emmanuel Ramazani Shadary, a former interior minister and presidential candidate, Mbuyu said."We're going to listen because the invitation contains no reason," he said. Minaku said the officials would respond to the invitations "to avoid any suspicion" and denied links to M23 or any other armed groups. "We are taking a purely Republican approach, not one of rebellion," he told Reuters, using "Republican" to indicate loyalty to the country."We clearly denounced any illicit presence of foreign forces," he said. The latest M23 advance is the gravest escalation of a long-running conflict rooted in the spillover into Congo of Rwanda's 1994 genocide and the struggle for control of Congo's vast mineral resources. Rwanda denies providing arms and troops to M23, and says its forces are acting in self-defence against the Congolese army and militias hos-

## Melting glaciers changing New Zealand's landscapes, lives

Hyderabad: Globally, New Zealand ranks third in the proportion of ice lost from glaciers. Almost 30 per cent of ice volume has melted during the past 24 years and what remains is disappearing at an accelerating pace.

Almost 300 glaciers have now vanished completely from New Zealand's mountains. As warming temperatures melt glaciers, the ice loss has repercussions for climate and water cycles. This in turn has significant impact on land-scapes, rivers, ecosystems, people and economies. New Zealand is tracking glacial ice loss closely since 1977. Each year, scientists carry out aerial surveys of the snowline to determine how much of the previous winter snowpack has survived the summer melt season.

## Zelenskiy heads to Saudi Arabia ahead of crunch US talks

KYIV, GNS News Agency, March 11,President Volodymyr Zelenskiy travels to Saudi Arabia to meet Crown Prince Mohammed bin Salman on Monday, ahead of talks between Ukrainian and U.S. officials on ending the war with Russia at an increasingly precarious moment for Kyiv. The United States, once Ukraine's main ally, has upended its wartime policies in its stated pursuit of a rapid end to the fighting, engaging directly with Moscow while cutting off military assistance and intelligence sharing for Kyiv.

Zelenskiy is expected to meet the Saudi crown prince, whose country has played various mediating roles since Russia's 2022 invasion, including brokering prisoner exchanges and hosting talks between Russia and the United States last month. Tuesday's talks between U.S. and Ukrainian officials - the first official meeting since a disastrous Oval Office encounter between Zelenskiy and U.S. President Donald Trump - are expected to focus on a bilateral minerals deal and how to end the war. Under huge pressure from Trump, who wants the war ended at lightning speed, Zelenskiy has been at pains to show they are on the same page, despite failing to win U.S. security guarantees that Kyiv sees as vital for any peace deal. Zelenskiy has said he will not attend Tuesday's talks with U.S. officials and that the Ukrainian delegation will include his chief of staff, his foreign and defence ministers and a top military official in the presidential administration."On our side, we are fully committed to constructive dialogue, and we hope to discuss and agree on the necessary decisions and steps," Zelenskiy said in a post on X."Realistic proposals are on the table. The key is to move quickly and effectively."

U.S. officials said they were planning to use the meeting with the Ukrainians in part to determine whether Kyiv is willing to make material concessions to Russia to end the war."You can't say 'I want peace, 'and, 'I refuse to compromise on anything'," one of the officials said of the upcoming talks. A second U.S. official said: "We want to see if the Ukrainians are interested not just in peace, but in a realistic peace."Trump said on Sunday that he expected good results out of the upcoming talks, adding that the United States had "just about" ended a suspension of intelligence sharing with Kyiv.Trump special envoy Steve Witkoff, who has been



arranging the talks, has said the idea is to "get down a frame-work for a peace agreement and an initial ceasefire as well". Zelenskiy has called for a truce in the air and at sea, as well as a prisoner exchange, in what he says could be a test of Russia's commitment to ending the war. Moscow has rejected the idea of a temporary truce, which has also been proposed by Britain and France, saying it was a bid to buy time for Kyiv and prevent its military collapse.

Zelenskiy has also said Kyiv is ready to sign the minerals deal with the U.S., which would create a joint fund from the sale of Ukrainian minerals. Washington says it is crucial to secure continued U.S. backing. With U.S. support in question, Zelenskiy has been urging his European allies to ramp up their support as Kyiv's battlefield position deteriorates and it faces mounting pressure to retreat from Russia's Kursk region. Ukrainian troops that stormed into the Kursk region last summer are nearly surrounded by Russian forces, open source maps show. Russia holds around a fifth of Ukraine's territory, including Crimea which it annexed in 2014, and its troops are also pressing in the eastern Donetsk region, having ramped up drone and missile strikes on cities and towns far from the front. Russia has launched 1,200 aerial guided bombs, nearly 870 attack drones and more than 80 missiles at Ukraine in the past week alone, Zelenskiy has said.

## Canada's Carney faces Trump, tariffs and looming election



TORONTO, GNS News Agency, March 11 Former central banker Mark Carney claimed a landslide victory on Sunday to lead Canada's Liberal Party and to become the country's next prime minister. Now comes the hard part: taking on U.S. President Donald Trump who has threatened annexation, tackling a trade war and punishing tariffs, and leading the party through what promises to be a bruising general election that is likely imminent.

Carney won with 86% of the votes cast by party members. In the coming days Canada's Governor-General, the representative of Britain's King Charles in Canada, will invite him to form a government and will position Carney to replace Justin Trudeau as prime minister. But this reconstituted Liberal government is likely to be short-lived. Two Liberal Party sources said Carney will call an election in coming weeks, banking on new momentum for the party in polls. If Carney does not call an election himself, his political opponents have said they would defeat the government at their first opportunity when Parliament reconvenes. For months the opposition Conservatives led in the polls, often by double-digits ahead of the governing Liberals.

However, the political landscape shifted with the emergence of Trump, the prospect of tariffs and the threat of annexation. This coincided with a surge of support for the

Liberals, who have ridden a wave of renewed national unity to come neck-and-neck with the opposition party, according to the latest polls. Now the challenge will be to maintain that momentum and convince Canadians to give a party that spent a decade in power under Trudeau another go while fighting a trade war on multiple fronts that seems to shapeshift by the hour."Without overstating it, the challenges are almost unique in Canadian history, if not unique in the post-war period," said Cameron Anderson, a politics professor at Western University."We have big challenges domestically in terms of cost of living and housing and health care and managing immigration. ... And then I think when we look at Canada as a country in the world, we're probably threatened and have the sense of being threatened in a way we haven't in many generations." Carney will be the first person to become Canada's Prime Minister with no prior experience in electoral politics. The former governor of the Bank of Canada and Bank of England shot to the front of the Liberal leadership race, ahead of two women who held seats in Trudeau's Cabinet. Carney promised on Sunday evening to scrap the consumer price on carbon and stop a planned increase in the capital gains tax. He says he supports dollar-for-dollar retaliatory tariffs in response to Trump's tariffs.

Like others, Carney pledged to remove barriers to trade within Canada. He vowed to double the pace of new housing construction over 10 years and cap immigration, a shift in policy Trudeau had started. Liberals sought to compare Conservative leader Pierre Poilievre to Trump in a recent advertisement. Poilievre in turn ramped up attacks on Carney on Sunday. Carney "will emphasize the policy departures that were kind of necessary conditions for countering Poilievre," said University of British Columbia politics professor Richard Johnston. "Whether these reversals are good policy is a whole other matter. "But a major emphasis, Johnston said, will be "keeping his cool in the face of Donald Trump. ## A new framework to bridge the skills gap in higher education

Challenges in higher education are becoming increasingly nuanced and complex. Technological innovations, shifting human-machine frontiers, and advances in AI, Healthcare, and Medicine are emerging as key focus areas. The World Economic Forum's Future of Jobs Report 2023highlights that 44% of workers' skills will be disrupted by 2027. Analytical and creative thinking will be crucial skills in the next five years, closely followed by leadership, social influence, resilience, flexibility, and agility.

Possible approaches The future of higher education lies in the fine integration of these skill sets. The Association to Advance Collegiate Schools of Business (AACSB) emphasises a principles-based and outcomes-focused approach and underscores the need for experiential learning, social impact, career readiness, and partnerships. Similarly, the Accreditation Board for Engineering and Technology emphasises skill competency while ensuring that academic programmes meet high-quality standards aligned with industry needs. The National Board of Accreditation in India focuses on achieving desirable outcomes in knowledge, skills, attitudes, and behaviour, based on an 'Input-Process-Output' model. Additionally, the National Educational Policy (NEP) 2020 emphasises knowledge, skills, values, and dispositions that support responsible commitment to human rights, sustainable development, and global well-being. The question now is whether Indian higher education institutions (HEIs) are equipping students with these skills, or still fixated on teaching them to remember and understand subjects through a taxonomical design, such as Bloom's Taxonomy? The answer, unfortunately, is a resounding "Yes", with some exceptions. How can we prepare students to be future ready? Competency-based education (CBE) and outcome-based education (OBE) are two dominant approaches to assess student learning. OBE emphasises mastery of specific skills and competencies that reflect real-world experiences, while CBE aligns educational outcomes with the labour market needs, increases employability, and fosters industry connections. Unfortu-

nately, both often focus on discipline-centric skills and overlook discipline-neutral ones. Consequently, HEIs assess educational relevance by emphasising multidisciplinarity and transdisciplinarity as educational outcomes. While CBE advocates for a transformative approach, there remains a transactional focus. The skill gaps in higher education are particularly pronounced in the technology sector. A high rate of graduate unemployment due to a mismatch between the skills taught in colleges/universities and those needed by industry has led to poor job performance and employer dissatisfaction, particularly in areas such as writing, editing, research, and data analysis. These challenges can be addressed by a newframework that effectively integrates knowledge, cognition, and social inquiry into the educational curriculum, focusing on skill development and social orientation. It positions students as key stakeholders alongside parents, industry representatives, and faculty and emphasises social orientation and skills competency by integrating OBE and CBE, promoting a multidimensional approach to learning. It enables students to develop higherorder skills, enhance their capacity for social inquiry, and refine and sharpen their competencies throughout their academic journey. Not only does it formally integrate social inquiry into educational design but also strengthens skills and competency courses while establishing a robust, communicative, and engaging framework. This allows for mapping students' skills and social orientation through a well-defined mentoring process, including corporate mentoring in subsequent stages. The framework involves a three-stage assessment:Stage I: Initial assessment of student skills during the orientation programme and/or at the start of classes. Students participate in the Learners Value Proposition (LVP), which, while not mandatory, facilitates skills mapping. Once the results are analysed, they are aligned with the programme's mission and objectives, creating a case file for each student. Stage II: Assigned mentors conduct continuous assessment at the end of each semester and implement the necessary intervention for skill development through electives and participation in activities or field

## Malaysia warns against travel to southern Thailand after attacks

BANGKOK, Malaysia has warned its citizens against travelling to southern Thailand after bombings and shootings by suspected insurgents killed five people and injured 13 others at the weekend. The attacks occurred in the mainly ethnic Malay Muslim southernmost provinces of predominantly Buddhist Thailand, where more than 7,300 people have been killed since a decades-old separatist rebellion reignited in 2004.

Gunmen fired into a district office and detonated a car bomb in the Sungai Kolok border town of Narathiwat province, popular with Malaysian tourists, killing two Thai security volunteers, authorities said. In neighbouring Pattani province, a roadside bomb killed a volunteer ranger and two government officials. "Malaysians are strongly encouraged to postpone non-essential travel to these areas for the time being," the Malaysian foreign ministry said in a statement issued on Sunday. About 4.9 million of the 35.5 million visitors to Thailand last year were from Malaysia, making it the second biggest source market for tourism after China. Security has been tightened in the area, Narathiwat governor, Trakul Thotham,

"This kind of incident has not occurred in the last four to five years," he said, adding and that there were still Malaysians in the area and there would be some impact in the initial stages. # South Korea prosecutors to pursue Yoon's conviction despite jail release

SEOUL, March 10 (Reuters) - South Korean prosecutors will pursue President Yoon Suk Yeol's conviction for insurrection despite a court decision ordering the release of the impeached leader from prison, the head of the prosecutors' office said Prosecutor General Shim Woo-jung said he respected the weekend court ruling but did not agree with its assessment that the indictment filing was past the legally allowed expiry time, which the court said made Yoon's detention while on trial illegal."I've directed that the prosecution makes arguments on various disputes during trial, and we'll do everything we can to pursue this indictment," he told reporters when asked whether the court ruling meant it was likely to drop the case.

Yoon has been on criminal trial since February 20 over allegations he led an insurrection by declaring martial law on December 3. He lifted the martial law decree after about six hours. His lawyers had filed a motion to cancel his detention and said Friday's ruling showed the case against Yoon was politically motivated and had no legal justification. The embattled leader walked out of a detention centre on Saturday, about a week short of two months after being arrested. He was impeached by parliament and remains suspended from power. The Constitutional Court is expected to decide in coming days whether to overturn the impeachment and reinstate him or remove him from office permanently. If Yoon is removed, a new presidential election will be held within 60 days. Yoon said his martial law declaration was needed to root out "anti-state" elements; parliament rejected it within hours. The decision by the Seoul Central District Court on Friday to cancel Yoon's arrest warrant rather than allowing the automatic extension of his detention during his trial drew mixed reactions from the public and political parties. The prosecution decided not to appeal the ruling based on a conservative reading of Constitutional Court decisions in previous cases rejecting prosecutors' appeals, Shim said. Yoon was met by enthusiastic crowds of supporters as he walked out of the detention centre and as he returned to his official residence, where he was arrested on January 15, becoming the first sitting president to be detained and indicted. ## North Korea fires missiles after slamming US-South Korea drills

SEOUL, GNS News Agency, March 11 North Korea fired multiple ballistic missiles on Monday, hours after condemning the South Korean and U.S. militaries for launching drills that Pyongyang called a "dangerous provocative act" that risked accidentally sparking a confrontation. South Korea's military said the missiles were fired from North Korea's western region toward the Yellow Sea. The launch was the first reported ballistic missile test since U.S. President Donald Trump took office in January.

The missiles were believed to be close range ballistic missiles, a South Korean defence ministry official said, referring to a type of weapon with a range of under 300 km (186 miles). The allies' annual Freedom Shield drills are scheduled to run until March 20, although live-fire exercises remain suspended after South Korean jets mistakenly dropped bombs on a civilian town near the border last week, injuring 29. North Korea has typically demanded U.S.-South Korea joint exercises to be halted, branding them a prelude

The South Korean military has said the joint drills aim to strengthen the readiness of the alliance to face threats such as North Korea.

"This is a dangerous provocative act of leading the acute situation on the Korean peninsula, which may spark off a physical conflict between the two sides by means of an accidental single shot, to the extreme point," North Korea's foreign ministry said, according to state media outlet KCNA. The drills would harm U.S. security, the ministry added.

## A city held hostage by pigeons

In a bustling lane on Ranade Road, Dadar, an elderly woman tossed a handful of grains onto the pavement, watching with satisfaction as dozens of pigeons swooped in, flapping their wings and jostling for space. Meanwhile, a shopkeeper on the opposite side grumbled as he scrubbed at the stubborn crust of droppings coating his storefront.Across Mumbai, from high-rise apartments to crowded markets, the city's love-hate relationship with pigeons is on full display. Once symbols of peace and endurance, these birds have multiplied beyond control, becoming an urban menace affecting public health and damaging infrastructure. Pigeons, also known as rock doves, have become an inseparable part of Mumbai's cityscape, fluttering around railway stations, perching on balconies, and congregating in designated feeding areas known as Kabutarkhanas. While many residents see them as harmless birds and even enjoy feeding them, their rampant population growth has triggered serious concerns that usually

The unchecked rise in Mumbai's pigeon population, fuelled by rapid urbanisation and human intervention, is posing a growing challenge to the city's biodiversity. Experts warn that while pigeons have seamlessly adapted to urban life, their increasing numbers are disrupting the ecological balance and outcompeting native bird species. "Urban environments create a highly conducive habitat for pigeons due to a confluence of factors," says Bharat Bhushan, honorary secretary of the Bombay Natural History Society (BNHS). "Beyond deliberate feeding, cities offer a consistent, readily accessible food supply from discarded human food scraps, spilled grains, and other refuse. Buildings provide ample shelter in various structural elements, including ledges, crevices, ducts, and abandoned spaces, offering protection from predators."

Unlike wild birds that face natural threats, Mumbai's pigeons have no significant predators to regulate their numbers. Their year-round breeding cycle, combined with a safe urban environment, allows them to multiply rapidly. This overpopulation is pushing native species like bulbuls, sparrows, and mynas out of their habitats. "The substantial increase in pigeon populations within urban environments can result in competitive exclusion, where pigeons aggressively outcompete native bird species for essential resources like food, nesting sites, and even territory," Bhushan said. The dominance of pigeons affects not just food availability but also breeding patterns of other birds. "The sheer number of pigeons can overwhelm available food sources, leaving less

for other birds, and their dominance can prevent other species from successfully breeding in preferred locations. Bhushan added. Even natural predators like kites and falcons are too few to control the overwhelming pigeon population. While several factors contribute to this rise, one of the most overlooked is the widespread practice of mercy feeding. Mercy feeding, the practice of feeding pigeons in public spaces, has become a deeply rooted tradition in Mumbai. Many citizens consider it an act of kindness, often influenced by religious beliefs and cultural sentiments. However, experts argue that uncontrolled mercy feeding does more harm than good to the birds. "Urban pigeon feeding, though seemingly kind, fuels overpopulation, creating unsanitary conditions. Artificially inflated populations disrupt local ecosystems and strain city resources," said Praveen Singh Pardeshi, president, BNHS. Pigeons in cities survive largely on food provided by people rather than natural sources. Large gatherings of pigeons at feeding spots lead to overpopulation, dependency, and unnatural changes in their behaviour. Unlike wild birds that forage for food, pigeons in Mumbai are thriving on easy food availability. Public spaces such as Girgaum Chowpatty, Marine Drive, and various railway stations have turned into feeding hotspots. While feeding pigeons might seem like a harmless act, it encourages them to flock in large numbers. This continues even as the authorities and conservationists advise to limit mercy feeding in a bid to maintain a balanced urban eco-

A PETA study on pigeon behaviour found that pigeons breed in direct proportion to the availability of food. Simply put, the more they are fed, the more they reproduce. To address this, awareness campaigns are gaining traction. BNHS, in collaboration with the JSW Foundation, recently launched a documentary titled Mercy Feeding: Pigeon Menace in Urban Areas, highlighting the consequences of excessive feeding. "Feeding pigeons in our cities may seem kind, but it creates serious issues for all of us. Overcrowding disrupts the balance of nature. True care means protecting both people and wildlife," said Sangita Jindal, chair-person of the JSW Foundation.

Pigeon droppings, feathers, and nesting material carry harmful pathogens, including bacteria, viruses and fungi that can cause severe respiratory and systemic illnesses. In densely populated areas where humans and pigeons coexist, the health risks are amplified. One of the most concerning conditions linked to pigeons is Hypersensitivity Pneumonitis (HP), a severe lung disease triggered by pro-

pigeon droppings. "Both pigeon droppings and feathers affect human health, affecting the lungs the most, resulting in acute, sub-acute, or chronic illness called Hypersensitivity Pneumonitis (HP)," said Dr Sundeep Mestri, Pulmonologist, MGM New Bombay Hospital. The disease starts with a dry cough and lung irritation, eventually leading to permanent lung damage if exposure continues. "In our own experience, Mumbai is witnessing a rise in HP patients, and there are many direct cases where patients share their exposure with pigeons resulting in the cause," said Dr Lancelot Pinto, Consultant Pulmonologist and Epidemiologist, Hinduja Hospital.HP has now become the leading interstitial lung disease (ILD) in India, with ongoing studies by Hinduja Hospital confirming a direct link to pigeon exposure. "The blood tests are positive for pigeon antigens, indicating that patients are generating antibody responses to them," Pinto added.Beyond HP, pigeons also spread Cryptococcosis, a fungal infection that can cause neurological issues in immunocompromised individuals, Histoplasmosis, which leads to lung infections, and Psittacosis, a bacterial infection that mimics pneumonia.

Beyond health hazards, pigeons are notorious for the destruction they leave in their wake. Their highly acidic droppings corrode concrete, metal, and stone, causing long-term damage to historical landmarks, residential buildings, and public infrastructure. Mumbai's humid climate exacerbates the problem, as damp conditions help pigeon droppings stick to surfaces, accelerating decay. Mumbai's heritage sites, including Chhatrapati Shivaji Maharaj Terminus and old colonial-era buildings, suffer from the continuous charge of pigeon droppings. The acidic excreta eat away at stone facades, leading to significant maintenance costs. Even residential buildings face a similar fate, with balconies, air conditioning units, and window sills covered in layers of droppings that harden over time, making cleaning an arduous and expensive task

To combat the issue, property owners install bird-proofing measures like spikes and nets, but these require constant upkeep, adding to the financial burden. Public spaces and markets face an additional challenge—pigeon feeding sites attract rats and other pests, worsening sanitation and increasing the risk of other disease outbreaks. The Brihanmumbai Municipal Corporation has the authority to fine individuals ?500 for feeding birds or animals in non-designated areas under the 2006 civic cleanliness and sanitation bylaws, framed under Section 461(ee) of the Mumbai



Municipal Corporation Act, 1888. Similarly, the Thane Municipal Corporation introduced fines for pigeon feeding last year. According to a BMC official, BMC does not have any separate bylaws specific to pigeons; they take action based on the SWM bylaws, which empower them to impose a fine for feeding any animals or birds. However, there is a need for implementation of stricter laws to free the city from the persistent crisis.

Mumbai's attempts to control its surging pigeon population have largely failed, as conventional methods proved ineffective. Trapping and relocation do not work, as pigeons instinctively return to their nesting sites. Poisoning is inhumane and often illegal, while deterrents like spikes and nets require constant upkeep. Before any large-scale intervention, experts emphasize the need to stop feeding pigeons. Nature conservationist Stalin D states, "This is a manmade problem and not natural. At least to start with, there has to be a strict ban on the feeding of pigeons at non-designated spots. Their food issue is taken care of, and the only task they have on hand is to reproduce."

Globally, cities like London and Barcelona have experimented with pigeon contraceptives—special grains that prevent egg fertilization. Such solutions could help Mumbai, but success depends on public cooperation. Uncontrolled feeding continues to fuel pigeon breeding, rendering control measures ineffective. "Birth control pills can also be given under scientific supervision," Stalin added. Experts suggest a multi-pronged approach – public awareness campaigns to educate citizens on the risks posed by pigeons, regulated feeding zones to prevent overpopulation, and architectural changes like sloped surfaces to deter nesting. Additionally, introducing pigeon contraceptive programs and improving waste management can limit their food supply.

## How climate change affects India's wheat production

India recorded its warmest February in 124 years this year. The India Meteorological Department has already raised an alarm for March, saying that the month will experience above normal temperatures and more than the usual number of days with heat waves. The period coincides with the beginning of India's wheat harvest season, and extreme heat poses a grave threat for the country's second-most consumed crop, after rice.

Wheat in Indialn India, wheat is primarily grown in the northwestern parts of the Indo-Gangetic plains. Primary producers include the States of Uttar Pradesh, Punjab, Haryana, and Madhya Pradesh. Wheat needs a cooler season to grow, and the crop is usually sown between October and December. It is harvested between February and April in the rabi crop season.

The Indian government set a wheat procurement target of 30 million tonnes for the 2025-2026 rabi marketing season, news agency PTIreported in January. The lower procurement target comes despite the agriculture ministry aiming for a record wheat production of 115 million tonnes in the 2024-2025 crop year (July-June), the report added.In 2024-2025, government wheat procurement was recorded at 26.6 million tonnes. While this exceeded the 26.2 million tonnes procured in 2023-2024, it fell short of the 34.15 million tonne target for the year.In May 2022, India had prohibited wheat exports. This was shortly after Russia invaded Ukraine, a major wheat-producing country, which disrupted international availability of the food grain and triggered a global price hike.Heat and wheat

Climate variability itself is not a new phenomenon, but it catches our attention when the crop growth season overlaps with heat wave conditions, Sandeep Mahato of the M.S. Swaminathan Research Foundation (MSSRF), Chennai. .A 2022 study in the International Journal of Molecular Sciences noted that increasing global warming is causing heat stress that "triggers significant changes in the biological and developmental process of wheat, leading to a reduction in grain production and grain quality". According to the paper's authors, heat stress is known to affect the growth and development of wheat by altering "physio-bio-chemical processes such as photosynthesis, respiration, oxidative damage, activity of stress-induced hormones, proteins and antioxidative enzymes, water and nutrient relations, and yieldforming attributes (biomass, tiller count, grain number and size) upon exposure to temperatures above the optimum

Stages of wheat growthAccording to the UN Food and Agriculture Organisation, stages of wheat growth are defined based on how different organs of the plant develop. This can be broadly grouped into four stages:(i) Germination to emergence: This includes the growth of the seed until the seedling breaks through the soil surface and the first leaf emerges.

(ii) Growth stage 1: Steps from emergence to double ridge. Shoots appear, and the plant growth shifts focus from producing primordial leaves to flowering structures called spikelets.(iii) Growth stage 2: This stage lasts from double ridge to anthesis. This is where the focus of the plant shifts from vegetative to reproductive stage. This is also one of the stages where the plant is comparatively more susceptible to heat stress.

(iv) Growth stage 3: This stage includes the grain-filling period, from anthesis to maturity. Optimal temperature required for different stages of growing wheat.

According to experts, the real problem starts with the oceans. The Indian Ocean is warming at an accelerated rate. A 2024 study conducted by scientists at the Indian Institute of Tropical Meteorology, Pune, noted that the Indian Ocean will likely be in a "near-permanent heat wave state" mainly as a result of global warming by the end of the century. The frequency of marine heat waves is expected to increase tenfold, from the current average of 20 days per year to 220-250 days per year, the study added. A warming Indian Ocean will in turn alter India's monsoon, on which most of the country's agriculture depends. For example, the kharif or summer crop season is starting and ending late, which inevitably delays the beginning of the rabi season. Wheat is a rabi crop. If its sowing starts late, the later stages of plant growth will coincide with early heat waves in India. February 2025 was warmer than usual, and

similar trends have been predicted for March. This is also the peak season for wheat harvest, and ideal temperature in later stages of the plant's growth should not cross 30° C.

"High temperatures cause early flowering and faster ripening, shortening the grain-filling period. This results in lighter grains with lower starch accumulation, reducing the total wheat output," Prakash Jha, assistant professor of agricultural climatology at the Mississippi State University, "Extreme heat causes wheat to develop higher protein content but lower starch, making the grain harder and affecting milling quality. Farmers may face lower market prices due to reduced grain weight and quality issues," he added.

Low crop yield also tends to make farmers desperate and result in overuse of fertilisers, fungicides, etc., Nikhil Goveas, lead climate advisor with the Environmental Defense Fund, told. "Higher but inefficient use of resources is another cascading effect of heat-stress challenges in crops." Food security is central to the adaptation and mitigation strategies officials use to lower the heat stress on wheat crops. "Wheat is ... important for farmers because it can be consumed immediately, so part of the produce is always saved for household consumption," Goveas said.

Farmers rely on older varieties of the crop because accessibility is a challenge, with problems related to the supply chain, costs, etc. Climate-resilient varieties are important, but they are not a silver bullet solution to the challenge, Goveas added: "The problem is a deeper challenge of the climate crisis on our food systems. The earth is getting warmer. We need to think about not just one crop but all crops: get timings right, have our information and weather systems updated with the knowledge of what to expect, and undertake mitigation efforts against the challenges."

"The larger question here is to be able to guarantee food security," Mahato of MSSRF Chennai said. "We have to focus on addressing yield gaps. This ties in the issue of efficient management of resources like fertilisers, pest control, etc." According to Mahato, immediate policy support to farmers to deal with heat stress effects on wheat can be in the form of compensation, but there are more long term solutions that need to be incorporated into our agricultural practices.

"Changes in agricultural management strategies to support early sowing of crops in areas that are likely to see early heat waves, or introducing improved yield varieties with shorter growth duration are some policy changes that can alleviate heat stress on wheat," he added. "There is no compromise that can be done on improving production and that should be the central goal to the adaptation question." "Policymakers must take a multi-pronged approach, combining scientific research, financial support, technological solutions, and farmer education to protect wheat crops from rising heat stress," according to Jha. "This includes promoting heat-resistant wheat varieties, adjusting sowing dates, financial support and crop insurance, and weather monitoring and advisories."

Between 2017 and 2023, rural female participation in the workforce jumped from 24.6% to 41.5%, with the JJM cited as a key driver of this positive change. By freeing women from the daily chore of water collection, this initiative is unlocking new opportunities for economic independence and helping local economies thrive. India's efforts in empowering women through targeted policies and initiatives are not just improving daily life. They are also creating a foundation for future progress. With continued focus on accessible resources, financial inclusion, and breaking down social barriers, India is paving the way for a generation of women to lead and succeed in every area of life. ### Towards a joyous smile: advancements in cleft lift and palate treatments

File photographCleft lip and palate, a congenital disorder affecting 1 in 700 live births, is a significant healthcare burden in India. The condition leads to mental agony for the patients and their families. Maternal iron deficiency, alcoholism/smoking, and consanguineous marriages are the most common causes for cleft lip/palate. It shouldn't be surprising to note that all of these fall very much in the realm of preventable factors

Managing a cleft baby is an extended commitment for the healthcare industry because the treatment is growth and time-bound, starting from prenatal counselling all the way up to orthognathic surgery and rhinoplasty during adulthood. The family is often distressed and confused on seeing the newborn with cleft lip/palate. The onus is on the cleft care team to transform this feeling to hope and clarity as early as possible. Feeding cleft babies requires modified techniques to prevent aspiration, and the parents should be trained appropriately. As soon as the baby attains adequate weight and fitness to tolerate general anesthesia, their lip is surgically corrected, offering the first psychosocial breakthrough. We often find the parents and the family gaining confidence and trust after this phase, and they understand the need to wait for timely interventions in a phased man-

One must accept that although the anomaly has common presentations to a large extent, every case is different in terms of severity and complexity. Complex clefts are often difficult to repair in a precise manner requiring additional interventions. Nasoalveolar moulding (NAM) is one such innovation to reduce the width of the cleft and enhance the shape of the nose, rendering surgical lip corrections more aesthetic. It involves fabrication of a custom appliance that could be fit on newborns with challenging clefts and distorted noses. Although originally described using conventional techniques employed in dentistry, digital technology

has off-late improved the way we perform NAM. The cleft team can now acquire an instant photo-scan of the babies' oral cavity, prepare a 3-D printed replica and fabricate an NAM device without traumatising the baby by contact. The palate, also called the roof of the mouth plays a crucial role in swallowing and speech. Most often, children begin to utter words around the 10th month of their life and it is during this phase that their palates need to be corrected. Once their cleft palate is anatomically corrected, they have a better chance of learning to pronounce words the right way, often with the help of speech therapy. Innovative assessment tools, such as nasopharyngoscopy and electromyography, enable speech therapists to accurately diagnose and treat velopharyngeal dysfunction (VPD). Newer techniques, including electropalatography and ultrasound biofeedback, facilitate more effective and targeted treatment of speech disorders associated with cleft palate. The canine teeth are considered the cornerstones of the smile, and need to be in proper alignment in the upper jaw. Unfortunately, due to clefting, they often fail to erupt in a desirable time and position. Alveolar bone grafting involves filling up the bony voids caused by clefting of the upper jaw and this is performed around 8 to 10 years prior to the eruption of the canine teeth, to restore continuity of the jaw bone as well as to facilitate the eruption of the teeth. Although the commonly-used donor site for grafting happens to be the hip bone (Iliac crest), research advances have facilitated the use of bioactive scaffolds, mesenchymal stem cells and growth factors like bone morphogenic proteins (BMP), vascular endothelial growth factors (VEGF) and platelet derived growth factors (PDGF) to enhance outcomes in alveolar bone grafting.

Virtual Surgical Planning (VSP) and Virtual Reality (VR) have revolutionized cleft and craniofacial surgery more than many other sub-specialties at the moment. In general, VSP improves accuracy, reduces operating time, enhances patient safety by identifying potential risks and offers better outcomes. From simulating the cleft lip and rehearsing operations at the skills lab prior to the main surgical theatre, to planning the defect size and bone requirement in alveolar bone grafting, VSP/VR are potentially useful tools for a surgical team. Even the orthognathic surgery, meant to be performed during early adulthood of a cleft patient, could be planned using VSP, and the outcomes discussed with the patient prior to surgery. This provides them with a chance to look at their future faces and decide on alternative approaches rather than accepting whatever is offered. We are of the strong opinion that cleft care involving the integration of AI in VSP along with augmented reality will positively influence the dynamics in a medically strong country like India. These advances will enhance the standard of care in aesthetically and functionally challenging anomalies involv-

## 100-day TB elimination campaign far from achieving main objective

The 100-day intensified TB elimination campaign was launched on December 7, 2024 across 455 intervention districts in 33 States and Union Territories to screen and test for TB among people belonging to the vulnerable or highrisk group — diabetics, smokers, alcoholics, people living with HIV, those with TB in the past, geriatric population, house-hold contacts of TB patients. Besides screening people who have TB symptoms, the main intent of the intensified campaign is to use a chest X-ray to screen people for subclinical or asymptomatic TB disease followed by bacteriological confirmation using a molecular test.

"This isn't just about diagnosing patients who show symptoms; it's about finding those hidden cases who would otherwise remain undetected by using Chest X-rays, enhanced with AI, an effective method for screening individuals who may have TB but may not have the classical symptoms of TB," Dr. Vinod Paul, Member of Niti Aayog wrote in an Opinion article in Business Line on March 5, 2025.

As per a February 22, 2025 PIB press release. over 5.1 lakh (0.51 million) TB notifications have been recorded across India. Of the 5.1 lakh total notifications across India, over 3.5 lakh TB notifications are from the 455 intervention. districts after more than 10 crore (100 million) vulnerable individuals were screened between December 7, 2024 and February 22, 2025. The detection of over 3.5 lakh TB cases in the intervention districts have been as a "result of accelerated case detection efforts and reduced diagnostic de-

lays", the press release says. According to data available on the Ni-kshay website, the number of TB cases notified across India from December 7, 2024 to March 6, 2025 is 6,35,035. During the corresponding period last year — December 7, 2023 to March 6, 2024 — 6,34,815 cases were notified across India. Between December 7, 2024 and February 22, 2025, there have been 5,77,676 TB notifications across India, which are more than the 5,10,000 notifications mentioned in the February 22 press release. The increase in the TB notifications on the Ni-kshay website is not unusual as there is generally a 15day lag for the exact data to get reflected on the website. The number of TB notifications during the corresponding period last year — December 7, 2023 to February 22, 2024 was 5,33,091. So compared with the corresponding period last year, the total TB notifications even across India has increased by only 44,585 between December 7, 2024 and February 22, 2025. Therefore, it is certainly wrong to attribute all the 3.5 lakh TB cases detected in the intervention districts to accelerated case detection during the 100day intensified TB elimination campaign. In other words, the government's claim would mean that all 3.5 lakh cases would have been missed in the absence of the accelerated case detection, which does not get reflected in the TB notifications on the Ni-kshay website. The total number of TB notifications across India between December 7, 2024 and March 6, 2025 has been almost the same as the corresponding period last year. While the campaign would have surely picked up more cases, even the increase of 44,585 cases during the period December 7, 2024 to February 22, 2025 compared with the corresponding period last year cannot be ascribed to intensified case detection alone. The reason: aside from the fact that the 44,585 more TB cases notified are across India (788 districts) and not from the 455 intervention districts alone, the number of TB cases notified has been increasing each year in the last few years. From 21,35,830 TB cases notified in 2021, it increased to 24,22,121 notifications in 2022, and then to 25,37,235 notifications in 2023, and 26,18,499 notifications in 2024. As per the National TB Prevalence Survey 2019-2021, 42.6% of TB cases would have been "missed" if a chest X-ray was not used for screening, thus revealing the magnitude of subclinical/asymptomatic TB cases in India. To detect such

cases, the campaign claimed that a "new strategy was de-

signed" for early identification of TB by using X-ray for

screening people without TB symptoms. Yet, only 38 lakh




of the over 10 crore (100 million) individuals have been screened using X-rays as of February 22, which is just 3.8%. Worse, despite the fact that asymptomatic TB disease cases can be detected only with a chest X-ray, all the 38 lakh people screened using a chest X-ray did not belong to this category. As per the press release, only a "substantial population" of people without TB symptoms were screened with a chest X-ray. Though it claims "several asymptomatic TB patients" are detected, there is no mention of the actual numbers. It is not surprising that only a small fraction of the high-risk population was screened using a chest X-ray. As per the press release, there are just 836 vans equipped with portable X-ray machines to screen the high-risk population in the 455 intervention districts.

All you need to know about: Hantavirus



According to the U.S. Centers for Disease Control and Prevention (CDC), hantaviruses are a family of viruses that can cause severe, potentially fatal illnesses. These viruses lead to life-threatening diseases, including hantavirus pulmonary syndrome (HPS), a severe respiratory illness, and hemorrhagic fever with renal syndrome (HFRS), a condition characterised by internal bleeding and kidney failure. The recent passing of Betsy Hackman, wife of renowned American actor Gene Hackman, has drawn attention to this deadly virus. Although cases are rare, the severity of the illness makes understanding its spread, symptoms, and treatment options crucial

How does hantavirus occur?

Hantaviruses are a family of viruses carried by certain rodents, such as deer mice, white-footed mice, rice rats, and cotton rats. According to the CDC, humans typically contract hantavirus through contact with infected rodent urine, droppings, and saliva. The most common way the virus spreads is through aerosolisation, when fresh rodent waste is disturbed, the virus particles become airborne and can be inhaled. This often happens during activities like sweeping infested areas, cleaning long-closed spaces such as sheds, or handling contaminated materials. Additionally, hantavirus can enter the body if a person touches their eyes, nose, or mouth after handling contaminated materials or if the virus enters an open wound. Though extremely rare, the virus can also spread through rodent bites. They do not typically transmit from person to person, although rare cases of human-to-human transmission have been reported with certain strains, such as the Andes virus.

What are the signs and symptoms? According to the World Health Organisation's manual,

hantaviruses are a family of viruses with several strains exhibiting varying degrees of severity. The infection typically progresses in two stages. The first phase, known as the "prodromal phase," appears one to eight weeks after exposure. It begins with flu-like symptoms such as fever, chills, muscle aches (often in the thighs, hips, and back), fatigue, headaches, and abdominal pain. Nausea, vomiting, and diarrhea may also occur. The second phase, which signals the onset of HPS, brings more severe symptoms. These include a sudden shortness of breath, coughing, and chest tightness as the lungs fill with fluid. This stage can escalate quickly, causing acute respiratory distress and, in some cases, heart failure. Without prompt medical intervention, the condition can be fatal. Who is at risk?

Those at higher risk of contracting hantavirus include people who live or work in areas where rodent populations are more prominent. This includes farmers, construction workers, and those involved in cleaning old or unused spaces. Campers and hikers who come into contact with rodent nests or droppings are also vulnerable. Even homeowners dealing with rodent infestations need to be cautious, as everyday cleaning tasks can unknowingly stir up contaminated particles. The CDC also emphasis that children under five, pregnant women, and individuals with weakened immune systems should avoid handling pet rodents, as they have a higher risk of serious illness.

What are the treatment options?

Currently, even though there is no specific antiviral treatment or cure for hantavirus, medical care focuses on managing symptoms and supporting the patient through the most dangerous phases of the illness. In cases of HPS, patients are often given oxygen therapy to ease breathing difficulties. Severe cases may require intensive care, including mechanical ventilation to assist lung function. Since no direct medication exists, early detection is vital. Those who experience flu-like symptoms after potential rodent exposure should seek medical attention immediately, as quick intervention, such as oxygen support, can prevent the progression of severe respiratory distress. Prevention remains the most effective way to combat hantavirus. Keeping homes and workplaces rodent-free by sealing entry points, safely disposing of food and garbage, and wearing protective gear when cleaning areas with rodent activity can significantly reduce the risk.

## India-EU FTA talks set to resume today amid Trump's tariff threats

India and the European Union (EU) will start the 10th round of negotiations for a bilateral Free Trade Agreement (FTA) on Monday, with a clear deadline from its top leadership to finalise the pact by this year-end. While the issues that were holding up the progress remain, the global tariff war set off by the US, change in approach of India to import duties reinforced in the latest budget and flexibility shown by EU on matters of carbon tax and related matters could push negotiations much further in this round, according to

The 10th round of talks in Brussels from March 10 to March 14 comes immediately on the heels of top-level engagement between the two sides with the European Commission's President Ursula von der Leyen and a full college of commissioners visiting India late last month for detailed talks on the entire spectrum of the relationship. For India, the EU is as big a market as the US with bilateral goods trade of \$190 billion. While there is a lot of uncertainty on what a Bilateral Trade Agreement (BTA) with the US would entail, talks with the EU have been going on since 2022 in the current phase. From the Indian side, the concerns centre around agriculture, duties on wines and automobiles, and flexibility on movement of professionals for services delivery. "While both sides seek to expand trade, differences persist over scope of tariff reductions, regulatory barriers, and market access across agriculture, labourintensive goods, and wines and the automobile sector. While the EU seeks tariff elimination on over 95 per cent of its exports, India may be willing to open not more than 90 per cent of its market," founder of Global Trade Research Initiative (GTRI) Ajay Srivastava said. In agriculture, the EU is pushing for India to cut tariffs on cheese and skimmed milk powder while it imposes high duties and very tough standards. Even if tariffs are reduced, the EU's regulatory framework will remain a major hurdle for Indian farmers and food producers.

The EU wants India to cut duties on wines to 30-40 per cent from 150 per cent. India has offered 50 per cent duties in its trade deal with Australia and this might be repeated for the EU. The duty cuts in labour intensive sectors can come very early on in the deal. Currently, India's textile exports to the EU face tariffs between 12-16 per cent, makng Indian products less competitive compared to exports from countries like Bangladesh and Vietnam, which enjoy preferential market access under EU trade agreements.In auto, EU manufacturers want India to cut import duties on completely built-up (CBU) vehicles to 10-20 per cent, down from the current 100-125 per cent. The EU already exports over \$2 billion worth of automobiles and auto parts to India annually, with most arriving in completely knocked-down (CKD) form, which face a 15 per cent tariff when assembled locally. India has previously refused to lower auto tariffs for Japan and South Korea under its existing FTAs, "A potential middle ground may involve allowing a limited number of European cars to enter India at lower tariffs," Srivastava said. The EU imposes restrictions on remote online service delivery and does not recognise India as a data secure country, thereby restricting data flows. In services, European firms are seeking greater access to India's banking, legal, accountancy, auditing, and financial services sectors. To these old issues new ones have been added through the Carbon Border Adjustment Mechanism (CBAM) or carbon tax. India has asked for exemption for small and medium enterprises from the obligations of CBAM. At the 2nd Trade and Technology Council (TTC) meeting, both sides agreed to address the challenges that the small and medium businesses will face due to CBAM.

## How continuing fall in the secondary market is impacting IPO activity

The domestic stock market has been reeling under heavy selling pressure for the past few months. Benchmark indices, Sensex and Nifty, have lost nearly 13 per cent from their peaks touched in September last year, eroding nearly Rs 79 lakh crore of investors' wealth. A sharp correction in the secondary market has impacted the initial public offering (IPO) fundraising plans of companies. Over two dozen companies that received IPO approval from the market regulator, SEBI, have yet to launch their offerings. These companies are waiting for the market to stabilise before they proceed with their IPO fundraising plans. A slump in the secondary market also lowers retail investors' interest in the primary market.

According to data obtained from Prime Database, 26 domestic companies received approval from the Securities and Exchange Board of India (SEBI) between April-December 2024 and are yet to hit the primary market. These companies have plans to raise Rs 42,390 crore through IPOs. A company has a 12-month period to launch its IPO after receiving approval from the market regulator. The prolonged delay by companies in launching their IPOs can be attributed to the current market volatility, characterised by weakening investor confidence due to concerns over tariff wars and lacklustre corporate earnings with incessant selling by foreign investors adding to the market woes.

"Companies that received approval from October 2024 onwards, which is when the selloff started, till December 2024 are perhaps hoping that market conditions will improve for them to launch their IPO," said Pranav Haldea, Managing Director, PRIME Database Group. Some of the big IPOs that have received SEBI's nod between October and December 2024 and are yet to launch the offer are Schloss Bangalore Ltd (Rs 5,000 crore), Ather Energy Ltd (Rs 4,500 crore), Avanse Financial Services Ltd (Rs 3,500 crore), Manjushree Technopack Ltd (Rs 3,000 crore) and Ecom Express Ltd (Rs 2.600 crore). Besides, there are a few companies that have received regulatory approval between April-September 2024 and still have valid approvals include National Securities Depository Ltd (Rs 3,000 crore), S K Finance (Rs 2,200 crore), Kalpataru Ltd (Rs 1,590 crore), Asirvad Micro Finance Ltd (Rs 1,500 crore) and Belstar Microfinance Ltd (Rs 1,300 crore). These companies seem to have missed the window to launch their IPO, Haldea said.

The sluggish IPO activity follows a robust IPO fundraising by companies in 2024. In the last calendar year, 91 companies raised Rs 1.6 lakh crore through IPOs. The number of small and medium enterprises (SME) IPO touched a high of 240 compared to 182 in 2023, as per Prime Database. Secondary market correction



After touching record highs in September 2024, the Sensex and the Nifty have lost nearly 13 per cent, so far. The BSE's 30-share Sensex has plunged 11,503.54 points, or 13.4 per cent from it's all-time high of 85,836.12. The broader Nifty 50 has corrected 3,663.55 points, or 13.97 per cent, from its peak of 26,216.05. Even the broader market has witnessed a massive sell-off, with BSE Smallcap crashing 21 per cent and BSE Midcap falling 20 per cent from their record highs. This fall in domestic equity benchmarks has primarily been led by a massive sell-off by foreign portfolio investors (FPIs) who dumped over Rs 2.12 lakh crore worth of equities since October 2024. Investors' sell-off is also driven by concerns over tariff wars, overvalued domestic stocks and subdued quarterly earnings of corporates.

Analysts said a correction in the secondary market has a significant impact on the IPO market. The current fall in the stock market has led to a decline in monthly IPOs in 2025. While in January only six companies launched IPOs. February saw only three primary market offerings. This is much lower than the number of IPOs seen in September (12), October (6), November (8) and December (15)In a falling market, companies also do not want to launch IPOs as they may struggle to raise the targeted funds, analysts said. "Promoters do not want to offload their stake in a bad market. In a declining market, they do not get the valuation, and subscription (to the IPO) is also not very good," said Ashish Nanda, Chief Digital Business Officer, Kotak Securities. When a retail investor incurs losses in the secondary market, his interest in the IPO market also reduces. In the past also there have been many companies that have chosen not to launch their IPOs even after receiving regulatory approval, due to unfavourable market conditions. Since 2019, 94 companies looking to raise roughly Rs 1.35 lakh crore, allowed their IPO approval to lapse. IPO is a oncein-a-lifetime event for a company and when markets are volatile or bearish, companies prefer to let their approval

## Ola stocks tumble on reports of raids, regulatory issues

New Delhi: Shares of EV company Ola Electric on Monday fell by nearly 4 per cent, following reports of raids, vehicle seizures, and showroom closures linked to the company. Reports suggested that the electric two-wheeler manufacturer is facing regulatory issues and has received warning letters from the government for allegedly violating rules under India's Motor Vehicles Act. Due to customer complaints, transport authorities in multiple States have reportedly conducted raids, shut down showrooms, and seized vehicles.

The company has also received show-cause notices regarding these alleged violations, the report added. However, an Ola spokesperson dismissed these claims, calling the reports "prejudiced" and "misplaced." The company stated that its distribution centres and warehouses across India follow the guidelines of the Motor Vehicles Act and that it maintains unregistered vehicles at these locations in compliance with the law. Following these reports, Bhavish Aggarwal-led company's stock faced fresh selling pressure, dropping over 4 per cent to touch an intra-day's low of Rs 54.11 per share on the Bombay Stock Exchange (BSE). The stock was close to its 52-week low of Rs 53.71, which it reached last week on March 3 amid speculation that the company is planning to lay off over 1,000 employees to reduce losses.

Since the beginning of 2025, Ola Electric's stock has declined by 36 per cent and currently trades over 60 per

cent below its peak since its listing in August.As per available data, only about 100 out of 3,400 showrooms had the trade certificates required under India's Motor Vehicles Act. This indicates that over 95 per cent of the reviewed showrooms lacked the necessary certification to display, sell, or offer test rides for unregistered vehicles. At least six transport officials are reportedly investigating Ola Electric for potential violations.

## Nitin Gadkari blames faulty DPRs, poor civil engineering for increasing road accidents

Union Road Transport and Highways Minister Nitin Gadkari on Thursday said that road accidents and fatalities in India are increasing and "the most important culprits are civil engineers", substandard detailed project reports (DPRs), consultants, and concessionaires.

In his address at the two-day Global Road Infratech Summit & Expo (GRIS), Gadkari said: "The most important culprits are civil engineers. I do not blame everybody, but after 10 years of my experience, I have come to this conclusion. Culprit are those who are making DPRs. Because of small civil engineering mistakes, there are hundreds of deaths."He further said that even though there are mistakes, no one is held accountable, "Even small things

like the road signages and marking system are very poor in the country. These can be copied from countries like Spain, Austria and Switzerland and implemented here," Gadkari said. He also said that the Indian Road Congress (IRC), the premier body for road & highway standards in India, has become a "pleasure trip organisation". "Our people are taking advantage of IRC. It is just a part-time organisation, pleasure trip organisation. You need continuous research and find out what is best available in the world and on the basis of that you have to recommend us. Now my target is how many person I am going to suspend, how many contractors to blacklist...Nobody is ready to rectify the mistakes," said Gadkari. He said that the industry and the government should collaborate to find solutions for building safer infrastructure in place of just holding seminars and discussions.

KK Kapila, president-emeritus, International Road Federation (IRF), said that the theme of the summit- "Vision Zero: Sustainable Infratech and Policy for Safer Roads"-represents a holistic approach to road safety, combining the latest technological advancements with innovative practices to create safer roads for everyone. "By prioritising safety in every aspect of road design, construction, and management, this theme seeks to move towards a future where road accidents become a rarity, ultimately aiming for zero fatalities," said Kapila. ## For capex, CPSEs rely more on budgetary support, less on own resources & private capital

Concerns have been raised within sections of the government about the shift in investment pattern of central public sector enterprises (CPSEs) away from their own resources and private capital to higher budgetary support for undertaking capital expenditure. It is learnt that two departments of the government have flagged concerns about the substitution of Internal and Extra Budgetary Resources (IEBR) of CPSEs, which fund their capex, with an increasing reliance on higher budgetary outlay in the form of equity and loans from the government in key infrastructure sectors, especially telecom, railways, and road and transport sector. While the greater reliance on taxpayers' money through the Budget for fixed asset creation in the key infrastructure sectors is being seen as a positive sign in some quarters, this trend is also being viewed as restricting space for the CPSEs to carry out their own capex plans. It is also at variance with what was envisaged through the National Infrastructure Pipeline, sources said. For instance, for the road sector, 38 per cent share was planned via private capital for CPSEs such as National Highways Authority of India (NHAI). However, the IEBRs mobilised by such entities have come down progressively in the last five years. "One of the reasons for reduction in IEBRs could be the increasing indebtedness of certain public entities like NHAI," a source said.

The reduction in resource mobilisation by the CPSEs on their own and through the private sector is being seen as a reason of concern for the infrastructure sectors, especially the roads sector, sources said. They pointed out that the IEBR in NHAI has been brought down to nil in financial years 2022-23 and 2023-24 and there seems to be no reversal in stance of the resource mobilisation from higher budgetary outlay. The budgetary outlay support from the government had come after a sharp rise in NHAI's debt liabilities. NHAI's debt had risen from Rs 23,797 crore in March 2014 to Rs 3.48 lakh crore in March 2022. Its debt servicing as a share of total allocation was 25 per cent in FY22.

The Standing Committee on Transport (FY22) had at that time noted that high budgetary support alone may not be sufficient to meet the investment requirements of NHAI. The Committee had recommended that the Ministry of Road Transport and Highways may work towards resolving the apprehensions of the private sector which are limiting their participation in the road transport sector in the last few years. by working in close coordination with concessionaires and financial institutions. Queries sent by The Indian Express to the Ministry of Finance on this issue went unanswered. The IEBRs mobilised by CPSEs came down progressively from Rs 6.42 lakh crore during FY20 to Rs 3.63 lakh crore in FY23 to be met by budgetary support. While it was estimated to come down further to Rs 3.26 lakh crore in FY24 as per the revised estimates, IEBRs then picked up to Rs 3.89 lakh crore as per actual figures. In FY25, it is estimated to have slipped to

Investment in CPSEs through budgetary support in the form of equity and loans has meanwhile more than doubled in the five years beginning from FY20. Budgetary support through equity and loans for CPSEs has risen by over 150 per cent from Rs 2.10 lakh crore in FY20 to Rs 5.48 lakh crore in FY25 (revised estimate) and Rs 5.35 lakh crore in FY26 (budget estimate). Experts and market players have been raising concerns about the change in the



capital investment strategies of public sector entities, especially in the context of higher dividend payouts to the government. In a note in October 2024, brokerage Motilal Oswal Wealth Management had said the approach of CPSEs towards capital allocation has raised concerns among investors. "The high dividends suggest a lack of focus on reinvesting for future growth. The government pressures PSUs to prioritise dividend payments over capital expenditures, which hinders their long-term development potential," it said.In a separate note outlining the reasons for the decline in PSU shares last year, Bajaj Broking said the backing by the government for PSEs has helped them in several ways but also results in limited autonomy. "The limited control also prevents the companies from making prompt decisions, which negatively impacts their performance and efficiency. However, on the other side, private enterprises enjoy full autonomy and are more flexible. Further, government policies and regulations, like pressuring the PSUs to offer and enhance dividend earnings, also limit a company's capacity for long-term growth, capital expenditure, and more," it said. Mergers and acquisitions among PSEs, as was seen earlier in the case of ONGC-HPCL deal, also adversely impact the cash reserves of PSEs, which then leaves less amount with such entities for incurring fresh capex.Capital expenditure includes two components spending by line departments and ministries along with gross budgetary support (GBS) to CPSEs. The investment by CPSEs is financed through budgetary support provided by the Central government, which is part of gross budgetary support. IEBR are raised by CPSEs on their own. Internal resources include retained profits net of dividend to government, depreciation provision and carry forward of reserves and surpluses. The EBR consists of receipts from issuance of bonds, debentures, external commercial borrowings, and term loans from financial institutions. IEBR is below-the-line expenditure which is not included in the fiscal deficit calculation of the government since it is an expenditure in the books of the CPSEs and not the Budget. I remain hugely grateful for the opportunities I have been given and the support I receive." Rashmika's last three releases — Animal, Pushpa 2 and Chhaava have earned over Rs 3,000 crore combined. With Chhaava reaching Rs 698 crore mark, it has already eclipsed Sultan (Rs 614 crore) and Gadar 2's (Rs 691 crore) lifetime collections. Chhaava's overall occupancy in Hindi was 18.90 percent, while the overall occupancy for the Telugu version being 28.79 percent. Chennai leads with 38 percent occupancy for the Hindi version with 33 shows. Pune had an occupancy of 36.25 percent with 511 shows. The Hindi occupancy in Mumbai



was 26.75 percent with 965 shows, while in Delhi, the Vicky Kaushal starrer's occupancy was 12.50 percent with 1070 shows. As for the Telugu version, Mahbubnagar had the highest occupancy of 53.50 percent with just 4 shows running. The occupancy in Kakinada was 46 percent, with 14 shows. With 313 shows, Chhaava's occupancy in Hyderabad was 30.75 percent. Overall in Telugu, Chhaava has a total of 710 shows running in South India. The film originally had its theatrical release on 14th February. Directed by Laxman Utekar and produced by Maddock Films, Chhaava also stars Divya Dutta, Ashutosh Rana, and Akshaye Khanna in important roles.

# 'Took a photo of Mammootty's feet,' reveals actor Anumol recalling working with him in Manorathangal: 'Wanted to study how he uses his body'





# When Priyadarshan announced he is stepping away from comedy films: 'Ridiculed and not taken seriously'



One of the most accomplished and influential directors in Indian cinema, Priyadarshan has gifted the film industry with several timeless movies, besides playing a key role in shaping the careers of stars like Mohanlal and Akshay Kumar. Although he has explored various genres over the years, comedy has remained his forte, with several of his films — such as Mazha Peyyunnu Maddalam Kottunnu (1986), Thalavattam (1986), Vellanakalude Nadu (1988), Chithram (1988), Vandanam (1989), Kilukkam (1991), Hera Pheri (2000), Hungama (2003), Hulchul (2004), Garam Masala (2005) and Bhool Bhulaiyaa (2008) — widely regarded as some of the finest comedies in Indian cinema.

However, did you know that Priyadarshan once contemplated stepping away from comedy films entirely? Yes, you heard that right. In 1997, shortly after the release of his Mohanlal-starrer Chandralekha, he announced that it would be his final full-fledged comedy. While he acknowledged that his future projects might still feature humour, Priyadarshan declared that he had lost interest in making pure comedies. This decision came despite Chandralekha


being a box-office blockbuster. "Chandralekha will be my last comedy film. Hereafter, my films will have humour but no comedy. I am not interested in comedy any more. I just wanted to make one comedy and prove to people that I still can make one and make it successfully," he shared during a chat with Rediff in 1997. Reflecting on this shift, he said: "However good the comedies are, nobody will accept a good comedy director as a good director. That is the sad part of it. Nobody knows who directed the Laurel and Hardy movies. They know only Laurel and Hardy. Directors will never get a good name if they direct a comedy film."

"But it is the most difficult thing to do — to make people laugh. After laughing a lot, they (the critics) will brush aside the film as 'just another comedy'. I felt bad when I learnt I was not taken seriously and ridiculed, even after all those hits," he remarked, suggesting that film critics had largely been unfair to him. "Most of them hide their faces and laugh a lot but they criticise the films later on. 
