### Thunder showers to bring relief from heat wave in Telangana between March 20 and 24

Hyderabad: Hyderabad and parts of Telangana can expect a reprieve from the ongoing heat wave like conditions between March 20 and 24. Given the hot summer conditions for the coming one week, temperatures will rise steadily and are expected to touch 40 degree Celsius to 44 degree Celsius.However, weather forecaster from Hyderabad, T Balaji, said that people in Hyderabad and elsewhere in the State, who have been suffering from heat wave, can look forward to some relief in the form of summer thundershowers. "The suffering from heat wave will continue till March 19. However, between March 20 and 25, a super respite from the ongoing heat wave due to strong unseasonal thunderstorms, which are ahead in Telangana State," Balaji on Friday posted on X (formerly Twitter).

### Mercury levels rise in Telugu States



Hyderabad, March 14 (NSS): The State is experiencing intense heat wave conditions since the past few days. Across the State, maximum temperatures are being recorded above 40 degrees in March alone, which is 3.3 degrees higher than normal. The Hyderabad Meteorological Centre officials stated that the severity of the heat was particularly high in the northern districts of Telangana and added that there was a possibility that the maximum temperatures could exceed 42 degrees in the next two days. The impact of the heat along with hot winds will be significant in the districts of Adilabad, Kumuram Bheem, Mancherial, and Jagityal. Yellow warnings have already been issued in these districts. Due to the likelihood of the maximum temperatures reaching 42 degrees on Saturday, yellow warnings will also come into effect in seven more districts starting Saturday. The Meteorological Department official mentioned that the temperatures were being recorded up to 39 degrees in the State capital and surrounding areas. On the other hand, the Heatwave conditions are likely to prevail in Coastal Andhra Pradesh Yanam and Rayalaseema regions of neighbouring AP during the next 48 hours. The Meteorological Centre said on Friday that the maximum temperatures would gradually rise by 2 to 3 degrees celsius in Coastal Andhra Pradesh Yanam and Rayalaseema during the next five days

#### PM Modi likely to re-launch Amaravati capital works next month

Amaravati: Prime Minister Narendra Modi is likely to visit Amaravati next month to re-launch the capital city works.The Telugu Desam Party-led National Democratic Alliance (NDA) government in the state has already decided to invite the Prime Minister for the resumption of works for the construction of the greenfield capital city. The ceremony is likely to be held between April 15 and 20. Officials said the state government will finalise the date after consultation with the Prime Minister's Office. The works are likely to resume

Uddandarayunipalem, the place where the foundation



stone was laid by Prime Minister Modi on October 22, 2015, when the TDP was in power in the state.

Few development works were undertaken by the state government. However, the works came to a halt after the TDP lost power in 2019 as the YSR Congress Party (YSRCP) government headed by Y.S. Jagan Mohan Reddy decided to develop three state capitals. The YSRCP government announced that Visakhapatnam will be developed as the administrative capital, Kurnool as the judicial capital, and Amaravati as legislative capital.

## BRS leaders urge police to initiate action against CM Revanth for his filthy words against KCR

Hyderabad, March 14 (NSS): Medchal district BRS party president & MLC Shambipur Raju Qutbullapur MLA Vivekanand Goud and Malkajgiri MLA Marri Rajashekhar Reddy today lodged a complaint to Petbasheerabad police station Station House officer requesting him to initiate action as per law against Chief Minister A Revanth Reddy for making violent and provocative comments against the first chief minister of Telangana State and BRS party supremo Kalvakuntla Chandrasekhar Rao at a programme held in Ravindra Bharathi on Thursday during distribution of appointment orders on March 12. They said while addressing the masses during the event, CM Revanth Reddy made a disturbing remark about the KCR stating: "From stature to stretcher and then from stretcher to Mortuary tomorrow morning he will go." The statement is derogatory, crossing the line of political discourse. Such inflicting speeches promote violence and hatred between political parties, specifically affecting the workers and supporters of the Bharat Rashtra Samithi party. Such a vulgar comments from a Chief Minister are alarming and affect the sentiment, comments such as these have the potential to inflame tensions within the State. This inflammatory language could incite both political and communal unrest, leading to an escalation of conflict between party supporters and disturbing the peace, harmony and stability of Telangana. "The language used by Revanth Reddy is disrespect-

ful and also dangerously divisive. It fuels hatred and violence, stirring up anger among party workers and creating an atmosphere of unrest, fear and instability. Comments and remarks of this nature cannot be tolerated in a democratic society, where respect and constructive dialogue should guide political discussions. We urge you to take swift action against these statements as they not only undermine the sanctity of political discourse, but also risk the safety and well-being of Telangana's citizens. It is essential to take measures to prevent such rhetoric from becoming normalized in public debate, as it only serves to deepen division and enmity within the State. The peace and democratic values of Telangana must be preserved by ensuring such reckless comments are not allowed to go unchecked. We request immediate intervention and necessary actions to address these provocative remarks to ensure the safety and harmony of the people of Telangana", they added. (NSS)

### Illegal trafficking of Bangladeshi girls into City, six get jail for life

Hyderabad, March 14 (NSS): Directorate of Enforcement (ED), Hyderabad Zonal Office, has provisionally attached assets worth Rs 1.90 lakh under the provisions of the Prevention of Money Laundering Act (PMLA), 2002 in connection with two cases of immoral trafficking rackets operated by Bangladeshi nationals in and around Hyderabad.

ED initiated investigation on the basis of two FIRs registered by the Telangana Police and subsequently re-registered by the National Investigation Agency (NIA), Hyderabad. Telangana police had conducted raids at two brothels on the outskirts of Hyderabad and busted an organized syndicate of prostitution and immoral trafficking, operated by Bangladeshi nationals, leading to registration of FIRs at Chatrinaka and Pahadishareef PS. Investigation by the NIA, Hyderabad revealed that most of the arrested accused were Bangladeshi nationals, who had illegally entered India without valid travel documents. They had obtained fake/forged Indian identity documents and despite arrests in other FIRs, continued to engage in prostitution and illegal trafficking of Bangladeshi girls. The victim girls were trafficked into India with the help of various agents active on the Indo-Bangladesh border, through illegal border crossings in West Bengal, on the false pretext of better paying jobs in beauty parlours, tailor shops, steel factories, housemaids and so on and later forced into flesh trade. The NIA Special Court awarded life imprisonment to all six accused in one of the FIRs.

ED investigation revealed that the accused were running brothels at various places in and around Hyderabad and were also sending the victim girls to other brothels and agents on commission basis. Using fake/forged Indian identity documents, the accused opened several bank accounts and online wallets for their illegal activities. For trafficking the Bangladeshi girls and others, the accused were paying around Rs 4 to 5 thousand per person to agents/middlemen abutting the Indo-Bangladesh border in West Bengal, which was shared between various parties involved in the trafficking on either side of the border.ED investigation revealed that payments for the trafficking of the Bangladeshi girls were made through banking channels and also in cash to the agents. To conceal the money trail, the accused used money transfer services of various financial intermediaries, sharing only their mobile numbers for the remittance. To evade detection, the transactions were systematically



structured into small payments below regulatory threshold limits. Substantial part of the Proceeds of Crime (POC) were found to be remitted to multiple persons abutting the Bangladesh border in West Bengal, who withdrew the money in cash and handed it to other hawala agents who ensured the remittance of the money to the families of the accused and the victim girls in Bangladesh, at times also using bKash (the mobile financial service of Bangladesh Bank). The assets attached by ED are in the form of balance amounts in Paytm wallets and bank accounts as well as immovable property of one of the accused Ruhul Amin Dhali, who was revealed to be one of the most prominent agents involved in the illegal trafficking of Bangladeshi girls into India. ### TGPSC releases Group-3 results

Hyderabad, March 14 (NSS): The results for Group-3 have been announced in Telangana. The Telangana Public Service Commission (TGPSC) announced these results on Friday, which include the general ranks and marks of the candidates who took the exams in November of last year. The final answer key, master question papers, and OMR sheets for the Group-3 examination are now available for download on the official website. A total of 5,36,400 candidates applied for 1,365 Group-3 positions in the Telangana State.

## KTR slams Revanth Reddy over secret meetings with BJP leaders

Hyderabad, March 14 (NSS): BRS working president K.T. Rama Rao has strongly criticized Chief Minister A. Revanth Reddy for allegedly holding secret meetings with BJP leaders to safeguard his position. In a scathing attack on social media platform X, KTR accused Revanth Reddy of indulging in "backdoor politics" while publicly pretending to oppose the BJP.

KTR labelled Revanth Reddy as a "Cheap Minister" instead of a Chief Minister and challenged Congress leader Rahul Gandhi to take action. "Rahul Gandhi keeps talking about BJP infiltrators in Congress. Does he have the courage to act against his own CM, who is striking secret deals with the BJP?" KTR questioned. He also accused the Congress party of engaging in a "dirty political culture" where leaders prioritize their power over public welfare. He claimed these secret meetings were part of a larger conspiracy to destabilize Telangana's progress.

"It is shameful that a Congress CM is holding secret meetings with BJP leaders. Telangana has never seen such treacherous politics," KTR remarked. "Congress has a history of creating divisions among people for its political survival, and this is yet another example. "Expressing his outrage, KTR criticized the Chief Minister for ignoring pressing State issues, including the agrarian crisis and student suicides in residential schools.

"Farmers are struggling, students are suffering, and yet the CM does not have time to hold review meetings. But he has enough time for these secret discussions with BJP leaders. This is an unpardonable betrayal," KTR stated.

KTR also pointed out that BJP MLA Raja Singh's recent statements had exposed Revanth Reddy's alleged backdoor dealings with the BJP. "The CM pretends to fight BJP in public while secretly colluding with them. This is exactly what Congress politics is all about," he added.

KTR warned that the people of Telangana would not tolerate such "ugly politics" and would reject both BJP and Congress, which he described as "two Delhi-based parties that do not understand Telangana's interests. This State has come too far to be dragged into the dirty tricks of Congress and BJP. Telangana society will fight back and ensure that these conspiracies fail," KTR asserted. (NSS)

Notorious for sponsoring cross-border terrorism ove he decades, Pakistan is now itself struggling to rein in ter orist groups. There has been an alarming surge in terro attacks on Pakistani soil in recent months, with the Jaffe Express hijacking in Balochistan being among the mos audacious. The security forces killed all the hijackers, who belonged to the proscribed Balochistan Liberation Army, and escued the majority of the train passengers, but the multingency operation is unlikely to deter separatists who are seeking independence for their mineral-rich province. The prazen targeting of Army, police and intelligence personners militants is clearly aimed at undermining the authority of he Shehbaz Sharif-led government and the military establishment.

Raising the bogie of the 'foreign hand', President As Ali Zardari has said that the authorities are aware of the external support and funding being received by terrorists to nflict human and financial losses on Pakistan. The allusion s to India and Afghanistan, two neighbours with which slamabad's relations are either in deep freeze or going fron ad to worse. At stake are Pakistan's ties with its all-weathe ally, China. Balochistan, bordering Iran and Afghanistan, fig ires prominently in the Chinese scheme of things. It ac ounts for a significant part of Beijing's \$65-billion invest nent in the China-Pakistan Economic Corridor, which falls ınder President Xi Jinping's Belt and Road initiative Prioritising Chinese interests, Pakistan has failed to alla Baloch concerns about rampant exploitation of the rovince's resources. This has emboldened insurgents to arget Chinese citizens and projects as well.Pakistan' Kashmir fixation has blinded it to its own problems. If the beleaguered nation wants to be seen as a victim rather thar perpetrator of terrorism, it must reach out to aggrieved groups and stop blaming foreign players.

### BIRED to conduct free vocational training for youths



Hyderabad, March 14 (NSS): The Bankers Institute of Rural and Entrepreneurship Development (BIRED) will conduct a 38-day free vocational training programme for rural and urban unemployed youths of both Andhra Pradesh and Telangana from April 7 to May 14. Candidates between 19 and 30 years are eligible for the training which will be offered on the institute premises at Rajendra Nagar, Hyderabad. The BIRED Director D. Nagaraja Kumarhas said the BIRED will impart training in MS-Office (Inter Pass and above), Refrigerator & AC Repair (SSC pass and above), PC hardware and Laptop Servicing (Inter pass and above), he said, adding, "those candidates who are continuing studies, who attended similar training, those who completed B.Ed., Engineering, MBA and MCA and the persons suffering from health issues are not eligible." ## Officials deploy Hydraulic powered robot to expedite rescue operations at SLBC



Hyderabad, March 14 (NSS): Arvind Kumar, the Special Chief Secretary for Disaster and Management, has announced that an autonomous robot powered by hydraulics is being utilised for the digging operations, rather than relying on manual labor. This advanced technology aims to expedite the ongoing rescue efforts at the SLBC tunnel near Domalapenta in the Nagarkurnool district, where seven workers are still trapped.

Aravind Kumar elaborated that this approach was implemented to efficiently remove the soil accumulated during the digging process. He also mentioned that the vacuum tank can transport up to 620 cubic meters of muddy soil per hour via a conveyor belt. He said the State government is utilising the best global technology to overcome the challenges in the final stretch of the 14-kilometer-long tun-Special Chief Secretary Arvind Kumar, along with Nagarkurnool District Collector Badawat Santosh, District SP Vaibhav Gaikwad Raghunath, and other senior officials of the relief teams, held a review meeting on the relief operations at the SLBC Tunnel office on Friday. He reviewed the progress of relief operations in the tunnel. On the occasion, Aravind Kumar stated the rescue teams are working round the clock, using the most advanced technology and equipment to safely extract the trapped workers. We are using a specialised machinery connected to an autonomous hydraulically powered robot to speed up rescue operations inside the tunnel," he saidAravind Kumar revealed that a machine with a 30 HP capacity liquid ring vacuum pump and a vacuum tank has been sent for effective relief operations. He said these machines will be useful for quickly removing soil and speeding up work inside the tunnel. "The use of advanced technological machinery will help in completing relief operations more efficiently and quickly," Aravind Kumar stated. He further informed that the Army, Singareni Mines Rescue Team, NDRF (National Disaster Response Force), SDRF (State Disaster Response Force), RAT Miners, Geological Survey of India, Hydra, Anvi Robotics and South Central Railway teams are participating in the res-

cue operations. (NSS)

#### Mallu Ravi demands cancellation of Jagadish Reddy's MLA membership

Hyderabad, March 14 (NSS): Mallu Ravi, the MP from Nagarkurnool, has called for the removal of Jagadish Reddy from his MLA position due to his disrespectful remarks directed at Speaker Prasad Kumar during the Legislative Assembly session. In a statement released on Friday, Ravi criticised the BRS party for its longstanding disregard for Dalits. #### Ktr Slams Suspension Of Mla Jagadish Reddy, Calls Statewide Protests



Hyderabad, March 13 (NSS): BRS working president K.T. Rama Rao strongly condemned the suspension of BRS MLA Jagadishwar Reddy from the Telangana Legislative Assembly, terming it an outrageous act that undermines democratic values with baseless allegations. KTR accused the Congress government of suspending Jagadishwar Reddy on fabricated grounds, claiming words he never uttered were attributed to him. He alleged that the Congress is attempting to stifle the BRS voice out of fear that the party's presence in the budget sessions would bring to light issues of contracts, commissions, and the transfer of funds to Delhi. Protesting against the suspension, KTR, along with BRS MLAs and MLCs, held a demonstration in front of the Ambedkar statue and announced Statewide protest programs across all constituencies on March 14, 2025.

KTR stated that Jagadishwar Reddy was deliberately targeted and suspended as part of a conspiracy while he was exposing the falsehoods and half-truths in the Governor's address to both Houses. Despite interruptions from Congress ministers and MLAs through running commentary, Jagadishwar Reddy maintained composure, KTR noted. He highlighted that Reddy was raising critical issues such as wilting crops, the decline of agriculture, farmers' hardships, stalled loan waivers, delayed Rythu Bandhu pay-

ments, unimplemented six guarantees, and the betrayal o 420 promises. Unable to counter these criticisms, the government resorted to unethical and shameless tactics by suspending him, KTR charged. He clarified that Reddy did not use a single unparliamentary word during his speech. KTR further pointed out that Reddy expressed anguish as a plea to the Speaker to protect the rights of Opposition leaders, treating him as a fatherly figure, and did not disrespect him in any way. Yet, the Congress government, following its habitual authoritarian tendencies, adjourned the House for five hours and acted on the orders of Chief Minister Revanth Reddy, who is currently in Delhi, KTR alleged.KTR revealed that on the advice of BRS chief KCR, they had urged the Speaker and the Legislative Affairs Minister to assess the mood of the House by consulting all parties, expressing regret if the Speaker felt hurt. However, he lamented that the government ignored this suggestion. He criticized the Congress for suspending Jagadishwar Reddy without even seeking an explanation or specifying his alleged fault, calling it a glaring example of the government's arrogance. KTR also slammed the Congress government for chaining the 125-foot Dr Babasaheb Ambedkar statue—the world's tallest, installed by the KCR government—describing it as a despicable act. He reiterated that the Congress fears the BRS raising issues of contracts, commissions, and funds being sent to Delhi during the budget sessions, which is why they are trying to suppress the party's voice. He asserted that while the government focuses on sending funds to Delhi, it has no concern for the welfare of the poor, a fact the public has clearly understood. KTR warned that the Congress would undoubtedly face punishment in the people's court in the future. Dismissing the Congress's illusion that silencing one voice achieves anything significant, KTR called for Statewide protests on March 14, 2025, against the party's undemocratic attitude and Chief Minister Revanth Reddy's arrogant and dictatorial tendencies. He urged people to join the burning of effigies of the government in all constituency centers across Telangana. (NSS)

### Severe water crisis stares at Telangana as water levels in irrigation projects deplete

Hyderabad: A severe water crisis is staring at Telangana. The dwindling water levels in major irrigation projects such as the Sripada Yellampalli, Sriram Sagar and Nagarjuna Sagar are not just affecting crops, but could also lead to drinking water shortages by May. The situation is critical. Political parties have been raising concern over the prospect of rabi crops getting impacted in over 10 lakh acres. The Rabi farmers in the Godavari basin projects in Telangana are grappling with a severe water crisis. The Sripada Yellampalli project, which has a gross storage capacity of 20.18 TMC, currently holds only 12 TMC of water. This is significantly below the minimum requirement of 15 TMC needed for drinking water supply to the command area towns and villages, including Hyderabad, which relies on this project for emergency drinking water supplies.

The Sriram Sagar Project (SRSP) is also in a dire state. It has only 26 TMC of water in current storage against its gross capacity of 90.31 TMC. Despite maximum inflows this year, the crops under the SRSP Stage II, mainly in Nalgonda, Suryapet and Mahabubabad, have dried up significantly, adding to the farm sector crisis. The crops under the SRSP Stage I are also impacted, with around 2,000 irrigation tanks on the verge of drying up, affecting drinking water supply in the villages and habitations relying on them. This situation is expected to impact groundwater levels as well. The irrigation support planned for 4.42 lakh acres during the Yasangi season in Nizamabad, Jagtial, Karimnagar and Peddapalli districts is now uncertain. Water supply to the Kakatiya canal zones, which began in December, is set to stop by April 10. Delayed crop transplantation and extended harvest periods due to the lack of water supply have put farmers at a risk of huge losses. Already, over one lakh acres of crops in the tail-end areas of the SRSP project are badly affected by partial water supply.

The Devadula Project, aimed at providing irrigation water to the farmers in the ayacut area, is facing severe challenges. The lack of proper water supply has left Rabi crops dry, causing distress among farmers. The Congress government's negligence in maintaining the canal system has aggravated the situation. Farmers in Hanamkonda and Jangaon districts are struggling to save their crops due to the lack of a proper water supply plan for the Rabi season. The government's failure to pay the bills for the pipeline maintenance has led to a halt in water pumping. The damage suffered by crops is extensive. Nearly 60 per cent of the crops in Devaruppula mandal are drying up. The lack of water in various reservoirs and failure to release water from the Devadula project have left farmers in a desperate situation.

As for the Krishna basin projects, the water level in the NSP, which is crucial for drinking water supply for Hyderabad city, Nalgonda, Suryapet and Khammam towns is fast depleting. The KRMB had already directed Andhra Pradesh to restrict its use to only meet the drinking water needs, but it continued to draw water to the right canal for irrigation purposes. Sensing the threat of a mid-May crisis.



the Hyderabad Metropolitan Water Supply and Sewerage Board (HMWS&SB) has been making arrangements in advance to start emergency pumping from the Nagarjuna Sagar project. The present storage in the NSP is 150 TMC against the gross storage of 312 TMC. The minimum drawdown level being 510 feet, the water level has already dipped to 520 feet in the project. In the Srisailam project, the present storage is only 69 TMC, with the net drawable by both States being close to 50 per cent of it.

### Residents write to NGT, seek its intervention against waste plant

Mumbai first waste to energy plant "The WTE plant will be the first attempt towards starting scientific treatment of the existing untreated legacy waste that is lying in the dumpyard," a civic official said. (Express archive photo/Tashi Tobgyal)Seven months left for Mumbai's first ever waste-to-energy (WTE) plant to become operational, residents of Govandi, Shivaji Nagar, have written to the National Green Tribunal (NGT), seeking its immediate intervention against the facility.

The facility, spread across 73 acres of the 311-acre Deonar dumping ground, will share its boundary with Mankhurd Shivaji Nagar area, one of the densely populated areas in Mumbai, comprising residents from lower income groups. The plant, being built at a cost of Rs 504 crore by the Brihanmumbai Municipal Corporation (BMC), is set to become operational in October this year. It will generate 7 mega Watt (MW) electricity by processing 600-700 metric tonnes (MT) of solid waste that comes to the dumping ground daily. The residents have been protesting the setting up of this facility at the heart of Shivaji Nagar. Faiyaz Alam Shaikh — a local resident and founder, convenor of Govandi Citizen's welfare Forum, alleged that no public consultation was carried out before initiating the project.WTE plants are globally known for emitting toxic particles in the air. This will adversely affect the local air quality. Mankhurd Shivaji Nagar is one of the polluted areas in Mumbai due to the presence of a dumping ground. People living here have the lowest life expectancy rate in the entire Mumbai. This



plant will only add up to the woes," Shaikh said. The resi dents have demanded immediate intervention of the NGT as well as scrapping of the project. He said that the reservation of the land was changed without any public consultation."A comptroller and auditor general (CAG) report had flagged financial irregularities in the run up to this project," he added. However, civic officials maintained that the project is being implemented after taking environmental clearances from the state and national pollution control boards. "The WTE plant will be the first attempt towards starting scientific treatment of the existing untreated legacy waste that is lying in the dumpyard. ### Mumbai gets respite from heat as temperature dips by 5 degrees

mumbai summersThis comes after the city recorded its warmest March day since 2023 on March 11 when the temperature rose to 39.2 degrees Celsius. (Express Photo by Sankhadeep Banerjee)Mumbai Friday experienced respite from the heat with the day time temperature touching 34.5 degrees Celsius, marking a significant dip of nearly five degrees in two days. This comes after the city recorded its warmest March day since 2023 on March 11 when the temperature rose to 39.2 degrees Celsius.

Abnormally high temperatures are likely to elude the city at least until March 20 with the forecasted temperature predicted to be in the range of 34 degrees Celsius. Data furnished by the weather bureau showed that while the Colaba coastal observatory recorded a maximum temperature 33 degrees on the mercury scales on Friday, the Santacruz observatory logged 34.5 degrees on the mercury scales. Over the past few days, the day temperature in the city had inched closer to 40 degrees-mark. According to meteorologists, Mumbai is prone to warm temperatures during March – which being a transition month – receives a combination of dry northerly winds alongside moist winds. The city's warmest March was recorded at 41.7 degrees in 1956. Meanwhile, weather experts have attributed the current drop in temperatures to the early influx of sea breeze.

Sunil Kamble, director of IMD Mumbai told The Indian Express, "Earlier, the westerlies (sea breeze) was getting



delayed due to the easterly winds. However, currently, the sea breeze is setting in by 11.30 am owing to which the maximum temperatures are dipped. Furthermore, the prevailing anti-cyclone system has also weakened."In its bulletin for the coming days, the IMD has forecast that the day time temperatures will hover between 33 – 34 degrees for the one week until March 20 at least.

The minimum temperatures are also slated to dip upto 20 degrees Celsius, during the same period. The air quality index also remained in the moderate category on Friday morning with the overall AQI touching 121. Of the city's 24 stations, at least four stations logged AQI in the 'satisfactory' category (between 50-100) with the best air quality observed in Borivali East. The worst AQI, meanwhile, was recorded in Chakala Easy at 197.

### Parliamentary panel recommends hike in wage rates under MGNREGA

Parliamentary Panel on Rural Development headed by Congress MP Saptagiri Sankar Ulaka in its report reviewing the budgetary allocation of Department of Rural Development on Wednesday (March 12, 2025), strongly argued for revision of wages and uniform rates across the country under the Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) in view of the rising cost of living. The per day wages currently vary from ?234 in Nagaland and Arunachal to ?374 in Haryana and Sikkim. The panel expressed disappointment that despite its multiple recommendations on this matter over the years, the government has not implemented any significant changes.

The wages currently are linked to the Consumer Price Index For Agricultural Labourers. This index, the panel said, "may not accurately reflect" the inflation trends. "The Committee believes that this index does not fully capture the real impact of inflation, and therefore, the method of wage calculation must be reviewed and updated on a priority basis to reflect actual economic conditions at the ground level," the panel report said. The panel has also urged the government to implement a "uniform wage rate" across all state and union territories, since the scheme is primarily funded by the central government. "This would help ensure fairness and consistency in wage payments under the Scheme," the panel said.

The panel also criticized the government for delay in disbursement of wages. As per the report, till February 15

this year, the pending liabilities in wages stand at ?12,219.18 crore and ?11,227.09 crore in material components and total pending liabilities are ?23,446.27 crore. The panel report pointed out that one fourth of the allocated funds (?86,000 crore) will go in clearing the last financial year's due. "Consequently, the actual working budget for the current financial year is reduced to ?62,553.73 crore, significantly limiting the scheme's capacity to function effectively and meet its primary objective of preventing rural distress and ensuring livelihood security," the report said.

#### Karnataka HC stays consumer forum order against PVR Cinemas for delaying film, points to jurisdiction issues

PVR cinemasThe court also observed that while an option existed for the multiplex association to approach the state consumer forum, that would not stop the high court jurisdiction under Article 226 of the Constitution. The Karnataka High Court has stayed a Bengaluru consumer forum's order imposing costs of Rs 1.28 lakh against PVR Cinemas for delaying the screening of films by playing advertisements, noting that it appeared to have gone beyond its jurisdiction in some aspects of the order. The case was related to a Bengaluru Urban District Consumer Disputes Redressal Commission order following a complaint by Abishek MR in January 2024 regarding a screening of the film Sam Bahadur in December 2023. In his complaint, Abhishek said that the film that was slated to begin at 4.05 pm was only screened at 4.30 pm due to advertisements. This delay, he said, inconvenienced him as he could not return to work on time.

"In the new era, time is considered as money, each one's time is very precious, no one has right to gain benefit out of others time and money. 25-30 (minutes) is not less to sit idle in the theatre and watch whatever the theatre telecasts. It is very hard for busy people with tight schedule watching unnecessary advertisements...," the consumer



court noted in February last year.In the current petition filed by the Multiplex Association of India before the high court, Senior Advocate Mukul Rohatgi argued, "When you go to a movie, for five

minutes, public awareness programmes are mandated by the Ministry of I&B. It is a business model that you have some trailers and advertisements. Everyone has known for years that the movie starts in 15-20 minutes....finally the (consumer) court has mandated that you should print on the ticket that advertisements will start at 4 pm etc...With great respect, the council has no such power. They have taken it like a class action...". The high court ordered, "The consumer forum accepts the plea of the petitioner (Abhishek MR) and traverses the complaint, answering it as if it has jurisdiction akin to a public interest petition and indulges in discourse as to how a movie should be run, directs that theatres should not project advertisements...the directions on the face of it are without jurisdiction. Days after protesters from the Nationalist Congress Party (Sharadchandra Pawar) blocked the Metro tracks in Pune, Shravan Hardikar, managing director of Maharashtra Metro Rail Corporation Limited, said Monday they took measures to ensure commuters did not face any issues. "Within 15 minutes, we had decided to start short loop operations rather than leaving everything stranded. "We held a hackathon last year with MIT-WPU for Artificial Intelligence/Machine Learning based video analytics solutions. This would alert us if anyone crosses the yellow line on the metro platform or jumps on the tracks. We will implement this in the next three to six months. However, this will not be enough and we have to find some better way of guarding ourselves from such incidents happening," he

On Sunday, NCP (SP) workers blocked the Aqua Line (Vanaz-Ramwadi) of the Pune Metro by climbing onto the tracks near PMC station to protest against 'lack' of employment and other issues. This affected Pune Metro operations for around two hours from 12.45 pm to 2.45 pm. Fire brigade teams arrived at the scene and nets were spread on the road below to prevent serious injury in case anyone fell. The police said the protesters behaved aggressively and splashed them with petrol.NCP(SP) city chief Prashant Jagtap distanced the party from the protest and said that it does not support any activity which affects the people of Pune. He also announced that the party expelled Narendra Pawtekar after the protest. The Pune police have booked 17 protesters, who blocked the Pune Metro on Sunday, under 17 sections of the Bharatiya Nyaya Sanhita (BNS), eight sections of the Metro Railways (Operation and Maintenance) Act, and two sections of the Maharashtra Police Act. As many as 17 people, including Pawtekar, have been arrested. The protesters have been booked under Sections 191 (rioting) and 189 (unlawful assembly) of BNS. Section 132 (assault or criminal force to deter public servant from discharge of his duty) of BNS, which is non-bailable, has also been included in the FIR, apart from Section 74 (maliciously wrecking a train or causing sabotage) of the Metro Railways Act, which stipulates a minimum imprisonment

of three years.

Only seven countries in the world met the World Health Organization's (WHO) guidelines for annual average PM2.5 levels, according to the 2024 World Air Quality Report. The countries that met the WHO guideline of 5 µg/m3, the annual average concentration of particulate matter PM 2.5, are Australia, the Bahamas, Barbados, Estonia, Grenada, Iceland, and New Zealand. The report, which looks at the data from over 40,000 air quality monitoring stations across 138 countries, territories, and regions, and was analysed by IQAir's air quality scientists, says Mayaguez in Puerto Rico was the cleanest metropolitan area of 2024, with an annual average PM2.5 concentration of 1.1 µg/m3.In terms of regional air quality, Oceania emerged as the cleanest area with 57 per cent of cities meeting the WHO guideline. The region comprises three countries – Australia, French Polynesia, and New Zealand. "Australia reported an unchanged national concentration of 4.5 µg/m3, New Zealand saw a marginal increase of 0.1 µg/m³, and French Polynesia recorded a decrease of 0.7 µg/m3. The capitals of all three countries also reported annual average concentrations within the WHO guideline. Wellington, the capital of New Zealand, however, experienced a year-over-year increase of 1.2 µg/ m³, reaching 4.3 μg/m³. Although still within the guideline, continued increases at this rate could eventually breach the limit. Oceania maintained the highest percentage of cities meeting the WHO guidelines, with over 56% of monitored cities reporting annual average concentrations below 5.0 µg/m³," the report says.global air pollution In terms of regional air quality, Oceania emerged as the cleanest area with 57 per cent of cities meeting the WHO guideline. Chad (91.8 µg/m3): The annual average concentration in the Central African country is more than 18 times the WHO PM2.5

#### Delhi world's most polluted capital for 6th straight year; pollution cuts life expectancy in India by 5 years: Report

Delhi as World's Most polluted Capital: With an average PM 2.5 concentration of 91.8 µg/m3, Delhi continues to be the most polluted national capital in the world for the sixth consecutive year, according to the 2024 World Air Quality Report. According to the report, 13 of the 20 most polluted cities in the world are in India, with Byrnihat on the Assam-Meghalaya border being the most polluted. The other cities include Faridabad, Loni (Ghaziabad), Gurgaon, Greater Noida, Bhiwadi, Noida, Muzaffarnagar, New Delhi (Central Delhi) and Delhi (taking the average from the rest of the city). India is the fifth most polluted country in the world, with an average Air Quality Index (AQI) of 50.6 μg/m3 - 10 times higher than the World Health Organization's (WHO) annual PM2.5 guideline value of 5 µg/m3. In 2023, it was the third most polluted country. "Air pollution remains a significant health burden in India, reducing life expectancy by an estimated 5.2 years," it said. The report has relied on data from over 40,000 air quality monitoring stations at 8,954 locations in 138 countries, territories and regions. It was analysed by IQAir's air quality scientists. Only 17% of global cities met WHO air pollution guidelines. Out of the 138 countries and regions, 126 (91.3%) exceeded the WHO annual PM2.5 guideline value of 5 µg/m3 Byrnihat, India was the most polluted metropolitan area in 2024, with an annual average PM2.5 concentration of 128.2 µg/m3. Central and South Asia were home to the top seven most polluted cities in the world. India was home to six of the nine most polluted global cities The most polluted major city in



Hindustan Times, The Times of India and Mint.

the United States was Los Angeles, California. Ontario, California was the most polluted city in the USPM2.5 concentrations decreased in every country in Southeast Asia, though trans-boundary haze and lingering El Niño conditions remain major factors.

Akshay Sahani, a resident of Sector 15, had embarked on the trek with his friend Vikram Singh to visit the temple of local deity Sri Sirgul Maharaj on Mahashivratri. While Singh reached the temple safely, Sahani lost his way amidst heavy snowfall and dense fog. #### Blood-soaked bodies, a condom packet, an unusual visitor: How Delhi Police cracked the 2019 Vasant Vihar triple murder case

June 23, 2019. 8 am. Babli, a part-time domestic worker, arrived as usual at her workplace in the posh Vasant Vihar neighbourhood. Her employers were an elderly couple, the Mathurs, who lived in a flat in Vasant Apart-

Vishnu Mathur (80) was a retired Central government official. His 75-year-old wife, Shashi Mathur, who once worked for the New Delhi Municipal Council (NDMC), was now mostly confined to bed due to her failing health. There was another resident of this first-floor two-bedroom flat -Khushboo Nautival, a live-in help hired to attend to Shashi.Babli rang the bell. There was no response. She rang the bell again and waited for several minutes. When no one opened the door, she wasn't alarmed. Instead, she took out the spare keys that the Mathurs had given her for such occasions. She was about to use it to open the door, when she realised the door wasn't locked. She walked in. What she saw inside would haunt her for days to come. The blood-splattered bodies of the couple, their throats slit, and their bodies stabbed innumerable times, lay in their bedroom. In another room, Khushboo was also lying motionless: her throat slit. All signs pointed at a friendly entry: the front door wasn't broken into, cups of tea sat quietly on the centre table. A few pieces of gold jewellery, though, were found missing even as the cash in the house remained largely untouched. The couple's mobile phones too were missing. Sifting through the house for more clues, the police stumbled upon a curious object in 20-year-old Khushboo's bedroom: a single condom packet. Investigators thought they had found their suspect.

Khushboo had been staying with the Mathurs for almost a year now. The couple's son had died in an accident a few years ago. With Shashi's deteriorating health and their only surviving child, a daughter, staying with her family in another South Delhi neighbourhood, the couple was completely dependent on Khushboo.

Neighbours told police that Khushboo had a boyfriend who would often visit the house. The discovery of the condom led police to believe the murder could have been the handiwork of Khushboo's partner, who may have accidentally dropped the packet while escaping from the spot. The man was tracked down and questioned, and so were a few other acquaintances of Khushboo. "We questioned them for the next 72 hours. We didn't find anything suspicious," a police officer involved in the investigation said. "The probe had hit a wall. We knew our main suspect had nothing to do with the murders. We realised that our investigation had not been on track." Police again went to the slain couple's daughter and asked her to recall if she noticed anything unusual in the days leading to the murders.

The woman remembered a surprise visitor - Preeti Sehrawat. An old acquaintance, Preeti, had been visiting the Mathurs rather frequently in the recent past, the daughter told police. Preeti's mother and Shashi used to be colleagues at the NDMC but had fallen out of touch after retirement. Preeti, 42, was from Nangloi in Delhi. Why did she want to revive an old connection? And where was she now? The police wanted to know. Investigators were yet to collect information about Preeti when they found her in a hotel room in Gurgaon. Four days after the murder, on June 26, 2019, the police were alerted when Vishnu Mathur's missing phone was switched on briefly. That was an important clue, and a police team tracked the phone to a room in a hotel in Gurgaon. At the spot, the police were surprised to find Preeti and her live-in partner, Manoj Bhatt, 39. Manoj had switched on Vishnu Mathur's phone briefly before switching it off again. It was, however, enough for the police to pinpoint the

After questioning, the couple led the police to a plot in Sushant Lok, DLF Phase 1, in Gurgaon. Sifting through the garbage and debris on the premises, the officers found the alleged murder weapons - a knife and a screwdriver. And then, something else caught their eye: A strip of two condoms. Police matched it with the single condom found at the Mathurs' place - it looked like the three pieces came from the same box. The packets were sent for forensic examination."Forensics revealed that the condoms were part of the same three-pack set. They were similar with respect to colour, shade, size... Further, when one end of exhibit-1 (pouch found at the crime scene) was juxtaposed with exhibit-2a (the packs recovered later), the symbol and text printed on both were found complementary to each other. The serrated part of exhibit-1 was physically fitted with the serrated part of exhibit-2a," a police officer who was part of the investigation said. The condom had been deliberately planted on Khushboo's bed to push the needle of suspicion towards her boyfriend, a police officer said. "It was a clever ploy to mislead the investigators," he said. "The criminals may try everything to mislead the police but they always leave clues behind. Once the investigation is done professionally, nothing stays hidden." Preeti had always wanted to have a business of her own. She grew up in the Chanchal Park area of Nangloi and joined the Food and Craft Institute in Lajpat Nagar in 1997 for a Hotel Management course. She then moved to Manali, where she worked as a front desk officer at a hotel. According to her statement to the police, she got married to Nicholas - a match arranged by her parents — in 2000. "His name sounds as if he is a foreigner. We also thought so initially. This Nicholas was from Nangloi," a police officer said.

The next year, she gave birth to a boy and began working for private companies to provide for the family, even as Nicholas was unemployed. In 2004, the couple welcomed another child, this time a girl. Beti ke hote hi vo chhod ke chala gaya (He left soon after the girl was born). He came back in 2006, and then again left us in 2007," Preeti told the police. Over the next nine years, Preeti worked multiple jobs, at hotels and call centres, across Delhi-NCR while her parents looked after her daughter in Nangloi. In 2015, she finally realised her long-cherished dream of becoming an entrepreneur by setting up her own hostel in Gurgaon's Sector 38. This is where she met Manoj, who had approached her posing as a property dealer. They soon grew close, and six months later, in a drunken state, 39-year-old Manoj told Preeti about his dark past — he had spent five years in jail for a murder. The victim: His wife. "We used to have a lot of fights. I was getting tired of it. In 2010, I, along with a friend, killed her (his wife)," Manoj told police.Manoj was sent to jail, from where he walked out in 2015, just a few weeks before he met Preeti.

By 2017, Manoj and Preeti had started living together in Gurgaon. They shut down the failing PG business and started a restaurant together. By 2018, they wound up this business as well due to mounting losses. Preeti was back to working at call centres while Manoj, more broke and bitter than ever before, began squabbling with her for money to buy liquor - much like her first husband.

In 2019, Preeti fell sick and had to leave her job and whatever earnings it brought. But that did little to deter Manoj from asking her for money. "I told her that either you give me money, ya ek bada hath marwa (or get me a chance to carry out a major robbery)," Manoj told police. This is when she remembered her 'Shashi auntie'; she told Manoj about her mother's old friend. On June 17, 2019, when Preeti was set to appear for a job interview, Manoj asked her to call on Shashi. What he wanted was a recce of the house.

The same evening, Preeti was at the Mathurs' home. "While inquiring about her well-being, I asked her everything: when is she alone, who else comes to meet her and uncle (Vishnu Mathur)... her whole routine," Preeti told the police. A few days later, on June 22, around 9 pm, Preeti and Manoj began executing their plan. "I asked her to wear black clothes (to avoid being noticed in the dark), but she didn't have any top like that. So, I got her to wear a dark blue T-shirt and black pants," Manoj told the police.

Around 10.30 pm, Preeti and Manoj left their Gurgaon home on his black Bajaj Pulsar and reached Vasant Apartments. To avoid being detected by the neighbours or CCTV cameras, Manoj parked his bike a little further away from the building, while Preeti covered her face with a dupatta. They walked up to the Mathurs' flat and knocked, taking the three inhabitants of the house by surprise. It was 11.15 pm, way past their bedtime. "Khusboo opened the door. Uncle and auntie were there as well, both awake. They asked about Manoj and me coming at this hour. I told them that we were just passing by and thought of visiting them,"

#### PMC undertakes land survey for creating parking bays near Metro stations

The Pune Municipal Corporation (PMC) recently surveyed the areas surrounding Metro stations to identify suitable locations for vehicle parking. This initiative aims to enhance last-mile connectivity and encourage citizens to use the Metro service by providing convenient parking options.

"We have conducted a thorough survey of all parking reservations, Pune Mahanagar Parivahan Mahamandal Limited (PMPML) depots, and truck and bus terminals related to the transportation department in the PMC region according to the Development Plan (DP)," said a civic officer. The officer said the use of Geographic Information System (GIS) for surveys and data representation is an effective approach for planning parking solutions near Metro stations. The civic body will gather survey data and additional information about all parking lots owned by the PMC in the Pune area. It has designated approximately 100 hectares of land in the DP for parking purposes.

The survey gatheted information on the existing op-

The civic officer added that amenity spaces data from the building permission department will also be identified for parking purposes. The draft report of the survey will include a prioritised list of parking options near stations. Pune Metro executive director Hemant Sonawane said, "The feeder service and parking for private vehicles plays a major role in providing lastmile connectivity to citizens travelling by metro rail and increasing response to the mode of transport. We have been demanding land from the PMC to develop parking bays near stations."The Metro Rail Policy developed by the Union government emphasises the need for infrastructure that integrates all forms of public transport, intermediate public transport, and private transportation with the Metro systems. This enhanced connectivity will improve access to Metro stations for private vehicles and other transport services, as per the policy. The policy says multimodal integration must support traffic dispersal in circulating areas that provide adequate parking space, essential for planning seamless transport facilities alongside Metro stations. Commuters can easily walk to the station for the catchment area within approximately 0.3 to 0.5 km from the station. Residents living within the next kilometre can access the station using bicycles, two-wheelers, or auto-rickshaws.

For areas beyond a 2 km catchment, regular feeder bus services will be required to reach the Metro station. Additionally, the policy states that people should have the flexibility to bring their own vehicles and have the option to park for the day or overnight. The Pune Metro has operationalised two lines: Vanaz to Ramwadi and Pimpri-Chinchwad to Swargate. While the footfall on the metro rail is steadily increasing, it has not yet reached the levels estimated during the planning phase. The third line, connecting Hinjewadi to Shivajinagar, is set to become operational this year. Additionally, work has begun to extend the lines from PCMC to Nigdi and Swargate to Katraj. Proposed routes from Vanaz to Chandni Chowk, Ramwadi to Wagholi, Nal Stop to Manikbaug, and Khadakwasla to Kharadi are currently awaiting approval from the Union government.

#### Telangana government forms **Future City Development Authority**

Hyderabad: The State government has constituted the Future City Development Authority (FCDA) to oversee the development of Chief Minister A Revanth Reddy's pet project Future City Area. The newly formed authority will cover 56 revenue villages across 765.28 sq.km in Rangareddy district, with a focus on integrated urban planning and economic growth. Simultaneously, the government has excluded 36 revenue villages from the Hyderabad Metropolitan Region (HMR) and expanded its jurisdiction to 1,355 villages across 11 districts, covering 10,472.72 sq.km. Thus, the HMR's jurisdiction will be upto the Regional Ring Road (RRR), covering a buffer area of upto 2 km outside the RRR which will be later designated as the RRR Growth Corridor.

The move aligns with the State government's plan to develop economic and industrial clusters in the Future City Area coming up near Mucherla. The Future City project will be developed into 12 zones, with comprehensive master

#### Jadavpur University student arrested in connection with March 1 vandalism on campus



Police arrested a Jadavpur University (JU) student in connection with the March 1 unrest and vandalism on the campus, taking the total number of arrests in the case to two. A leader of the JU SFI unit told PTI on Wednesday that Soumyadip Mahata, a student of philosophy, was called to Jadavpur police station to record his statement in connection with the violence during TMC's West Bengal College and University Professors' Union AGM where West Bengal Education Minister Bratya Basu was also present.

A group of students formed human chains around Basu's car and tried to prevent him from leaving, demanding immediate discussions on the pending student union elections. Two students were injured when the minister's car went past the human chain and left the campus. In the protests that followed, the education wing office of TMC nonteaching staff was set aflame and several hoardings and festoons were put up on the campus.

The Students Federation of India (SFI) leader claimed Mahata was a left student activist but not associated with the federation. The organisation along with other student protestors will hold a general body meeting on Thursday to discuss about their future course of movement in the wake

"While the university authorities are giving assurances of withdrawing cases against student protestors who only demanded holding of long overdue student union polls after five years, our students are getting arrested. This cannot continue," he said. A spokesperson of Jadavpur University Teachers Association confirmed Soumyadip's arrest on Wednesday. On March 2, a former JU student was arrested from his rented flat in South Kolkata on charges of being present on the campus during the protest and arson and taking part in the vandalism. The ex-student hails from Birbhum and currently works in an IT firm in Salt Lake.

#### Gang that stole over 100 cars in 10 months busted, used walkie-talkie, took 5-7 mins per vehicle: Police

Delhi Police, Delhi Police bust car theives, Delhi Police bust car robbers, delhi news, India news, Indian express, current affairs Even as raids were carried out in Ludhiana, Rajpura, and Sirsa to arrest the receivers of the cars, only one Fortuner and a Creta were recovered, said police. From avoiding the use of cellphones to evade surveillance and relying on walkie-talkies instead, using advanced tools to make copies of car keys, preferring morning hours and specific car models while committing thefts, to ensuring that the vehicles are stolen within five to seven minutes — the Delhi Police on Tuesday busted a gang with an elaborate modus operandi that allegedly stole around 100 cars in the last 10 months, said officers

Police have arrested three men who have been identified as Ravi, 42, Monu, 45, and Vishal, 40. Ravi, who had been allegedly stealing cars since 2002 and had worked as a car mechanic like Vishal, has 48 cases filed against him. The gang sold the vehicles stolen from Delhi primarily in Punjab and Haryana, said police, adding that other members are being traced. The gang members usually went 'carhunting' in the morning hours, said officials. CCTV clips accessed to trace them showed them using sophisticated

"They were targeting predominantly three types of vehicles — Hyundai Creta, Fortuner, and Maruti Brezza, which were parked near parks or gyms. It was also observed that theaccused hardly took a few seconds to break into the locked car and stole it within five to seven minutes," DCP (Dwarka) Ankit Singh said.On March 6, an informer told the police that Ravi was going to come in the Kakurola area of Suraj Vihar of South West Delhi. A trap was laid, and the car he was driving, with a fake number plate, was tracked, the police said. The three accused were in the vehicle. As the gang was busted, all their tools were recovered from the car, apart from several number plates. "Walkietalkie sets, drill machine, two screw drivers, hammers, iron rod, wire cutter, master keys were also recovered from the vehicle," DCP Singh said. Ravi, the key accused, is an expert in using X-tool, which allegedly eased their operation, said police. "All modern cars have an onboard diagnostic port that authorises bonafide technicians to access the vehicle's mainframe and check for errors in the engine and other systems. However, Ravi and Vishal, being car mechanics themselves, used this port to download the car's original digital keys onto a blank key and thereby stole these cars through these Chinese scanners such as X-tool," DCP Singh said. Ravi allegedly started stealing cars after his business as a property dealer landed him in losses. He then got in touch with an alleged Punjab-based auto-lifter and began supplying stolen cars. He gradually expanded his gang and roped in even his family members, the police said. "Ravi was assisted by Monu in stealing cars, while Vishal was in charge of driving the cars away," DCP Singh said. "They sold these cars to receivers based in Haryana and Punjab. This gang is estimated to have stolen approximately 90-

100 cars in the last 10 months," DCP Singh said.

#### "Cops said go and search for the agent yourself": US deportees from Punjab rue police apathy, many reach "compromise" with agents

Deported from the US for crossing the border illegally via "Dunki Route", and now under huge debts, the deportees from Punjab are facing a fresh trouble- the apathy of Punjab Police.Of 131 Punjabis who were deported from the US last month, just 23 have come forward until now to get the FIRs registered against their travel agents whom they had paid lakhs to reach the American shores via illegal Dunki Route.

However, most of these 23 deportees who got police cases registered, told The Indian Express that after initial 'sympathy" and "photo ops" by the ministers of the ruling Aam Aadmi Party (AAP) government, "no concrete action was being taken by the police" and the "booked agents were not being arrested."Only four arrests have been made so far in 23 FIRs, according to the data from Punjab Police's SIT constituted to probe US deportees cases. On the other hand, some of these deportees who got the cases registered initially, have now also entered "compromise" with their agents after their money have been refunded, hence leaving Punjab Police in an embarrassing situation.

The return of 131 deportees and 23 FIRs against travel agents have literally opened a Pandora's Box for Punjab Police, as deportees revealed how they travelled from one country to the other, leaving financial trails in multiple countries, to reach the US-Mexico border illegally. The 23 FIRs registered by Punjab Police find mention of at least 34 countries which the deportees traversed to reach the US. Adding to the complexity are several overseas agents and their middlemen (donkers) who made these deportees hop from one country to the other. After reaching South America via Europe, Middle East or Africa, most deportees undertook the strenuous path via the Darien Gap- the only land route that connects South and North America- and crossed rainforests, mountains and several rivers by rickety boats, on foot and further by taxis/buses. From Brazil, they crossed several other countries illegally including Bolivia, Peru, Ecuador, Colombia, Panama (jungles), Costa Rica, Nicaragua, Honduras and Guatemala before finally reaching the Mexico to cross the border. Each deportee paid their agent anywhere from Rs 40 to 60 lakh to fulfil their American dream, only to be deported after the journeys that spanned three months to even over a year. Punjab deportees paid at least Rs 44.70 crore to the agents as per the initial data. "Police said that go and search for the agent on your

Speaking to The Indian Express, the deportees who got the FIRs registered against their agent, said that while initially the ruling AAP government showed "all kind of sympathy", now "nothing was being done by the police on the ground.""The minister (NRI affairs minister Kuldeep Singh Dhaliwal) came at the airport to receive us and made all kinds of promises that once FIR is registered, police will retrieve our money from the agent. But after those photo ops, nothing has been done. Now, the police or other officials are not even answering our calls," said a woman deportee from Ludhiana district, who paid Rs 45 lakh to the agent against whom the FIR has been registered by Khanna Police. Mandeep Singh, a deportee from Tarn Taran district, said: "My agent is not only roaming freely in the area but is even threatening openly that no one can harm him, not even police. He has clearly refused to return my Rs 35 lakh but

"Police told us that we should go and search for the agent on our own. If we had to find him on our own, what is the police for?," said Baby Rani, wife of Sukhpal Singh, a



has been registered, I am only running from pillar to post and begging the police to arrest the agent but nothing is being done. Why this entire FIR drama was done if we had to do everything on our own," said Jugraj Singh, a deportee from Batala. "My agent is roaming free locally but policemen say they can't find him," said Harpreet Singh, a deportee from Batala. Harjot Singh from Gurdaspur district, who along with his cousin paid Rs 80 lakh to the agent, and both were deported, said: "Two FIRs are registered against the agent but he is not being arrested. He doesn't take our calls when we asked for our money back." Hardeep Kaur, whose husband Gurwinder Singh from Ludhiana district was arrested immediately after deportation from the US, said: "My husband was arrested for snatching case pending against him but the agent who duped us of Rs 69 lakh is not being arrested. Police said he is absconding." "I had assumed that once FIR was done, police will arrest my agent immediately but it has backfired on me. Now neither he has been arrested, nor he is returning my money. He is now threatening me that since I have got the FIR registered, he won't return a penny," said another deportee.

"Took Rs 42 lakh, now offering Rs 3 lakh for compromise"Some deportees have also entered "compromise" with the agents and do not want to proceed with the FIRs. Daler Singh, a deportee from Amritsar said: "The agent has returned half the amount (of Rs 60 lakh). Once the full amount is returned, we will get the FIR cancelled."Harwinder Singh from Hoshiarpur district said: "We have entered compromise with our agent via the NRI affairs committee of our village. We will get the FIR cancelled. Half of our money has been returned."Taranveer Singh from Mohali district said: "I paid Rs 42 lakh to the agent but he is offering me merely Rs 3 lakh for compromise. I will continue with the FIR till he doesn't offer an agreeable amount." "My agent was arrested but he has returned Rs 30 lakh of the 50 lakh I had paid. We have agreed for the compromise via our village panchayat and the court will be informed the same," said Davinder Singh, a deportee from Sangrur. Jaswinder Singh, a Moga deportee, on whose complaint his agent cum BKU (Totewal) farm leader Sukh Gill was booked for fraud, said he too has reached "compromise" with him. "We will get FIR quashed as our money has been returned," he said.Punjab Police ADGP (NRI affairs) PK Sinha, who heads Punjab Police's Special Investigation Team (SIT) on US deportees probe, said that SSPs/CPs across the state have been directed to accelerate probes and make arrests in US deportees' cases. "Raids are being conducted regularly to arrest the accused who are based in Punjab. We will gradually try to reach the agents based abroad as probe will progress," said the senior officer. On some deportees entering "compromise" with the agents, he said: "Only the court can quash the FIR once registered. Police will continue with

#### What is International Criminal Court?

The Hague: The International Criminal Court where detained former Philippine President Rodrigo Duterte is being taken after his arrest in the Philippines is a court of last resort for the most serious international offenses, such as genocide and crimes against humanity. The 79-year-old former president has become the first former Asian leader to be arrested by the International Criminal Court (ICC). Duterte was taken to the Netherlands on March 12 after his arrest on an ICC warrant accusing him of crimes against humanity over deadly anti-drug crackdowns he oversaw while in office

The ICC handles allegations of war crimes, crimes against humanity, genocide and aggression, and takes on cases when nations are unable or unwilling to prosecute crimes on their territory. The court's newest member, Ukraine, formally joined in January, bringing the number of member States to 125. Major powers — the United States, Russia and China — are among nations that are not members. The ICC, which has a budget this year of more than US\$ 213 million, does not have a police force and has to rely on the cooperation of States to arrest suspects. Judges at the court have issued 60 arrest warrants and convicted 11 people.

Congolese warlord Thomas Lubanga was the first, sentenced in 2012 to 14 years in prison for conscripting child soldiers. In 2021, the court convicted Ugandan commander Dominic Ongwen of dozens of war crimes and crimes against humanity, including multiple killings and forced marriages in Uganda. Ongwen was a one-time child soldier, who morphed into a brutal commander of a notorious rebel group known as the Lord's Resistance Army. Three verdicts are pending at present. Former Central African Republic soccer federation president Patrice-Edouard Ngaissona and Alfred Yekatom, alleged leaders of a predominantly Christian rebel group in the Central African Republic, are accused of multiple counts of war crimes and crimes against humanity. The trial of Ali Mohammed Ali Abdul Rahman Ali, who is accused of committing atrocities as the leader of the Janjaweed militia in Sudan, wrapped up

The court's detention centre is housed behind the high brick walls of a Dutch prison complex in The Hague seaside suburb of Scheveningen, about a 1.5 km from the court's headquarters. Detainees have access to books, television and news, as well as a gym and sports facilities. They also can use a computer to work on their defence case and get computer training, if they need it. The court also arranges for family members to visit people in its custody. Photos on the ICC website show a communal area with a foosball table, kitchen facilities, a table and chairs. The centre also has a small medical facility. Each cell contains a bed, desk, cupboard, toilet, hand basin, television and an intercom system to contact guards when the door is locked. If Duterte goes to trial and is convicted, he would not serve his sentence in The Hague but be transferred to a prison in another country. The detention centre currently houses five other suspects — Mahamat Said Abdel Kani, Yekatom, and Ngaissona from the Central African Republic, Al Hassan Ag Abdoul Aziz Ag Mohamed Ag Mahmoud



from Mali and Abdul Rahman from Sudan.

The ICC has issued arrest warrants for dozens of suspects since it was established in 2002. Among them are Russian President Vladimir Putin and Israeli Prime Minister Benjamin Netanyahu. The court issued a warrant for Putin two years ago, accusing him of personal responsibility for the abductions of children from Ukraine. Putin has rejected the accusations. In November, the court's judges issued warrants for Netanyahu, his former defence minister and Hamas' military chief, accusing them of crimes against humanity in connection with the war in Gaza. Netanyahu condemned the warrant against him, saying Israel "rejects with disgust the absurd and false actions" by the court. The case against the Hamas military leader has been terminated because he is believed to have been killed. Other suspects wanted by the ICC include former Sudanese President Omar al-Bashir and Joseph Kony, leader of the shadowy Ugandan militia Lord's Resistance Army.

#### Chandigarh Police constable found dead in car, husband booked for murder

A day after the body of Chandigarh Police constable Sapna was found in her car near Mansa Devi, her brother Gaurav filed a murder case against her husband at Mansa Devi police station under Section 103(1) of the Indian Penal Code.In his complaint, Gaurav stated that their family consists of three siblings, with Sapna being the eldest. She married Parvinder, an army soldier from Jhajjar district, in 2014. The couple had a six-year-old daughter, but their relationship was strained. Gaurav alleged that Parvinder harassed Sapna, was addicted to drugs, and frequently demanded money from her. He had even attempted suicide in June 2024. On March 11, 2025, Parvinder informed Gaurav that Sapna was neither answering her phone nor reporting for duty. Sapna's friend Urmila mentioned that she had gone to Mansa Devi temple due to distress. While searching the area, her car was found parked near Saketri Road, with her body inside.

#### Spelling mistake in Panjab University's new logo angers students

A controversy has erupted over Panjab University's new logo, with students alleging that an incorrect spelling on the convocation dress has damaged the university's reputation. According to students, when the convocation dress was redesigned in 2019 following UGC guidelines, the university incorporated traditional embroidery like Phulkari to promote cultural identity. However, they argue that if the university seeks to honour its heritage, it must also ensure the accuracy of its name and logo. In the new logo, the university's name has been misspelt as 'Punjab.' Students expressed surprise that this error occurred despite oversight by the Fashion Technology Department's committee. They criticised the committee for failing in its duty and accused the administration of not taking the issue seriously, leading to growing frustration. The students are demanding an immediate correction and action against those responsible. It remains to be seen what steps the university will take.

#### Car smuggling alcohol overturns, two local residents who pocketed IMFL from scene, arrested in Vadodara

Vehicles transporting illegal stash of liquor, overturning while speeding on highways in Gujarat and local residents rushing to the scene to grab the same is a common occurrence. But in a rare case of crackdown on Wednesday, the Vadodara city police arrested two people in an alleged case of Prohibition for allegedly stealing several 180ml bottles of Indian Made Foreign Liquor (IMFL) that got scattered on the road after a hatchback car transporting the illegal stash overturned near Kapurai on National Highway 48. The incident occurred when the Kapurai police station received a call of an accident on the NH-48, involving a hatchback car that had overturned and spilled over alcohol on the road. When Kapurai police officials reached the spot they found several broken glass bottles of liquor scattered around the overturned vehicle and an injured passenger in the car. The car driver, police said, had escaped. Eve the police rushed the injured passenger to the SSG hospital, bystanders informed the police that locals residing in settlements around the highway had grabbed several boxes of the liquor that had been saved from damage inside the

Kapurai Police Inspector DC Raol told The Indian Ex-

press, "We received an instruction from the Commissioner of Police to comb the area and nab those persons, who had pilfered the illegal liquor cartons. Accordingly, we formed teams and went into the settlements and nabbed two people, including a woman, who had managed to take away a total of around 190 bottles between them."The accused, Ishwar Jadav and Kamla Raju Patel — both residents of settlements around the highway, were booked under the Prohibition Act and arrested. The police also recovered the liquor bottles from the duo. While Jadav had managed to grab 45 bottles of 180 ml of alcohol, amounting to Rs 8,190, Patel had taken away 134 bottles worth Rs 22,780, police said. "We found the bottles stashed away in big plastic bags from their homes in their settlements... They had rushed to the spot immediately after the accident and pilfered as much as they could."Raol added that while the passenger of the car involved in the accident is undergoing treatment for injuries and "unable to record a statement yet", a hunt has been launched for the driver of the car, who had managed to escape from the spot. The police have booked both the occupants of the car, who are yet to be identified, under the Prohibition Act, in a separate FIR. Apart from the stash recovered from Jadav and Patel, liquor worth Rs 18,000 was destroyed in the accident and another 182 bottles worth Rs 30,960 were confiscated by the police.

#### ISRO achieves de-docking of SpaDeX satellites

New Delhi: ISRO on Thursday said it has accomplished de-docking of the SpaDeX satellites, clearing the way for future missions such as exploring the moon, human spaceflight, and building its own space station.

After several attempts, the space agency successfully docked the two satellites on January 16. PTI

#### Russia lays out demands for talks with US on Ukraine, sources say



NEW YORK/WASHINGTON - GNS News Agency, March 14 Russia has presented the U.S. with a list of demands for a deal to end its war against Ukraine and reset relations with Washington, according to two people familiar with the matter. It is not clear what exactly Moscow included on its list or whether it is willing to engage in peace talks with Kyiv prior to their acceptance. Russian and American officials discussed the terms during in-person and virtual conversations over the last three weeks, the people said. They described the Kremlin's terms as broad and similar to demands it previously has presented to Ukraine, the U.S. and NATO.

Those earlier terms included no NATO membership for Kyiv, an agreement not to deploy foreign troops in Ukraine and international recognition of President Vladimir Putin's claim that Crimea and four provinces belong to Russia. Russia, in recent years, also has demanded the U.S. and NATO address what it has called the "root causes" of the war, including NATO's eastward expansion.U.S. Presi-

#### Donald Trump says Ireland cheats the US as Irish PM Micheál Martin joins him to celebrate St. Patrick's Day

U.S. President Donald Trump welcomed Irish Prime Minister Micheál Martin on Wednesday (March 12, 2025) for the annual St. Patrick's Day celebration at the White House, where he added Ireland to the list of countries he says are taking advantage of the United States.Mr. Martin countered by noting Ireland's contributions to the U.S.

It was Mr. Trump's first Oval Office meeting with a foreign leader since his recent sit-down with Ukrainian President Volodymyr Zelenskyy, which morphed into a shouting match as they jousted over ending Russia's invasion of Ukraine. The session ended with Mr. Zelenskyy being asked to leave the White House.Mr. Martin, who offered only gentle pushback to some of Mr. Trump's comments, returned to the White House in the evening and presented Mr. Trump with a bowl of shamrocks at an early St. Patrick's Day celebration. The duo also attended an annual luncheon at the Capitol

The President's banter during the Oval Office meeting also touched on Vice President J. D. Vance's shamrockthemed socks and Mr. Trump nemesis Rosie O'Donnell's recent move to Ireland. The Republican President has been sparring with U.S. allies and adversaries alike over trade, slapping double-digit tariffs on imports from countries from Canada to China and in between. During the appearance with Mr. Martin, Mr. Trump repeated his claim that the European Union was created just to stick it to the U.S. Asked if Ireland, a member of the EU, was taking advantage, too, Mr. Trump said, "of course they are. I have great respect for Ireland and what they did and they should have done just what they did, but the United States shouldn't have let it happen." He was referring to the concentration of U.S. pharmaceutical companies in Ireland, due to the country's tax policies. "We had stupid leaders. We had leaders that didn't have a clue or let's say they weren't businesspeople, but they didn't have a clue what was happening and all of a sudden Ireland has our pharmaceutical companies," Mr. Trump said.Mr. Martin countered that the trade relationship is "a two-way street," adding that Ireland's two largest airlines buy more aircrafts from Boeing Co. than anyone else outside of America. More than 700 Irish companies are also based in America, creating thousands of jobs, Mr. Martin said. "That's a little known fact that doesn't turn up in the statistics," he added."I understand where you're coming from, fully," Mr. Martin told Mr. Trump, "but I think it's a relationship that we can develop and that will endure into the future."At one point, Mr. Trump became distracted as he talked about inflation in the U.S. "By the way, I love these socks. What's with these socks? dent Donald Trump is awaiting word from Putin on whether he will agree to a 30-day truce that Ukrainian President Volodymyr Zelenskiy said on Tuesday he would accept as a first step toward peace talks. Putin's commitment to a potential ceasefire agreement is still uncertain, with details yet to be finalized. Some U.S. officials, lawmakers and experts fear that Putin, a former KGB officer, would use a truce to intensify what they say is an effort to divide the U.S., Ukraine and Europe and undermine any talks.

The Russian embassy in Washington and the White House did not immediately respond to a request for comment.In Kyiv, Ukrainian President Volodymyr Zelenskiy hailed this week's meeting in Saudi Arabia between U.S. and Ukrainian officials as constructive, and said a potential 30-day ceasefire with Russia could be used to draft a broader peace deal. Moscow has raised many of these same demands over the last two decades, some making their way into formal negotiations with the U.S. and Europe. Most recently, Moscow discussed them with the Biden administration in a series of meetings in late 2021 and early 2022 as tens of thousands of Russian troops sat on Ukraine's border, awaiting the order to invade. They included demands that would constrain U.S. and NATO military operations from Eastern Europe to Central Asia. While rejecting some of the terms, the Biden administration sought to forestall the invasion by engaging with Russia on several of them, according to U.S. government documents reviewed by Reuters and multiple former U.S. officials. The effort failed and Russia attacked on February 24, 2022.

U.S. and Russian officials in recent weeks have said that a draft agreement discussed by Washington, Kyiv and Moscow in Istanbul in 2022 could be a starting point for peace talks. The agreement never went through. In those talks, Russia demanded that Ukraine give up its NATO ambitions and accept a permanent nuclear-free status. It also demanded a veto over actions by countries that wanted to assist Ukraine in the event of war. The Trump administration has not explained how it is approaching its negotiations with Moscow. The two sides are engaged in two separate conversations: one on resetting U.S.-Russia relations and the other on a Ukraine peace agreement. The administration appears to be divided on how to proceed

U.S. Middle East envoy Steve Witkoff, who is helping lead the discussion with Moscow, last month on CNN described the Istanbul talks as "cogent and substantive negotiations" and said that they could be "a guidepost to get a peace deal done."But Trump's top Ukraine and Russia envoy, retired Gen. Keith Kellogg, told a Council on Foreign Relations audience last week that he did not see the Istanbul agreement as a starting point."I think we have to develop something entirely new," he said.

Experts say Russia's demands likely are not only intended to shape an eventual agreement with Ukraine, but also to be the basis of accords with its Western supporters. Russia has made similar demands of the U.S. over the last two decades - demands that would limit the West's ability to build a stronger military presence in Europe and potentially allow Putin to expand his influence in the continent. "There's no sign that the Russians are willing to make any concessions," said Angela Stent, a senior fellow at the Brookings Institution who was the top U.S. intelligence analyst for Russia and Eurasia. "The demands haven't changed at all. I think they are not really interested in peace or a meaningful ceasefire."In their effort to forestall what U.S. intelligence officials concluded was an imminent Russian invasion, senior Biden administration officials engaged with Russian counterparts on three of the Kremlin's demands, according to the U.S. government documents reviewed by Reuters. They were a ban on military exercises by U.S. and other NATO forces on the territories of new alliance members and a ban on U.S. intermediate-range missile deployments in Europe or elsewhere within range of Russian territory, according to the documents. The Russians also sought to bar military exercises by the U.S. or NATO from Eastern Europe to the Caucasus and Central Asia, the documents showed. "These are the same Russian demands that have been made since 1945," said Kori Schake, a former Pentagon official who directs foreign and defense policy studies at the American Enterprise Institute. "With the behavior of the Trump administration in recent weeks, Europeans aren't just scared we're abandoning them, they're afraid we've joined the enemy.'

#### G7 foreign ministers meet in Canada amid tensions with Trump

LA MALBAIE, Canada, March 13 (Reuters) - Foreign ministers of leading Western democracies meet in Canada on Thursday after seven weeks of rising tensions between U.S. allies and President Donald Trump over his upending of foreign policy on Ukraine and imposing of tariffs. The Group of Seven ministers from Britain, Canada, France, Germany, Italy, Japan and the United States, along with the EU, meet in the remote tourist town of La Malbaie, nestled in the Quebec hills for two days of meetings that in the past have broadly been consensual on the issues they face. Top of the agenda for Washington's partners will be getting a debriefing on U.S. Secretary of State Marco Rubio's talks on Tuesday with Kyiv in Jeddah, Saudi Arabia, where Ukraine said it was ready to support a 30-day ceasefire deal. But in the run-up to the first G7 meeting of Canada's presidency, the crafting of an agreed all-encompassing final statement has been tough.

A U.S. decision to impose 25% tariffs on all steel and aluminium imports immediately drew reciprocal measures from Canada and the EU, underscoring the tensions. Washington has sought to impose red lines on language around Ukraine and opposed a separate declaration on curbing Russia's so-called shadow fleet, a murky shipping network that eludes sanctions, while demanding more robust language on China. On Monday, Rubio cautioned that Washington did not want language that could harm efforts to bring Russia and Ukraine to the table. Speaking to reporters on Wednesday he said a good G7 statement would recognise that the United States has moved the process to end the war forward. G7 diplomats said the positive outcome from Jeddah may at least ease talks on Ukraine. The United States, since Trump's return to office on January 20, has taken a less-friendly stance on Ukraine, pushing for a quick deal to end the war, demanded European partners take on more of the burden without openly endorsing their role in future talks, and warmed Washington's ties with Moscow.TARIFFS TO 51ST STATE

Even Japan, so reliant on American security guaran-



tees, has found itself in Trump's firing line."It's very difficult. Maybe we should wait for the G8," said one European diplomat ironically. Trump has suggested the G8 might be revived with the return of Moscow 11 years after its membership in the group was suspended over its annexation of Crimea. Nowhere have the difficulties for U.S. allies been more apparent than in Canada. Relations between the United States and Canada are at an all-time low, thanks to Trump's threats to impose tariffs on all imports from Canada and his constant musing about annexing the country to make it the 51st U.S. state. "We're going to be focused in the G7 on all of those things. That's what the meeting is about. It is not a meeting about how we're going to take over Canada," Rubio told reporters, highlighting how offbeat their ties have become. That may not appease Ottawa. Foreign Minister Melanie Joly said on Wednesday she would be on the offensive at the G7."In every single meeting, I will raise the issue of tariffs to coordinate a response with the Europeans and to put pressure on the Americans," she said. European diplomats said they hoped to use the G7 to assess directly how much influence Rubio has on U.S. foreign policy. Trump has used a wide array of officials not linked to the State Department in talks ranging from Ukraine to the situation in the Middle East, where allies have been alarmed by some of the erratic statements coming from

#### Will Musk be expelled from the Royal Society? | Explained

The story so far: The 365-year-old Royal Society in Britain, one of the most reputed scientific institutions in the world, is experiencing a crisis that raises fundamental concerns about the role of a top scientific institution. The Royal Society's former members include notable figures like Isaac Newton, Charles Darwin, Albert Einstein, and Stephen Hawking, among others. Becoming a member of the Royal Society is frequently regarded as the culmination of an extensive research career, and fellows are chosen after a rigorous process. The Royal Society also imposes a code of conduct on its fellows once they are elected. Of late, there has been a growing demand to rescind Elon Musk's fellowship for violating the code.

Who is making the demand?

In 1775, the German scientist and writer Rudolf Erich Raspe was expelled from the Royal Society after being accused of "divers frauds and gross breaches of trust". Today, the actions of the world's richest man has been deemed a "threat to science" by numerous scientists. The first fellow of the Royal Society to resign over this matter was Dorothy Bishop, emeritus professor of developmental neuropsychology at the University of Oxford. In 2024, she lodged two complaints with the Royal Society. "On both occasions they consulted lawyers, and it may well be the case that the lawyers are concerned about the prospect of legal action," she told the BBC. Another fellow, Andrew Millar of the University of Edinburgh, did the same in February this year. An open letter to the president of the Royal Society, currently British statistician Adrian Smith, has been signed by almost 3,500 members of the wider scientific community. Stephen Curry, an emeritus professor of structural biology at Imperial College London, penned it and ex-

pressed similar dismay. Fellow of the Royal Society, Al pioneer, and 2024 physics Nobel Prize winner Geoffrey Hinton also wrote on X that he was in favour of Mr. Musk's removal, "I think Elon Musk should be expelled from the British Royal Society. Not because he peddles conspiracy theories and makes Nazi salutes, but because of the huge damage he is doing to scientific institutions in the US," Mr. Hinton wrote. Mr. Musk replied: "Only craven, insecure fools care about awards and memberships". What have been the charges? Many fellows believe the billionaire's inflammatory remarks on British politicians have breached the Royal Society's code of conduct. Scientists have also expressed concerns regarding Mr. Musk's conduct within the current Donald Trump administration. In his leading position at the U.S. Department of Government Efficiency (or DOGE), Mr. Musk has overseen unprecedented cuts to funding meant for scientific research. He has also been spreading false material and engaging in political propaganda on his social media platform, X. His company Neuralink recently reported developing a novel brain-computer interface. Although this is a worthwhile objective, the research methodology is distinguished by Mr. Musk's resistance to allowing others to influence his methods. This has resulted in allegations of non-compliance with 'Good Laboratory Practice' regulations. Additionally, Mr. Musk's slanderous charges against public scientists like Anthony Fauci and other public personae have also drawn criticism from a number of scientists. Mr. Musk is also accused of encouraging vaccine hesitancy and baselessly doubting the foundations of climate change science. Why has he not been expelled? The Royal Society counts more than 1,700 fellows, and at least 60 of them have signed Mr. Curry's letter to have Mr. Musk expelled. But not everyone in the scientific community agrees with it.

#### For families of Philippines drug war victims, Duterte's arrest revives hopes for justice

The moment Jerica Ann Pico, the widow of a man who was killed during the war on drugs in the Philippines, heard the news of former President Rodrigo Duterte's arrest, she said it felt like a fresh breath of life had rushed back into her. She said she never thought she would live to see the day when justice no longer seemed out of reach for her husband, one of the thousands killed during Duterte's brutal anti-narcotics campaign.

"I was surprised and felt as if I had been brought back to life because what we have been fighting for is finally coming to fruition - we are finally getting justice for our loved ones who were taken from us," said Pico after attending a Mass in the Quezon City region of Manila with families of

At the church, stark reminders of the drugs war lined the steps of the altar - photos of those who lost their lives under Duterte's six-year campaign. Many of their families, like Pico, now hope to see the former president behind bars.In a dramatic turn of events, Duterte was arrested in Manila on Tuesday at the request of the International Criminal Court and flown to The Hague hours later, marking the biggest step yet in the court of last resort's probe into his bloody "war on drugs." The 79-year old Duterte could become the first Asian former head of state to go on trial at the ICC."For families of extra-judicial killing victims, this is our only wish-that those responsible be held accountable," said Pico, the 30-year-old mother of one.

Although Duterte withdrew the Philippines from the ICC's founding treaty in 2019 to block its drugs war probe, the court says it has jurisdiction to investigate alleged crimes that took place while a country was a member. Victims and human rights groups said that Duterte should not be the only one held accountable. They also demand justice against others involved, including his former police chief, now Senator Ronald dela Rosa, who oversaw the bloody crackdown and is under ICC investigation. "They should be with Duterte and not just Duterte being the only one held accountable, Emily Soriano, whose son was killed in the anti-drugs campaign, said at a press conference attended by families of other victims. Dela Rosa's office did not immediately respond to a request for comment. But he and Duterte petitioned the Supreme Court on Tuesday to compel the government to stop cooperating with the ICC.

During Duterte's six-year presidency, 6,200 suspects were killed during anti-drug operations, by police count.But activists say the real toll was far higher, with thousands of urban and poor drug users, many placed on official "watch lists", killed in mysterious circumstances. Pico said her husband, Mark Anthony Ruivivar, was added to such a list in 2018. The following year, she said, he was dead, shot and killed by police outside his home in Quezon City. At the time, police said he had fired at officers first."At least Duterte will only be imprisoned. His family will still get to see him, visit him," Pico said, holding back tears. "Unlike us who lost our loved ones, we will never see them again."

#### Mark Carney to be sworn in as Canada's prime minister

OTTAWA, Mark Carney will be sworn in as Canada's next prime minister on Friday morning, marking the final day of Justin Trudeau's more than nine years in power.Governor General Mary Simon will preside over the swearing-in of Carney and his cabinet ministers Friday at 11 a.m., her office said in a statement. Carney, a former central banker who led the Bank of Canada and Bank of England, was elected leader of the Liberal Party of Canada on Sunday. He will become Canada's 24th prime minister. Carney's new cabinet may be about half the size of Trudeau's executive, Bloomberg reported on Wednesday.

#### NASA's newest space telescope blasts off to map entire sky

Vandenberg Space Force Base: NASA's newest space telescope rocketed into orbit Tuesday to map the entire sky like never before — a sweeping look at hundreds of millions of galaxies and their shared cosmic glow since the beginning of time.

SpaceX launched the Spherex observatory from California, putting it on course to fly over Earth's poles. Tagging along were four suitcase-size satellites to study the sun. Spherex popped off the rocket's upper stage first, drifting into the blackness of space with a blue Earth in the background. The \$488 million Spherex mission aims to explain how galaxies formed and evolved over billions of years, and how the universe expanded so fast in its first moments. Closer to home in our own Milky Way galaxy, Spherex will hunt for water and other ingredients of life in the icy clouds between stars where new solar systems emerge.

The cone-shaped Spherex — at 1,110 pounds (500 kilograms) or the heft of a grand piano — will take six months to map the entire sky with its infrared eyes and wide field of view. Four full-sky surveys are planned over two years, as the telescope circles the globe from pole to pole 400 miles (650 kilometers) up. Spherex won't see galaxies in exquisite detail like NASA's larger and more elaborate Hubble and Webb space telescopes, with their narrow fields of view.

### Strings of legacy: the lone veena-maker of Nuzvid



Nestled in the narrow lane opposite the now-defunct Apsara Theatre in Nuzvid, a town famed for its luscious mangoes, the third house from the entrance looks markedly different from its neighbours. Unlike the well-maintained, urbane-looking houses, this house lays bare its brickwork, giving off an incomplete, rickety appearance. Yet, within this modest-looking abode thrives a legacy of cultural richness.

This is the house of Sheikh Mabu Saheb, 50, where more than 70 or 80 Veenas — India's national instrument — reside alongside the dying craft of making them. "Just like playing a veena, making it is a skill which only a few can master," says Sheikh Mabu, seated on the floor surrounded by his tools and materials, carefully sandpapering a veena. Brushes, paint bottles, wooden logs, chisellers and hammers of all shapes and sizes lie scattered around him, each playing a role in the designing and making of the instrument. "This is a Madhura Veena. It is distinguishable by its pear-shaped body. This particular one is bound for overseas," he says, while meticulously brushing the sandpaper over the veena's wooden surface. Nearby hang rows of finished and unfinished veenas, ready to be dispatched upon receipt of an order.

For over seven decades, this dilapidated structure has served both as a residence and a workshop for Sheikh Mabu's family. The family does not own any land, and neither does Sheikh Mabu have a storefront. He relies on word of mouth to sell his instruments. "It is not a business, you see. Those who know my work come here to buy," he says. He crafts all kinds of veenas, including the famed Saraswati veena, Madhura veena, Mayur veena, Sankhu veena, Rudra veena, Vipanchi veena, and the Gotu or Chitra veena. He also makes the folding veena, which can be dismantled, and a 21-inch veena. The 21-inch veena was recognised as the smallest playable veena in the world. While the normal size of a veena is 53 inches, Sheikh Mabu used his skill in crafting the smallest one, which retained all the 'sapta swaralu' (seven strings), which took over a month to craft. "It is difficult to put a number on the orders we get," he says, adding that, on an average, 20 to 30 veenas get sold in a year. But, orders or no orders, Sheikh Mabu sits down to make veenas every single day since his family has been dependent on this for decades. "It takes 12 days for one person to finish making a Veena. It requires a lot of patience, perseverance and attention. There should not be any scope for errors," Sheikh Mabu says, adding that making the 21-inch veena took him more than a month. Having more craftsmen could have helped him finish work in less time. Earlier, there used to be 10 skilled persons to help him with designing or chiselling. "Some of them left for better work, while some died. Nuzvid had around 20 craftsmen earlier who made musical instruments. Their number. too, has shrunk over the years due to lack of support from the government," he says, his voice tinged with sorrow. Sheikh Mabu, whose family has been making veenas for more than 50 years, is the last man standing in Nuzvid, once known for the veena industry, striving to preserve the art despite the challenges.

Laborious processThe entire instrument is made from a single piece of wood procured from the jackfruit tree. Three to four instruments can be made from a single tree, depending on its size. Sheikh Mabu says the tree has to be 70 to 80 years old for its wood to be useful. "We usually go to Devarapalle in West Godavari for the tree. We have to cut down there itself and transport it to our place by truck, after paying for the tree, for cutting and transporting," he says, adding that these days the Forest Department's permission has to be sought. Once the logs reach home, they are put aside for a month to dry. Once they are dried and hardened, he begins carving, shaping, and smoothing the body using sandpaper. To make the resonators, one called Tumba and the other Kunda, a circular shape on the wood is carved at first. The log is then hollowed and plated. After the initial carvings, the artisans use sandpaper to smoothen the wooden surface. The whole process takes 10-12 days for a single person. The entire process is meticulous and labour-intensive. Purchasing the wood alone and other raw materials, none of which are available in Nuzvid, cost him around ?40,000. The starting price of the veena is ?50,000.

The folding veena is the costliest at ?1.50 lakh, but the expenses are also much more. In any case, the profit margin is hardly ?10,000 or less, which is hardly enough for sustenance these days, Sheikh Mabu says, wondering how a family can live on such a low income.

Despite low returns and hardships, he wants to ensure that the art lives on. While his son and nephew know the process, he fears that the art, which was propelled to fame by his father, would die out if there are few to take it forward. Nuzvid's veena connection Nuzvid has been associated with veena-making for centuries. Tracing its history, Sangeet Natak Akademi awardee Ayyagari Syamasundaram, who was also the principal of Ghantasala Venkateswara Rao Government Music College in Vijayawada for 15 years, says classical music flourished under the patronage of kings and zamindars. "The art received great patronage from them. The flourishing of music led to a boom in musical instrument makers," says Mr. Syamasundaram, who is himself an eminent veena player. Sheikh Mabu's grandfather, Sheikh Kasim Saheb, began the family's association with veena-making, followed by his father, Sheikh Meera Saheb, who gained a reputation for his lightweight, finely tuned instruments.

"My father was particularly fascinated by the veena as in those days it was common to see yesteryear actresses such as Anjali Devi, Jamuna and Savitri playing the instrument," Sheikh Mabu says. Then, his father left for Vijayawada, where he learnt its manufacturing from one Ratna Varma, whose son Lakshmana Rao used to run the lone veena manufacturing shop in the city. After learning the ropes Sheikh Meera Saheb went back to Nuzvid and began making veenas on his own. After he became adept at the skill, he presented the instrument as a gesture of gratitude to all three actresses. He also presented veenas to former President late A.P.J. Abdul Kalam, a keen aficionado of the instrument, and spiritual guru Ganapathy Sachchidananda Swami. Later, as he grew famous, legends of Carnatic music such as Mangalampalli Balamurali Krishna, M.S. Subbulakshmi and veena maestro Chitti Babu procured their veenas from this humble household, recalls Sheikh Mabu. "Sheikh Meera Saheb's veena was known for its lightweight, slender body. The sound from the resonators was of great quality and the veena would last for years. All the maestros of the day would source their instruments from him," recalls Mr. Syamasundaram, who recommends his students to purchase veenas from Sheikh Mabu.

"In Sheikh Mabu's case, the apple did not fall far from the tree," smiles Mr. Syamasundaram, noting how Sheikh Mabu has carried forward his family legacy with unstinting devotion to his craft. He wonders where the next generation of veena enthusiasts would have procured the instrument from had Sheikh Meera Saheb's sons chosen to pursue a different path. Both Sheikh Mabu and his brother, who from a tender age saw their father making veenas and playing on them, naturally gravitated towards the art. While his brother died at a young age, Sheikh Mabu carried the legacy for-"It is the grace of Ammavaru (Goddess) that we, being Muslims, were able to learn this art. The veena is highly revered in Hinduism. How else can one explain it?" he says. Today, his name is taken in the same breath as the veena, and has come to be known as Veena Sheikh or Mabu Veena. He not only exports the instrument to different cities but also to other countries. Sheikh Mabu fondly recalls being approached by temple authorities to repair the golden Veena at the Durga Malleswara Swamyvarla Devasthanam in Vijayawada. He has also presented a veena to the Saraswati temple in Nuzvid, the Meenakshi Amman temple in Madurai and Durga temple at Patamata in Vijayawada. Sheikh Mabu has been a recipient of many awards and certificates, including from the A.P. Handicrafts Development Corporation Limited in 2014, 'Aasthana Vidwan' from Avadhoota Datta Peetham, and Wonder Book of Records for the smallest veena, among others. "While I am thankful to all those who recognised my work, my humble request to the State government is to grant me two acres, which I can use to set up an institute to teach others," Sheikh Mabu says, adding that the jackfruit tree, too, should be available to them free of charge. The Central government, recognising the art as an endangered form, is organising training sessions in veena making under the mentorship of Sheikh Mabu through the Lepakshi Handicrafts Development Corporation Limited.At a workshop near Nuzvid, 30 trainees, including 20 women from farming backgrounds, are learning the basics. The five-month classes will go on till March. "All 30 people are being given a stipend. Once the sessions are over, they will be taken into work by Sheik Mabu," says Lakshmikanth Inapala, Managing Director, Lepakshi. He said the training sessions are part of their efforts to preserve the ancient art of veena making, found only in Bobbili and Nuzvid in Andhra Pradesh. For Sheikh Mabu, the veena is more than an instrument — it is a lifeline to a rich cultural heritage he refuses to let fade into obscurity.

## Is it time for an Indian Banksy? The list of issues in need of public scrutiny is growing by the day but Indian street art continues to play it safe



Some years ago, in the U.S., I remember attending a charity auction organised by the Philadelphia Arts League. Local artists were invited to display and sell their works by placing them on a conveyor belt that moved slowly towards a shredder. If a piece was picked by a buyer, the proceeds went to the children's hospital; if not, it was shredded into the garbage bin. The artist merely watched helplessly.London-based street artist Banksy similarly sold a painting at a Sotheby's auction for £1 million. As soon as the bid was accepted and the hammer came down, the artwork slipped out of its frame and shredded onto the floor. The self-destruction ironically increased the artistic value of the painting which was renamed Love is in the Bin.

Whether the shredding was an artistic act done to add theatrical value to the painting, it is hard to say, but in all likelihood it was part of Banksy's plan to ensure that art is not taken too seriously. His bigger works are altogether different. In 2017, in West Bank, Banksy established the Walled Off Hotel, a temporary art exhibit on the tragedy of Palestine. A play on New York's Waldorf chain, the hotel looks right into Israel's West Barrier and proudly boasts the worst view in the world. Part art, part politics, part satire, the artwork has to date attracted over 140,000 visitors.A 2017 Banksy mural shows cherubs prying open the separation barrier in Bethlehem, West Bank, opposite the Walled Off Hotel. Without a doubt, Banksy is today one of the most important and prolific street artists of our time. In August 2024, nine animal-related artworks appeared in quick succession on London walls. A gorilla at the entrance to the local zoo, two elephants stretching trunks out of building windows, pigeons on an imaginary wire — the graphic simplicity of much of the work is often undercut by scathing satire. Two surveillance cameras strut about like pigeons on the sidewalk; on a wall in Ukraine, a young boy wrestles a bully to the ground; another is seen painting a sign 'Graffiti is a Crime'. It is hard to qualify Banksy's work — site-specific and done at night — as art or vandalism; but as a critic noted, it is the most essential form of public vandalism. Sadly, such vandalism falls entirely out of the framework of art in India. How well would Banksy do in a country where the primary showcase for public art is a triptych of the Mahabharata in a metro station, or a bronze statue of Shivaji at a roundabout? Would he be allowed to run his painterly fingers on the walls surrounding Churchgate Station in Mumbai, or to deface Delhi's India Gate? Could he in fact write a cryptic message about Indian democracy on the dome of Rashtrapati Bhavan, or wrap the new Parliament building in plastic. Unlikely.

For the past decade, despite increasing popularity and visibility, Indian street art has been a reluctant commentator in the public sphere, even though it originally evolved from the political graffiti of Kolkata. Since then it has progressed to three-dimensional wall paintings, quotations, and many forms of caricature and large-scale imagery, visible in many cities. In Delhi's Lodhi Colony, high-walled arched colonial compounds are filled with a bright colour palette that skilfully disguises the fraying neutrality of the old colonial architecture. At Kala Ghoda in Mumbai, and annual street art festivals in Bengaluru, Kochi and Pune, portraits of famous personalities cut across building facades, trees spread their painted branches around corner walls; murals even appear on private properties that abut the road. Talented local artists display their work on many varied themes with an unusually rich style of pictorial representation.

Banksy's work, by contrast is remarkably spare relying on the directness of its evocative message. It is unusual in content, display and execution as much as it is a product of its surprising location. As always, the artist remains hidden in plain sight. Everyone knows him, but publicly, he remains invisible, going about his nightly production without frill or fuss. A pandemic poster, 'Do not wash your hands' - is it social comment or satire?; Girl with Balloon — graphic art or cultural artefact?; surveillance cameras posing as street pigeons — public protest or political comment? The calculated absurdity of the artist's position is baffling, clever, disturbing, always surprising, but rarely self-conscious. When will it appear next, where, and in what medium...? As the Indian art season reopens, our own illtempered cities — desolate, bereft of landscape, and falling apart — cry out for such expression. Religion, separatism, censorship, communal rage, growing illiteracy, bureaucratic apathy, political arrogance, business bluster, media manipulation, the list of Indian issues in need of public scrutiny grows day by day. But an Indian Banksy refuses to step out of the shadows.

### Medical education in India is at a crossroads; here's a road map

The Indian government replaced a system — the Medical Council of India, which was regulating medical education and practice for over eight decades — due to allegations of inefficiency and corruption. NITI Aayog was a strong proponent of this change, and even the judiciary advocated the need to improve medical education. The Medical Council of India was superseded by the National Medical Commission in 2020, through an Act of Parliament, which now sets new standards and regulations to reform the system. This has compelled even private medical schools to comply with certain norms. The medical community, particularly academicians and educators, closely observe the NMC's operations.

Although it may be premature to evaluate its performance within just four years, the regulators' eagerness to implement significant changes to the curriculum has led to considerable disarray and confusion. Adhering to Western medical policies without considering India's unique circumstances has contributed to this turmoil. The implementation of the new curriculum has been counterproductive in many medical schools. Competency-based medical education (CBME) was introduced to emphasise practical skills over theoretical knowledge. However, the opposite occurs, with more time allocated to lectures (symposiums, group discussions, seminars, etc.). Reforms have made medical education shrivelled and truncated. Previously, medical students would begin clinical rotations from 8 a.m. to 1 p.m. after completing one and a half years (Basic Science) of the MBBS course. They would spend time in wards, procedure rooms, and operating theatres, with theory classes scheduled for the evening (2 p.m. to 4 p.m.). This schedule has been inverted, with students attending clinics after 10 a.m. and theory classes in the morning. Consequently, students are no longer seen with teachers during the morning rounds, a departure from the past when unit chiefs, associates, assistants, residents, and students were all present. Bedside teaching is a crucial component of medical training, yet it has nearly vanished from medical schools. Students are now often seen merely following faculty to get their logbooks signed, where high scores are prevalent. Teachers are deeply concerned, but collective action to address this issue with policymakers is lacking. Medical professional bodies and other stakeholders must seriously

More medical schoolsThe graph depicting the growth of medical colleges from 1974 to 2024 illustrates a sharp increase in both government and private institutions. In 1970, India had fewer than 100 medical colleges for a population of 54 crore but today, there are 766 medical colleges across both government and private sectors for a population of 144 crore. The past decade alone has seen a rapid increase in new medical colleges leading to increased MBBS seats from 64,464 to 1,15,812 seats and PG seats from 31,185 to 73,111 seats. The number of medical colleges in India almost doubled to 595 from 335 between 2011 and 2021. This year, the government sanctioned 60 new medical colleges. According to Western standards, we would still need 300 more medical schools based on our population size. Since 2014, there has been a rapid rise in the number of seats for undergraduate and postgraduate students. Last year, on the 78th Independence Day, Prime Minister Narendra Modi announced a plan to create 75,000 new medical seats across India over the next five years. The government's policy changes aim to transform general and district hospitals into medical colleges and ease the criteria for establishing new ones. While these changes may appear beneficial, a deeper analysis suggests they could lead to academic decline. The well-known lack of adequate infrastructure and faculty, even in established institutions, is concerning. Many new institutions are missing basic amenities and have a shortage of faculty, threatening the quality of medical education.

Adopting the Western model without the necessary infrastructure and faculty could have catastrophic conse-



tries, where the faculty-student ratio fosters a conducive academic environment, the situation is reversed here. Additionally, examination results from medical colleges indicate a troubling trend: four decades ago, with more government and fewer private medical colleges, the failure rate was about 20-30% among meritorious students. Now the failure rate is 1-2% only, that too with mediocre students. Some people reason that the decline in failure rates could indicate lowered educational standards, affecting the the overall competence of future doctors. The dramatic shift in the quality of medical education, inspection standards, and regulatory inconsistency certainly pose a major concern. Producing well-qualified doctors is essential for societal welfare. Academic institutions and regulatory bodies should indeed prioritise these issues. Regular and thorough inspections are crucial to ensure the quality of education. Examinations and testing

While the National Exit Test (NEXT) is a step in the right direction, the delays and inconsistencies are disheartening. A clear, consistent plan needs to be established for such crucial examinations. Reforming this system requires collaboration between academicians, professional bodies, and regulators. Are there some practical steps that can be taken right now to improve the situation? The main issue, however, is the lack of adequate infrastructure and faculty. An independent study by a professional body would reveal startling findings. The government should not relax norms and regulations merely to start new institutions due to political compulsion. In the long term, this approach is detrimental to the quality of doctors in India. Immediate action from academicians, professional bodies, and policymakers is required to address these issues. The government's focus on expanding medical education should be balanced with ensuring adequate infrastructure and sufficient qualified faculty. An in-depth independent study is crucial to uncover

For the last many days, farmers in Kandukur, Yacharam, Gajulaburj Thanda, Agarmiyaguda and neighbouring villages in Rangareddy district have been protesting against the land acquisition for laying roads to the proposed Fourth City. A video of a tribal woman farmer crying inconsolably and pleading with the officials not to acquire lands is going viral. In the video, a group of officials and police personnel are seen passing through agricultural lands and the woman farmer from Marlakunta village is appealing to the officials to spare her lands.

#### Man's palm amputated after rare infection caused by fish bite at Thalassery



A 38-year-old man from Thalassery had his right palm amputated following a severe bacterial infection reportedly caused by fish bite while cleaning a pit. Rajeesh, a dairy farmer from Madapeedika, said he was bitten by a fish, locally known 'Kadu', in early February. What initially seemed like a minor cut on his fingertip escalated into a life-threatening condition, he added.

"I sought treatment at the Kodiyeri primary health centre, where I was administered a tetanus injection. However, as the wound worsened, I got admitted to a hospital in Mahe and later to a private hospital in Kozhikode," he said. Rajeesh was reportedly diagnosed with gas gangrene, also known as clostridial myonecrosis, a severe and life-threatening bacterial infection that destroys tissue and produces gas within it. The infection had spread to his palm, leaving amputation as the only option to prevent further complications, including possible brain damage. Meanwhile, the Health authorities advised caution as the bacteria responsible for gas gangrene thrive in muddy water.

#### Warning signs of kidney fungus you shouldn't ignore (especially if you're diabetic)

Kidney fungal infections, though uncommon in healthy individuals, can pose significant health risks when immunity is compromised. These infections are particularly prevalent among individuals with underlying conditions like diabetes or those recovering from severe illnesses. Recognising the signs early and understanding how to prevent them can improve health outcomes.Dr Vijay Kumar Sarma Madduri, Consultant Urologist at the Asian Institute of Nephrology and Urology, Hyderabad, explains that these infections usually affect individuals with compromised immunity, such as those with diabetes, AIDS, or cancer.

What causes kidney fungus?

Fungi thrive in conditions where the immune system is weakened. "Diabetes is the most common underlying cause of kidney fungal infections," notes Dr Madduri. High blood sugar levels and impaired immunity in diabetics create a conducive environment for fungi to grow. A surge in kidney fungal infections was observed post-COVID, Dr Madduri said, as severe viral illnesses like COVID-19 can significantly weaken the immune system. This trend paralleled the rise in black fungus infections of the nose during the pandemic. Skipping breakfast can set off a cascade of physiological and psychological effects, complicating blood sugar management and increasing the risk of long-term com-

#### WHO starts slimming down in response to U.S. cuts, document shows

The World Health Organization (WHO) has started reassessing its priorities and introduced a one-year cap on staff contracts, as revealed in an internal memo. This move aims to secure the organisation's survival following the United States' withdrawal in January. The memo, dated March 10 and signed by WHO assistant director-general Raul Thomas, laid out further cost-cutting measures, the latest in a series of such steps since U.S. President Donald

Washington, which was instrumental in helping set up the agency after World War II and has been one of its most active members, is by far the U.N. health agency's biggest financial backer, contributing around 18% of its overall funding. According to the document, senior WHO officials have begun "prioritisation" work over the past three weeks to make the global health agency sustainable. "While operating in an extremely fluid environment, WHO's senior management are working to navigate these shifting tides by undertaking a prioritization process," the memo said.

"Their work will ensure that every resource is directed toward the most pressing priorities while preserving WHO's ability to make a lasting impact," the document said. Additionally, staff are working to secure additional funding from countries, private donors and philanthropists, without saying if these efforts had been successful. It stopped short of announcing immediate staff cuts but said that "given



the magnitude of the challenges we face, some difficult decisions are unavoidable. "Margaret Harris, WHO spokesperson told a press briefing that, even before U.S. funding cuts, the agency was undergoing a transformation to shift resources away from its Geneva headquarters and into recipient countries. "So what's really been happening is a big transfer of funding and staffing and commitment at country level away from headquarters, It has been a slow process and for sure, the cold winds of economic rationalisation are speeding that up," she said. The documents show that the U.N. agency has over a quarter of its 9,473 staff based in its headquarters in Geneva, Switzerland which is one of the most expensive cities in the world.

#### Osteoarthritis cases, related disability up by over 130% globally, finds study

According to a study published in the British Medical Journal (BMJ) Global Health, globally, cases of osteoarthritis and the resulting disability among menopausal women have increased by over 130 percent in the last three decades. The findings show that an excess weight or body mass index accounted for about a fifth of the duration lived with disability resulting from the condition that steadily de-

Researchers, including those from Hangzhou Medical College, China, said declining oestrogen levels in menopause affect skeletal health and are directly related to functioning and stability of joints. Osteoarthritis affecting knee joints were found to be the most common type, associated with the highest loss of healthy living, followed by that affecting hands. According to the study, countries in East Asia and high-income Asia Pacific experienced the fastest increase in burden of this chronic condition. While the most rapid rise in new cases of knee osteoarthritis was seen in Southeast Asia, the most rapid rise in prevalence was seen in East Asia. The trends noted in East Asia "may be linked to rapid population aging, increased workforce participation and a surge in obesity rates due to urbanisation and changing lifestyles," the authors wrote.

However, "the high burden observed in high-income Asia Pacific could be attributed to advanced healthcare systems with better diagnostic capabilities, facilitating comprehensive identification and reporting of cases", they wrote.



The findings also show an escalating burden of osteoarthritis among menopausal women and calls for proactive measures, especially those promoting lifestyle adjustments for controlling BMI, the authors said. Additionally, a 2023 study published in The Lancet Rheumatology journal estimates that osteoarthritis affected approximately 600 million people worldwide in 2020, accounting for nearly 8% of the global population.

Projections suggest that this number may swell to nearly 1 billion by 2050. The study's findings are based on data from the Global Burden of Disease 2021 study, which analysed the prevalence, severity, and mortality rates of 371 diseases across 204 countries and territories between

#### Classify Cancer as a notifiable disease to succeed in fighting it: Dr. Dattatreyudu Nori

The cancer incidence is growing in India primarily for two reasons. The first factor is that the older population is increasing even though there is a significant number of middle-aged groups. Secondly, there is an increased awareness about cancer. On the diagnostic side, there are more facilities. Everyone feels cancer numbers are going up. It is true to some extent but the awareness has also improved among the public.

Except for the M.N.J. Institute of Oncology and Regional Cancer Centre, there is no other government-dedicated hospital to treat cancer in Andhra Pradesh and Telangana states. What is your suggestion?

MNJ Hospital is a Regional Cancer Centre started with the approval and funds given by the Union government. Serving not only A.P. and Telangana but the entire southern region because care is free. The government is strengthening it. Such Regional Cancer Centres help a group of patients who cannot afford to go to private hospitals. What I suggest to the governments is that they should strengthen their government hospitals with the latest technologies and treatments. Everything that a corporate hospital can deliver should be available for deliverance in government hospitals. The first order of duty is to identify deficiencies in government hospitals and strengthen them. That way you will serve more people, who cannot afford cancer treatment. The governments should see that treatment is accessible by free transport from anywhere to anywhere within the State; providing accommodation to the patient's family. All these are crucial if you want to provide optimal care for underprivileged people.

Do you feel that there is a need for sub-regional can-

I will tour all the hospitals in Andhra Pradesh. I am from A.P., and I studied in Kurnool, I know in and out of every hospital. I will study and report to Chief Minister N. Chandrababu Naidu on what can be done immediately, short-term, intermediate and long-range plans. That is the first order of my responsibility to present the information to the Chief Minister. The report should be ready in three months probably but for data available with the government.

Do you advocate the PPP model as the governments are not in a position to invest more in cancer hospitals?

First, we find deficiencies and find funding. I have to know what the deficiencies are. Then funding can be accommodated automatically. Either requesting the Central government or institutions like Tata Trusts which has hospitals in places like Visakhapatnam and Tirupati. The A.P. government already has a tie-up with Tata Trusts. We will ask them to establish centres where there is a deficiency. Government hospitals are not fully equipped yet. Corporate hospitals have taken over cancer care. The problem is that middle and low-income classes cannot afford cancer treatment despite Aaryogyasri and other schemes. There are about 1.4 to 1.5 million cancer cases every year. We need more cancer centres but not at the corporate level because cancer treatments are very expensive.

You are meeting Prime Minister Narendra Modi. What do you have to suggest to him to address cancer-related

The government has to classify Cancer as a notifiable disease. India should adopt a strategy akin to fighting COVID-19. District and State-level data for the entire country has to be prepared, and thus prepare a Cancer Atlas



The establishment of a cancer command and control (CCC) centre in India is necessary. The cancer department has to be a single entity not a sub-division of the health department. The government should adopt a five-point solution, which we call Panchamrit, to address the cancer crisis in India. There is a need to declare cancer a notifiable disease, subsidise cancer screening and establish a command-and-control centre. We should get accurate cancer incidence and prevalence data. This will help in identifying high-density areas and how to allot resources. In the backdrop of a lot of opposition and conspiracy theories to the HPV vaccine in India, what's your take on the vaccination? What is the scenario in other countries regarding the vac-

Western countries have proved that the HPV vaccine is successful. The Government of India is also encouraging. Remember that 200 women die every day due to cervical cancer. Social media writes all kinds of nonsense. You should write the truth about cervical cancer and spread awareness about the HPV vaccine.

What is your suggestion to governments to fight can-

To address the crisis in India and A.P., it has to be a two-pronged strategy. Apart from treating the existing patients, it is also important to focus on creating awareness, health education, prevention screening and early detection. If you want to succeed in the cancer fight you have to give a balanced approach to both.

How do you look at traditional medicine and various kinds of treatments for cancer?

All medicines are available. Immunotherapy medicines are available and the government and pharma companies are subscribing to them. Some traditional medicines may work, but they don't have time to do research. I am not against traditional medicines, but it has to be proven with

It is said that cancer is a genetic disease. How far is it

90% of cancer cases are due to somatic mutations, and the remaining 10% are genetic. If one changes their lifestyle by quitting smoking and alcohol, and eating nutritious food, cancer can be prevented.

What about the research centre at Basava Tarakam

A research centre is coming up with ?10 crore in Hyderabad. The building has been identified. We are buying new equipment. Research teams are ready. Actually, this is not new, we are moving from the old building to the new one

#### Snake-bitten patients get a new lease of life at Kozhikode MCH

The Government Medical College Hospital (MCH), Kozhikode, has been successful in treating snakebite cases in recent times, with a majority of patients receiving a new lease of life. Sources in the General Medicine department said on Wednesday (March 12, 2025) that 102 of the 108 people admitted there in 2024 had survived the ordeal. Seven patients each recovered in both January and February this year. A woman from Perambra died on March 3



after being bitten by a Cobra in a field. However, she had already died by the time she was brought to the casualty,

Doctors said that the six patients who died last year had been taken to multiple places before being admitted to the hospital. They were in critical condition when they arrived at the casualty. Though many of the survivors were also in serious condition, they could be saved as they were admitted on time.P. Jayesh Kumar, Head of the Department, General Medicine, said that most patients had been bitten by Cobras, Common Kraits, Saw-scaled Vipers, and Russell's Vipers. "Antidotes are available for all these. Recently, there has been a rise in Pit Viper bite cases, especially from the Hump-nosed Pit Viper, for which no antivenom is available. However, complications and the risk of death are rare from its bite," he added.

Dr. Jayesh said that the highest number of snakebite cases were reported in October, November, December, and January, during the breeding season of snakes. "Most patients are bitten by snakes from their surroundings or fields often at night when proper lighting is unavailable. A majority of those admitted to the hospital are from Kozhikode, with some cases from Malappuram and Wayanad as well. The hospital has a special intensive care unit for treating such cases, and research studies are also being carried out," he added. The doctors pointed out that snakebite victims should be taken to a hospital as soon as possible. Polyvalent antivenom is generally administered to the patient. "The snake species can usually be identified through a blood test or by inspecting the symptoms. There is no need to catch the snake, as it can be dangerous. However, if possible, a photo of the snake can be taken, which will help the treat-

#### Ice baths popular for exercise recovery, general wellness. But what does science say?

Ice baths have become increasingly popular over the past few years. Fitness enthusiasts and casual exercisers around the world are embracing this trend that was once reserved for elite athletes. Ice baths (also known as "cold water immersion") are exactly what they sound like. They involve immersing your body in cold water for a set amount

Ice bath temperatures typically range from 10–15°C, though many people opt for water that's literally icy.Social media is filled with videos of people plunging into freezing water, claiming this helps with everything from recovery after exercise to mental health. But do ice baths live up to the hype? Here's what the evidence says. One of the main reasons people use ice baths is to reduce muscle soreness and improve recovery after exercise. Athletes, including endurance runners, weightlifters and football players, commonly use ice baths. And there's plenty of evidence to suggest ice baths can improve recovery after exercise. Research shows having an ice bath immediately after a bout of intense exercise can reduce muscle soreness in the following hours and days. Ice baths have also been shown to help with recovery in areas including muscle

strength, power and flexibility.

Ice baths do this by reducing post-exercise inflammation, muscle swelling, and muscle damage, while improving the clearance of metabolites, such as lactate. So, if you are someone who needs to perform bouts of intense exercise on back-to-back days, ice baths could be a good option. But they shouldn't be used all the time, even if you are an athlete. As mentioned above, one of the ways ice baths work is by reducing inflammation in the muscle tissue that occurs after exercise. While this helps muscle recovery, this inflammation also acts as a signal that tells the body to adapt and become stronger. For this reason, using ice baths too often (that is, after most training sessions) may blunt training-related increases in strength, endurance and power, as well as muscle growth. Notably, ice baths don't seem to harm aerobic fitness. This means you might be OK to use them as often as you want after aerobic training sessions.lce baths and general health

More recently, ice baths have gained traction in the broader fitness and wellness communities. Proponents suggest they can enhance mental health, immune function, and overall wellbeing. But the research in this space is sparseWe recently did a systematic review examining all the published research looking at ice baths and health outcomes in the general population (rather than athletes). We found only 11 studies, some of which used cold showers instead of ice baths. The evidence suggested regular cold water immersion might lead to small reductions in stress. small improvements in sleep quality and self-reported quality of life, and might reduce how often people get sick (such as with a cold or the flu). However, many of these findings came from single studies, so they should be interpreted with caution until more research is conducted. Also, we didn't explore how ice baths (and cold showers) may have caused these effects, so we don't know exactly how they work.ice bath Ice baths are great for muscle repair and recovery

Are there any risks?

While there isn't any research examining the dangers of ice baths at a population level, there are some possible risks.In rare instances cold water immersion has been shown to lead to cold shock. This condition is caused by a rapid fall in skin temperature and can lead to gasping, hyperventilation, high blood pressure, and, infrequently, cardiac arrhythmia (irregular heartbeat), which can be fatal if not treated quickly

#### Starlink partnerships open new era of seamless global connectivity: Sunil Bharti Mittal



New Delhi: As Airtel announced a partnership with Elon Musk's SpaceX to bring its affordable satellite internet service to India, Sunil Bharti Mittal, Founder and Chairman, Bharti Enterprises, said on Wednesday that a new era of seamless global connectivity beckons for customers.

Mittal said that soon, customers will be able to carry their mobiles to the remotest part of the world, with them in the skies and blue oceans. In his opening remark at the recently concluded "Mobile World Congress 2025" in Barcelona, Mittal made a call to both the telecom and satellite players to work together, combine their strengths, and complete the mission of connecting the unconnected, covering the oceans and the skies as well as difficult-to-reach areas."I am glad that this is being followed through with active announcements of partnerships between satellite com-

panies and telecom operators," he said in a statement. Airtel has signed an agreement with Musk's SpaceX to bring Starlink's high-speed internet services to its customers in India. This is the first agreement to be signed in India, which is subject to SpaceX receiving its own authorisations to sell Starlink in the country. According to Mittal, he had made a similar appeal in my keynote address at the Mobile World Congress in 2017 for operators to slash roaming charges, which were preventing customers from carrying their home networks and seeking local SIMs or Wi-Fi hotspots.

"The industry responded favourably; roaming rates went south, and the international home network switch-on rates shot up. Today, roaming tariffs across the globe are affordable," he noted, adding that "I have no doubt the satellite and the telecom industry globally will respond to my call to combine their strengths."For the telecom industry, the addition of satellite technology should be no different from bringing new technologies to its customers. "Just like 4G, 5G, and 6G in the future, we will now have one more technology in our mix, i.e. SAT-G," said Mittal. Airtel and SpaceX will explore offering Starlink equipment in Airtel's retail stores, Starlink services via Airtel to business customers, opportunities to connect communities, schools, and health centres, among many others, in even the most rural parts of India. Airtel and SpaceX will also explore how Starlink could help expand and enhance the Airtel network, as well as SpaceX's ability to utilise and benefit from Airtel's ground network infrastructure and other capabilities in India, said the company.

#### India needs to grow 8% for progress, core sector must invest: SBI chairman

(Photo: Ganesh Shirshekar)INDIA definitely needs to grow at 8 per cent to progress, and this needs consumption and private capital expenditure, said Challa Sreenivasulu Setty, Chairman, State Bank of India, the largest bank in the country with a deposit base of Rs 52.29 lakh crore. "India definitely requires a growth rate of 8 per cent to progress, but this (current) growth rate (of around 6 per cent) is not to be really worried about... We must realise that the slowdown which we are talking about could be a blip. The long-term story of India is intact," Setty told The Indian Express in an interview.

According to him, while private capital expenditure is happening in certain sectors, the core sectors, such as steel and cement, must start to invest. "They all have reached the capacity utilisation of 75-76 per cent," he said. Setty, who took charge as SBI Chairman in August 2024, is of the view 8 per cent growth needs consumption to pick pace. "Rural consumption is alright, but we may have to see the trend post rabi harvesting. But broadly some of the indicators are better. In terms of urban consumption, the expectations of consumption have been created. Now, the Budget proposed there will be no tax on annual income up to Rs 12 lakh," he

The Indian economy grew 6.2 per cent during the quarter-ended December 2024 and is estimated to grow 6.5 per cent for the full year 2024-25. The Reserve Bank of India (RBI) has projected a GDP growth rate of 6.7 per cent for the next financial year 2025-26. Setty said the economic data indicates private consumption in the current guarter has picked up. The Private Final Consumption Expenditure (PFCE) has reached 7.6 per cent, which means that the consumption is coming back. "There are certain sectors which are slightly slower than others, such as the auto seg-



ment. The auto sector witnessed very good growth in October-November, but December onwards it has slowed down. But overall, private consumption seems to be moving in a positive direction," he said. Referring to private sector investment, the SBI Chairman said companies seem to be worried about external factors. "...how tariffs are going to work out or if a particular country is not able to export, then whether the dumping will happen here. But I think these are all concerns which we feel that can be overcome," Setty said. Once consumption picks up, private capital expenditure will happen in the sector which is not witnessing (private capex). "Otherwise, if you see our (SBI's) pipeline of corporate lending is about Rs 4 lakh crore...half of it is sanctioned but yet to be disbursed and half of it is under discussion. This is a significant pipeline and the sectors also are diversified other than the core sector," the SBI Chairman said.On tariff wars, Setty said the broader assessment is that the export basket of India is diversified, both in terms of products and also in terms of geographies. "While every export matters, and even if you are exporting \$10 billion or \$20 billion to the US, the impact will be there, but it will not be as significant in our view. What is the most important in the whole tariff talk is about the narrative," he said.

#### Market sell-off wipes out Rs 2.33 lakh crore from mutual fund retail assets in February



The sell-off in the stock market has dealt a heavy blow to the mutual fund industry with assets of retail investors in various funds plummeting by Rs 2.33 lakh crore and inflows into small-cap and mid-cap schemes plunging by up to 34.9 per cent in the month of February. Highlighting the vulnerability of mutual fund investments to market volatility, retail assets under management (AUM), including equity, hybrid and solution-oriented schemes, plummeted to Rs 36,44,112 crore in February from Rs 38,77,595 crore in January this year, according to figures released by the Association of Mutual Funds in India (AMFI).

This decline occurred during a period of significant market correction due to multiple external factors primarily global trade tensions created by uncertainty on US tariffs. "This resulted in the benchmark BSE Sensex TRI experiencing a month-on-month decline of over 5.5 per cent," said Jatinder Pal Singh, CEO, ITI Mutual Fund. Significantly, mutual fund industry's overall AUM declined by Rs 2.71 lakh crore to Rs 64,53,493 crore in February 2025 as against Rs 67,25,449 crore in January. While net investments in the small-cap fund category decreased by 34.9 per cent to Rs 3,722.46 crore, and inflows into mid-cap funds fell by 33.8 per cent to Rs 3,406.95 crore, large-cap funds experienced a more modest decline of just 6.4 per cent, reaching Rs 2,866 crore.

Gross equity inflows also saw a reduction of 18 per cent, falling from Rs 66,630 crore in January 2025 to Rs 54,428 crore in February. This asset price reduction comes on the backdrop of global uncertainties and macroeconomic factors which has caused the benchmark indices Niftv 50 and BSE Sensex to decline by approximately 6 per cent. "However, investors continue to repose faith in the industry despite these turbulent times, net equity inflows have remained positive for the last 48 months, witnessing Rs 0.29 lakh crore net inflows in February 2025 with all equity categories registering net inflows for the month. Further, the net inflows declined by 26 per cent as compared to January 2025," said Sanjay Agarwal, Senior Director, CareEdge Ratings.In January also, the net AUM of equity mutual funds

plummeted by Rs 1.1 lakh crore, or 3.26 per cent, on a month-on-month basis, to Rs 29.46 lakh crore as of end-January 2025. According to AMFI, SIP assets were at Rs 12,37783 crore for the month of February. SIP contribution for the month stood at Rs 25,999 crore. It seems the downfall in the AUM of large-cap funds is over. The market share of large cap AUM kept falling from 17 per cent in October 2021 to 11.7 per cent in December 2024, and now finally rose to 12.2 per cent in February 2025.

"We had anticipated this rise and now it is playing out. This is led by inflows of Rs 2,866 crore in month of February. When times are volatile, it is large cap category that is the preferred investment destination," said Viraj Gandhi, CEO, SAMCO Mutual Fund. The party in small-cap schemes which started post Covid has now taken a halt and its market share in the total AUM fell from 10.8 per cent in December 2024 to 10 per cent in February 2025. This indicates a sharp cut of 9 per cent in two months due to fall of almost 10 per cent in small-cap index during this time.Meanwhile, Gold ETF category recorded net inflows of Rs 1,979 crore in February 2025, significantly lower than the Rs 3,751 crore inflows in January. "The decline in inflows can be attributed to profit booking, as gold surged to an all-time high last month, prompting investors to lock in gains. Additionally, equity market corrections presented attractive buying opportunities, leading some investors to shift focus from gold ETFs to equities," said Nehal Meshram, senior analyst-manager research, Morningstar Invest-

#### Gas leaks at ONGC's station in Andhra Pradesh, affects nine persons including 4-year-old child

Kesanapalli (Andhra Pradesh): Lack of maintenance at ONGC's gas collection station here in Konaseema district resulted in a Hydrogen Sulphide gas leak, said an official on Thursday. District Collector R Mahesh Kumar said the gas leaked around 2:30 pm on Wednesday had affected about nine persons, including workers and a four-year-old child who vomited. Because of anaerobic respiration of micro-organisms, there was some accumulation of H2S gas (Hydrogen Sulphide). This is a result of lack of maintenance of those wells," Kumar told According to the Collector, the gas collection station has six units and H2S leaked when Oil and Natural Gas Corporation (ONGC) workers were trying to wash a well located near the panchayats of Gollapalem and Turpupalem.

#### Singapore's Temasek buys 10 per cent stake in Haldiram Snacks Food



New Delhi: Temasek, Singapore's sovereign investment firm, is acquiring a minority 10 per cent stake in Haldiram Snacks Food — India's largest packed snack and sweets company and restaurant operator — at a valuation of USD 10 billion, according to industry sources. It signed a definitive term sheet agreement earlier this week at a valuation of USD 10 billion (around Rs 85,000 crore), which is considered to be the largest for the Indian packed food industry, they said. The Agarwal family, promoters of Haldiram Snacks Food, may rope in another investor for selling some more stake in the company which had a revenue of over

Rs 12,500 crore in FY24. The agreement with Temasek came after months of negotiations as several PE firms, including Blackstone, Alpha Wave Global and Bain Capitalled consortiums, were in the race to pick up a stake in Haldiram Snacks Food.

The Agarwal family may also opt for the IPO (initial public offering) route next year to capitalise on India's buoyant stock market. Earlier, the promoters were intending to divest a larger portion. However, they have decided to offload a minority stake only. This cash infusion will help Haldiram Snacks Food to fund its expansion plans and expedite its journey in the domestic as well as some of the foreign markets, where it has a presence. Haldiram Snacks Food is the combined business of the two fractions of the Haldiram family — Delhi and Nagpur. The National Company Law Tribunal has already approved the process of merger of the two fractions, while other regulatory approvals are awaited. Established in 1937 as a retail sweets and namkeen shop in Bikaner, Rajasthan, by Ganga Bhishen Agarwal, Haldiram products are now sold in over 80 countries. In 2022, it was announced that the packaged snacks businesses of Delhi-based Haldiram Snacks and Nagpur-based Haldiram Foods International would be first demerged and then merged into an entity named Haldiram Snacks Food.

#### 'Retail credit growth continues to moderate across most products': TransUnion CIBIL CEO

Bhavesh Jain, MD & CEO, TransUnion CIBIL, a leading credit information company, says the slowdown in consumer credit demand, coupled with a decline in loan originations by lenders, has resulted in a cooling of overall retail credit growth. In an interview with The Indian Express. Jain said, "non-performing assets (NPAs) in the microfinance sector have increased to Rs 51,000 crore. The marked increase in credit card spending indicates its expanding acceptance among consumers as a tool to access credit."

What's your assessment of the credit market in India? Has the slowdown in the economy affected it?

Retail credit growth continued to moderate across most products. Several factors including challenging global economic conditions, slowing urban consumption and regulatory measures designed to stabilise the credit-deposit ratio, may have affected the credit market in India. The slowdown in consumer credit demand, coupled with a decline in loan originations by lenders, has resulted in a cooling of overall retail credit growth. Identifying eligible and lower-risk consumers who can afford to service their credit obligations will be critical for the sustained growth of credit and

There are reports that microfinance NPAs have risen to Rs 50,000 crore. Is there a concern in the MFI segment?

Yes, the non-performing assets (NPAs) in the microfinance sector have increased to Rs 51,000 crore. At present, microfinance institutions (MFIs) function as highengagement businesses, where the loan disbursals may be based on subjective underwriting and collection strategies, based on individual lenders' processes and policies. By utilising advanced data analytics, lenders can evaluate MFIs' creditworthiness more precisely, thereby reducing the potential risk of defaults. Furthermore, it facilitates enhanced monitoring of loan performance and improved customer behaviour.

Additionally, financial literacy initiatives can inform borrowers about financial management, enabling them to make well-informed decisions and decreasing the likelihood of over-indebtedness.

Credit card use and outstanding have shot up in the last one year. What are the reasons for this surge?

Although still significant, portfolio balances grew at a slower rate y-o-y (year-on-year) in December 2024 for all retail credit products, except credit cards which grew at 24 per cent y-o-y. There has been a cooling off in new loan originations for personal loans and consumer durables loans since the quarter ending March 24. This may have led to consumers increasing their spending on their existing credit cards to finance their consumption needs. The marked increase in credit card spending indicates its expanding acceptance among consumers, not only for transactions but also as a tool to access credit. This may be an opportunity for lenders to identify consumers who require additional credit for their consumption and aspirational goals, and service them with customised solutions that are better suited and affordable for them. These customised credit offers should focus on helping the consumer fulfil their needs effectively while also supporting them in building a stronger credit profile. By using more comprehensive data insights to understand the changing dynamics of consumer spending and credit usage, lenders can devise dynamic strategies better suited to evolving market conditions while enhancing customer loyalty.

Have NPAs in the credit card segment risen in the last ten months?

Credit performance showed a mixed picture with balance-level delinquencies improving for secured loans but deteriorating y-o-y for credit cards. Balance-level delinquencies (measured as 90 days or more past due) on credit cards stood at 2 per cent in the December 2024 quarter a year-on-year change of 31 basis points which is still range

Unsecured lending has moderated in the last couple of months. Is the moderation continuing? What led to the fall in growth?

Faced with current market dynamics, lenders seem to be taking a measured approach to risk management with a general cooling of origination volumes. In addition, it is likely that where they are granting non-consumption loans, these are typically for higher amounts. Loan origination (a measure of credit supply and in part a measure of credit demand) volumes are positive across all key retail loan products, except home loans and credit cards. However, the origination volume growth is lower on a year-on-year basis, indicating a cautious approach by lenders.

Have delinquency levels in unsecured lending risen in the last 10 months? Can you give us the quantum of increase in absolute numbers as well as in percentage terms?

Achieving the dual objectives of sustained credit growth while simultaneously, maintaining asset quality requires issued loans to be repaid on time to help minimise default risks and preserve financial stability. Balance-level serious delinquency (measured as 90 days or more past due) is around 1.89 per cent of overall retail outstanding as of December 2024. Overall, there has been an improvement of 22 bps from 2.12 per cent in Dec-23, indicating stabilising of delinquencies.

Credit performance for consumption loans has improved sequentially in Dec 2024 as compared to September 2024, even for high-risk consumers. Credit performance showed a mixed picture with balance-level delinquencies improving for secured loans but deteriorating y-o-y for credit cards. This could be because when faced with financial constraints, borrowers generally tend to prioritise payments on life-essential utilities such as home loans and vehicle

What are your observations on the new entrants to the credit market? What are their priorities?

tour. Conditions will shift from the North Pole to the South Pole. Completely different," said Sidhu

"Moreover, India's last Test series in England had started on August 4. This time, it is ending on August 2. The matches are in June and July. There will be grass and moisture and the air will be so heavy that the ball will gain ample movement. And then it will move more off the seam," Sidhu added.

The last time India toured England in 2021/2022 the series ended up 2-2.

Won't expose Varun ChakarvarthyThe wrist-spinner Varun Chakarvarthy has been going through a purple patch in his career. However, Sidhu predicts that there are issues in the Indian side especially when it comes to playing all-rounders in overseas conditions. Though he feels Chakarvarthy might add value he expected India not to expose him. "India's biggest problem is that in the middle order there are no all-rounders the way you see in white ball cricket. Is there a Ravindra Jadeja, or Hardik Pandya or Axar Patel? There is only Jadeja among these three and even he will be limited there. Will he take 4-5 wickets in an innings there? No. You will have to bring a mystery spinner with all of them, that is England's weakness. But India won't expose Varun Chakravarthy."

According to an ESPNcricinfo report, Marsh is expected to link up with the LSG squad on March 18 after missing Australia's Champions Trophy tournament. Marsh was one among four players that Australia lost to injuries before the campaign. The Aussie all-rounder was snapped up by LSG during the IPL 2025 Mega Auction last November for Rs 3.4 crores. While he will not bowl in the forthcoming event, Marsh has had a few run-ins with injuries during previous IPL seasons too. Having featured for the Delhi Capitals in the previous three seasons, Marsh suffered a hamstring injury early on in the 2024 season before making a return during the T20 World Cup. The 33-year-old has played for Sunrisers Hyderabad, Rising Pune Supergiants,



Pune Warriors and Deccan Chargers in the past.

Meanwhile, Marsh's compatriots, Test skipper Pat Cummins, Mitchell Starc and Josh Hazlewood are also expected to return to action through the IPL. The pace trio missed the recent Champions Trophy due to varying injuries. 

### Julian Alvarez's two-touch penalty: How Atletico lost to Real Madrid in the UEFA Champions League

Atletico Madrid were left to rue a bitter loss to city rivals Real Madrid in the UEFA Champions League despite a superb performance that saw them win the second leg 1-0 to square the tie 2-2 on aggregate. A review of the incident showed the forward touched the ball twice in one movement as he slipped while shooting.Although Atletico keeper Oblak saved Lucas Vazquez's spot-kick gave Atletico hope, Marcos Llorente

hit the bar for the hosts and Antonio Rudiger sent Real through in a tense finale. Atletico coach Simeone cast doubt on the decision."The referee said when Julian got to the penalty spot he touched the ball with his standing foot, but the ball did not move," he said. "I've never seen a penalty where they've called the VAR, but well, they would have seen that he touched it. I want to believe they saw he touched it. "Did you see him touching the ball twice? ### Rima Das on life after Village Rockstars: 'I didn't expect all my films to go for Oscars'



Rima Das thrives as a filmmaker when she's left to write, shoot, and edit her stories, out in the open, and mostly in her home state of Assam. But she attributes these USPs to her limitations, more than her skills. "I do most of my shoots outside because I work in natural light as I'm not a trained cinematographer," she tells SCREEN in an exclusive interview. Which is why when she was approached to direct a segment in the upcoming anthology, My Melbourne, she took the challenge head on. It's a commissioned project, in which she had to share the various hats that she dons in her independent films. It's also set in Melbourne, Australia, a land far removed from her home turf of Assam.

Her segment, Emma, also stars not a local actor, but an Australian. Like most of her critically acclaimed films, like Village Rockstars and Bulbul Can Sing, Emma is also a story of self-discovery. But the lens through which it's told is that of disability. Emma is an aspiring dancer, who is deaf and is also going blind. In this interview, Rima talks about being defined by her own creative 'disabilities,' surrendering to them like her protagonist, and discovering facets about herself that she was hitherto not in touch with.

Your filmography so far is populated by homegrown, independent films. How different was it to make a movie within the existing framework of an anthology? A commissioned project is like a game you're participating in. Unlike the self-produced films, you don't decide the rules of that game. But still, you need to play well. When you're in the game, you have to hit the ball. Sometimes, I make a film for three years, sometimes for a year. But this film was shot across only five days. If I'm doing my own film, I can go back and reshoot. But here, you can't really go back. So

somebody's gossip' The ongoing scandal involving South Korean star Kim Soo Hyun and the late actor Kim Sae Ron has not only sparked global attention, but has now involved Sae Ron's family, who are seeking justice for their late daughter. On March 13, her mother issued a statement explaining why the family was revealing the truth behind Sae Ron's past relationship with Soo Hyun. The update came through Gaerosaro Research Institute, the same outlet that first broke the news of their alleged romance. The statement comes on the heels of Sae Ron's aunt sharing multiple photographs of the two stars, claiming that Soo Hyun was romantically involved with Sae Ron when she was still a minor, just 15 years old. The family later released a love letter reportedly written by Soo Hyun to Sae Ron during his military service, along with postcards he allegedly sent her from Paris while drunk. Speaking to the YouTube channel, Sae Ron's mother explained the family's reason for coming forward now. "We are only trying to restore our lost daughter's image," she said. Sae Ron tragically passed away in February 2025 after years of struggling with harsh public backlash and career cancellation following her DUI incident in 2021.In a statement (via Koreaboo), her mother added, "The reason I am speaking about a child who has already left me is because I want to restore her honour, which was destroyed in a split second by articles full of lies. I am not trying to gain anything or sow discord. I only hope that her life will be remembered and treasured posthumously as an acknowledged actress. I don't want her to become someone's gossip, so please help me restore her name." Earlier, Dispatch's in-depth investigation revealed claims that Kim Soo Hyun's agency, Gold Medalist, pressured Sae Ron to pay for damages related to her DUI case. The outlet also confirmed that the Queen of Tears star had been romantically involved with Sae Ron for years, though the two chose to keep their relationship private and never spoke publicly about it. In another development, Kim Soo Hyun, once the highest-paid and most popular actor in the industry, is slowly seeing his

you realise to let go and prioritise. When the film comes out, the story is important. Maybe some shots are not beautiful. And some shots are not performed well. But finally, as a whole, the film should be there, the story should be there. You not only worked with an Australian cast and crew, but also collaborated with an Australian cinematographer. For someone who's used to filming her own stories, how liberating or challenging was it to let someone else crank the camera? I had a very good DoP, who is like-minded which is very important. I'm very intuitive and improvise a lot. So if my cinematographer doesn't align with me, it becomes very difficult. Sometimes, when I shoot my own films, I have some limitations. Because I'm not trained, I don't know certain things. I also feel tired sometimes. But when you have good equipment and a proper team, then you can just imagine and they can execute it for you. In My Melbourne, I explained what I wanted to my cinematographer and he got that. So it was enjoyable, in a different way.

You're a director, writer, producer, editor and cinematographer. Now that you have the goodwill and the resources, what are the roles you like to keep for yourself and what are the ones you'd like to outsource?

Mostly, I love to direct and write. I don't mind co-writing. If there are interesting ideas, we can develop them together. Editing, I don't know, because I feel filmmaking is all about editing later on. Time will tell that. Sometimes, when I'm doing everything alone, it does get lonely. There are advantages too. It's a lot of freedom because it's your vision at the end of the day. Seeing something through that you imagined, that's more magical and beautiful.

The four segments in My Melbourne touch upon sensitive issues like sexuality (Onir's Nandini), gender (Imtiaz Ali's Jules), and race (Kabir Khan's Sitara). You chose disability, and that too double disability. That's not something you've dabbled with in the past. Why did you zero in on it?

It's a sensitive issue, and also quite personal to Mitu Bhowmick (producer and director of Indian Film Festival of Melbourne). Her daughter is battling a similar issue. The double disability is exactly why I wanted to tell this story. When you watch the film, you already know she's deaf. But that she's going blind is the unseen part. As a filmmaker, that unseen part is more intriguing and exciting for me. How I can bring that unseen part to screen, that was my challenge. That's what I like to do actually. There are other films on disability and music, like Sound of Metal (2019) and CODA (2021). What is this inextricable link between deafness and a passion for music?

Normal people also have some kind of 'disabilities.' We also have dreams, we look for something, we search something. Music or any art form helps us get freedom, helps us survive, and helps us escape. To me, Emma felt like any person chasing her dream. She's curious, just like you are as a journalist, I am as a filmmaker. Just that our medium is different from hers. But we all do it primarily for ourselves, it's more internalized. Everything else – success, money, fame are external. In Emma, you use sound very ingeniously. The sound is drowned out not when she can't hear someone, but when she's not being listened to. Can you talk about that?It was more intuition, honestly. I generally don't think much. I just had an organic discussion with the sound designer back then. When I was making the film, I'd kept that bit open. I generally don't plan much. It just felt right in the moment.

Why did you decide to end the film when you did and where you did, Emma dancing to the voice within in the lap of nature?

When I was looking for location, the production person took me there. I saw the trees and felt, 'This is the one.' There's light, freedom, and nature, and that's what we want in life. Everything comes from that space. It just came from within. She has a hearing problem and is now losing her vision. So there's uncertainty. That space somehow told her there's still something to look forward to. It made her

Which story or stories are you chasing next?

I started Tora's Husband and Village Rockstars 2 just after the first lockdown, when a lot of people weren't working. But I didn't know I was going through an emotionally challenging phase because of whatever I lost during the time. It took me much longer to finish both the movies. Village Rockstars 2 took four years. I started feeling monotonous. At that time, I began developing different ideas. Because I'm really hungry to do different genres – folk horror, love stories, friendship stories, a couple of films in Mumbai. I want to make another children's film, but it's different from Village Rockstars. I'll probably explore a two-women story in Mumbai in June-July.

Your breakthrough film, Village Rockstars (2017), received a wide theatrical distribution, especially after it was announced as India's entry to the Oscars. Why do you feel your films after that haven't been treated similarly?

For that, I'm also responsible. Sometimes, I don't plan





Rajesh Khanna was one of the biggest superstars of his era, but towards the end of his life, his stardom declined. Kaka, as he was fondly known by his fans, could not cope with his dwindling fame, and so, he contemplated participating in the reality show Bigg Boss. Rajesh was approached to be a contestant on the show and

consider his decision later. In a recent chat, his alleged girlfriend Anita Advani recalled that period in his life, and said that she was in shock when Kaka expressed his willingness to be on the show. In a chat with Mid-day, she shared that she was there when he was offered Bigg Boss. "They were paying him a huge amount. # Shah Rukh Khan was in New York on 9/11 with son Aryan and wife Gauri, required special permission to leave country



The World Trade Centre attacks in 2001 changed the fabric of society. Those who were present in New York at the time were deeply affected by the tragedy as they witnessed the events closely. Bollywood star Shah Rukh Khan was one of them. In an old interview, conducted in 2010, Shah Rukh revealed that he was in New York during the 9/11 attacks and recalled that his wife Gauri Khan, son Aryan Khan and Karan Johar's mother, Hiroo Johar, were with him as well.

In a chat with DW News, Shah Rukh was asked about 9/11 as he was promoting his film My Name Is Khan, which dealt with growing Islamophobia in the West after the terror attack. Shah Rukh recalled that he was in New York at the time and said, "My director's mother (Hiroo), my wife (Gauri) and my little son (Aryan) and we were to do an interview for the launch of a film called Asoka. And the rest of the crew was supposed to fly off to Toronto four hours before us."

Shah Rukh recalled that Hiroo woke him up in shock and showed him the visuals of the attack. At first, he thought that the plane carrying the film crew had crashed. He said, "I was woken up... Karan's mother, Mrs Hiroo, she showed me the television and I thought it's the plane that our crew is taking, that's why she is showing that there has been an accident. There was press on floor below my room, waiting to do the interviews and I was like, 'What has happened?"

Shah Rukh said the he was stuck in New York for the next few days, as airlines were grounded. But, after a few days, he got special permission from the authorities and flew to Toronto with his family and Hiroo. "I was stuck there for 3-4 days with my family. Then, we kind of made our way out, went to Toronto and flew back because all the flights and everything was cancelled. So we asked for special permission and requested some people, and they kind of understood. Very kindly, they let the family go because the kids and mothers and everyone... so we got out of it. I think I was deeply affected by it, like everyone else was," he said. In the years after 9/11, Shah Rukh was detained thrice at different airports in the US. Once, when he was invited by Yale University to deliver an address, the actor reached three hours late because he was detained at the airport. "Whenever I start feeling too arrogant about myself, I always take a trip to America. The immigration guys kicked the star out of stardom," he said during his address at Yale, and hinted at the racial profiling being practiced at US air-

# After being rejected by Shark Tank India, Rajesh Kumar takes indirect dig at Anupam Mittal: 'You can get two people married, make money but...'

rajesh kumar anupam mittalRajesh Kumar seemed to take a subtle dig at Anupam Mittal after being rejected at Shark Tank India.Rajesh Kumar, who is best known for playing Rosesh in the sitcom Sarabhai vs Sarabhai, took a break from acting a few years ago and became a farmer. Rajesh made his comeback as an actor a couple of years ago, but in a recent interview, he opened up about his farming experience where he lost around Rs 2.5-3 crore. Rajesh said that he also applied to appear on Shark Tank India and was disappointed that he did not get to sit down for a discussion with the 'sharks' on the show.

Talking to Hindi Rush, Rajesh said that he failed in his farming business, where he was growing and selling organic vegetables, because he "could not raise funds at the right time." He said during his interactions with investors, he could not understand their jargon when they asked him about being "bootstrapped" or his "burn."

"Wherever I went, I spoke from my heart and that was the failure because these are corporate people, they want to see the numbers. I had numbers. I had kind of hit breakeven point but it started failing because of tech," he said before revealed that he lost Rs 2.5-3 crore in his business. Rajesh said that he lost the money because an app developer duped him. "People are making mediocre apps everywhere and I got trapped in that. Time is money and I lost six months because that man, that app developer, took us for a ride," he said. Rajesh had previously shared that he applied to appear on Shark Tank, but was rejected after clearing two rounds. It appeared that he was hinting at Anupam Mittal, who is the CEO of Shaadi.com, and is one of the 'sharks' on the show. Rajesh said that he wanted to speak about the hard labour that goes behind farming on the show. "When I went on Shark Tank, this is what I wanted to communicate. You aren't from some other planet, you have made a lot of money, you have the resources, please market this. You should help me because there are things that I lack. At least sit with me," he said.

Rajesh then said, "You can get two people married, and make money by becoming a pandit but how much have you invested yourself in their wedding? You are making those two people meet, but do you even know them? You don't." He added that there are many corporate houses and business people "who are sitting with loads of money" and if they spend even one percent on farming, the agriculture sector would transform. He said that actors also need to play their part and bring their "glamour" to this sector as that could help in turning things around. In an earlier chat with Siddharth Kannan, Rajesh said he was rejected by Shark Tank India.
