#### Begumpet Railway Station redevelopment nears completion

Hyderabad: The works related to redevelopment of the Begumpet Railway Station, being taken up as a part of the 'Naya Bharat Naya Station' initiative of Amrit Bharat Station Scheme (ABSS) of Railway Ministry, is underway at a brisk pace. As on date, about 90 per cent of the development work has been completed. This includes entry ramps and Foot over Bridge among others. #### PM Narendra Modi to visit Sri Lanka in April

Colombo: Prime Minister Narendra Modi will arrive in Sri Lanka early next month to finalise agreements reached during President Anura Kumara Dissanayake's visit to Delhi last year, a minister said on Saturday. Foreign Minister Vijitha Herath made the statement while responding to a question on budget allocation debate in the parliament here.

"We have maintained a close relationship with our neighbour India. Our first diplomatic visit was to India, where we reached several agreements on bilateral cooperation," Herath said. "Indian Prime Minister Narendra Modi will arrive here early April," he added.

Herath said that during PM Modi's visit, several new memoranda of understandings will be signed, in addition to the opening of the Sampur solar power station. In 2023, the state power entity Ceylon Electricity Board and India's NTPC agreed to build a 135 MW solar power plant in Sampur town of eastern Trincomalee district. Herath said the National People's Power (NPP) government's goodwill policy towards India has resulted in many benefits to the island nation, including several ongoing Indian projects. "We will remain neutral in our foreign policy without taking any sides while working to maintain national interest," Herath said. This will be PM Modi's fourth visit to the island nation since 2015.

## BRS party is now in mortuary: CM Revanth

Hyderabad, March 15 (NSS): Chief Minister A Revanth Reddy has stood by his comment regarding the Bharat Rashtra Samithi (BRS) party being in a state akin to a mortuary, asserting its accuracy and insisting that there is no issue with his statement. During a discussion on the motion of thanks following the Governor's address in the Assembly on Saturday, Revanth Reddy explained that his remarks about the mortuary were specifically directed at the BRS party and not intended as a slight against KCR. The Chief Minister expressed that he would never demean former Minister Chief Chandrashekar Rao and expressed his hope that KCR would live a long life and continue to be in the opposition.Revanth Reddy also mentioned that he has made 32 trips to Delhi over the past 15 months and would be willing to go there 300 times if necessary.He underscored the importance of the state government fostering a positive relationship with the central government, describing the Prime Minister as a figure akin to an elder brother for any



state.Revanth raised questions about the nature of politics involved in the matter and made it clear that, unlike BRS leaders, he had not solicited anyone in secret. 

Again in Siddipet, the BRS government waived Rs 96.62 crore from 2018 over a period of five years, the Congress government waived Rs 177.91 crore farm loans in Siddipet. Notorious for sponsoring cross-border terrorism over he decades, Pakistan is now itself struggling to rein in errorist groups. There has been an alarming surge in teror attacks on Pakistani soil in recent months, with the laffer Express hijacking in Balochistan being among the nost audacious. The security forces killed all the hijackers, who belonged to the proscribed Balochistan Liberaion Army, and rescued the majority of the train passeners, but the multi-agency operation is unlikely to deter separatists who are seeking independence for their minral-rich province. The brazen targeting of Army, police and intelligence personnel by militants is clearly aimed at indermining the authority of the Shehbaz Sharif-led government and the military establishment. Raising the bogie of the 'foreign hand', President Asif Ali Zardari has said hat the authorities are aware of the external support and unding being received by terrorists to inflict human and inancial losses on Pakistan. The allusion is to India and Afghanistan, two neighbours with which Islamabad's relaions are either in deep freeze or going from bad to worse At stake are Pakistan's ties with its all-weather ally, China Balochistan, bordering Iran and Afghanistan, figures rominently in the Chinese scheme of things. It accounts or a significant part of Beijing's \$65-billion investment in he China-Pakistan Economic Corridor, which falls under President Xi Jinping's Belt and Road initiative. Prioritising Chinese interests, Pakistan has failed to allay Baloch conerns about rampant exploitation of the province's reources. This has emboldened insurgents to target Chihese citizens and projects as well.Pakistan's Kashmir fixaion has blinded it to its own problems. If the beleaguered ation wants to be seen as a victim rather than a perperator of terrorism, it must reach out to aggrieved groups and stop blaming foreign players. Violence mars Holi celebrations in parts

of Uttar Pradesh, over a dozen injured

Lucknow, Holi celebrations in parts of Uttar Pradesh were marred by incidents of violence, resulting in injuries to over a dozen people and highlighting existing social tensions. Clashes erupted over forced application of colours, caste-based disputes, and drunken altercations, leading to arrests and heightened security measures.

In Mathura district, a confrontation between uppercaste men and Dalit residents in Bati village in Jait area of the district resulted in injuries to 8 to 10 people. Station House Officer of Jait Police station, Ashwini Kumar said, "Two men from an upper-caste community attempted to forcibly apply 'gulal' on people from Dalit community, leading to tensions and minor skirmishes. Eight people were injured and nine individuals have been arrested. Further investigation is underway.

In Farrukhabad district, six people, including a woman were injured after miscreants allegedly opened fire on Dalit people heading to perform Holi rituals. Additional Superintendent of Police Dr Sanjay Kumar told PTI on Saturday, citing the report filed, that Jitendra and Pappu came to Anil Kumar's house in Bibipur village in Kamalganj area on Friday and started abusing him. "Later in the evening when Anil's family members were going to perform Holi rituals, Shivam Katiyar, Som Katiyar, Jitendra and Pappu open fired," the officer said. He said the injured have been admitted to a hospital and the accused have been arrested. A case has been lodged under relevant sections. In Kaushambi district, two sons of a local Nagar Panchayat chairman al-



legedly assaulted a sub-inspector and tore his uniform in an inebriated state. Circle Officer of the area, Awdhesh Kumar said, "The incident occurred following an altercation between sub-inspector Anand Swarup Prajapati, Satyendra Kushwaha and Abhishek Kushwaha.

The two accused have been arrested and investigation in the matter is underway, the CO said. In Sant Kabir Nagar district, several huts were burned to ashes in Kari village following a dispute over music played during Holi

Additional Superintendent of Police said, "A clash erupted after a group demanded a change in the music, leading to a fire that consumed multiple huts.""Four people were injured, and police have registered a case against the accused, though no arrests have been made so far," he said. ### Congress will get justice for Telangana in Krishna water sharing: Uttam



Hyderabad, March 15 (NSS): Minister for Irrigation and Civil Supplies N. Uttam Kumar Reddy reaffirmed the Congress government's commitment to protecting the state's rightful share of Krishna River water, exposing the previous BRS government's failures in securing Telangana's interests. Intervening during the debate on the Motion of Thanks on the Governor's Address in the Assembly on Saturday, he accused the BRS regime of surrendering Telangana's water rights to Andhra Pradesh and allowing illegal withdrawals to continue unchecked. The Minister pointed out that the allocation of Krishna River water remains unjust, with Andhra Pradesh receiving 512 TMC while Telangana gets only 299 TMC, despite the latter's larger catchment area, drought-prone regions, and agricultural needs. He criticised the previous BRS government for not contesting this unfair division and revealed how the previous administration's inaction led to Telangana's loss.

Uttam Kumar Reddy blamed the previous BRS regime for enabling Andhra Pradesh to float tenders for the Rayalaseema Lift Irrigation Scheme (RLIS) by delaying the Apex Council meeting, which could have challenged the project. Similarly, he asked under whose regime, Andhra Pradesh increased its irrigation capacities "The BRS government failed to take legal or political action, allowing AP to continue excessive withdrawals," he said. The Minister said the Congress government is now taking corrective measures, including the installation of telemetry instruments at Nagarjuna Sagar and Srisailam Dams to monitor water levels and prevent unauthorised diversions by Andhra Pradesh. Uttam Kumar Reddy said he remained deeply committed to protecting Telangana's water rights. "Unlike the previous government, we have reopened the Krishna water dispute and will fight to secure justice for Telangana,"

### Kishan Reddy visits Begumpet Rly station, reviews phase-I redevelopment works

Hyderabad, March 15 (NSS): Union Minister for Coal and Mines G. Kishan Reddy inspected the Phase-I works of Begumpet Amrit Station redevelopment works including the new station building with improved façade, platform surface improvements, 12 M wide Foot Over Bridge, escalators, lifts, booking counters, signages, waiting hall and so on. Addressing media personnel at the station later, the Union Minister stated that under the leadership of Prime Minister Narendra Modi, Rail development in Telangana State is undergoing a fundamental change. He informed that 90% of the Begumpet Station redevelopment works have been completed and the station will soon be dedicated to the Nation. He stated that the station is being upgraded on par with airport like standards with an expenditure of Rs 38 crore in a phased manner. The new Begumpet Amrit Station will be entirely run by All Women Staff, he said.

He also informed that Telangana State has been given a Railway budget allocation of Rs 5,337 crore for the financial year 2025-26. He stated that an amount of Rs 39,300 crore is being invested for various Railway projects in the State, including electrification of new lines, doubling, tripling and so on. He informed that the Railway network of Telangana is now 100% electrified. The Union Minister in-



formed that 'KAVACH' Research Institute will soon be set up at Secunderabad. He stated the indigenously developed Kavach technology will be installed across the Nation's network. He stated that 40 Railway stations in Telangana are being redeveloped under ABSS and the works are progressing swiftly. Earlier, SCR General Manager Arun Kumar Jain briefed the media on progress of work and salient features of the Begumpet Amrit station project. He stated that the Begumpet Railway station is being developed as ecofriendly green Railway station. It will be equipped with water recycling plant to cater the needs of greenery at the station.

#### Uttam secures major victory for Telangana as EAC blocks clearance for RLIS

Hyderabad, March 15 (NSS): Minister for Irrigation and Civil Supplies N Uttam Kumar Reddy has achieved a major victory for Telangana by convincing the Expert Appraisal Committee (EAC) of the Ministry of Environment, Forest, and Climate Change (MoEF&CC) to recommend blocking environmental clearance (EC) for the Rayalaseema Lift Irrigation Scheme (RLIS) of Andhra Pradesh. The Telangana government has been continuously putting efforts at every level and every forum to halt RLIS, making strong representations at the National Green Tribunal (NGT), MoEF&CC, the Supreme Court, Krishna River Management Board (KRMB), and KWDT-II. Uttam Kumar Reddy has been at the forefront of this battle, personally taking up the issue with the Union Environment Minister, warning that Andhra Pradesh's unilateral execution of RLIS would severely impact Telangana's rightful share of Krishna River water. In a significant development, the EAC, in its 25th meeting on February 27, ruled that Andhra Pradesh must restore the RLIS site to its pre-construction stage before applying for environmental clearance.

The committee, while reviewing a case related to RLIS and its compliance with an NGT order, concluded that Andhra Pradesh had violated environmental norms and must roll back all work beyond the initial planning stage before proceeding further. The ruling emphasised that Andhra Pradesh must submit an affidavit confirming that no construction had been carried out beyond the preparation of the Detailed Project Report (DPR) and provide photographic evidence, restoration details, and a timeline of corrective actions. The committee warned that any false or misleading information would invite legal action under the Water (Prevention and Control of Pollution) Act, 1974, and



the Environment (Protection) Act, 1986. The Telangana team, led by Uttam Kumar Reddy, has been unwavering in its opposition to RLIS, citing violation of environmental laws and inter-state water sharing norms. Telangana has consistently argued that RLIS is an illegal project that diverts Krishna waters without approval from the Krishna River Management Board (KRMB) or the Apex Council. The latest EAC ruling has been hailed as a crucial legal and environmental victory for Telangana, as it reinforces the state's position that RLIS is an illegal project that cannot be allowed

This decision is expected to bring major relief to thousands of farmers, particularly in the drought-prone Krishna basin region, who feared that RLIS would severely impact water availability for irrigation. "Telangana will continue its determined legal and policy battle to safeguard its rightful share of Krishna River water and prevent unauthorised projects that could threaten its water security," Uttam Kumar Reddy said. President Droupadi Murmu has given her approval for the registration of an FIR against AAP leaders Manish Sisodia and Satyendar Jain in an alleged scam of Rs 1,300 crore in the construction of classrooms in Delhi government schools, sources said. In 2022, the Delhi government's vigilance directorate recommended a probe into the alleged scam and submitted a report to the chief secretary.

The President has given her approval for registering the FIR against Sisodia and Jain in connection with the alleged scam during their tenure as ministers in the Arvind Kejriwal-led Delhi government, the sources said. The Central Vigilance Commission (CVC), in a report dated February 17, 2020, highlighted "glaring irregularities" in the construction of over 2,400 classrooms in Delhi government schools by the Public Works Department (PWD).

#### Sajad Lone flays J&K reservation policy; says it is a tool to disempower Kashmirispeaking ethnic group

J&K People's Conference (JKPC) chief and MLA Sajad Lone on Thursday (March 13, 2025) said the current reservation policy was being used as a tool "to exclude Kashmirispeaking population from power structure and reorder the social supremacy" in the Union Territory (UT). Speaking in the J&K Assembly, Mr. Lone, who is an MLA from Handwara, said, "Attempts are being made to change the social supremacy by disempowerment. It looks like reordering through the current reservation policy. After 20 years, very few Kashmiri-speaking people will be seen in the Secretariat of J&K."Referring to the Kashmiri-speaking population, comprising Muslims and Hindus, as a "distinct ethnic group", Mr. Lone highlighted the figures that show lower representation of the Kashmiri-speaking population in competitive examinations like J&K Administrative Services (JKAS) in recent years.

"Each passing day, Kashmiri-speaking candidates figure less in the results of competitive examinations. This is not because they are incompetent but because the space was being squeezed. They are being crowded out from the competitive space by virtue of system of reservation, which is totally rigged against them by the current 60% reservation policy," Mr. Lone said. Figures suggest that the Kashmirispeaking population who qualified for the JKAS examination was 19% in 2023, 25% in 2022 and 21% in 2021. "An internal survey needs to be carried out to check the net loss to Kashmiri-speaking population if this reservation policy did not exist in J&K," Mr. Lone said. The Centre reworked the reservation policy in J&K in the past five years, which grants 20% reservation to Scheduled Tribes (ST), 8% to Scheduled Castes (SC), 10% to Reserved Backward Areas, 8% to Other Backward Classes, 4% to Local Area Candidates/Integrated Borders, 10% to Economically Weaker Section and 10% to children of defence personnel, sports, CDP, PWD etc. The policy pushes open merit to around 40% in admissions and jobs in J&K.

Urging the elected government to rationalise the current reservation policy, Mr. Lone said, "Kashmir region has no SC population. In the Kashmir region, ST population is 40% and in the Jammu region, it is 60%. ST living in the Jammu region are comparatively marginalised and scattered unlike Kashmir region where entire constituencies belong to the ST communities. ST communities should be allowed to compete more within the Jammu region."He said Kashmir being a conflict State should ideally see special measures but "reverse is happening". "For 30 years, discourse from Delhi was 'teach them a lesson' and 'show them this place'. This is a post-dated cheque for disaster. The last 30 years Kashmir region has seen turmoil and violence. Overall mental makeup has gone through a lot. That script was written by enemies and this script is written by us," the JKPC chief said. He said those bureaucrats who drafted the reservation policy will leave J&K "but we will face a social disorder". "If you are going to push merit to the wall and not give them admission in colleges, it will cause disorder that our children will have to face. It is something generational," Mr. Lone said.

### In 7 decades, agriculture's share in Himachal's GSDP falls from 70% to 14%: Economic Survey

Himachal Pradesh's economy, once primarily dependent on agriculture, has undergone a significant transformation over the last seven decades, with a marked shift towards the service and manufacturing sectors in terms of their contribution to the Gross State Domestic Product (GSDP). The agriculture sector's share of the GSDP has declined from 70.37 percent in the financial year (FY) 1950-51 to merely 14.74 percent in FY 2023-24. However, the Economic Survey 2024-25, released on Thursday, highlights that despite this decline, 53.98 percent of the state's population remains engaged in the primary sector for employment. Agriculture, horticulture, and tourism form the backbone of this sector, with agriculture continuing to employ a large portion of the workforce and playing a crucial role in the state's economy.

According to the survey report, "Himachal Pradesh has witnessed a shift from agriculture to industries and services, as the percentage contribution of agriculture to the total GSDP declined from 70.37 per cent in 1950-51 to 35.06 per cent in 1990-91, 17.16 per cent in 2011-12, and 14.74 per cent in FY 2023-24. The share of the secondary and tertiary sectors, which stood at 7.41 per cent and 22.22 per cent, respectively, in 1950-51, increased to 26.50 per cent and 38.44 per cent in 1990-91, 43.81 per cent and 39.03 percent in 2011-12, and 39.98 percent and 45.28 percent in FY 2023-24." The tertiary sector, or service sector, includes activities such as trade, hotels and restaurants, transport, storage, communication, banking, real estate, and professional services, contributing significantly to the state's Gross State Value Added (GSVA). The secondary sector comprises industries such as textiles, food processing, and

Rishiraj Pathania, a retired officer from the state agriculture department, said, "There are multiple ways to interpret this shift from the primary sector to the secondary and tertiary sectors. While it is true that many people have moved



from agriculture to modern jobs and industries, several professions remain closely tied to the primary sector, particularly agriculture and rural life. For instance, food processing though categorized under the secondary sector — is deeply linked to agriculture, especially in rural areas of Himachal Pradesh and other hilly states like Uttarakhand."The report further states, "The declining share of agriculture does not diminish its importance to the state's economy, as growth in the primary sector is still influenced by trends in agriculture and horticulture production. Agriculture remains a key contributor to the total domestic product and has a cascading effect on other sectors through input linkages, employment, trade, and transportation. Due to inadequate irrigation facilities, agricultural production continues to depend heavily on timely rainfall and favourable weather conditions." A senior officer from the finance department, requesting anonymity, said, "This shifting trend has multiple implications. First, the younger generation is increasingly uninterested in agriculture as a profession. Second, despite a large share of the population being engaged in agriculture and horticulture, incomes from these sources may be insufficient. This is why subsidies, special schemes, and new technologies are being introduced to support and promote agriculture in the state.

### Bengaluru paying the price for scrapping steel flyover project, says Dy CM Shivakumar

Karnataka Deputy Chief Minister D K Shivakumar said on Thursday that Bengaluru was now paying the price of traffic congestion for scrapping the steel bridge project, which had drawn objections over environmental concerns as well as corruption allegations. Shivakumar, who is also the Bengaluru development minister, was responding to a question raised in the Legislative Council by MLC Sudham Das on the steps taken to ease traffic in Bengaluru.

"When K J George was the Bengaluru development minister, he planned a steel bridge on Bellary Road, but there was severe opposition. We are paying a price today for not executing that project," he said, adding that as a result, the government was now exploring alternative solutions like tunnel roads, elevated corridors, and double-decker flyovers to tackle the congestion problem in the city.He added, "We have now planned two tunnel roads-a 17-km stretch from East to West and a 23- km stretch from North to South. We will be calling for tenders for the first phase

The controversial steel flyover project was aimed at easing traffic congestion on Bellary Road (NH 44), connecting Chalukya Circle to Hebbal. The Rs 1,791-crore project was a 6.9 km six-lane elevated corridor that was aimed at providing a traffic signal-free corridor. However, the project was met with severe criticism from activists and residents over environmental concerns, in view of the chopping of 800 trees the project would have necessitated. The project was scrapped following massive protests and the BJP's allegations of corruption. Soon after coming to power in 2023, Shivakumar had said he would not buckle under pressure from residents' groups and activists like before, in an apparent jibe at Chief Minister Siddaramaiah."I have taken up the responsibility of Bengaluru seriously. Bengaluru is not a planned city like New Delhi. Only areas like Jayanagara,



Indiranagara, and Malleshwara are planned layouts. The PRR project would have reduced traffic woes of the city to a large extent, but it was not executed," he said in the Council on Thursday. "PRR (Peripheral Ring Road) would have cost Rs 3,000-4,000 crore if it was executed then, but today it costs Rs 26,000 crore. We are going to execute PRR by taking a loan from Hudco," he said. "We are planning to build double-decker flyovers wherever the new metro lines are coming up. The BBMP and BMRCL will bear the cost equally. It costs Rs 120 crore to build one kilometre of a double-decker flyover. We have given a grant of Rs 9,000 crore for this project.

We are also planning to build 300 km of 50-ft wide buffer roads along the storm-water drains to ease traffic as well. Rs 3,000 crore has been earmarked for this. We are also planning to build roads by issuing TDRs. A notification has been issued for the 7.8 km road from Hebbal to Hennur. A total of 320 km of new roads are being built in Bengaluru." Shivakumar explained. "We have allocated Rs 9,000 crore for white-topping of 1,682 km of roads. We have taken a loan of Rs 2,000 crore from the World Bank to build 850km-long storm-water drains. Of the 850 km, a 480-km

### Tamil Nadu should implement 14-language formula

I like to give lectures, especially to people who have no interest in my opinions. I can afford to do so because I have connections, I have influence, and I know how to use ChatGPT. I am also very humble. For all these reasons, I want Tamil Nadu politicians to follow my advice on how many languages they should teach in their government schools. I speak two languages (both of them softly). They are Hindi and English. It is true I don't know Tamil. But I love Tamil. Tamil culture is amazing, just like Hindi culture. Brilliant guy, your Thiruvalluvar. So here is my humble submission: junk your 2-language formula. Be more ambitious. Think bigger.

As I have explained in many wonderful videos on my social media channel (do subscribe, if you haven't already), children have an unlimited capacity to learn several different languages simultaneously. Therefore, restricting them to two languages is a terrible idea. True, a 3-language formula is not much of an improvement over a 2-language formula. According to a new paper published in the Harvard-Cambridge Journal of Advanced Mathematics, it turns out that 'three', numerically speaking, is only one more than two.In other words, a 3-language formula would force children to learn only one language more than a 2-language formula would. This is a travesty in a country renowned for its linguistic diversity and lack of public investment in education. Ideally, the poorer a country, and the worse the condition of its government schools, the greater should be the

number of languages forced down the throats of school children. And given the recent changes in our economy, Tamil Nadu's language policy needs to be upgraded — from a 2-language to a 14-language formula. Why 14? I say 14 because that's the number of years of mandated schooling (if you include LKG and UKG). An average adult can easily learn a brand new language in six months. Since we're dealing with children, let's go easy, and double the time required to 12 months. So, a child can start by learning one language in LKG, a second language in UKG, a third language in Class I, and so on until she would have learned 14 languages by

### 2 Delhi airport employees steal \$2,500 from US citizen, arrested

The Delhi Police have arrested two employees of the Delhi Airport for stealing \$2,500 from a passenger's bag. The accused, identified as Gaurav Kumar, 38, and Prakash Chand, 59, work in the Lost and Found department at the Indira Gandhi International (IGI) Airport. A case was registered under Bharatiya Nyaya Sanhita (BNS) Section 303(2) (theft) after a complaint was filed by the passenger, Roshan Patel, a US citizen and Overseas Citizen of India (OCI)

Patel had arrived in Delhi from the United States on September 11, 2024, and realised that her green camouflage bag, containing \$2,500 and other personal belongings, was missing. The bag was later recovered and deposited at the Lost & Found department by Central Industrial Security Force (CISF) personnel, but upon retrieval, the cash was found missing, said the police on Thursday. A police team meticulously analysed CCTV footage from various cameras at the airport. The footage confirmed that the bag was not tampered with at the terminal, compelling the police to shift the focus of the investigation to the Lost and Found department staff. After thorough interrogation of the department staff, suspicion eventually fell on Kumar and Chand, who initially denied their involvement but later confessed when confronted with CCTV evidence showing them tampering with the bag inside the Lost and Found office, added the police. During questioning, Kumar allegedly revealed the details of the theft. "On 12th September, 2024, a CISF staff member deposited the alleged bag in their office. While he (Gaurav Kumar) was handing the bag over to Prakash Chand in the T-2 LP room, he discovered \$2,500 inside the bag. Overcome with greed, he suggested to Prakash that they could keep the money and divide it between them. To which, Prakash agreed, and they each took \$1,250. The accused Gaurav also revealed that he had deleted the entry of the \$2,500 from the system, with Prakash's complicity. Later, they exchanged the stolen currency at a money exchange office in Connaught Place, Delhi, and equally distributed it between them," said Usha Rangnani, Additional Commissioner of Police (IGI Airport). Both the accused have been sent to judicial custody.

#### Madras High Court restricts number of tourist vehicles to the Nilgiris, Kodaikanal

The Madras High Court on Thursday (March 13, 2025) fixed a cap of 6,000 tourist vehicles a day during weekdays and 8,000 vehicles during weekends to the Nilgiris and 4,000 vehicles a day during weekdays and 6,000 during weekends to Kodaikanal during the summer season between April and June this year.

A special Division Bench of Justices N. Sathish Kumar and D. Bharatha Chakravarthy made it clear the cap would not apply to the tourists who visit the hill stations using public transport such as government buses and trains and also to the vehicles of local residents and those which transport essential commodities. The orders were passed after taking note that only 23,000 tourists could be accommodated in a day (at the 1,035 commercial accommodations with 5,620 rooms apart from 575 licensed homestays) in the Nilgiris and only a much smaller number of tourists could be accommodated in Kodaikanal.

The Bench also ordered that the tourists visiting the hill stations in e-vehicles should be given preference in issuance of e-pass and directed the local bodies concerned to take steps for establishment of enough number of electric charging points at vantage locations for the benefit of the e-vehicle users. The judges requested Advocate General P.S. Raman to persuade the State government to deploy mini e-buses with transparent bodies to encourage the tourists to park their private motor vehicles on the foothills and undertake the tour to the hill stations in those buses.

The Bench said, ideally, it should become a norm in the future in order to promote quality tourism. They expressed serious concern over the ghat roads being flooded with motor vehicles especially during the tourist season thereby causing great harm to the environment and hardship to local residents. The judges said, even the tourists do not get to enjoy their travel because of being stuck in the traffic jam for hours together. Most of them end up entering reserve forest areas even during night hours and sleep in their cars or in the open leading to man-animal conflict and commission of forest offences, they lamented. Taking note of submissions made by amici curiae Chevanan Mohan, Rahul Balaji and M. Santhanaraman regarding the need to impose a strict ban on plastics in the hill stations, the judges directed the authorities concerned to keep a vigil and ensure provision of adequate drinking water dispensers for the benefit of tourists. The court also stressed upon installation of sufficient number of temporary toilets across the two hill stations during the ensuring tourist season and implementing effective solid waste management system. The judges said, the pristine nature of the hills should not be allowed to be disturbed by unregulated tourist activity.

### **RSS-BJP** workers illegally detain Tushar Gandhi

A group of Rashtriya Swayamsevak Sangh (RSS) and Bharatiya Janata Party (BJP) activists allegedly illegally detained Tushar Gandhi, the great-grandson of Mahatma Gandhi, near Neyyattinkara, in the outskirts of Thiruvananthapuram on Wednesday evening, causing public outcry and politically non-partisan protests from both the ruling front and the Opposition. The protesters were reportedly irked by Mr. Gandhi, who was in Kerala at the invitation of the Sivagiri Madhom, terming the RSS a cancer on the nation's soul in a speech commemorating the 100th anniversary of Sree Narayana Guru's historic meeting with Mahatma Gandhi at the Madhom. Mr. Gandhi was later in Neyyattinkara to unveil the statue of late Gandhian P. Gopinathan Nair at the latter's ancestral home. After the function, the RSS activists besieged Mr. Gandhi when he entered the vehicle. The protesters gheraoed Mr. Gandhi and demanded that he retract his speech condemning the RSS at the Sivagiri Madhom.

Mr. Gandhi stepped out of the vehicle, confronted the protesters, and was seemingly unrepentant. He shouted, "RSS murdabad and Gandhiji zindabad" back at the RSS activists. There was no noticeable police presence at the scene. Mr. Gandhi left the area after clarifying his political stance. When contacted, the Neyyattinkara police stated



they had received no reports regarding the incident. When contacted, the Sivagiri Madhom said it would react to the development on Thursday. Meanwhile, the Leader of the Opposition V.D. Satheesan condemned the RSS's action. He said Mr. Gandhi had arrived in Kerala to commemorate the 100th anniversary of Mahatma Gandhi's historic meeting with Sree Narayana Guru at the Madhom. "The RSS has put Kerala to shame and revealed their true colours as a revanchist force," he said. Communist Party of India (CPI) State secretary Binoy Viswam said the RSS's contempt for Mahatma Gandhi and the Independence Movement and the organisation's support for the feudal colonial set-up was evident in their act against Mr. Gandhi.

### In Mauritius, Modi calls for 'free, open, safe' Indian Ocean

Prime Minister Narendra Modi on Wednesday said a "free, open, secure, and safe" Indian Ocean was a common priority for both India and Mauritius.Mr. Modi, who is on a two-day state visit to the island nation, said this while delivering a speech alongside Mauritian Prime Minister Navinchandra Ramgoolam. He conveyed India's unambiguous support for the sovereignty of Mauritius over the Chagos archipelago. "In the next five years, five hundred civil servants of Mauritius will be trained in India. We have reached an agreement for settlement of mutual trade in local currency. The Prime Minister and I agree that defence cooperation and maritime security are key pillars of our strategic partnership. Free, open, secure, and safe Indian Ocean is our common priority...In this regard, we will extend every possible assistance to meet the needs of the Coast Guard, Mr. Modi said after the conclusion of bilateral talks. "We fully respect the sovereignty of Mauritius with regard to Chagos," he said.Mr. Modi assured that India would extend all possible help in the establishment of the Police Academy and the National Maritime Information Sharing Centre in Mauritius. He said that India would advance the position of Mauritius over the Chagos dispute through the Colombo Security Conclave, the Indian Ocean Rim Association, and the Indian Ocean Conference."We are fully committed to ensure protection of the Exclusive Economic Zone of Mauritius," he said.

The Exclusive Economic Zone of Mauritius gained prominence during the U.K.-Mauritius negotiations over the Chagos archipelago. The two countries had reached an agreement on October 3, 2024, under which the U.K. would

give up sovereignty over Chagos but maintain a lease over the joint U.K.-U.S. military base on Diego Garcia, the largest island, for 99 years. The deal was signed under previous Mauritian Prime Minister Pravind Jugnauth, but the current Prime Minister has been critical of it. Prior to the commencement of Mr. Modi's visit, Foreign Secretary Vikram Misri had reiterated India's support for Mauritius's claim over the Chagos archipelago. Affirming India-Mauritius cultural ties, Mr. Modi said travellers from Mauritius would receive assistance for the Char Dham Yatra (pilgrimage to four holy spots in India) and the Ramayana Trail. He announced that new development projects worth Mauritian rupee 500 million would be launched under bilateral partnership. The two sides also sealed eight memoranda of understanding, including one that will allow settlement of trade issues through local currencies.

Mr. Modi was earlier conferred the highest honour of the country, the Grand Commander of the Order of the Star and Key of the Indian Ocean. Following the meeting, Mr. Misri said the objective of the agreement on national currencies was to "promote the use of local currencies for current account as well as capital account transactions, encourage direct exchange rate quotations, encourage the setting up of an Indian rupee clearing centre in Mauritius, and extend an Indian rupee clearing centre to COMESA (Common Market for Eastern and Southern Africa) countries. The idea is to provide avenues for enhancing trade, tourism, other kinds of business activities between the two countries."

Mr. Misri said the Reserve Bank of India and the Bank of Mauritius would have to implement the agreement and "put in place the last mile systems and procedures to actually start benefiting from the agreement". The two teams also signed seven other agreements, including one between the Enforcement Directorate and the Financial Crimes Commission of the Republic of Mauritius. Mr. Misri said the agreement on sharing of white shipping information would lead to "greater maritime domain awareness" of the authorities in Mauritius. "The agreement that has been exchanged today on sharing of white shipping information between the Indian Navy and the government of Mauritius will essentially enhance Mauritius' maritime security. Its safety of its trade will lead to real-time sharing of data, preventing illegal activities," he said in response to questions from the media.

#### Former CJI Ranjan Gogoi criticises Bill on simultaneous elections

Former Chief Justice of India and Rajya Sabha member Ranjan Gogoi, in a three-hour deliberation with the Parliament's Joint Committee reviewing the Bill on simultaneous elections, on Tuesday (March 11, 2025) pointed out loopholes in the Bill. He cautioned that it will not be advisable to give the Election Commission (EC) unrestricted powers to decide the schedule, according to informed sources. The Parliamentary Joint Committee headed by BJP MP P.P. Chaudhary is reviewing the Constitution (One Hundred and Twenty-Ninth Amendment) Bill, 2024, which was introduced in the Lok Sabha on December 17, 2024. The Bill seeks to empower the Election Commission to conduct simultaneous elections for the Lok Sabha and all State Assemblies. According to the sources, DMK Rajya Sabha member P. Wilson pointed out that Section 82 A(5) of the new Bill states that "if the EC is of the opinion that the elections to any Assembly cannot be conducted along with the general election to the House of the People, it may make a recommendation to the President, to declare by an order, that the election to that Legislative Assembly may be conducted at a later date." By not specifying a deadline for the Election Commission, isn't the legislation giving it "arbitrary and unregulated powers". Justice Gogoi, it is learnt, accepted the argument and said it would not be advisable and the Section needed to be suitably amended to plug the loophole and was not legally tenable. The EC, he said, could not be given unchecked powers to decide to prolong or curtail a State Assembly's tenure. During the deliberations, Congress MP Manish Tewari also pointed out the example of 1991 general elections, when the outgoing Prime Minister



Chandra Shekhar, citing the law and order situation in Punjab, withheld the general elections in the State. The Lok Sabha seats of Punjab went for polls along with the Assembly in 1992. The Election Commission, unlike the Central government, does not have machinery to help it take such decisions, Mr. Tewari, according to sources, said. In the last meeting, former Chief Justice of India U.U. Lalit had also pointed out several infirmities with the Bill and argued that it could not withstand a legal challenge.

Meanwhile, the panel has decided to launch a website to get the views from the general public on the Bill. This move comes after the Opposition questioned the submission by the high-level committee headed by former President Ram Nath Kovind that 80% of response that it received on the Bill was in favour of simultaneous elections. The parliamentary panel has asked the Kovind committee to submit all the responses.

### Parliamentary panel recommends hike in wage rates under MGNREGA

Parliamentary Panel on Rural Development headed by Congress MP Saptagiri Sankar Ulaka in its report reviewing the budgetary allocation of Department of Rural Development on Wednesday (March 12, 2025), strongly argued for revision of wages and uniform rates across the country under the Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) in view of the rising cost of living. The per day wages currently vary from ?234 in Nagaland and Arunachal to ?374 in Haryana and Sikkim. The panel expressed disappointment that despite its multiple recommendations on this matter over the years, the government has not implemented any significant changes.

The wages currently are linked to the Consumer Price Index For Agricultural Labourers. This index, the panel said, "may not accurately reflect" the inflation trends. "The Committee believes that this index does not fully capture the real impact of inflation, and therefore, the method of wage calculation must be reviewed and updated on a priority basis to reflect actual economic conditions at the ground level," the panel report said. The panel has also urged the government to implement a "uniform wage rate" across all state and union territories, since the scheme is primarily funded by the central government. "This would help ensure fairness and consistency in wage payments under the Scheme," the panel said.

The panel also criticized the government for delay in disbursement of wages. As per the report, till February 15 this year, the pending liabilities in wages stand at 12,219.18

crore and 11,227.09 crore in material components and total pending liabilities are 23,446.27 crore. The panel report pointed out that one fourth of the allocated funds (86,000 crore) will go in clearing the last financial year's due. "Consequently, the actual working budget for the current financial year is reduced to 62,553.73 crore, significantly limiting the scheme's capacity to function effectively and meet its primary objective of preventing rural distress and ensuring livelihood security," the report said.

## Kunal Kamra vs Zomato yet again: Comedian slams company's post on delivery agents

Hyderabad: Comedian Kunal Kamra is at it again! Slamming food delivery app Zomato, yet again, the comedian has shared a post on his X account. This time, Kamra slammed Zomato's post on X, in which the company said: "Some people skip giving ratings to delivery partners, the same people get upset when their work does not get recognition." Wasting no time in responding, the comedian replied to Zomato's post, saying "Someone people skip giving minimum wage and social security same people get upset when they are sent to prison. (sic)"

His comments have once again ignited discussion on gig worker wages, with people quickly taking sides even as some came in support of the comedian, some criticised his views on the matter. The latest post from Kamra comes months after he slammed Zomato CEO Deepinder Goyal over his post on achieving the Guinness world record by setting up a session for first aid lessons with over 4300 delivery partners. Criticising the CEO's post, Kamra had posed a challenge to him asking if he could declare the number of delivery partners with Zomato has and what their average income was." Can you declare the no of delivery partners you have with their average income & working hours over the last 3 months? No you can't But you can tell kgs of biryani ordered in one day. You're such a hack bro... (sic)" Kamra had said.

#### India's AI needs an Isro-like push



If one looks at the biggest tech companies in the world in the top 50 list, one could find many well-known names such as Apple, Microsoft and Google — American companies — as well as Asian tech giants like Tencent, TSMC and Alibaba. In the game of Big Tech competition, two continents are very well represented — North America and Asia. Interestingly, it is difficult to find any European companies in the top 10. In fact, in the top 50 list, shockingly, there are only a few European tech companies. This has not always been the case.

Historically, there have been European tech giants like the Finnish company Nokia, which was the largest maker of cell phones from 1998 to 2012. But today Europe's top tech companies — SAP, Accenture, ASML, Schneider Electric and Dassault — struggle to reach a combined market cap of \$700 billion, falling significantly short of their American and Chinese counterparts. The disparity in market capitalisation is a clear indicator of the difference in the scale and impact of tech companies hailing from these regions. Apart from that, while the US and China are competing intensely in chip manufacturing, 5G technology, electronics, and, of course, artificial intelligence, Europe is nowhere to be seen. Even today in the AI race one could see the US leading with 73% of large language models developed domestically, driven by giants like OpenAI and Nvidia. China's state-Backed \$75 billion AI industry leverages military-civil fusion and low-cost models like DeepSeek-R1.

In this regard, the recent Paris AI Action Summit hosted by France represented its strategic bid to establish Europe as a 'third pole' in the global AI race, countering US and Chinese dominance through a mix of collaborative governance, ethical frameworks and sovereign AI initiatives. From a larger perspective, the summit aimed to address critical challenges in AI development and promote its use for public interest. It basically focused on issues such as growing inequality between AI controllers and users, concentration of AI progress among a small group of private actors and the missed opportunities to solve key social problems due to fragmented public interest in AI initiatives

Thus, the Paris Al Action Summit presented an ambitious vision for harnessing Al's potential while addressing critical societal risks. However, its proposals invite significant debate, particularly around feasibility, equity and unintended consequences.

For instance, France announced euro 109 billion in Al investments to position Europe as a 'third pole', emphasising open-source models and sovereignty. But France's investment pledge pales against the \$500 billion US private-sector Al investments. In addition, private companies like

DeepSeek and OpenAl drive rapid advancements due to competitive pressures and capital access. Hence, public interest initiatives may lag without similar incentives and while Macron's 'third pole' aims to reduce dependency, sceptics warn Balkanised AI ecosystems could stifle interoperability and worsen geopolitical tensions. Furthermore, the summit talked about promoting "socially responsible AI" through labour observatories and anti-discrimination tools, aiming to balance productivity with worker well-being. But, on the sidelines of the summit, unions highlighted Al-driven job losses in public services. They also opposed metrics like "productivity gains" that often mask workforce reductions as postal workers cited AI tools like "Lucy" (a banking chatbot) are increasing surveillance and workload without improving outcomes, ultimately resulting in a tool of algorithmic exploitation. It is interesting to note that while the summit emphasised reskilling, no concrete funding mechanisms was discussed to address structural unemployment and skill gaps in sectors like manufacturing. Similarly, the summit aimed to combat disinformation and cyber risks while promoting ethical AI, but parallel discussions on defence Al highlighted contradictions which can cause military AI escalation because dual-use technologies could fuel autonomous weapons proliferation. This exemplifies that the summit's vision hinges on unprecedented global cooperation, yet faces scepticism due to power asymmetries, implementation gaps and unintended consequences that may prioritise corporate interests over societal needs.

Therefore, while the summit marked progress in acknowledging Al's risks, its success depends on translating rhetoric into actionable, equitable frameworks which still exists as a challenge yet to be met. Relying heavily on voluntary safety pledges from corporations and non-binding agreements among nations risks being ineffective against pressing challenges like disinformation, algorithmic bias and cybersecurity threats.

Though India's focus on responsible AI aligns with its democratic values, offering a counterpoint to China's authoritarian model successes is yet to be seen. India's Rs 10,300 crore IndiaAl Mission focuses on democratising Al access through Indigenous models (eg BharatGen), GPU infrastructure and datasets tailored to the Global South, but it must address structural challenges at home and push for more substantive outcomes at international forums to solidify its leadership role in the evolving Al landscape. Eric Schmidt, former Google CEO, during a talk at Stanford University, said India could be a potential swing state in the AI supremacy battle as it has a skilled Al workforce. Thus, the major challenge for the Indian establishment is to stop the flow of its critical resource ie, "skilled Al workforce" to Western countries. Because, what is happening today is a certain form of digital colonialism where skilled human resources of India are being used by other countries to create digital products which are being sold back to India again.

India must not miss this Al wave and build its own Big Al companies that may drive the next wave of innovation in the Indian tech ecosystem. AIRO, an artificial intelligence research organisation, can strengthen India's AI development capabilities, similar to how India created ISRO to streamline space technology development.India's active participation in the Paris AI Action Summit positions it as a key player in shaping global AI policies. By championing equitable access and localised solutions while strengthening its domestic capabilities in Al research and development, India has an opportunity to bridge the gap between developed and developing nations.

### History of the rupee symbol: how it came into existence?

The DMK-led Tamil Nadu government has decided to remove the official rupee symbol (?) from the state's Budget 2025, replacing it with the Tamil script. This marks the first time a state has rejected the national currency symbol, taking its resistance to the National Education Policy (NEP) to a new level. The rupee symbol '?' was designed by Udaya Kumar, the son of a former DMK MLA and currently an IIT professor. The M.K. Stalin government has replaced the rupee symbol with the Tamil letter for 'Ru' in the state budget logo, amid the ongoing three-language controversy.

How did this symbol come into existence?

Before 2010, the Indian rupee was often abbreviated as "Rs" or "INR" in international markets, leading to confusion with other currencies like the Pakistani and Sri Lankan rupees. In 2009, the Ministry of Finance announced a national competition, inviting designers, artists, and the general public to submit their ideas for the rupee symbol. The initiative aimed to create a mark representing India's economic strength while embracing its cultural roots.

Who is Udaya Kumar, the man who designed the symbol?

The iconic rupee symbol (?) has a history that dates back to 2010. Udaya Kumar, then a postgraduate student at IIT Bombay, was on the verge of joining the design department at IIT Guwahati when he won a national competition to create India's official currency symbol, beating hundreds of other entries. He spent a lot of time researching, from history to the modern times. Initially, he started with



graphic elements, but then moved to scripts for he thought it could best identify the country. The Devanagari script, he thought, was especially unique. After extensive research, Udaya Kumar Dharmalingam combined the Devanagari 'Ra' for rupiah and the Roman 'R' for rupees to create the rupee (?) symbol, giving it a distinctly Indian yet universal identity. Winning the competition in 2010 was a milestone in his life, opening new avenues in design and education. Since then, he has designed logos for institutions like IIT Hyderabad and the National Testing Agency. Now a professor at IIT Guwahati, he mentors students, encouraging innovative thinking in design. His work continues to bridge tradition and modernity, shaping India's visual and cultural identity. On July 15, 2010, the Manmohan Singh-led UPA government officially introduced the symbol, marking a significant moment in India's monetary history.

### 100-year-old Pushpabanta Palace to turn into five-star hotel

Agartala: The Tripura government on Friday inked a pact with the Indian Hotels Company Ltd (IHCL) to turn the Pushpabanta Palace, a royal property, into a world-class five-star hotel, Chief Minister Manik Saha said. "The government has been in consultation with the IHCL, a Taj groupowned entity to set up a world-class five-star hotel at the Pushpabanta Palace," he said at a press conference. "This is indeed a historic day for the state as the pact was signed on the auspicious occasion of the Holi, the festival of colours," he said. Industries and Commerce Minister Santana Chakama and Tourism Minister Sushanta Chowdhury were also present at the press meet. Saha said this was the first time IHCL inked an MoU with any State government to develop a world-class five-star hotel.

"The proposed hotel will be named Taj Pushpabanta Palace and developed by the Taj group with an estimated cost of Rs 250 crore in the next three years," the Chief Minister said. It will have a total of 104 rooms, of which four will be developed, keeping in mind the lifestyle of the kings. Asserting that the government wants to promote the

history and legacy of the Manikya Dynasty to the global stage, he said the foreign tourists visiting the State will have a clear idea of the dynasty's history.

Built by Maharaja Birendra Kishore Manikya Bahadur in 1917, Nobel laureate Rabindranath Tagore stayed at the Pushpabanta Palace and celebrated his birthday during a programme in May 1941. Claiming that the deal will generate at least 200 direct jobs, the Chief Minister said the move was aimed at promoting the State's tourism potential at the national and international levels. On the opposition of Tipra Motha Party (TMP), an ally of the BJP-led coalition government on turning the royal property into a five-star hotel, Saha said a problem is bound to erupt when any good work is initiated, but ultimately it has been solved. "We have meetings with them (Tipra Motha Party) on the issue and they have agreed to the project leading to the signing of the MoU," he said. Saha also said Prime Minister Narendra Modi would visit the northeastern State to inaugurate the redeveloped Tripureswari temple in the Gomati district. He, however, declined to reveal the date of the formal inauguration.

### Ukraine ceasefire needs 'reworking', would give nothing to Russia, says Putin's close aide





Kremlin aide Yuri Ushakov said on Thursday (March 13, 2025) that a proposal for a 30-day ceasefire in Ukraine backed by the U.S. and Ukraine needed to be reworked to take account of Russia's own interests, the RIA state news agency reported."The document, it seems to me, has a hasty character... It will be necessary to work, think and take into account our position too. It outlines only the Ukrai-

nian approach," RIA cited Mr. Ushakov as saying. "A 30-day temporary ceasefire. Well, what does it give us? It gives us nothing. It only gives the Ukrainians an opportunity to regroup, gain strength and, to continue the same thing," Mr. Ushakov told Russian media.

Mr. Ushakov's remarks came as U.S. officials are set to present the ceasefire deal to the Russian side on Thursday (March 13, 2025). He told the state media that the ceasefire in Ukraine was not conducive to long-term peace and the joint U.S.-Ukrainian idea was a "hasty" step that "is not in favour of a long-term settlement." Meanwhile, Ukraine President Volodymyr Zelensky said Thursday (March 13, 2025) the fact there was no "meaningful" response from Moscow to a 30-day ceasefire proposal from the United States meant the Kremlin wants to keep fighting in Ukraine. "Regrettably, for more than a day already, the world has yet to hear a meaningful response from Russia to the proposals made. This once again demonstrates that Russia seeks to prolong the war and postpone peace for as long as possible. We hope that US pressure will be sufficient to compel Russia to end the war," Mr. Zelenskyy said

### China urges 'diplomatic' Iran nuclear solution ahead of Beijing talks

China called ,for a "diplomatic" resolution to the Iran nuclear issue as it prepared to host diplomats from Tehran and Moscow for talks. The United States withdrew from a landmark deal, which had imposed curbs on Iran's nuclear programme in return for sanctions relief, during President Donald Trump's first term. Tehran adhered to the 2015 deal for a year after Washington's withdrawal but then began rolling back its commitments.

Beijing is set to host Russia and Iran — both key diplomatic partners — on Friday for trilateral talks on Tehran's nuclear programme."In the current situation, we believe that all parties should maintain calm and restraint to avoid escalating the Iran nuclear situation, or even walking towards confrontation and conflict," Foreign Ministry spokeswoman

Mao Ning told a regular briefing. The meeting will be attended by China's Vice Foreign Minister Ma Zhaoxu, Russian Deputy Foreign Minister Sergey Ryabkov and Iranian Deputy Foreign Minister Kazem Gharibabadi, Beijing has said.

Iran's Foreign Ministry has said the meeting would focus on "developments related to the nuclear issue and the lifting of sanctions". No details about the timing of the meeting have been shared. However, Beijing has said the talks would aim to "strengthen communication and coordination, to resume dialogue and negotiation at an early time". "China sincerely hopes that all parties can work together, continuously increase mutual trust and dispel misgivings, and turn the momentum of restarting dialogue and negotiation into reality at an early date," Mao said. Since returning to the White House in January, Mr. Trump has called for a new nuclear deal with Tehran while reinstating his "maximum pressure" policy of sanctions. Iran has officially ruled out direct talks as long as sanctions remain, with President Masoud Pezeshkian vowing on Tuesday that his country "will not bow in humiliation to anyone". Mr. Trump said last week he had sent a letter to Iran's supreme leader Ayatollah Ali Khamenei urging negotiations and warning of possible military action if Iran refused. A quarterly report by the UN's International Atomic Energy Agency (IAEA) in February said Iran had significantly increased its stockpile of highly enriched uranium to 60% purity — a short step from the 90% needed to make a nuclear weapon.

### Pakistan PM meets survivors of deadly train hijack and the commandos who ended the siege

Pakistan's Prime Minister Shehbaz Sharif was in the restive southwestern Balochistan province on Thursday (March 13, 2025) to meet survivors of a train attack and the commandos who rescued over 300 passengers from insurgents who killed 21 civilian and four troops. The Baloch Liberation Army, an outlawed group behind multiple deadly attacks in recent months, claimed responsibility for the attack that began Tuesday and ended Wednesday when troops killed all 33 insurgents in an operation that the military said resulted in no further passenger deaths.

The train was heading from the Balochistan capital, Quetta, to the northern city of Peshawar when insurgents blew up the track, forcing nine coaches and the engine of the Jafer Express train to stop partially inside a tunnel. The BLA regularly targets Pakistani security forces and has attacked trains, but had never been able to hijack any train in the past. They have also attacked outsiders such as Chinese workers, thousands of whom are involved in multibillion-dollar infrastructure projects in Balochistan.Oiland mineral-rich Balochistan is Pakistan's largest and least populated province. Members of the ethnic Baloch minority say they face discrimination and exploitation by the central government. Amid tight security, Sharif and members of his Cabinet were received by senior government officials on his arrival at an airport in Quetta, his office said. It provided no further details. Authorities said arrangements were made to transport the bodies of victims to their hometowns and people who were wounded were receiving medical treatment. Shafqat Ali Khan, the spokesman at Pakistan's ministry of foreign affairs, told reporters in Islamabad that BLA assailants who hijacked the train were in contact with their handlers in Afghanistan.

"Our security forces successfully eliminated all 33 terrorists, including suicide bombers, while rescuing the hostages," he said.Khan said the attackers had been "in direct communications with Afghanistan-based planners throughout the incident" and Pakistan has repeatedly asked Kabul "to deny the use of its soil for terrorist groups like BLA for their attacks against Pakistan." "We urge Afghanistan to hold perpetrators, organizers, financiers, of this reprehensible act of terrorism accountable and cooperate with the gov-



ernment of Pakistan to bring all those who are concerned with this attack, including the real sponsors of terrorism to iustice." Khan said. In an overnight statement, the military said it had "confirmed intelligence" indicating that the assault was "orchestrated and directed by terrorist ring leaders operating from Afghanistan, who were in direct communication with the terrorists throughout the incident."In Kabul, Abdul Qahar Balkhi, a spokesman for the Afghan Ministry of Foreign Affairs, rejected the Pakistani charges, saying: "We are saddened by the loss of life of innocents in the incident."However, the military in the statement urged the Afghan Taliban government to uphold its responsibilities and deny the use of its soil for terrorist activities against Pakistan. According to a military statement, the "terrorists, after blowing up the railway track, took control of the train and held the passengers hostage including women, children and elderly, using them as human shields. "Many survivors said the assailants opened fire on the windows of the train, entered the cars and killed or wounded people before taking them hostage. Three soldiers who had been guarding the railroad track were among those killed, according to military spokesman Lt. Gen. Ahmad Sharif. Seperately, Pakistani security killed 10 militants after spotting them near a military facility in South Waziristan, a district in Khyber Pakhtunkhwa province bordering Afghanistan, officials said. Authorities said those killed were members of Pakistani Taliban, known as Tehrik-e-Taliban Pakistan or TTT. The group is an ally of the Taliban in Afghanistan and has been emboldened since the Afghan Taliban seized power there in 2021.

### NTPC eyes Andhra Pradesh for nuke plant, State govt. yet to respond

If the on-going talks on nuclear power plant proposed by NTPC Limited with the Andhra Pradesh government materialise, the atomic energy plant is likely to be set up anywhere in one of the proposed places such as Nellore, Prakasam and Anakapalli districts in future, reliable sources in the NTPC and the Andhra Pradesh government, said.NTPC is evaluating sites in various States, including Andhra Pradesh, to rapidly expand nuclear power generation in the country to meet net zero targets by 2070. Each potential location requires regulatory approval from the Atomic Energy Regulatory Board (AERB). NTPC has already constituted a dedicated team to consult the State governments, mostly along the East and West coasts.

"A formal proposal has been made to Andhra Pradesh government to allot the required land (at least 2,000 acres) and water for the nuclear power plant. We have not received

any response from the State yet. But, NTPC has received a positive response from Chhattisgarh, where a MoU has also been signed for setting up 4,200 MW of nuclear power capacity at an estimated cost of ?80,000 crore. We are exploring 23 locations across the country, including some in Andhra Pradesh, but we are interested in Anakapalli district due to its geographical conditions and water resources. including Polavaram major irrigation project," an NTPC official told The Hindu on Thursday on condition of anonymity. When contacted, an official from the State government secretariat said, "Yes, the proposal from NTPC regarding a nuclear power plant at possible locations in Andhra Pradesh, is true. Coastal areas like Nellore, Prakasam and Anakapalli districts have been proposed. However, the State government is yet to take any formal decision on it. Public concern is likely to be one of the major

## U.N. probe says Israel attacks on Gaza reproductive centres 'genocidal'; Netanyahu calls it 'false, absurd'

A United Nations investigation concluded Thursday (March 13, 2025) that Israel carried out "genocidal" acts in Gaza through the systematic destruction of sexual and reproductive healthcare facilities. The U.N. Commission of Inquiry said Israel had "intentionally attacked and destroyed" the Palestinian territory's main fertility centre, and had simultaneously imposed a siege and blocked aid including medication for ensuring safe pregnancies, deliveries and neonatal care. "Israel categorically rejects the unfounded allegations," its mission in Geneva said in a statement.

The commission found that Israeli authorities "have destroyed in part the reproductive capacity of Palestinians in Gaza as a group through the systematic destruction of sexual and reproductive healthcare", it said in a statement. It said this amounted to "two categories of genocidal acts" during Israel's offensive in Gaza, launched after the attacks by Hamas militants on Israel on October 7, 2023. The United Nations' genocide convention defines that crime as acts committed with intent to destroy, in whole or in part, a national, ethnical, racial or religious group. Of its five categories, the inquiry said the two implicating Israel were "deliberately inflicting on the group conditions of life calculated to bring about its physical destruction" and "imposing measures intended to prevent births within the group".

"These violations have not only caused severe immediate physical and mental harm and suffering to women and girls, but irreversible long-term effects on the mental health and reproductive and fertility prospects of Palestinians as a group," the commission's chair Navi Pillay said in a statement. The three-person Independent International Commission of Inquiry was established by the U.N. Human Rights Council in May 2021 to investigate alleged international law violations in Israel and the Palestinian territories. Ms. Pillay, a former U.N. rights chief, served as a judge on the International Criminal Court and presided

over the International Criminal Tribunal for Rwanda. Israel accused the commission of advancing a "predetermined and biased political agenda... in a shameless attempt to incriminate the Israel Defence Forces".

The report said maternity hospitals and wards had been systematically destroyed in Gaza, along with the Al-Basma IVF Centre, the territory's main in-vitro fertility clinic. It said Al-Basma was shelled in December 2023, reportedly destroying around 4,000 embryos at a clinic that served 2,000 to 3,000 patients a month. The commission found that the Israeli Security Forces intentionally attacked and destroyed the clinic, including all the reproductive material stored for the future conception of Palestinians. The commission found no credible evidence that the building was used for military purposes. It concluded that the destruction "was a measure intended to prevent births among Palestinians in Gaza, which is a genocidal act". Furthermore, the report said the wider harm to pregnant, lactating and new mothers in Gaza was on an "unprecedented scale", with an irreversible impact on the reproductive prospects of Gazans. Such underlying acts "amount to crimes against humanity" and deliberately trying to destroy the Palestinians as a group, the commission concluded. The report came after the commission conducted public hearings in Geneva on Tuesday (March 11, 2025) and Wednesday (March 12, 2025), hearing from victims and witnesses of sexual violence. It concluded that Israel had targeted civilian women and girls directly, "acts that constitute the crime against humanity of murder and the war crime of wilful killing".

Women and girls have also died from complications related to pregnancy and childbirth due to the conditions imposed by the Israeli authorities impacting access to reproductive health care, "acts that amount to the crime against humanity of extermination", it added. The commission added that forced public stripping and nudity, sexual harassment including threats of rape, as well as sexual assault, comprise part of the Israeli Security Forces' "standard operating procedures" toward Palestinians.Israeli Prime Minister Benjamin Netanyahu on Thursday (March 13, 2025) condemned the report as "false and absurd". "The anti-Israeli circus known as the UN Human Rights Council has long been exposed as an anti-Semitic, corrupt, terrorsupporting, and irrelevant body," Mr. Netanyahu said in a statement issued by his office. "Instead of focusing on crimes against humanity and the war crimes committed by the Hamas terrorist organisation in the worst massacre against the Jewish people since the Holocaust, the U.N. once again chooses to attack the state of Israel with false accusations, including absurd claims" of destroying sexual and reproductive healthcare facilities in Gaza, he said.



U.S. President Donald Trump, in his second term in the White House, has said America will impose reciprocal tariffs on nations that charge high levies on U.S. goods. The Trump administration's global tariffs on steel and aluminum have come into effect, prompting the European Union (EU) and Canada to also announce levies on U.S. products. The administration has also announced tariff on imports from Canada, Mexico and China. In a retaliatory

action, these countries have also announced tariffs on goods

imported from the United States.Mr. Trump has said

America is "going to take in hundreds of billions of dollars in tariffs", and "we are going to become so rich, you are not going to know where to spend all that money. I am telling you, you just watch. We are going to have jobs. We are going to have open factories. It is going to be great".Mr. Trump has repeatedly called out India for the high tariffs that it imposes on American products. Last week, he criticised the high tariffs charged by India and other countries, terming them "very unfair", and announced that reciprocal tariffs will kick in next month on nations that impose levies on American goods. ### The invisible struggle: Addressing the plight of deserted women in India



Marriage, a cornerstone of societal structure, is traditionally viewed as a fundamental institution, not only forming the bedrock of family life but also defining social roles and statuses. However, the phenomenon of desertion, the abandonment of a spouse without justifiable cause, starkly contradicts these ideals, leaving a trail of vulnerable women in its wake. A deserted woman, defined as one whose husband has denied marital co-existence, faces a unique set of challenges often overlooked in broader discussions of women's empowerment.

While India's Draft National Policy for Women (2016) acknowledges the vulnerabilities of various categories of women, including divorced, separated, and widowed, it fails to adequately address the specific plight of deserted women. This omission is not a mere oversight but reflects a systemic negligence that perpetuates their marginalisation. Despite the wealth of data on India's female population, the absence of reliable figures on deserted women renders policy responses speculative and ineffective. The 2023 survey conducted by the CEO of Zilla Parishad, Ahilyanagar district, Maharashtra, revealing that 4,582 out of more than one lakh single women were deserted, underscores the magnitude of this overlooked crisis. These women, abandoned without the legal certainty of divorce, exist in a judicial and social limbo, their voices lost in the formal policy discourse. While they may be included in general welfare schemes, the lack of a clear definition leads to fundamental lacunae in India's gender-sensitive policymaking, perpetuating their socio-economic and psychological marginalisation.

Historically, India's legal and social institutions have been anchored in the normative understanding of marriage, with legal systems primarily focussed on its preservation. In a patriarchal society, the onus of maintaining this relationship falls heavily on women, making them particularly vulnerable to the fallout of marital discord. The stark contrast in treatment between divorced, widowed, and deserted women highlights this disparity. Divorced women have legal entitlements, and widows receive social and official acknowledgment and assistance. Deserted women, however, are caught in a paradoxical situation, ineligible for the benefits afforded to either group. This discrepancy necessitates a re-evaluation of gendered hierarchies and a more nuanced approach to gender-sensitive policymaking. The challenges faced by deserted women extend far beyond the legal realm, encompassing socio-economic and psychological dimensions. Economically, they struggle to achieve financial stability, often facing social ostracism that limits employment opportunities. Forced into poorly paid or irregular jobs, they lack access to credit, shelter, and essential welfare programmes. Their vulnerable economic situation is exacerbated by limited skills and education, rigid social norms, and a lack of support systems. Psychologically, the impact of desertion is devastating. These women endure severe emotional trauma, characterised by low self-esteem, anxiwith familial and community rejection, leads to social isolation and hinders their reintegration into society. In rural areas, where patriarchal norms are deeply entrenched, these challenges are compounded by factors such as caste, religion, and geographic location.

The lack of targeted State welfare measures further exacerbates their plight. Stringent criteria for social welfare benefits, such as residency requirements, create insurmountable barriers for women who have migrated in search of sustenance. Inter-State disparities in welfare provisions leave many deserted women excluded from essential support. Housing is another critical area of concern, with significant gender disparities in property ownership. While recent initiatives such as PMAY-G mandate joint ownership, many properties remain solely in the husband's name, leaving deserted women without a secure social safety net. Similarly, while some States have categorised deserted women for ration card benefits, a lack of uniformity at the Central level hinders their formal recognition as eligible beneficiaries. Even well-intentioned schemes such as the Swadhar Greh Scheme often fail to deliver tangible benefits owing to budgetary constraints and implementation challenges. Limited access to property, low literacy rates, and childcare responsibilities further reduce their bargainng power in the labour market. While schemes such as MGNREGA have identified deserted women as a special category, these measures are insufficient to address their

The pervasive lack of awareness regarding legal rights and personal agency compounds these obstacles. Despite the existence of laws designed to protect deserted women, prohibitive legal fees, procedural complexities, and social stigma deter many from seeking justice. Even with free legal aid, many deserted women do not file maintenance cases or receive minimal support. Studies, like the one from Sakhi: One Stop Centres in Maharashtra, show that even when cases are filed, outcomes are uncertain and prolonged. These challenges highlight the need for legal reform and sociocultural advocacy. Rules that edge out women from employment for getting married are 'coarse', unconstitutional: Supreme Court

Addressing the plight of deserted women requires a comprehensive policy intervention. Integrating them into State welfare measures and expanding empowerment initiatives through self-help groups (SHGs) are crucial steps. Improving legal literacy through dedicated legal support centres is equally essential. Community support networks and free counseling are needed to address their psychological needs. Expanded access to healthcare and insurance coverage will provide a safety net against economicand social instability. A formal national institution dedicated to the care of deserted women would ensure uniform policy implementation and recognition of their specific needs.Legal reforms are necessary to expedite processes and remove administrative barriers. Simplifying procedures and enforcing existing legislation are key goals. Organisations such as CORO India and Ekal Stri Sangahtana are working to bring awareness to the plight of single women. Women's rights organisations must continuously challenge and transform the socio-cultural beliefs that marginalise deserted women. The plight of deserted women underscores the need for a more inclusive approach to women's empowerment. Their legal invisibility and socio-economic vulnerability highlight a critical deficiency in current gender-sensitive policymaking. A multi-pronged strategy encompassing legal reform, policy innovation, and grassroots advocacy is essential. Excluding deserted women from the policy narrative is a moral and practical failure that demands urgent


## Sharpening India's anti-tuberculosis fight

The omnipresence of tuberculosis (TB) in the pages of history and literature is testimony to how the disease has plagued generations across the world and continues to be a major problem even today. India bears over a quarter of the global TB burden. Political will in India has helped drive a great deal of progress in the fight against the disease. For example, in 2023, addressing the big challenge of 'missed' TB cases, 25.1 lakh patients were diagnosed in India as having TB, highlighting strengthened case finding efforts. However, as we work toward the goal of TB elimination — the Prime Minister has urged citizens to work towards TB elimination — we must look to innovate and deploy proven technologies and tools at our disposal.

Regimens issuesThe first low-hanging fruit that I believe must be invested in urgently is new shorter regimens for drugresistant TB. It has been encouraging to learn that India will soon introduce the World Health Organization (WHO)-recommended shorter regimen for drug-resistant TB. The current regimens on offer are long and arduous, requiring patients to consume nearly 13 to 14 tablets every day if they are on the shorter nine to 11month regimen, or four to five tablets every day if they have been put on the 18 to 24 month longer regimen. The treatment is physically and psychologically draining and has severe side effects, such as loss of hearing, and

even psychosis.

Moreover, a problem with such an extended treat-

ment regimen that requires regular visits to a TB clinic for nearly two years is loss of employment, driving many families into poverty.In 2022, WHO recommended the shorter, safer and more effective regimens called BPaL/M for all drug-resistant TB patients, and there is a lot of recent data that show this regimen to be more effective with better compliance. With only three to four tablets every day, patients can complete their treatment within six months, with minimal side effects. The success rates of this regimen are also reported to be higher — 89% as compared to the 68% treatment success rate reported in the country in the 2023 India TB Report. Given its efficacy, close to 80 countries around the world have already procured the BPaL/ M regimen and about 20 of the highest burden countries are already rolling it out.

Research indicates that savings from implementing this regimen will be between 40% to 90% of the cost of current treatment regimens, and that an immediate transition to BPaL/M could result in an annual saving of ap-

for health systems globally. This is a more effective and safer solution to treat drugresistant TB and we must work on expediting access to this regimen to all eligible patients across the country. Making the best use of new treatmentsThe next question is this. How do we go about diagnosing more people with TB so that they can benefit from these game-changing new treatments? The answer lies in making sure that we are screening and testing quickly and efficiently to reduce delays in accurate diagnosis. For this, a proactive approach is essential. It is time we modernised and used health datasets, which include GIS mapping, to identify vulnerable populations such as those with comorbidities (for example, malnutrition, diabetes and HIV), former COVID-19 patients, and at-risk communities in slums, prisons, or those who are homeless. Targeted multi-disease fo-

among those without typical symptoms. In fact, recent evidence highlights that a significant number of people with pulmonary (i.e., lung) TB may not exhibit recognisable symptoms such as cough, fever, weight loss, or night sweats.

The National TB Prevalence Survey (2019-21) highlights the importance of chest X-rays, which detected 42.6% of cases that would have otherwise been missed. Leveraging advancements in technology, portable X-ray machines equipped with Al-driven tools can significantly reduce diagnostic delays, especially in remote and underresourced areas. Further, there is a critical need to expand the use of rapid molecular tests over less sensitive microscopy methods for faster detection and drug resistance profiling. This shift is crucial in promptly identifying TB cases and determining appropriate treatment options. In short, by proactively identifying atrisk populations and investing in and leveraging advanced/innovative diagnostic technologies,

### Caught between the warp and weft of business and life



In name, Akkalkot road falls in an industrial area. But the 4-5-km potholed road, in Maharashtra Industrial Development Corporation (MIDC) in Solapur district, is deserted. The factory units, spread across 216 hectares of the industrial area, resemble homes with white rangolis outside each gate. In the quiet afternoon, the only sound is the khat-khat of power looms, bearing testimony to still-running textile industry of the area. Here, 600-700 units operate with about 10 people in each, weaving textile for Solapuri chaddars and towels. Chaddars are used in daily life for everything from a floor spread to a blanket. In his Solapur home Govind Zanwar, 54, who produces bamboo towels now after switching out of the chaddar, says there are many reasons for its decline. Besides a change in customer tastes, cheaper synthetic textiles flooding the market, and the increased cost of production, he ascribes the downfall to the lack of innovation in design. "Aesthetics matter and the chadar features loud colours. There is scope for a revival, but it will be difficult," he says. Zanwar, who lives in a joint family of Marwaris, who were initially trading in cloth, got into the production of chaddar and towel about 15 years ago. His daughter and son do not want to get into the business, and are looking at careers as professionals in corporate jobs.

In 2005, the jacquard chaddar made from cotton yarn got the Geographical Indication (GI) stamp, an Indian government certification that a particular craft originated in an area. That year, the Geographical Indications Journal, a government document issued for GI tags, had listed at least 15,000 handlooms and power looms operating in Solapur, employing over 2 lakh people, all producing the Solapuri chaddar. In 2004, the journal reports that exports amounted to ?500-600 crore.Now, only 600-700 looms remain, according to data from the Textile Development Foundation (TDF), an association of manufacturers established in 1995 in Solapur. Exports have grown to ?800-1,000 crore, as per estimates by an industry expert. The government does not have current figures

Shriniwas Bura, 59, a textile engineer who worked in a corporate office in Mumbai, and then returned to start Bravo Kids School to train a generation to think independently and like entrepreneurs, is also the founder of TDF. He points out that chaddar production started declining from the year 2000. He blames the government and manufacturers for the downfall. "The government ignored the industry, while the producers failed to innovate. We realised only when external players from Haryana's Panipat captured our chaddar market. Now made-in-China towels are posing a danger to our towels," Shriniwas says, going through old records, covered in dust. He says Haryana producers use synthetic fibres and claim they are cotton.

Pentappa Gaddam, 65, a manufacturer and the president of the Solapur Zilla Yantramag Dharak Sangh (SOZIYA), an association that represents the community's needs to the government, says, "We complained to the government about the duplication, but no one listened to us." The association last complained eight years ago in letters, and has since stopped, since the number of producers has come down. In a grey building in in Siddheshwar Nagar, Suraj (name changed to protect privacy), 53, sits in his cramped office surrounded by piles of brightly coloured cotton towels. He is a third-generation producer, who owns 12 power looms operating in two shifts. "We all are working for survival. Forget bringing the next generation into the business. I am working at a 5% margin in towels; earlier it was 20%." He has had to shift from the Solapuri jacquard chaddar to towels, because there is barely any demand for the chaddar any more. Suraj's voice is drowned in the noise of the thana-bana (warp-weft) coming together to form cloth. It is Tuesday, the day he pays out weekly wages before the weekly day off on Wednesday. Suraj belongs to the Padmashali community of weavers, who repeat a legend, where people from the community made a piece of cloth from padma tantu (lotus fabric) for Lord Vishnu THEN?. Around 1877, when Solapur's first mill — Solapur Spinning & Weaving Mills — was established, they migrated here from Karimnagar, Warangal, and Siddipet, now in Telangana. It wasn't just about job opportunities, but also to escape the drought in those areas."We are able to sustain ourselves today only because our past generations built the foundation. We own the land, so we don't take its value into account while pricing products. If we do, we will run into losses," says Siddheshwar Gaddam, 61, the owner of a chaddar and towel factory, and the third generation in the business. His grandparents worked in mills like Jam Mill, Laxmivishnu Mill, and others, which collapsed in the 1950s. They purchased looms at a low price and started small units. becoming self-employed and giving employment to others. "From grey cloth, they shifted to chaddar, and 15 years ago we started with towels, as it had an international market."

Many like Suraj and Siddheshwar have quit manufacturing Solapur chaddar and shifted to towels. Suraj asks, "When Prime Minister Narendra Modi is saying 'go local', why is the government not banning Chinese products." The decline of the Solapur chaddar is also tied to economic growth and a rise status among customers.

Gurubai is lost between the warp and the weft, as she carefully winds thread on the bobbin. Spreading her hands out as she speaks, she says, "I don't know how old I am; maybe 50. I came to Solpaur when I got married and started working with the chaddor. I was 15 then." She wears a shirt over her saree, so that the cotton dust doesn't stick to her body and clothes. "It gets itchy," she adds. She earns ?800 to 1,000 every week for a 12-hour shift, and fears losing her job, because she knows no other work. Some months though, her salary just about pays her medical bills. Her work involves concentration and the use of her eyes, back, and hands. When these body parts ache, she takes an injection to deal with the pain.

Shridhar Gudheli, 48, a member of the labour union associated with the right-wing-politics Maharashtra Navnirman Sena (MNS), pointed out that workers don't have uniforms or safety gear, characteristic of informal work in India. He started as a worker, but now he fights for the rights of workers. "The wages were last increased in 2022. Business owners will tell you the market is tight, just to avoid a wage increase," he says.On their lunch break, a group of power loom workers, all in their 30s and 40s, sit under a tree and open their tiffin boxes. They are covered in cotton dust. All the workers were in their late 30s to 40s., covered with cotton dust. Nagesh Usapoyal, 43, a third generation

chaddar maker says, "I rode a cycle yesterday; I am still riding a cycle today. That is us, the textile industry workers." He dusts off cotton threads from his torn brown vest and folded pants. Usapoyal says he earns ?8,000 a month.Laxman Kusma, 35, is at the managerial position as he is a college graduate, but earns the same amount as a weaver. His work is to manage the weavers and look after the factory in the absence of the owner. Sitting on his bike, Laxman says, "I work double shift. In the morning I deliver milk for ?250 a day. I come to the factory at around 8 and leave at about 7 in the evening." SOZIYA has been demanding civic facilities like water, smooth roads, drainage lines, a fire unit, and low rates of interest on loans.

The decline of the Solapur chaddar is also tied to economic growth and a rise status among customers. As incomes increase, people migrate from the chaddar to branded bedsheets that arrive in plastic packaging. Plastic mats have taken over from floor seating.

"With the chadar, washing is problematic, and our product was perceived as a poor man's commodity," says Govind Bura, 57, a manufacturer, and Shriniwas' brother. Today, labourers prefer the towel, and those who have the chaddar say it lasts at least five years, so there are few repeat buyers. Solapur holds a geographically strategic position as it is situated in the southeastern part of Maharashtra.

Manufacturers talk about the fact that Solapur receives water only once every five days, so it's difficult for a waterintensive industry to run. For 1 kg of yarn, 60 litres of water is needed. Currently, the producers use tanker water. "Many shifted to recycled hosiery waste yarn as it is already dyed, which doesn't require water, says Zanwar. SOZIYA has been demanding civic facilities like water, smooth roads, drainage lines, a fire unit, and low rates of interest on loans. District Industries Centre (DIC) officer Santosh Kolte says, 'We are aware of the water issue. The work of setting up a new pipeline has been in progress." DIC's job is to take care of Solapur's needs. In his home-balcony office, Ashok Indapure, a trader who commissions goods and sells them on Amazon.in, says, "Solapur Government Polytechnic College discontinued textile-related courses as the students did not opt for the course, given the outdated syllabus." He feels if the Maharashtra State Board of Technical Education (MSBTE) sets up diploma courses it may help. A few mill owners blame politicians for ignoring Solapur, a city of migrants with people who speak Marathi, Telugu, and Kannada. There is also a mix of Hindus and Muslims, preventing politicians from creating religion- and caste-based vote banks. One producer says, "Baramati had Sharad Pawar who made sure the region developed. We had Sushil Kumar Shinde (a former chief minister), but he did not have the political will to do anything."

Solapur holds a geographically strategic position as it is situated in the southeastern part of Maharashtra, bordering Karnataka and a six-hour road ride from Telangana. The textile industry flourished in this area because of train connectivity. "But we needed an upgrade with airline connectivity," says Shriniwas, adding that there has been an airport here for 30 years, but it has been mostly non-operational. The closest international airports are Pune and Hyderabad, both a five-hour drive away. "Buyers from other countries avoid travelling here, as they have to take various modes of transport to reach here."

Charwak Burgul, whose 2,200 square foot unit was started in 1987 by his father, says for any textile-based industry to survive generations, there must at least be a 10% year-on-year growth, so there is a cushion for the bad years. His margins have dropped from 25% WHEN to 10%. To cut the cost of production, manufacturers shifted from power looms to shuttle-less looms in 2010 or so. The speed is high and gives four times the output compared to the power loom, and requires limited manpower. Charwak runs a full-fledged chaddar production unit with 10 power looms and 20 rapiers. "This is our legacy, we have to keep it alive somehow," he says, while walking through rows of power looms that can produce 10 chaddars a day, unlike the rapiers that do double.

He claims Solapur is the only place in India where everything from the doubling of yarn (twisting two yarns) and dyeing to the winding (hanks transferred to bobbins) and warping (yarn transferred to beam) is done under one roof. For the towel, the process is the same, with the dyeing being done after weaving. The entire process takes 15 days. The most common sizes are 48x90 inches, 54x90 inches, and 60x90 inches. Charwak has tried to innovate by creating wall hangings, portraits, and bags, but he is unsure of where to find a market. Youth and women in factory leadership are uncommon. Amit Bura, 25, is one of the few who has taken up his father's trade, but he does not see the Solapur chaddar as a profitable business. "We are experimenting with other products. We tried bottle-making but did not succeed. We are exploring other ideas," he says.

### Fire, fidelity and an inhuman heritage

In Europe, Christian clergy burnt alive women suspected of being Satan-worshipping witches. In Arabia, the 'People of the Ditch' were martyrs who chose death by fire rather than giving up Islam. The theatre of death in matters of faith is very much part of human culture. The practice of Sati — burning of Hindu widows — needs to be seen in this

In 1829, the East India Company passed a law banning Sati. Christian missionaries had long highlighted this practice in European circles to argue that, despite its lofty philosophy, India was a barbaric land in need of civilisational rescue. Defying this ban, a decade later, the Sikh controlled lands saw the burning of four Rajput queens and seven slave girls on the funeral pyre of Raja Ranjit Singh. A Kangra miniature painting was commissioned to commemorate this event.In 1861, Michael Madhusudan Dutta wrote his famous ballad Meghnad-Badh that valorised the sati-hood of Prameela, widow of Indrajit, daughter-in-law of Ravan, a story with roots in the 700-year-old Telugu Ranganatha Ramayana. Even Hindu social reformers, known for supporting the ban against Sati, praised this Bengali ballad as a literary masterpiece.

No one knows when the pan-Indian practice of warrior widows burning themselves with (sahagamana) or without (anugamana) the corpse of their husband came to be known as 'sati' — a word that means the chaste wife. The inhuman practice was strongly linked to the belief in fidelity-magic; that a woman who thinks of no one but her husband had supernatural powers. She could collect water in unbaked pots, as in the story of Sati Renuka; she could stop the sun from rising, as in the story of Sati Shilavati; she could turn the Hindu Trinity into her babies, as in the story of Anasuya. Sati Savitri even saved her husband from the jaws of death. So, it was assumed that a chaste wife would protect her warrior husband from death.

### Understanding the neurobiological basis of substance abuse addiction

In the complex landscape of public health challenges. substance use disorders stand as a testament to the intricate relationship between the brain and behaviour. As Brain Awareness Week (March 10-16) brings neuroscience into focus, it becomes imperative to examine addiction not merely as a moral failing but also as a chronic brain condition with neurobiological underpinnings that can be understood, treated, and potentially reversed. The human brain, with around 86-100 billion neurons, represents perhaps the most complex living structure in the known universe. Each neuron, equipped with an axon, dendrites, and a cell body forms an elaborate communication network that regulates everything from basic bodily functions to complex cognitive processes. This communication occurs through neurotransmitters — chemical messengers that can either excite or inhibit neural activity. Recent advances in neuroscience have illuminated how specific neural networks become disrupted during addiction.

The ground breaking multi-centre study by Dr. Michael D. Fox and Dr. Jacob L. Stubbs at the University of British Columbia, published in Nature Mental Health, analysed data from 144 imaging studies involving over 9,000 participants. Their findings reveal that addiction is not isolated to discrete brain regions but rather involves a unified circuit encompassing areas associated with craving, emotional regulation, and decision-making processes. This discovery marks a paradigm shift in our understanding of addiction. Rather than focusing on isolated brain regions, research suggests a more holistic approach is necessary — one that considers the interconnected nature of neural pathways involved in substance use disorders.

Three interconnected brain regions emerge as central players in the development and maintenance of addiction the basal ganglia, the extended amygdala, and the prefrontal cortex. Each contributes uniquely to what researchers describe as the three-stage cycle of addiction: binge or intoxication, withdrawal, and preoccupation or anticipation. The basal ganglia, particularly the nucleus accumbens (NAc), plays a decisive role in processing rewards. This region teaches the brain to repeat activities that produce pleasure, whether derived from food, social interaction, or addictive substances. Working in close coordination with neurotransmitters like dopamine and serotonin, the NAc reinforces behaviours that "feel good" — a natural becomes hijacked during addiction. Meanwhile, the extended amygdala governs stress responses and the negative emotional states that accompany withdrawal from substances. This region helps explain why discontinuing substance use often leads to profound feelings of anxiety, irritability, and unease — symptoms that drive continued use despite negative consequences. The prefrontal cortex, responsible for executive functions such as decision-making, time management, and prioritisation, completes this triad. Impairment in this region helps explain the seeming irrationality of continued substance use despite awareness of harmful consequences

Adolescence represents a critical "at-risk period" for substance use and addiction. During this developmental stage, the brain undergoes significant reorganisation, with the prefrontal cortex — the region responsible for impulse control and rational decision making — being among the last areas to fully mature. This neurobiological reality helps explain why adolescents are particularly vulnerable to substance use disorders and why early intervention is crucial. The neuroadaptations that occur with ongoing substance use not only impair brain function but accelerate the transition from controlled to compulsive use. Perhaps most concerning is that these alterations may persist long after substance use ceases, contributing to relapse vulnerability and periodic cravings even after prolonged periods of abstinence.

It is essential to recognise that while substance use



can lead to addiction, it does not inevitably do so on its own. A complex interplay of genetic predisposition, psychological history, environmental factors, and the age of first-use determines individual vulnerability. This multifactorial understanding challenges simplistic narratives and underscores the need for more nuanced approaches to prevention and treatment. The scientific community has made significant strides in understanding addiction through animal models, which provide controlled conditions for examining how substances affect the brain. These studies have elucidated the impact of genes, developmental processes, and environmental factors on substance-taking behaviour. Human studies using brain imaging technologies like MRI and PET scans have further illuminated the biochemical, functional, and structural changes induced by substance use.

However, despite these advances, our understanding of how the brain changes during recovery remains incomplete. What factors support or hinder long-term recovery from substance use disorders? What neurobiological processes allow individuals to sustain behavioural changes and build resilience against relapse? These questions represent the frontier of addiction research. A deeper comprehension of the recovery process will undoubtedly influence the development of more effective treatment and support programs. It may also help address the broader social, educational, and professional functioning challenges that often accompany substance use disorders.

Perhaps one of the most significant contributions of neurobiological research on addiction has been its role in reducing stigma. By framing addiction as a chronic brain condition rather than a moral weakness, this research has encouraged the integration of substance use disorder treatment into mainstream healthcare. Clinical trials continue to explore effective medications for various substance use disorders, with promising developments, particularly in the realm of opioid addiction. As our understanding of the neurobiological basis of addiction evolves, so too will our treatment approaches, potentially leading to more targeted interventions that address the specific neural circuits disrupted in addiction. As we observe Brain Awareness Week, it behoves us to reflect on how neuroscientific insights can inform public policy, treatment approaches, and societal attitudes toward addiction. Embracing a neurobiological framework, we can move beyond simplistic blame narratives toward more compassionate and effective responses. The brain's remarkable plasticity — its ability to reorganise and adapt -offers hope even in the face of addiction's persistent challenges. With continued research, improved public understanding, and evidence-based interventions, we can work toward a future where substance use disorders are prevented where possible and treated effectively where necessary. In this endeavour, we must remember that behind every statistic and brain scan lies a human being — someone whose neural circuitry has been altered but whose capacity for recovery remains. ## Restorative sleep with mind-body techniques to sleep smarter

The good news is, mindfulness, something from our ancient traditions backed with scientific evidence, is emerging as a powerful aid in fighting the poor sleep dilemma. It is not rocket science, but a non-judgemental practice that has you remain in the present. One of the most common advocated techniques to improve sleep quality is meditation, giving focused attention to breathing and allowing thoughts to reduce and settle into stillness. Integrating simple techniques like guided imagery, body scan and mantra meditation into your sleep routine can help achieve better sleep outcomes. Scientific evidence shows that mindful meditation is even equivalent to sleeping pills, demonstrating a significant reduction in time to fall asleep and improving sleep quality. This can be achieved using a mindfulness technique called progressive muscle relaxation. In this, the individual systematically tenses and relaxes various muscle groups, enhancing body awareness and fostering relaxation. Gentle yoga, like the child pose, downward dog pose, forward bending, shavasana and breath control can reduce stress and im-

nervous system, signalling the body that it is time to unwind. Simple breathing techniques like the 4-7-8 breathing technique or alternate breathing technique relaxe the brain, heart and also reduce stress, thus preparing us for a good night's sleep. Sleep, when planned well, is a battle half won. This means planning a mindful bedtime routine which can contribute to maintaining good sleep hygiene. Every small act counts if it is done with deliberation and planning. # No insurance coverage, lack of government support are barriers to improving India's dental care: experts

According to the World Health Organisation (WHO) Global Oral Health Status Report (2022), dental caries (tooth decay) in permanent teeth is the most common dental health concern globally. Subsequently in India, dental caries and gum disease dominate the oral health landscape.P. D. Madan Kumar, dentist, professor, Department of Public Health Dentistry, Ragas Dental College, Chennai, points out that dental caries affects nearly 60% of the population, while gum disease, or periodontal disease, is even more widespread, impacting about 85%. Particularly concerning is the emergence of cervical caries, also known as root caries, which is increasingly seen among both young children and the elderly. Dental diseases and the need for routine checkups

According to Yashwanth Kumar Venkataraman, senior dentist and orthodontist, Chennai, gum disease is the most commonly encountered problems in Indians. "I think 99% of our population at some age or the other would have undergone some kind of gum problem," he says. Many people mistakenly believe it is limited to occasional bleeding or swelling, but the reality is far more complex. As Dr. Venkataraman explains, "People often visit the dentist only when the damage is irreversible." Gum disease typically starts with gingivitis, an early stage of inflammation, but if left untreated, progresses to periodontitis, where the gums recede, bone levels drop, and teeth eventually become loose or fall out. Additionally, as per a report published by the National Centre for Disease Control, Directorate General of Health Services, around 60 million people are at risk of developing dental fluorosis across several states in India. Dr. Kumar, emphasis that the major cause of fluorosis is due to excessive fluoride in groundwater, that is spread across in many regions, contributing significantly to dental issues. The risks of oral cancer, other diseases

Another concern Dr. Venkataraman notes is the link between broken teeth and oral cancer. "I see at least one case every two months where oral cancer developed simply because of an untreated sharp or broken tooth," he says. Continuous friction from a sharp edge of a tooth against the inner cheeks, gums, or tongue creates repeated trauma, which over time can cause tissue changes and lead to cancer. "It's tragic because these cases are entirely preventable," he says. "A simple fix, like trimming the tooth, capping it, or polishing the edges, could have stopped the cancer from developing." Small cavities might not cause severe pain, so people ignore them," Dr. Venkataraman points out. "By the time they come to us, the decay has progressed so much that it requires root canals or extractions." Early detection could save both teeth and money, as a simple filling can last for 10–20 years, while a root canal is costly and may still result in tooth loss after a decade. This lack of awareness about preventive care leads to a lack of regular dental check-ups.Dr. Venkataraman also emphasises the need to understand that oral health isn't just about teeth, as it's linked to diabetes, heart disease, and cancer. Addressing



the cost concerns, one of the most critical barriers to dental care in India is the absence of dental insurance. While health insurance typically covers surgeries and hospitalisations, dental care is excluded unless linked to an accident. "Not a single dental hospital in India has insurance coverage for routine or preventive dental care," says Dr. Venkataraman. "Even private hospitals offer eye care insurance, but not dental care." This means people have to pay out of pocket for basic procedures like cleanings, fillings, and root canals. The cost deters many from seeking treatment early, allowing minor issues leading to major health concerns. "If dental insurance became part of health schemes, people wouldn't delay treatment," he says. "He stresses that this lack of coverage is a systemic failure, one that pushes dental care into the category of luxury rather than necessity.

S. Srinivas, HOD, dentistry, Prashanth Multi Speciality Hospital, Chennai, points out the importance of community education. " Awareness about simple practices like gargling after meals, drinking water regularly to cleanse plaque, and chewing sugar-free gum to stimulate saliva production can greatly enhance oral hygiene. Also, proper brushing techniques, using the right toothpaste, along-side regular dental check-ups are crucial," he says.Dr. Venkataraman also stresses the need for the government to launch awareness campaigns in regional languages. The WHO's Global Oral Health Action Plan (2023-2030) aims to shift from curative to preventive care, promoting fluoride use, reducing sugar intake, and expanding access to affordable dental care, Likewise, Dr. Kumar, notes that India's national oral health policies, also include initiatives like subsidised fluoride toothpaste and sugar control measures, but it still needs to be implemented nationwide, covering rural parts in India. Other initiatives like the national tobacco control and cancer control programmes according to Dr. Kumar, should strengthen public-private partnerships to improve tertiary care in dentistry. Experts also call for government hospitals with functioning dental clinics in every town to address India's oral health crisis. Despite having thousands of unemployed dentists, the country struggles with streamlining dental care services. Therefore, a collaborative effort between the government, healthcare providers, and the public is necessary to address this issue.

# With drug Empagliflozin going off patent, doctors look forward to price reduction, benefitting diabetic, heart and kidney patients

manufacturer Boehringer Ingelheim's Empagliflozin, a medication to treat type 2 diabetes mellitus, expired in India. Empagliflozin is sold under brand name Jardiance. "Empagliflozin belongs to the SGLT-2i group of drugs. (Sodium glucose transporter inhibitor) drugs. These drugs have shown multiple benefits, including weight loss, control of diabetes, prevention of heart failures, heart attacks and kidney damage, said V. Mohan, chairman, Dr. Mohan's Diabetes Specialities Centre, Chennai. "Now that the drug is going off patent, it will be prescribed more," he said.

Until the year 2000, Indian diabetologists prescribed only three classes of metformin, sulfonylureas and insulin. But these medications can cause hypoglycaemia. During this time, research to improve the control of diabetes was ongoing, and gliptins and gliflozins were the answers. These two new classes of drugs not only controlled blood sugar without causing hypoglycaemia, but also protected the heart and kidneys. Gliptins were introduced in 2006 but were expensive. A few years ago the manufacture of these drugs became universal.

With the end of patent, the price of 25mg tablet of empagliflozin which until till now cost ?70 per tablet, could cost ?15 to 20. A 10mg tablet will cost ?10 to ?15, surmised diabetologist A. Panneerselvam. "As a clinician, if 100 patients needed it, I would prescribe it for only 10 patients, because of the cost factor. Now we will recommend it for all patients who will benefit," he said. The expected fall in price however, does not translate into

a panacea for the ailment, he

What is the drug Empagliflozin?

Empagliflozin, marketed as Jardiance, is a drug for type 2 diabetes mellitus, manufactured Boehringer Ingelheim, a pharmaceutical company headquartered Germany.It is used as an adjunct to diet and exercise, to improve glycemic control and reduce the risk of cardiovascular death in patients with established cardiovascular disease, as per its website. The patent for the drug expired on March 11, and reports indicate multiple generics are expected to hit the market, at lower pricesThe India diabetes care drugs market was estimated to be worth USD 1.7 billion in 2024 and is expected to reach USD 2.01

R a j a r a m Anantharaman, consultant cardiologist with Kauvery Hospital said research on the drug had revealed its protective effects for the heart. Studies showed that the drug helped people at risk for

not have diabetes. "In the past 20 years we had no new major heart medication. These SGLT 2 inhibitors prevent glucose absorption in the kidney. The fluid collection in the lung is therefore reduced, and hospital admission with heart failure comes down. Overall deaths also drop," he explained.Cardiologists use four different medications for heart failure. They are beta blockers, ARNI inhibitors. mineralocorticoid receptor antagonists and SGLT2 inhibitors. The other three drugs are already available in generic form, Dr. Rajaram said. "We call them the four pillars of heart failure (treatment). With empagliflozin becoming cheaper, the medications will reduce symptoms, deaths and hospitalisations. "We do have a lot of heart failure patients in India. This drug will help in terms of symptoms he added.

Benefits for the kidneyRajan Ravichandran, senior consultant nephrologist with MIOT, said: "For some unknown reason the drug also protects the kidney. The drug's mechanism

reduces protein leak into

urine. When sugar is removed along with water, the heart function will improve. Once the tissue oedema goes away the organ functions better. That applies to kidneys also," explained. The drug was found useful in kidney disease as it helped in weight loss and prevented water retention. "Experience has shown that the drug can be used in kidney patients with or without heart failure or diabetes," Dr. Rajan said, recalling that he had used the drug soon after it was introduced a decade ago. "When I used the drug when it first came out, on a patient, the achievement was remarkable." He has a word of caution: People who are thin, those with repeated urinary tract infections and those who have experienced sudden deterioration in kidney function must be careful."A person who takes the medicine and gets diarrhoea will become dehydrated. The drug will draw away water along with sugar. It acts as a diuretic. Persons with food poisoning should avoid the medicine as it can affect the kidneys. Those with gastro-

enteritis or infections in the

genitals should also avoid it,

### Will the state be India's next big travel destination?



I grew up in Guwahati in the 1990s, a time when Assam rarely made it to national conversations, let alone global news. It was often defined by insurgency, bandhs, and a sense of isolation — both geographical and cultural. Yet, life carried on in its own unhurried rhythm. Rainy mornings smelled of petrichor, afternoons were reserved for siestas and freshly brewed lal cha, and summer evenings unfolded by the Brahmaputra's banks. Bihu and Durga Puja brought the city alive, momentarily dissolving the troubles of the time. But for those beyond its borders, the state remained a distant, unfamiliar land — reduced to tea gardens, dense forests, and one-horned rhinoceros. The idea of it as a thriving tourism hub felt improbable.

Cut to 2025, and Assam is making headlines for all the right reasons. There was the recent UNESCO addition of Charaideo Moidams — the 700-year-old mound burial

system of the Ahom dynasty, often called the 'Pyramids of India' — to its World Heritage List. It has brought the medieval kingdom's legacy into the global spotlight, leading to the announcement of a new Charaideo Museum. The state, which banks heavily on its wildlife destinations to attract tourists, has also declared Sikhna Jwhwlao, a vital corridor between Manas and Raimona National Parks, as its eighth national park, further cementing its reputation as a biodiversity hotspot. The fact that Assam was ranked No. 4 on The New York Times' '52 Places to Go in 2025' list for its "incomparable biodiversity", "tea estates and river islands", and its deep-rooted history and indigenous cultures — has also added to the buzz. And the developments don't end there. Luxury tourism is on the rise with The Postcard Hotel's debut in the Durrung Tea Estate and Reliance's partnership announcement with the Oberoi Group to build a seven-star hotel. Is Assam finally on the brink of a longawaited tourism breakthrough?

Tourist arrivals in Assam have surged dramatically over the past five years, signalling a shift in the state's travel landscape. Domestic footfall, which had plummeted to just 13.5 lakh in 2020-21 due to the pandemic, rebounded sharply to 98.12 lakh in 2022-23 before settling at 70.36 lakh in 2023-24. International arrivals tell a similar story—rising from a mere 347 in 2020-21 to a high of 26,128 last year, according to Assam Tourism. Come summer, when temperatures climb to a toasty 32 degrees Celsius, the state government hopes the numbers will increase even more.

In aid of this, last month, at the Advantage  $\mbox{\sc Assam}\,2.0$ 

Summit held in Guwahati, the state secured ?4.91 lakh crore in investments, with 270 MoUs signed, focusing on tourism, culture, and hospitality. At a time when overtourism in popular destinations such as Goa and India's many hill stations — and its attendant troubles of environmental degradation, rising real estate costs, and overstretched infrastructure — are driving tourists to seek less congested options, Assam hopes to step up as a tranquil alternative. "Earlier, people only knew about Kaziranga [home to the endangered rhino] and, to a lesser extent, Manas. Now, with Instagram and content creators, even community festivals that were once local events are getting national attention," says Amit Kumar, executive editor of EastMojo, one of the Northeast's leading digital multimedia news platforms. He points to hidden gems such as Goalpara's Jain Caves and Kaipholangso Waterfall in Karbi Anglong, now weekend destinations thanks to social media creators seeking fresh, high-engagement content. "With insurgency at an all-time low [according to Minister of Home Affairs Amit Shah this week, "violent incidents in the state decreased by 70%"], previously inaccessible regions are now welcoming more visitors," he adds. The state is also further strengthening its appeal. There are the 'Awesome Assam' campaigns in other Indian states, proactive tourism initiatives, better road and digital connectivity, and the introduction of a tourist police force to ensure visitor safety. The Guwahati airport is undergoing a major expansion, too. Scheduled to open soon, it is increasing its runway capacity and will be able to accommodate 13.1 million passengers annually. Rural tourism is coming up, with

homestays in Majuli, Goalpara and Nagaon offering immersive experiences. "I work with women to help them set up homestays — not just as a business but as a way to introduce authentic Assamese culture to travellers," says Arijit Purkayastha of Koyeli Tours and Travels. Tea tourism, once confined to specific seasons, is also expanding, reinforcing Assam's position as a year-round destination.

There's a shift towards experience-driven tourism as well, exemplified by hospitality brands such as The Postcard. Set within the 140-year-old Durrung Tea Estate, this boutique property marks a turning point for high-end hospitality in a region long overlooked by luxury travellers. "From the very inception of The Postcard, we recognised the immense potential of India's Northeast. Durrung stood out for its accessibility, deep-rooted tea legacy, and seamless connection to Assam's culture and wildlife," says founder and CEO Kapil Chopra. In 2022, the Assam government allowed tea estates to use 5% of their land for eco-friendly tourism.

"We chose Assam as our first destination in the Northeast for a very strategic reason: India's tea trails begin here. Durrung is also surrounded by five national parks and offers excellent accessibility — just three hours from Guwahati, two from Itanagar, and 15 minutes from Tezpur airport, which is being upgraded," states Chopra, adding that instead of a large-scale development that disrupts the place's natural beauty, "we've taken a more thoughtful approach, with just 12 rooms spread across 1,400 acres of pristine tea estate".

### Student violence in Kerala: The many layers behind the mayhem

When he retires as Principal of a government school in Palakkad district this May, A.K. Anilkumar is likely to carry the memory of an incident that happened towards the fag end of his 36-year-long career, though he would prefer to forget it.In January 2025, the video of a 17-year-old Plus One student from his school went viral on social media. Furious over the confiscation of his mobile phone, which was not allowed in the school, the boy could be seen making a death threat at his teachers, including Anilkumar. It created such a furore that it prompted the State government to order a probe. "It was the first such experience in my long teaching career. It wasn't the fear of bodily harm that hurt me but the pain of whether all my years in teaching have been rewarded in such a manner," rues Anilkumar.

The incident came close on the heels of another incident in which a man was stabbed to death by two minor boys, aged 14 and 16, for allegedly questioning the public use of drugs at Thekkinkadu Maidan in Thrissur district on the New Year eve. Since then, a spate of violent incidents involving youngsters has struck Kerala, claiming many lives and disrupting several families. A gang war-like clash between two groups of teenage students led to the death of a 15-year-old boy at Thamarassery in Kozhikode. Several instances of group clashes involving school students have gone viral on social media. The violent incidents involving schoolchildren and teenagers have triggered a debate about what has gone wrong with the youth. While some blame it on the drug menace and the alleged influence of violent movies, others have raised deeper concerns that include gaps in parenting, mental health anxieties, and the impact of tech and social media on Gen Z.Arun B. Nair, Professor of Psychiatry, Government Medical College, Thiruvananthapuram, feels that the younger generation is facing a social disconnect syndrome, which has been exacerbated by the COVID-19 lockdowns and the digital revo-


"Digital revolution appears to have made humans more impulsive and impatient. The revolution, which facilitates instant fulfilment of a desire, whether going for a movie or expressing love has also eliminated the previous tent time lapse between a desire and gratification. This leaves the brain hardly any time to evolve an alternative plan if that desire goes unfulfilled, resulting in aggressive overreaction with suicidal or homicidal ramifications," Dr. Nair says. Thampy Mathai, Director of Maithri, the Kochi chapter of Befrienders Worldwide, a global organisation working for suicide prevention, points out that "suicidal tendencies are often found to be triggered by relationships, which, in the first place, are built on fleeting interactions on social media. When those relationships go haywire, they are hell-bent on either self-destruction or the destruction of the other partner," he says.

Aseel Muhammed, a social media influencer and a third-year psychology student at Farook College, Kozhikode, accuses the older generation of setting the narrative over the violent conduct of the new generation and the mainstream media running debates pandering to that. "The older generation who runs the system is not willing to admit their follies in parenting and deficiencies in academic curriculum. They are even unwilling for a course correction. They, along with the media, are impatient to wrap up the debate by finding convenient scapegoats such as cinema and solutions like bringing back corporal punishment to straighten up the children. The stressful surroundings in which children are growing, their emotional well-being, and lack of avenues to express themselves are often neglected," he

Amruth G. Kumar, Professor of Education, School of Education, Central University of Kerala, attributes the child aggression to a large extent to the authoritarian and violent parenting styles, unresolved sibling rivalry, feuds between family members and with neighbours, and lack of parental supervision. "Violence can be used as a tool to establish dominance and status in peer groups. Students grab this idea from their surroundings. Violence for dominance is rampant around them and if the family environment also suggests that violence is an effective means for gaining control or respect, children tend to emulate it," he says. Award-winning Malayalam filmmaker Blessy says that a few recent movies in Malayalam, which had an overdose of violence and reaped success at the box office, had tried to normalise killings or murdering. "I feel there is an attempt to celebrate such violence on screen knowingly or unknowingly," he says. Muhsin Parari, a popular scriptwriter, questions the very premise of the debate, which he alleges has put the entire Gen Z under the needle of suspicion.

"Have we carried out any scientific study yet on whether there is a spike in violence among the youth? Isn't it irresponsible to make such inferences without concrete data-based evidence?" he wonders. Coming to the defence of cinema, Parari feels that the grip of a social media giant on public opinion was way more dangerous than cinema's influence on the youth. The public falls for algorithm-driven sensationalism and populism, producing absurd paranoia to evade accountability, he says.

Blessy agrees that the blame of instilling aggression and violence in the minds of the youth cannot be placed on cinema alone, as it figures among several other psychological and social issues prevalent in society. "But cinema



is capable of an instant transfer of an emotion to the audience," he says. A few members of the film fraternity, who preferred not to be quoted, share the apprehension that the debate may even lead to backdoor censorship of cinemas, which, according to them, the moralistic elements in society have been craving for long. The first salvo has been fired with the Central Board of Film Certification denying satellite rights to a recent Malayalam flick on the grounds of extreme violence, points out a popular filmmaker, who wished not to be quoted.

P. Vijayan, Additional Director General of Police, Intelligence, who was behind the concepts of social policing and Student Police Cadet programme, feels that attributing the violence amongst youth to a few convenient factors may result in a lopsided conclusion."The general deterioration in mental health, loss of a values-based system, the rising pleasure-seeking attitude, and the environment around the younger generation also play a role in shaping their responses and behaviour," he says."Films and drugs may serve as triggers but portraying them as foundational issues will not help. Working in silos will not help but collective societal efforts are needed. Also, scientific studies on behaviour of the youth are needed," he says. Prof. Kumar has called for the elimination of undemocratic spaces in households and society as the first step towards preventing violence among children, besides a collaborative approach from the family, school, and community. "Parents shall provide emotional security and a safe home environment for their children. Also, schools should learn to decode the cues to understand the problems students face at home and in the community, their fears, and concerns. Rather than having a counsellor in every school, every teacher needs to become a psychologist who understands the child," he says.Dr. Nair finds faulty parenting practices as problematic, especially parents' lack of communication during their children's adolescence

"Adolescents often complain that parents either don't listen to their problems or trivialise them while parents complain of their adolescent children being not obedient. What is needed is not authoritarian parenting, which the previous generations were used to, but authoritative parenting, which is a blend of affection and discipline. Parents need to understand that their children were born in a more rights-based world with greater emphasis on personal rights and space," Dr. Nair says. He also warns that addiction to gadgets and graphically violent online games could serve as a trigger to a generation, which is already subjected to faulty parenting and is impatient and impulsive owing to their over exposure to digital technology. Anilkumar remains worried about the aggressive behaviour of his teenaged student. So are many parents and teachers about the lives of the youth lost to violence on the streets.

### A new discovery sheds light on our long-extinct cousins

Hyderabad: Fragments of face bones from a species of extinct human previously unknown, dating from between 1.2 million and 1.4 million years ago, were discovered in the caves in the Atapuerca Mountains in Spain during archaeological excavations, which were going on for the last 50 years.

The human traces stretched from the Bronze Age to hundreds of thousands of years into the past – before modern humans like us (Homo sapiens) even existed. These are earliest human remains ever found in Western Europe.Back in 2022, during an annual field season, the team unearthed a series of bone fragments from a cave called Sima del Elefante (Pit of the Elephant). The fragments are from the left side of the mid-face of an adult human.In 2008, a human jawbone more than 1.1 million years old had been found at the same site. The new fragments were found around two metres deeper than the jawbone, which suggests they are even older. Since the discovery, the team spent more than two years meticulously studying the re-

## Is learning Hindi as a third language necessary?

The National Education Policy, 2020, encourages students up to at least Class 5 to learn a regional language in addition to the local language or mother tongue and English. While the Central government asserts that the choice of the additional regional language is left to the States, the NEP's strong pitch for the three-language formula has led to fear, especially in Tamil Nadu, that there is an attempt being made to impose Hindi on non-Hindi speaking States. This week, Tamil Nadu Chief Minister M.K. Stalin dubbed the NEP a "Hindutva policy" aimed at promoting Hindi, rather than focusing on India's overall development. Is learning Hindi as a third language necessary? Yogendra Yadav and T.M. Krishna discuss the question in a conversation moderated by K.V. Prasad. Edited excerpts:

Should learning a third language be made compulsory?

Yogendra Yadav: Absolutely not. First, because the spirit of federalism and respect for diversity is foundational to the Union of India. So, nothing can be imposed on any State, least of all a language policy. If we have different views on language, they are resolved through consensus, not through imposition. I'm entirely with the DMK and the people of Tamil Nadu on the imposition issue. T.M. Krishna: If I may ask, why learn three languages? To be clear, we are not talking about students learning other languages of their own accord, which is anyway happening. A government that selectively deletes chapters from history textbooks, stating that there is too much of an education burden on students, is not even willing to look at the fact that learning another language is definitely a burden on them. Also, children in primary and middle school don't have an imagination of time or the distant future. So asking them to learn a third language, in the name of future benefit, is basically an imposition. There is also the argument being made that learning more languages creates unity. This is a smokescreen. Forcing a language on someone is not unity. Yogendra Yadav: Once we disentangle the idea of teaching three languages from Central imposition and the compulsion of Hindi, we can discuss the issue dispassionately. The point about the burden of education is something that experts have handled. They have come to the consion that if you teach a third language, it only helps your primary and secondary language, so I believe that the threelanguage formula merits serious consideration on grounds of pedagogy and national unity. As for practicality, I know of schools which do follow this formula. They do not give you the option of all the 22 languages (recognised in the Eighth Schedule of the Constitution), but they give you three or four options to choose from. These things can be worked out provided there is a political will and a capacity to teach

If compulsory learning of an additional language will be a burden on students, will it not be equally burdensome on schools, since they will need qualified teachers and funds for this purpose?

T.M. Krishna: More than 5,000 schools in Uttar Pradesh are managed by a single teacher. Bihar has a massive teacher shortage. So, even in terms of resources, this formula does not make sense. When resources are few, it makes more sense to look at the ways in which we can teach primary subjects better. And when the mother tongue is the mode of learning and communication in class, and there is English as well, I don't believe that adding another language is necessary.

Is it fair to make adoption of the three-language formula a pre-condition for the release of Central funds for schemes?

Yogendra Yadav: Holding back grants is unconstitutional. This is part of a political assault on the autonomy of the Tamil Nadu government, led by the Governor himself. I understand why not just the DMK, but all parties and the people of Tamil Nadu feel slighted.T.M. Krishna: It is unconstitutional, unethical, and devoid of any basis. Some people say, let the people decide whether they want three languages or two. But people did not decide about the three-language policy; individuals in the Union government made this decision.

Why is there so much resistance to an educational policy that stresses on the need to learn an additional language?

Yogendra Yadav: My suspicion is that the resistance does not come from pedagogical concerns. It emanates from disquiet with double standards. Frankly, the formula was sabotaged by north India. The expectation was that all the southern and eastern States would learn Hindi, while the Hindi speakers found a shortcut for themselves — they used Sanskrit as a shield so that they would not have to learn a new language. So, in effect, the policy meant that everyone would be forced to learn the mother tongue of Hindi speakers, but they would not have to learn anyone else's mother tongue. That legitimate unease has clouded the debate on multilingualism in our country. T.M. Krishna: Multilingualism is not just a political problem; it's pedagogic too. The pedagogical methods have changed. At the primary and middle-school level, activity-based learning and experiential learning should be the focus. There are already two languages at play; that itself is multilingualism. I do not view multilingualism in terms of language alone; it is a way of making people be diverse in feeling and in being. People



learn languages when they forge relationships, for instance. We can't forget that cultural character and emotional connections make people learn a language. Monolingualism is predominant in many Hindi-speaking States, irrespective of the three-language formula. Yogendra Yadav: The problem is the false sense of pride that many people in north India have developed, especially in Hindi-speaking areas, that somehow Hindi is a more privileged language than any other language. Many people in the north use the term 'national language', which is nowhere mentioned in the Constitution. This is what irks the non-Hindi speaker. The Hindi that we know today is a recent and young language, unlike Tamil or Kannada, which are some of the oldest and richest languages in the world.

T.M. Krishna: It is difficult to get data on this, but I would like to know how many schools in north India that profess to teach three languages really do that. Is the policy actually being followed?

Yogendra Yadav: As I said, in most north Indian States, Hindi is taught along with English and Sanskrit. Sanskrit has become a way to bypass the requirement of the third language. So, technically, yes, it is followed. T.M. Krishna: Exactly my point. There is a very important cultural point that needs to be understood about the Tamil people and the Tamil language. Tamil as a language is very distinct from every other Sanskrit-based or Sanskrit-derived language. Fundamentally, it is a very difficult task for a Tamil speaker people have learned other languages on their own. The dominant positioning of Sanskrit in the NEP, especially for a Tamil speaker, is intimidating especially when the language is so different grammatically and structurally. Yogendra Yadav: To position Sanskrit as the sole carrier of our cultural heritage is a serious mistake. Besides, Sanskrit is not being taught to inculcate classical learning, but mainly to sabotage the three-language formula. In effect, Hindi speakers are not learning a new language or

What do you propose is the way forward to end the current stand-off?

Yogendra Yadav: Learning three languages, which are distinct from each other, is a good idea to nurture multilingualism that is inherent in our cultures. But this cannot be imposed on anyone. Students should learn a modern Indian language that is distinct from their mother tongue. In the north, it would be "preferably a south Indian language" — exactly what the original formula had mandated and was never implemented.T.M. Krishna: The distinctness is exactly why I feel there should be only two languages. English is already so distinct from whatever language you speak, be it Hindi or Tamil. Therefore, adding another language is not going to help.

"As we scale we will continue to add more workforce," Rao noted. The London-headquartered company just launched the Nothing Phone (3a) series which has been strategically priced keeping Indian consumers in mind. "Starting at Rs 22,999, the Phone (3a) is what we expect will get the general consumers ticking who are looking for good overall performance with a best-in-class camera module," said Rao. On the other hand, if I talk about the Pro version, "we are hoping that those with inclination towards photography will make the pick considering the introduction of the 50 MP Periscope lens with Sony LYTIA 600 sensor which delivers lossless in-sensor zooming at up to 6x and when boosted with AI clarity-enhancing algorithms.

### Trai may restrict Starlink, satcom firms to mobile dark spot regions



With both Bharti Airtel and Reliance Jio forming strategic partnerships with Starlink, the Telecom Regulatory Authority of India (Trai) is now expected to expedite its recommendations on satellite spectrum pricing. Sources said that the regulator will likely recommend that satellite companies initially focus on providing services in mobile dark areas—regions where terrestrial networks are unavailable. This move could alleviate concerns earlier expressed by Jio and Bharti Airtel, among other telecom operators, that global satcom players, such as Starlink and Amazon Kuiper, might capture urban market share without participating in spectrum auctions.

Sources said that Trai's cautious approach is driven by the evolving nature of satellite communications technology. Currently, satellite signals cannot be received directly on standard mobile devices, and satcom services are significantly more expensive than conventional mobile plans. However, technological advancements could change this, therefore Trai wants to retain the discretion to make amends in a changed scenario. By restricting satellite services to areas lacking mobile coverage, Trai would be able to evaluate market dynamics and the role of satcom operators in bridging the digital divide. Given that satellite broadband is primarily intended to reach remote locations where fiber or wireless connectivity is unviable, this phased approach would enable it to test and monitor the effectiveness of satellite networks. Currently, five companies are vying to provide satellite Internet services: Eutelsat OneWeb, Jio-SES.

Starlink, and Amazon Kuiper. Bharti Enterprises-backed OneWeb and Jio-SES have already received regulatory clearances, whereas Starlink and Kuiper are still awaiting approvals.

Since satellite broadband services would be priced at a premium compared to fiber-based broadband, government subsidies might be required to make them affordable for the masses in rural and remote areas. A potential funding mechanism could be the Digital Bharat Nidhi initiative, which supports rural connectivity projects. According to estimates by Bernstein, Starlink's pricing is substantially higher —10 to 14 times —than the country's leading broadband providers. Based on current rates, a 50-200 Mbps Starlink connection would require an upfront payment of Rs 52,242, followed by a monthly charge of Rs 10,469. Including taxes and levies, the annual cost would amount to Rs 2,15,600. In contrast, fiber broadband plans from Airtel and Jio offering similar speeds cost between Rs 11,000 and Rs 15,000 annually

According to analysts, Starlink's direct-to-cell technology, which utilises specially designed satellites to function as space-based cell towers, could complement existing telecom networks. Instead of replacing conventional mobile services, this technology may enable Starlink to serve as a roaming partner for Airtel and Jio in remote regions. Since direct-to-cell technology requires access to telecom spectrum for compatibility with existing smartphones and terrestrial networks, any such arrangement would need regulatory approval and structured agreements with telecom operators. Bharti Enterprises chairman Sunil Bharti Mittal on Wednesday said that satellite technology should be integrated into the telecom sector under similar regulatory conditions. At the India Mobile Congress last year, Mittal joined Reliance Industries' chairman, Mukesh Ambani in advocating that satellite operators planning to serve urban consumers should be subject to the same licensing conditions as telecom operators. "If satellite companies want to serve elite urban consumers, they must acquire telecom licences, purchase spectrum, and pay licence fees just like telecom operators," Mittal had stated.

### Identify areas where US goods can be chosen over China, Govt asks industry

Amid fears of export disruptions due to US reciprocal tariffs set to take effect April 2, the Ministry of Commerce and Industry Thursday asked the industry to identify areas where sourcing from China and other countries can be replaced by American goods, executives familiar with the development told According to a statement from the Ministry, Commerce Minister Piyush Goyal said the government is working to protect exporters' interests while simultaneously pursuing multiple strategies to ensure the best outcomes for Indian exporters.On reciprocal tariffs, Goyal urged exporters to move beyond a "protectionist mindset" and encouraged them to be bold.

During a meeting with industry representatives Thursday, officials discussed the opportunities and impact of these tariffs. Steel and aluminium exporters informed the government that \$5 billion worth of goods have already been affected by Trump's 25 per cent tariffs on these metals, which took effect this week. "The Micro, Small and Medium Enterprises (MSME) sector is particularly concerned, as exports worth \$5 billion have been hit by Trump's recent tariffs. Total exports under Chapters 72/73/76 amount to \$5 billion. Chapter 73, covering iron and steel products, accounts for \$3 billion and is primarily driven by MSME exporters," said Pankaj Chadha, Chairman of the Engineering Export Promotion Council (EEPC) India. "Since the voyage time to the US is around 60 days, about \$1 billion worth of shipments are currently on the high seas and will be affected by this duty." Chadha said.

Industry representatives also provided input on market access that the government could offer the US in sectors such as textiles, gems and jewellery, carpets, and electronics. While the textile sector expressed willingness for zero-duty access on US products, the gems and jewellery sector urged the government to maintain a minimum 2.5



per cent duty on cut and polished diamonds, down from the current 5 per cent. Meanwhile, several exporters told the government that India is already receiving higher orders as key US suppliers such as China, Mexico, and Canada face steeper tariffs. "Apart from agriculture and few other sectors, these tariffs could work in India's favour, as we produce goods at much lower costs than the US. Even if tariffs are reduced for the US in certain segments, competitiveness is what matters," said a participant at the meeting. Meanwhile, the World Trade Organization (WTO) has warned that increased trade policy uncertainty and the prospect of new tariffs could weigh on trade in the medium term. "The latest reading of 102.8 for the barometer index is above both the quarterly trade volume index and the baseline value of 100. This would normally indicate that merchandise trade is above trend, with accelerating growth. However, rising trade policy uncertainty could have temporarily boosted trade as businesses and consumers front-load imports ahead of potential measures, possibly reducing demand later in the year. As a result, the barometer index should be interpreted with caution," the WTO said in its re-

### Trump 2.0's first sweeping tariff goes live, could increase dumping pressure on India

US President Donald Trump on Wednesday imposed his first across-the-board 25 per cent tariffs on steel and aluminium, which could increase dumping pressure in the Indian market, already experiencing a surge in steel supply due to Chinese overcapacity. The US tariffs escalation raises concerns over dumping in India as neighboring China would have 45 per cent effective tariffs on its steel and aluminium products in the US giving it higher incentive to look for other markets. Notably, Trump had announced a 20 per cent across-the-board tariff on Chinese imports prior to Wednesday.

Higher tariffs in the US market traditionally lead to dumping elsewhere, particularly in European and Indian markets, where steel demand currently exceeds domestic production capacity. During Trump's first term, the EU has imposed restrictions on steel and aluminium fearing trade diversion, hurting Indian exports. Minister of State in the Ministry of Steel, Bhupathuraju Srinivasa Varma, in response to a parliamentary question on a plan to impose a levy or tariff on imported steel, stated that the government has already introduced a quality control order banning substandard steel.

"Anti-Dumping Duty (ADD) measures on certain steel products—such as seamless tubes, pipes, and hollow profiles of iron, alloy, or non-alloy steel (excluding cast iron and stainless steel) from China PR; electro-galvanised steel from Korea RP, Japan, and Singapore; stainless steel seamless tubes and pipes from China PR; and welded stainless steel pipes and tubes from Vietnam and Thailand—are currently in place," Varma said in response to a question raised by Congress MPs M.K. Vishnu and Kalyan Kale on Tuesday. "Countervailing Duty (CVD) is in place for welded stainless steel pipes and tubes from China and Vietnam. Basic Customs Duty (BCD) has been reduced from 2.5 per cent to nil on ferro-nickel and molybdenum ores and concentrates, which are raw materials for the steel industry," Varma said in the response.

The think tank Global Trade and Research Institute (GTRI) noted that India imports more iron and steel (excluding finished products) and aluminium products from the US than it exports. This means that if India retaliates, the US would face a bigger impact in these sectors. India has a trade deficit in iron and steel, exporting \$494.2 million to the



US while importing \$842 million. In aluminium and aluminium products, trade is nearly balanced, with exports at \$859.8 million and imports slightly higher at \$898.9 million.

"Unlike in June 2019, when India responded to similar

US tariffs with higher duties on American goods, this time India appears unwilling to take countermeasures, despite the economic impact. Even though both countries have agreed to negotiate, these tariffs indicate that Trump has little regard for India's concerns. Given this, India should reconsider its engagement in trade negotiations," GTRI stated.US blanket tariffs increase the risk of a global trade slowdown, as the European Union—the world's largest trading bloc-has decided to retaliate against US tariffs. China, the second-largest economy, has already hit back with tariffs targeting US farm products. "In response to new US tariffs affecting more than Euro18 billion of EU exports, the Commission is putting forward a package of new countermeasures on US exports. These will come into force by mid-April, following consultations with Member States and stakeholders," the EU announced. It added that the countermeasures could apply to US goods exports worth up to Euro 26 billion, matching the economic scope of the US tariffs. "In the meantime, the EU remains ready to work with the US administration to find a negotiated solution. The aforementioned measures can be reversed at any time should such a solution be reached," the EU stated. Earlier this year, the World Bank warned that across-the-board US tariffs of 10 per cent could reduce already lacklustre global economic growth of 2.7 per cent in 2025 by 0.3 percentage points if America's trading partners retaliate with tariffs of their own.

## India 'super important' market, to discuss potential partnerships with IndiGo, Air India: Riyadh Air CEO Tony Douglas

Saudi Arabia's ambitious new airline Riyadh Air considers India a "super important" market and will explore potential partnerships with Indian carriers IndiGo and Air India in addition to its plans of operating flights between the two countries as passenger flows between India and Saudi Arabia are growing rapidly, Riyadh Air's Chief Executive Officer Tony Douglas said Wednesday. Saudi Arabia expects India to become its largest source market for tourism by 2030, and Indian nationals are already the biggest non-Saudi resident group in that country, making India a lucrative market for Riyadh Air. Douglas is in New Delhi as part of a Riyadh Air delegation for meetings with India's aviation regulator Directorate General of Civil Aviation (DGCA) to discuss the requisite permissions and support for launch of the airline's India operations. Douglas is also slated to meet top executives of IndiGo and Air India to discuss possible

The Riyadh-based full-service airline, which is Saudi Arabia's second national carrier alongside Saudi Arabian Airlines (Saudia) and is slated to start commercial operations later this year, has already forged partnerships with various global airlines including Delta Air Lines, Singapore Airlines, Turkish Airlines, Virgin Atlantic, China Eastern, Air China, and Egypt Air.Saudi Crown Prince Mohammed bin Salman is the force behind Riyadh Air, which aims to fly to

over 100 destinations by 2030. The airline has 39 wide-body Boeing 787 aircraft on order, with an option to expand the order size to 72 jets, in addition to 60 Airbus A321 narrowbody planes. According to Douglas, Riyadh Air currently has two major gaps in its airline partnerships — North-Western Europe and India — and it wants to cover those. Speaking to reporters in Delhi, while Douglas did not elaborate on the likely talks between Riyadh Air and the Indian airlines, he said that the conversations at this early stage would be mostly exploratory, and expressed keenness to forge partnerships in India as long as they are a "win-win" proposition for Riyadh Air as well as the potential partner airline. The Riyadh Air CEO is bullish on the Indian-Saudi Arabia air traffic and sees significant opportunities in both point-to-point traffic between Riyadh — which will serve as the airline's central hub — and India, as well as transfer traffic between India and Western destinations with the Saudi Arabian capital serving as a connecting hub.

But unlike other West Asian hub airports and their flagship airlines that connect flyers from India travelling onwards to destinations in Europe and North America in vast numbers, Riyadh Air feels that point-to-point traffic between India and Saudi Arabia will form the baseload of its India operations as travel demand between the two countries themselves is expected to surge in the coming years. Notably, India's aviation establishment wants to see homegrown carriers dominate international passenger traffic from and to India and major Indian airports transform into international hubs competing with major connecting hubs like Dubai and Doha. For this reason, India has been loath to expand the authorised capacity under bilateral air services agreements with various countries in Asia. But Douglas believes Riyadh Air and Saudi Arabia cannot be viewed from that lens. "Riyadh (airport) today has 93 per cent point-to-point (traffic) and there is only 7 per cent in Riyadh which is transfer (traffic)...that isn't going to fundamentally change anytime soon," Douglas said, adding that Riyadh is polar opposite to certain hub airports in neighbouring West Asian countries that have over 80 per cent of traffic as transfer traffic. "We (Saudi Arabia) are not using anywhere near the limit on the existing bilateral (flying rights between India and Saudi Arabia). There is plenty of headroom...At the moment we are not constrained by that," he said. Saudi Arabia targets to have 7.5 million visitors from India annually by 2030. The number of Indians travelling to Saudi Arabia increased by 50 per cent in 2023 to more than 1.5 million.

### Retail inflation drops to 7-month low in Feb, food inflation eases most since May '23; IIP grows by 5% in Jan

Retail inflation eased to a seven-month low of 3.61 per cent in February, compared to 4.26 per cent in the previous month, led by a sharp decline in food inflation, provisional data released by the National Statistics Office (NSO) on Wednesday showed. Food inflation, based on the Consumer Food Price Index (CFPI), fell to 3.7 per cent, the lowest since May 2023, when it was 3.19 per cent.

Factory output, as measured by the Index of Industrial Production (IIP), also grew by 5 per cent in January, compared to 3.5 per cent in the previous month, led by manufacturing of basic metals, refined petroleum products, and electrical equipment, quick estimates from the NSO showed. According to retail inflation measured by the Consumer Price Index (CPI), the headline inflation rate in rural India dropped to 3.79 per cent in February compared to 4.59 per cent in January. In urban India, too, headline inflation fell to 3.32 per cent from 3.87 per cent. On February 7, the Reserve Bank of India (RBI) had reduced the reporate by 25 basis points (bps) to 6.25 per cent after keeping it unchanged for two years. With further easing of headline inflation in February, comfortably within RBI's band of 4+/- 2 per cent for medium-term inflation targeting, the central bank could consider another rate cut in the next meeting of its six-member Monetary Policy Committee (MPC) in April.

"The RBI started its rate cut cycle in February and today's inflation print gives space for the RBI to deliver another 25 bps rate cut in April. Beyond that, a 25 bps rate cut could be delivered in the June or August policy depending on incoming data. We see cumulative rate cuts of 50-75 bps in this cycle for now," HDFC Bank's Treasury Research Desk said in a note. The inflation rate for the food and beverages segment, which accounts for 45.86 per cent of the total weight of CPI, was registered at 3.84 per cent in February, 4.05 per cent for rural and 3.44 per cent for urban. Food items such as ginger, tomato, and garlic recorded the lowest year-on-year inflation at -35.81, -28.51, and -20.32 per cent respectively. Overall, the inflation rate for vegetables was registered at -1.07 per cent.

"However, we believe that the sequential uptick in vegetables inflation in March 2025 is likely to prevent a further softening in the food and beverages inflation print in the month, after the substantial cooling seen over the past four



months. This would push up the CPI inflation print mildly to ~3.9-4.0 per cent in the next month. Overall, the CPI inflation is now expected to average at 3.9% in Q4 FY2025, well below the MPC's projection of 4.4 per cent for that quarter," rating agency ICRA's chief economist Aditi Nayar said. "The problem areas appear to be fruits and vegetable oils. The latter has also been affected by the volatile rupee which has pushed up imported cost," Madan Sabnavis, chief economist at Bank of Baroda, said. The inflation rate for fruits was registered at 14.82 per cent and for oils and fats at 16.36 per cent in February. On the industrial output front, manufacturing, which accounts for 77.6 per cent of the weight of the IIP, grew by 5.5 per cent in January against 3.4 per cent in December. Mining output recorded a growth of 4.4 per cent against 2.7 per cent in December, whereas electricity output was up 2.4 per cent against 6.2 per cent in the preceding month. Growth in output of capital goods an indicator of investment — declined slightly to 7.8 per cent from 10.4 per cent in December. The growth rate was high compared to 3.2 per cent in January 2024. "At the usebased level, the two lead indicating sectors in IIP - basic goods and intermediate goods – grew more than 5 per cent after a gap of five months. This along with capital goods, infrastructure goods and intermediate goods growing at more than 7 per cent in January 2025 are pointers towards nascent stage of broad-based recovery. However, this should not be treated as full industrial recovery as we have witnessed in the past most of the times, these recoveries fizzle out quickly," Devendra Kumar Pant, chief economist

### Musk's Tesla wants to sell these two models in India

New Delhi: Elon Musk-led Tesla Inc has initiated the process for the certification and homologation of two of its electric cars in India, which is an essential requirement for all vehicles before they can be sold in the country. Tesla India Motor & Energy Pvt Ltd, the local unit of Musk's firm, has submitted two new applications for homologation of the Model Y and Model 3 cars in India, according to industry sources. Homologation is the process of certifying that a vehicle is roadworthy and meets the norms laid out for all vehicles manufactured in India or imported into the country. The tests ensure that the vehicle matches the requirements of the Indian market in terms of emission and safety and roadworthiness in accordance with the Central Motor Vehicle Rules. The company had earlier submitted seven applications for homologation in India earlier which were meant for test cars. An eighth application was approved recently. The move comes amid talks with the US and India on a free trade agreement under which tariffs are expected to be lowered by both countries to enhance bilateral trade. Musk has been keen to enter India as he is looking for a foothold in the world's third-largest car market as an alternative to China after the communist country came under strict US sanctions. While the Indian government is keen that Musk set up a plant in India to make Tesla for the local market, the billionaire wants to export the car to the country without any immediate manufacturing plans. Electric car



sales in India recorded a 20 per cent jump to 99,165 units in 2024, from 82,688 units in 2023. Tata Motors and JSW MG Motors are currently the market leaders. In addition, the luxury electric vehicle market also posted an increase in sales during the year, with 2,809 EVs sold by BMW, Mercedes Benz India, Volvo Cars India, Audi and Porsche in 2024, up from 2,633 units in 2023. According to the Federation of Automobile Dealers Associations (FADA), the electric passenger vehicle retail sales in India grew by nearly 20 per cent. The EV market is expected to continue growing, with industry forecasts predicting a compound annual growth rate (CAGR) of 43 per cent. The electric two-wheeler segment recorded significant growth, with 1.13 million units sold in 2024, up from 8,60,000 units in 2023.

### Para Athletics GP not a one-off, we are in India for the long haul: WPA

The lack of sufficient top-level international participation in India's maiden Para Athletics Grand Prix event was not a concern for the world body with officials confident of things getting better in the coming years. World Para Athletics (WPA) Competitions Head Martin Chorley, while admitting it was a much smaller event both in scale and participation compared to other WPA competitions, insisted that the timing was as much a reason as uncertainty about the organisation. "Considering that the contract was signed only last December, it's fantastic to organise and deliver the event to the levels expected and it gives me confidence moving forward for the World Championships in September," Chorley said on the sidelines of the final day's action at the Jawaharlal Nehru Stadium here on Thursday. "More importantly, it is a chance for many of the youngsters, both Indian and from overseas, to experience what international competition is all about, get used to bigger events and get guaranteed classification opportunities. At the same time, this is only the beginning. It's a multi-year contract for the entire paralympic cycle of four years, a pathway to bigger

events, not a one-time thing where India will just host this and the World Championships and be done with major events," he explained. Asked about the way forward in terms of improving the organisation, Chorley was optimistic. "The local organising committee has been very willing to make changes and address the issues in the run-up to the Worlds, take suggestions and improve. Already the teams and athletes here this time have been pleasantly surprised with the facilities and many will be coming in September. Once they see what facilities India has, and with the proposed track and the stadium refurbishments, I am sure they will come in much higher numbers in 2026," he hoped. Meanwhile, Vanessa Low did not disappoint, the Australian taking top spot in the women's Long Jump (T38, T44, T61) category despite a below par 4.96m jump in the three-competitor event. Vanessa, who set a new world record of 5.45m in her category at the Paris Paralympics, had only three legal jumps but they were enough to beat the other two participants - Zhana Fekolina of Russia, participating here as a neutral para athlete like many others since the suspension of Russia and Belarus from the Olympic programme, and India's Bhavani Munniyandi.

Among the men, Para Asian Games medallist Ravi Rongali finished third in the shot put (F40-41) category with a best throw of 9.89m, behind Russians Denis Gnezdilov (11.36m) and Aiaal Sivtsev (12.10m). Indian-American U.S. Congressman Shri Thanedar also attended the event and urged the U.S. to condemn 'human rights violations' in Pakistan against Hindu minorities and demand quick actions against Pakistan to ensure that these atrocities stop. The Australian had a tough time against Bumrah in the series scoring just 72 runs in 3 matches and getting sent back by the Indian pacer 4 times out of 5. He would then be dropped from the Australian side for the last 2 Test matches. Meanwhile, Bumrah was the Player of the Series against Australia in the BGT, bagging 32 wickets across five Tests. However, he sustained a back injury in the series and could not bowl in the second innings of the 5th and final test.

The work begins long before the IPL, during the 7-10 days of preparation. I try to spend as much time as possible outside my room, talking to my players and coaches, building that camaraderie. And then, we embark on the journey together as a unit. That's where the joy of being a captain comes in," he added. In the IPL auction last year, Rajasthan managed to secure Jofra Archer, Maheesh Theekshana and Wanindu Hasaranga while also adding the likes of Akash Madhwal and Kumar Kartikeya Singh into their ranks. They also brought in 13-year-old Vaibhav Suryavanshi who scored 104 off 62 balls in India Under-19's Youth Test against Australia in Chennai last year.

### Stuart Broad says England should not make Ben Stokes ODI captain – 'Would be lost for words'

While England are in search of a new ODI captain, former seamer Stuart Broad has cautioned against taking a backward step in appointing Test skipper Ben Stokes as leader of the 50-over side. After England's harrowing leaguestage Champions Trophy exit and Jos Buttler's resignation from captaincy, ECB managing director Rob Key had suggested Stokes among the potential candidates for the ODI captaincy. "Ben Stokes is one of the best captains I've ever seen. So it would be stupid not to look at him. It's just the knock-on effect of what that means," Key told reporters last week. "I think nothing's off the table really. You look at every single option and you think, right, what is the best thing to do? How is that going to impact on other things?While Stokes had previously hinted at returning for the Champions Trophy, a hamstring tear during last year's New Zealand tour doused the plans. Stokes has not featured in a 50-over match since the 2023 ODI World Cup, a tournament for which he had returned from retirement. As Stokes' name is making the rounds for a potential ODI leadership role, his former teammate Broad cautioned against the move.

'Going for Stokes would be a move of desperation. I would be lost for words if England appointed him," Broad told Daily Mail. "Firstly, there is the schedule. He's not going to the Indian Premier League to try to prioritise the Test match team and get his physicality right for the big events on the horizon. How many overs has Stokes bowled successfully in the last three years while battling his knee injuries? Not many. "And you're going to add another eight to 10 overs in a 50-over format onto his workload? The mathematics of that make no sense. As someone who played 121 one-day internationals I can honestly say I found the 50-over format more tiring than Test match cricket. Why? Because it's such high intensity. "You bowl 10 overs in three and a half hours, during which you are running from fielding positions, sprinting after balls all the time, non stop. Ben Stokes is the best captain we've got, but it doesn't mean he's the right person to do the 50-over job," Broad remarked. Stokes will have a busy year ahead of him on the Test front with two heavyweight five-match Test series loaded against India at home and the Ashes in Australia later this year. England will next play a three-match ODI series against West Indies at the end of May.



Half-Daddies Hendra Setiawan is now coach and saw the immediate impact as Sabar Karyaman Gutama and Moh Reza Pahlevi Isfahani mentored by him made Last 8, first beating Olympic silver medallists Liang-Wang and then getting rid of second Chinese Huang-Liu.

Mixed doubles have interesting names lining up. The Mairs couple from England, Jenny and Gregory. And the Indonesian disruptors – Rehan Kusharjanto who mans the net, and the super tall Gloria Widjaja who attacks incessantly from the back.

While the number of fraud cases is on the rise, with even public servants and celebrities falling victim to scammers and losing large sums of money, a Malayalam actor narrowly escaped being duped by fraudsters who attempted to extort money from her through a fake casting call, claiming that she had been selected to play Superstar Rajinikanth's wife in a Tamil film. Actor Shiny Sarah, who made her on-screen debut with a notable role in director Dileesh Pothan's Fahadh Faasil-starrer Maheshinte Prathikaram (2016), opened up about the incident in a self-shot video shared on the social media handles of her friend, fellow actor Maala Parvathi.

"The other day, I received a message on my WhatsApp number saying that my application through a casting agency has been accepted. They informed me they were looking for actors who could play Rajinikanth's son's wife in Jailer 2. They then asked me if I had an artiste card. When I said we don't have such a card in Mollywood, he said they would make arrangements for the same. He then informed me that I would receive a call from a man named Suresh Kumar. I got a call two days later asking me to wear a saree and appear for a video call interview," she shared, OnManorama reported. Rekhachithram | How a Rs 9 crore film, Al Mammootty succeeded where big-budget 'spectacles' GOAT and Indian 2 fell short"Suresh Kumar introduced himself and said I was selected for the role of Rajinikanth's wife. I was confused since actor Ramya Krishnan already plays the wife of Rajinikanth in Jailer. When I asked him about that, he said I was being considered for another film. He then told me he was sending an application for my artiste card via email and asked me to share my Aadhaar card details and photo," she added. Shiny initially shared the requested details but soon became suspicious when he demanded an immediate payment of Rs 12,500 for the artiste card. When she explained that she needed at least two days to arrange the money, he insisted on receiving a partial payment right away. This deepened her doubts, prompting Shiny to reach out to her actor friends Maala Parvathi and Lijomol, both of whom had prior experience in Tamil cinema. Since they were unavailable, she eventually contacted another artiste, who informed her that such a process did not exist in the Tamil film industry. "Many people have fallen victim to such a fraud. People need to be careful," she warned. His passion reflected in Dangal's quality and its success," expressed Tiwari.Lagaan: Once Upon a Time in India (2001) created history by becoming a box

Toh sahi hai na mehnat karo bhai. (These people earn double the money, so they must do the hard work). I'm getting paid to laugh, and they're getting paid for their hard work. Some get paid for their beauty, others for their talent, but I get paid for all of that," she said.

## Dino Morea knows his worth, recalls feeling insecure when offers dried up: 'I am not at the top'



Actor Dino Morea entered the Hindi film industry just before the turn of the century. After making his mark in the fashion sphere, the supermodel turned to acting with the Raj Kaushal film Pyaar Main Kabhi Kabhi (1999). His next film, Raaz (2002), made him an overnight sensation, and he received high praise for his role. His career slowed down in the 2010s, which prompted him to diversify.

In a recent interview with Pinkvilla, the actor shared the insecurities that he faced after the offers started drying up. He also shared the importance of staying in touch with reality. "When you are sitting at your home and waiting for the offers, sometimes you do bad roles just to remain relevant for the audience," said the actor.

Dino stated that when he entered the industry, playing the lead role was much more important compared to now. He said that in the current scenario, there are no 'lead roles, just characters,' and that the industry has evolved. "Now you can't go around thinking you're the lead role or you deserve one; you need to face reality," the actor added that he understands his current worth in the industry, and that is the reason why he is doing smaller roles more often.

He said that his parents taught him to be kind and humble to everyone, because you never know when you might need their help. When asked whether he ever needed monetary help from his parents during his low phase, Dino replied that he was the one taking care of his parents. "I did not want to choose the wrong movies, but in order to do that you need to earn money from somewhere else, like a business," he said. The actor has made a return since the 2020s, working in Telugu and Malayalam films like Agent and Bandra, and was also seen in the web series The Empire. He was last seen in Mere Husband Ki Biwi alongside Bhumi Pednekar and Arjun Kapoor.
