RTC unions to go on complete strike from May 6

Hyderabad: The unions of Telangana State Road Transport Corporation (TGSRTC) on Monday announced state-wide strike from May 6. The RTC workers submitted the strike notice to the Labour Commissioner and the Corporation's Managing Director, VC Sajjanar at Bus Bhavan on Monday. The JAC (Joint Action Committee) of RTC workers stated that the RTC staff will boycott duties from May 7, if their demands are not accepted. Vexed over the State government's apathy towards RTC employees, the TGSRTC union members said that none of their demands have been met so far by the State government. This is the first time after five years that the RTC unions are resorting to strike. Earlier, too, they had issued strike notices to the government and the corporation management. The union leaders had expressed dissatisfaction over the State government's inaction on promises made to the Corporation employees, despite being in power for over 16 months. No wage revisions and nonpayment of dues are forcing the workers to protest. The union leaders accuse the State government of neglecting their promises made during the election campaign, including those of the TGSRTC's merger with the government, removal of restrictions on trade unions and immediate implementation of wage hikes. Additionally, they alleged that their salaries are also not being creditedThey lamented that deploying electric buses as part of RTC is putting thousands of jobs at risk. These buses, they allege are maintained by private operators. The union leaders have warned the State government of intensifying their protests Statewide if their demands are not met.

SCR registers highest-ever revenue of Rs 20,452 crore

Hyderabad, April 7: South Central Railway has been consistently performing well during the last three financial years and has registered the best figures in terms of Revenue by achieving the highest ever Gross Originating Revenue of Rs 20,452 crore, backed by the excellent performance in both freight and passenger segments. This is also Rs 117 Crores more than the previous best of Rs 20,335 Cr achieved in 2023-24, followed by Rs 18,973 Cr registered during 2022-23

One of the major factors for this achievement is the major thrust given by the Zone towards freight segment. Fight not over yet

The Waqf (Amendment) Act, 2025, has sparked a storm of protest from Muslim organisations across the country. The All India Muslim Personal Law Board (AIMPLB) has called the Act unconstitutional, vowing to challenge it legally in the Supreme Court and launch a nationwide agitation to seek a repeal of the Act. At the heart of the opposition lies the inclusion of non-Muslim members in Waqf boards and the Central Waqf Council — seen as a dilution of Muslim control over religious endowments. More troubling, however, is the provision empowering the government to determine the ownership of Waqf properties in the absence of documents, raising fears of arbitrary takeover of historical religious sites.

The board is especially critical of political parties like the JD(U), TDP and LJP (Ramvilas), which, despite their secular claims, voted for the Bill. The AIMPLB also sees the legislation as a deliberate move to weaken Muslim institutions under the guise of reform. It plans to fight it legally and politically, through street-level campaigns and democratic mobilisation. A phased agitation will involve outreach to minority bodies, jurists, Opposition parties and the public at largeHowever, the government maintains the changes are aimed at transparency and curbing corruption. Minority Affairs Minister Kiren Rijiju has defended the move as necessary reform. But many in the Muslim community fear it is part of a broader strategy to erode autonomy of their religious affairs. With Muslims forming 14 per cent of the population, the law has struck a nerve, potentially stoking communal resentment. If the government does not engage in inclusive dialogue, the confrontation could deepen societal divides

Telangana officials object to Banakacherla project at GRMB meeting

Hyderabad, April 7 : The Godavari River Management Board (GRMB) meeting saw intense debates among the irrigation officials from Telangana and Andhra Pradesh. Chaired by AK Pradhan, the meeting took place at Jal Soudha on Monday and lasted over three hours, focusing on water distribution and projects related to the Godavari River. During the session, the Telangana representatives raised their concerns regarding the Banakacherla and Godavari interlinking initiatives. Telangana's irrigation officials accused the Andhra Pradesh government of withholding critical information about the Godavari-Banakacherla project. Telangana's Principal Secretary for Irrigation, Rahul Bojja, along with Engineer-in-Chief Anil, voiced their objections to the Banakacherla project. They highlighted that it has been five months since the GRMB received correspondence from the Union government, yet no updates have been provided. Telangana officials have claimed that Andhra Pradesh is proceeding with the Banakacherla project without the necessary authorisation. They have requested the

Board to furnish comprehensive information about the project, including its effects on Telangana. In response, officials from Andhra Pradesh clarified that the Detailed Project Report (DPR) for the Banakacherla project is still in the planning stages and has not been finalised. The meeting also discussed the modernisation efforts for the Pedavagu project, where it was agreed to initiate urgent repairs at an estimated cost of Rs. 15 crore.During the meeting, Telangana officials raised concerns about the conduct of GRMB Secretary Ajageshan, asserting that board meetings are being conducted without adequate consultation with the states. They further expressed grievances regarding the treatment of officers from both Andhra Pradesh and Telangana who are on deputation at GRMB, citing harassment and inappropriate language directed at female employees.Representing Andhra Pradesh, Engineer-in-Chief Venkateswara Rao from the Water Resources department, along with other officials, took part in the meeting.

If any dealer or official is found guilty of malpractice, strict action will be taken," he warned.

Shabbir Ali also noted that the distribution of new ration cards and enrolment of eligible beneficiaries was underway to ensure that no deserving family is left out. Kamareddy Additional Collector Victor, along with RDO, MRO, MPDO, Congress leaders, and several party workers were present at the event. Earlier in the day, Shabbir Ali launched the 'Jai Bapu, Jai Bhim, Jai Samvidhan' campaign with a Constitution Protection Padayatra in Machareddy. The march culminated in a public meeting at the Shabbir Ali Function Hall, where Kamareddy in-charge Kathi Venkataswamy also participated. Pakistan stock exchange plunges over 8,000 points

Karachi: Trading was suspended at the Pakistan Stock Exchange (PSX) for an hour as the benchmark KSE-100 index plummeted by more than 8,000 points on Monday.

Financial analysts blamed the fear of a global recession for the massive fall in the stock exchange. Even after a cooling period of one hour, the PSX lost another 2,000 points when trading resumed, resulting in a record 8,600 points drop in intraday trade.

The index closed at 114,909.48, down by 3,882.18 or 3.27 per cent, from the last close. Uzma Khan, financial analyst at Arif Habib Securities, said the automatic circuit breakers are designed to prevent panic selling and provide investors time to reassess during extreme market volatility.

She said that investors are worried about a global recession due to the tariff hikes by the United States and retaliatory measures from other global economies.

The benchmark KSE-100 index initially declined by 6,287.22 points, or 5.29 per cent by 11:58 am, before trading was halted. Shortly after reopening, it declined by a cumulative 8,687.69, or 7.31 per cent, from the last close to stand at 110,103.97 at 1:15 pm. At 2:02 pm, the index stood at 113,154.63, down by 5,637.03 or 4.75 per cent from the last close.

An ASHA, a self-styled doctor, accused involved in a bank robbery: How Barnala police cracked the kidnapping of a toddler

The police in Punjab's Barnala Monday claimed to have cracked the case of the kidnapping of a two-year-old child from the slums behind the grain market in the city within three days with the arrest of all nine accused. Among those arrested are Ravinder Kaur, an Accredited Social Health Activist (ASHA) based in Ludhiana; self-styled doctor Vikas Tiwari, who runs a hospital; Kaur's son Kohinoor Singh; Damanpreet Singh; and Aditya. Damanpreet and Aditya were involved in an Rs 8 crore bank robbery in Ludhiana in June 2023 and have been out on bail since January 12, 2024

The other accused who were arrested include Manav Arora, Davinder Singh, Rohit, and Dashrath, who was booked in another case of kidnapping a child in Madhya



from Anaj Mandi, Barnala on a motorbike, and handed him Singh and Davinder S over to hinoor to Ludhiana.Sidhu said they also traced a few locations in Rajasthan, and sent a team to the state. A team also went to Madhya Pradesh.

Congress terms Waqf Bill unconstitutional, vows legal battle

Hyderabad, April 7 : The TPCC on Monday launched a scathing attack on the BJP Central government over the controversial Waqf (Amendment) Bill, 2025.Addressing mediapersons at Gandhi Bhavan on Monday, TPCC official spokesperson Syed Nizamuddin, termed the legislation a direct assault on constitutional rights, religious autonomy, and minority identity. He announced that the Congress party would challenge the Bill in the Supreme Court and mobilise democratic resistance on the ground. "The Congress party fought the Bill in Parliament clause by clause, line by line. It was not ordinary opposition - it was a constitutional duty. Despite this, the BJP government rammed it through both Houses without serious debate," Nizamuddin said. Highlighting the depth of Congress's commitment, he said party leader Sonia Gandhi returned to the Rajya Sabha at 1 am to vote against the Bill at around 2.30 am. "That act itself is a message to the nation - that we will not remain silent when the rights of any community are under threat," he said. He termed the Wagf (Amendment) Bill, 2025 as unconstitutional, anti-minority, and a calculated attempt to interfere in Muslim religious affairs. "Waqf is a centuriesold Islamic institution meant for community welfare - education, healthcare, religious duties. The inclusion of non-Muslim members in Waqf Boards violates Islamic jurisprudence and is an affront to religious autonomy," he said.

He also challenged the government's claim that the Bill was reviewed by a Joint Parliamentary Committee

(JPC). "The JPC process was eyewash. All suggestions from Congress and opposition parties were summarily rejected. There was no consensus, no real consultation, and no regard for legal or community voices. This was bulldozing of parliamentary norms," he said. He further pointed out that under the amended law, any official can serve notice asking for documents related to a Waqf property. "In case of old mosques or graveyards where documents are unavailable, the government can simply take over the property. This is not reform - this is institutionalised land grab," he warned

Calling out the larger political motive, he said the Bill was part of the BJP's systematic effort to marginalise Muslims in every sphere - education, economy, representation, and now, religious institutions. "Instead of strengthening Waqf Boards with proper audits and accountability, the government wants to capture and control them. The absence of Muslim voices in decisions regarding Muslim endowments is nothing short of discrimination," he said. He added that Telangana, particularly Hyderabad, has a rich legacy of communal harmony and is home to hundreds of Waqf institutions. "We appeal to people of all faiths - Hindus, Muslims, Sikhs, Christians - to recognise what this Bill represents. Today it's Waqf. Tomorrow, Christian institutions and Sikh gurudwaras will face similar interference," he cautioned. "The BJP is dismantling the very fabric of our secular democracy

The police said Ravinder Kaur, ASHA, allegedly confessed that she planned to sell the child to a childless couple through Tiwari for Rs 2 lakh.Mohammad Sarfaraz Alam, Senior Superintendent of Police (SSP), said they acted swiftly and successfully cracked the case. The child was handed over to his parents Monday morning. According to the police, the accused allegedly kidnapped the child on a motorbike, transferred him into a car, and took him to Ludhiana to Vikas Tiwari's hospital.

The police said Kohinoor Singh, Aditya, and Damanpreet Singh played key roles in executing the plan. Manav Arora and Damanpreet Singh kidnapped the child

In a joint operation, the Punjab and Madhya Pradesh Police nabbed Davinder, Rohit, and Dashrath Singh from Suwasara in MP's Mandsaur. Damanpreet Singh (alias Aman alias Phooli), Aditya (alias Nanni), Manav Arora, Ravinder Kaur, and Vikas Tiwari were arrested in Ludhiana. The Barnala police said when they reached Suwasara, they found the accused had set up a place for some ritual, which they suspect to be associated with the occult. They added the kidnapper had shaved the child's head, which investigators believe might be linked to the "tantrik setup". The police also recovered a motorbike and a Honda Amaze car using technical input. The Puniab Police announced cash rewards and promotions for the investigating officers. Additionally, they said officers would sponsor the child's education in the best school in Barnala until Class 10. The core investigation team included Sandeep Singh Mand, Superintendent of Police (Investigation), Barnala, Satvir Singh, Deputy Superintendent of Police (Sub-Division), Barnala, Inspector Baljit Singh, In-charge CIA Staff, Barnala, Inspector Lakhwinder Singh, Station House Officer (SHO) City, Barnala, and ASI Charanjit Singh, In-charge Bus Stand Police Post, Barnala.A case was registered under Sections 140(3) and 111(2)(II) of the BNSS at the City Barnala Police Station.

MEA notifies 3,281 illegal travel agents across country till Feb 2025; Congress **MP Kumari Selja questions figure**

The Ministry of External Affairs (MEA) has notified 3,281 illegal travel agents from across the country till February 2025 on the eMigrate portal of the Government of India. The figures were revealed by the ministry in Lok Sabha on April 4 in response to a question by Sirsa MP and AICC general secretary Kumari Selja.Selja expressed surprise over the ministry's response and said it appeared that the MEA "does not have accurate data on illegal travel agents." In a statement issued on Monday, she said: "In India, in 2020, there were more than 2,50,000 small-sized travel agents. The Indian travel agent market size in 2020 was approximately 38 billion USD, which is estimated to exceed 67 billion USD by 2027. Instead of a decrease, the number of illegal travel agents has increased since 2020. The data provided by the Ministry [3,281 illegal travel agents] could be found only in Punjab alone."

In her statement to the media, Selja said that if the central and state governments had taken strict action against illegal travel agents, millions of families could have been saved from devastation. "Youth used to sell their homes, land, and shops to go abroad via the 'dunki' route, only to end up without jobs and forced to work as bonded labourers, where they faced physical, mental, and financial exploitation," she stated."There is a rampant presence of illegal travel agents, including those in Haryana, who have been notified on the eMigrate portal. On the other hand, the youth, who are desperately searching for employment and dreaming of going abroad, are falling victim to these illegal agents," she said in her statement. "The youth are spending Rs 50 lakh each on average and heading abroad via the 'Dunki route' in search of jobs, only to be deported like criminals with handcuffs. This is the most shameful situation for the country. The government should collect accurate data on this issue and take strict action against illegal agents," she added. The MEA, in its response, also cited various steps taken to prevent illegal migration. "The Ministry has conducted awareness campaigns on safe and legal migration through workshops, training sessions, informational meetings, media groups, police officers, law enforcement agencies, local administrations.



Israel's PM Benjamin Netanyahu in Budapest despite international arrest warrant as Hungary says it will quit ICC

Israeli Prime Minister Benjamin Netanyahu arrived in Hungary's capital early on Thursday (April 3, 2025) to red carpet treatment despite a warrant for his arrest issued by the world's top war crimes court. It was only the second foreign trip Mr. Netanyahu has made since the International Criminal Court (ICC) issued the warrant against him in November. As Mr. Netanyahu arrived in Budapest, Hungary said it will begin the procedure of withdrawing from the ICC. "The government will initiate the withdrawal procedure on Thursday, in accordance

with the constitutional and international legal framework."Mr. Netanyahu was greeted with full military honours in the Castle District of the capital Budapest, where he stood alongside Mr. Orbán as a military band played and processions of soldiers on horseback and carrying swords and bayoneted rifles passed by. The two leaders were set to hold talks later on Thursday (April 3). Mr. Netanyahu will spend several days in Hungary before departing on Sunday (April 6). The ICC, based in The Hague, Netherlands, said there was reason to believe Mr. Netanvahu and former Israeli Defence Minister Yoav Gallant used "starvation as a method of warfare" by restricting humanitarian aid to the Gaza Strip, and intentionally targeted civilians in Israel's campaign against Hamas - charges that Israeli officials deny. Member countries of the ICC, such as Hungary, are required to arrest suspects facing a warrant if they set foot on their soil, but the court has no way to enforce that and relies on states to comply.After the ICC issued the warrant in November, Mr. Orbán accused the world's only permanent global tribunal for war crimes and genocide of "interfering in an ongoing conflict for political purposes", saving the move undermined international law and escalated tensions.

His invitation to Mr. Netanyahu was in open defiance of the court's ruling. Hungary joined the court in 2001 during Orbán's first term as prime minister.Mr. Netanyahu in February met U.S. President Donald Trump in Washington, where Mr. Trump suggested that displaced Palestinians in Gaza be permanently resettled outside the war-torn territory and proposed the U.S. take "ownership" in redeveloping the area into "the Riviera of the Middle East". Neither the United States or Israel are signatories to the ICC. Mr. Trump in February issued sanctions against the court for its investigations into Israel's conduct of the war in Gaza which has killed tens of thousands of Palestinians, many of them children.

China vows 'countermeasures' to sweeping new U.S. tariffs

China on Thursday (April 3, 2025) said it "firmly opposes" sweeping new US tariffs on its exports, vowing "countermeasures" to protect its rights and interests.U.S. President Donald Trump has ignited a potentially ruinous global trade war after imposing 10% levies on imports from around the world and harsh extra duties on key trading partners.Mr. Trump unveiled particularly stinging tariffs of 34% on China, one of its largest trading partners. The commerce ministry in Beijing said in a statement that those tariffs "do not comply with international trade rules and seriously harm the legitimate rights and interests of the relevant parties". It urged Washington to "immediately cancel" them, warning they "endanger global economic development", hurting U.S. interests and international supply chains. It also accused the United States of a "typical unilateral bullying practice". The tariffs come on top of a 20% rate imposed last month

At a weekly briefing Thursday, the Commerce Ministry slammed Washington's "protectionism and bullying".But it also said that the two sides were "maintaining communication" over sources of contention in trade and economic issues.Beijing's Foreign Ministry also warned the United States that protectionism has no "exit ramp" and noted the broad international opposition to the measures. China previously responded to U.S. tariffs with levies of up to 15% on a range of U.S. agricultural goods including soybeans, pork and chicken. Chen weniing, chief economist at the China Center for International Economic Exchanges in Beijing, told AFP that Beijing could potentially impose export controls of critical and rare minerals to the United States in response."The United States has become a high-tariff nation, and its status as the flagbearer of free trade has diminished," Mr. Chen said.U.S. duties have threatened to harm China's fragile economic recovery as it struggles with a long-



running debt crisis in the property sector and persistently low consumption.'No winner in a trade war'An intensified trade war will likely mean China cannot peg its hopes for strong economic growth this year on its exports, which reached record highs in 2024.Mr. Trump labelled Wednesday's measures "reciprocal" but many experts say his administration's estimates for levies placed on U.S. imports by other countries are wildly exaggerated.

"The U.S. claims to have suffered losses in international trade, using so-called 'reciprocity' as an excuse to raise tariffs on all trade partners," Beijing said. "This approach disregards the balance of interests achieved through years of multilateral trade negotiations and ignores the fact that the US has long profited significantly from international trade," it added. It instead called for "dialogue" to resolve the dispute. "There is no winner in a trade war, and there is no way out for protectionism," it said, adding that "history has proven that raising tariffs does not solve the U.S.'s own problems". The U.S. has also imposed tariffs of 25% on steel and aluminium imports. China is the world's leading steel manufacturer, though not a major exporter of the product to the United States.

The chart indicated that India charged 52% tariffs "including currency manipulation and trade barriers," and America would now charge India a "discounted reciprocal tariff" of 26%. Earlier, a senior White House official had told reporters that the president would impose a "baseline" tariff on all imports to the U.S. That rate is set at 10% and will go into effect on April 5. Some countries will only face the base rate. These include: United Kingdom, Singapore, Chile, Brazil, Australia, New Zealand, Turkiye, Colombia, Argentina, El Salvador, United Arab Emirates, Saudi Arabia, among others.White House officials also said that they would impose what they describe as custom reciprocal tariffs on roughly 60 of the "worst offenders". These will go into effect on April 9. The key trading partners subject to these customised tariff rates include: The reciprocal tariffs will not apply to specific goods such as copper, pharmaceuticals, semiconductors, lumber, bullion, energy, and "certain minerals that are not available in the United States", according to a White House fact sheet.

Trump's tariffs target tiny Australian islands, including some with no people

Australia's remote, uninhabited islands in the Antarctic and a tiny territory with barely any exports found themselves caught up alongside global heavyweights in U.S. President Donald Trump's sweeping tariff regime, leaving locals and officials baffled. Richard Cottle, owner of a concrete-mixing business on Norfolk Island, said on Thursday (April 3, 2025) there was only one explanation when Trump unveiled a hefty 29% tariff on the tiny territory about 600 miles off eastern Australia: "it was just a mistake". Though the rugged volcanic island in the southern Pacific does ship a modest amount of Kentia palm seeds abroad, typically worth less than \$1 million a year, mostly to Europe, news of the unusually steep tariff passed through its 2,188 residents on Thursday with a mixture of amusement and confusion."Norfolk Island is a little dot in the world," said Mr. Cottle by phone. "We don't export anything."

Norfolk Island was among dozens of tiny territories which appeared on the same list as China and the European Union as recipients of Mr. Trump's highly anticipated tariff regime, even though they do not have a real manufacturing or export industry.No humans on Heard, McDonald IslandsSome, like the Heard and McDonald Islands in the Antarctic, which like Norfolk Island is overseen by Australia, did not even have human inhabitants. No matter - as of Thursday, they faced a 10% tariff for exports to the U.S.Australian Prime Minister Anthony Albanese, on the campaign trail ahead of an election in a month, told the media his country did better than most with a tariff of 10% - half of what the EU was hit with and one-third of what China got but he had no explanation for Norfolk Island."Last time I looked, Norfolk Island was a part of Australia," he told the Australian Broadcasting Corp. The separate, higher tariff "was somewhat unexpected and a bit strange", he added.According to U.S. government data, the U.S. has



recorded trade deficits with Norfolk Island for the past three years. The island exported \$300,000 worth of goods to the U.S. in 2022, \$700,000 in 2023 and \$200,000 in 2024. Its imports from the U.S. stayed at \$100,000 in those years.

Norfolk Island's imports from the U.S. peaked at \$11.7 million in 2020, when no exports were recorded. The data did not specify what goods were traded. Other Norfolk Island business owners who spoke with Reuters could think of no manufacturing industry on the island, and added that its main industry by far was tourism. One pest control business owner, who asked not to be named, said that although they did not export to the U.S., they imported some rodent bait from the U.S. via Australia."Products from Norfolk Island are going to have a 29% tariff? Well, there is no product, so it's not going to have an effect," said Gye Duncan, who owns a tax consultancy on the island. Miles Howe, a retired Australian public servant and former Norfolk Island Chamber of Commerce president, who lives on the island, said he did not think the tariffs worried Norfolk Island's people.I think everyone's rather amused by the idea that we'd even register on the radar of somebody like Donald Trump."

Order book of BHEL crosses 1.80 lakh crore

Bharat Heavy Electricals Ltd. (BHEL), a premier Central Public Sector Enterprises, has geared up to meet its commitment on delivering high pressure boilers to various State-owned power corporations and private entities for their thermal power plants. According to sources, BHEL, which was struggling with dwindling orders for a few years until recently due to various factors, has made a significant turnaround in terms of securing some big ticket orders from various domestic companies for producing boilers to erect thermal power plants in recent months.

As on December 31, 2024, BHEL reported a total order book worth ?1,60,157 crore. Of it, the power segment alone constituted ?1.21,413 crore, which is 76% of the total order book. The industry segment constituted ?35,063 crore and the value of export order stood at ?3,682 crore. The company has further received orders to the tune of over ?20,000 crore during the last three months, thereby increasing the total order book value to 1.80 lakh crore.

It has 39 boilers in its order book so far. Of them, Adani Power stands first in placing the maximum number of boilers with an installed capacity of 800 MW producing thermal power plants. The private company has placed 14 boilers followed by National Thermal Power Corporation (NTPC) with 11 boilers. The State-owned companies from Chhattisgarh, Gujarat and Maharashtra have also placed orders for boilers. The number of boiler orders placed by Neyveli Lignite Corporation (NLC) and Damodar Valley Corporation (DVC) stands at three and four respectively. Of the 39 boilers, 31 were for 800 MW each and eight were for 660 MW each. Buoyed by the pouring orders, the company has put in place the maximum utilisation of its installed capacity and all its resources to fulfil its order commitment to various companies within the stipulated time, says sources. The volume of order, which is unprecedented in recent years, is said to have energised BHEL, which has a High Pressure Boiler Plant in Tiruchi and a Power Plant Piping Unit at Thirumayam in Tamil Nadu

Sources added that a systematic plan had been put in place at the Tiruchi plant and BHEL's other plants across the country to execute the orders. Going by the present orders and the upcoming big ticket orders, which were on the pipeline, BHEL had jobs for the next five to 10 years. While focusing on maximum utilisation of its installed capacity, the company had taken steps to make use of its ancillary units in Tiruchi and other parts of the country. It had already placed orders to its number of vendors to produce various components of boilers. The CPSE major hopes that the heavy order book will open up avenues for the revival of ancillary industries in Tiruverumber, Thuvakudi, Mathur, Ariyamangalam, Kattur and others. BHEL has begun the process of expanding its vendor base to outsource various job works so as to meet its order commitment. It has conducted vendors' meet in Pune, Bhilai and others to add more vendors in the list of vendors.

The company is believed to be in touch with Small Industries Development Bank of India (SIDBI) to facilitate Ioans to the Micro Small and Medium Enterprises (MSMEs) in Tiruchi, Coimbatore, Madurai and Chennai to produce necessary components of boilers.

Trump tariffs, but keeps door open for negotiations

E.U. chief says bloc 'prepared to respond' to

Hours after U.S. President Donald Trump announced tariffs on America's trade partners, including 20% on E.U. goods, European Commission President Ursula von der Leyen said the bloc was "prepared to respond", even as she appeared to keep the door open for negotiations.

"I deeply regret this choice," she said, referring to Mr. Trump's tariffs, as she delivered a video broadcast on Thursday morning. The U.S. President had announced a baseline tariff of 10% on all goods coming into the U.S., with some countries and entities facing higher tariffs, roughly at half the average tariff rate charged by them for U.S. goods, as per Mr. Trump. The U.S. would charge China 34%, India 26% and Vietnam 46%. Non-EU European countries were taxed at different rates: the U.K. at 10% and Switzerland at 31%. Tariffs would hurt people across the world, Ms. Von der Leven said, adding that there was no clear path through the uncertainty."And what is more, there seems to be no order in the disorder. No clear path through the complexity and chaos that is being created as all U.S. trading partners are hit," she said. The E.U. had already announced last month h that it was preparing to respond to Mr. Trump's tariffs on steel and aluminium. Ms. Von der Leyen confirmed that process was underway.

"And we are now preparing for further countermeasures, to protect our interests and our businesses if negotiations fail," Ms. Von der Leyen added. The bloc's executive head also said that the E.U. was watching for indirect



impacts on Mr. Trump's announcement , i.e., in terms of the dumping of cheap goods by third countries, whose exports were originally intended for the U.S.Ms. Von der Leyen appeared to offer an off-ramp though saying there are "others" taking advantage of the trading system and that she was ready to assist in making the international trading system "fit for the realities" of a global economy. "But I also want to be clear: Reaching for tariffs as your first and last tool will not fix it," she added.Earlier this week , Ms. Von der Leyen said the E.U. would be looking at removing bureaucratic and regulatory challenges to trade within its borders as part of the strategy to counter Mr. Trump's moves. On Thursday, she told Europeans who were feeling let down by their "oldest ally" that with a strength of 450 million, the European Single Market was their "safe harbour" in difficult times.

First legacy widebody aircraft of Air India gets new feel and look

The first of Air India's (AI) 13 legacy Boeing 777 widebodies rolled back from Singapore on Wednesday sporting a revamped passenger cabin - new seat covers, fresh carpeting and a sharp interior lift. The aircraft, registered as VT-ALK, returned from Singapore where its interiors underwent "colour, material and finish (CMF)" rework for 52 days to give passengers a new feel and look. This is only an interim enhancement programme for aircraft interiors and includes new upholstery for passenger seats, new carpeting and curtains, and fresh coat of paint on the cabin panels as well as lavatories, said a senior official of the airline. The interiors now sport the airline's new colour scheme for seats.AI aims at concluding the heavy cabin refresh programme for the 13 widebody aircraft used for flying some of the most profitable ultra long-haul routes to the U.S. and Europe by December this year. However, a more thorough makeover for these planes such as replacement of seats as well as the dysfunctional in-flight entertainment screens on the back of the seats, is now delayed until 2026 after

being originally scheduled to start in 2023.A "retrofit" which includes seat and IFE replacement on the Boeing 787 will roll-out this month with the first of these 27 aircraft set to

rejoin service in October, following which two to three B787s will be inducted per month until all of them have been upgraded. A similar exercise for the 27 legacy Boeing 787s will roll out this month as well. The retrofit for the narrowbodies has already take off, with the first of the 27 A320 neos completing the process last month. Works on four such planes is said to have concluded and the airline aims



to finish the process for all 27 aircraft by the third quarter of 2025.



APAAR ID explained: Centralised student records, privacy concerns and digital integration

The APAAR ID is a government-sanctioned digital identifier designed to centralise and verify academic records for students across institutions. In an exclusive Q&A with The Hindu, Apar Gupta, Advocate and Founder Director of the Internet Freedom Foundation (IFF), delves into the implications of APAAR ID. Aimed at centralising academic records and streamlining student transfers, APAAR ID promises benefits such as enhanced authenticity and digital storage. However, Mr. Gupta raises important concerns about privacy, data security, and equitable access, particularly for students in rural or underprivileged areas.

How does APAAR ID enhance the authenticity of academic records and prevent duplication or fraudulent documentation?

APAAR ID purports to provide a single, governmentsanctioned source of verified academic documentation, building on the concept of "One Nation, One Student ID." By centralising verification – and requiring institutions to upload academic documents to an official repository – it ostensibly reduces forgeries. The Academic Bank of Credits (ABC) which stores the credit course documents of the students will not directly accept them from the students and will only consider them if it's provided by the appropriate, registered academic institutes. However, it's also worth noting that centralisation itself may generate new points of failure. If an institution wrongly inputs data — or if access controls are inadequate — a single error or breach can proliferate across the system.

In what ways does APAAR ID eliminate the risk of losing academic documents by securely storing them digitally, reducing paperwork and hassle for students?

The immediate advantage of APAAR ID is digitisation via DigiLocker which is integrated within APAAR which prevents paper certificates from getting lost or destroyed .The Ministry of Education has long touted paperless solutions to reduce administrative burden. Nonetheless, the claim of "secure" digital storage is only as strong as the platform's technical safeguards. The Terms of Service repeatedly references the Ministry's adherence to "industry-standard security measures". However, it does not outline concrete encryption protocols, access logs, or independent audits.Without robust and transparent security measures and regular scrutiny by cybersecurity experts digitisation can lull users into a false sense of security. A data breach in a central repository can be more catastrophic than losing a single paper record, especially when minors' personal details are at stake.

What are the key changes proposed in the new Waqf Bill? | Explained

How does APAAR ID simplify student transfers across schools, colleges, and universities? Does it make accessing academic records easier for students?

Centrally-stored credentials can be retrieved by any authorised institution, purportedly enabling seamless transfers. As per the scope of services section, APAAR ID is a "lifelong academic passport", hinting at continuous portability. Students, theoretically, no longer need to physically shuttle documents across institutions. In practice, the success depends on institutional adoption and digital literacy. Rural schools often lack stable internet connectivity. When trying to implement APAAR ID, if the system experiences downtime or if staff are insufficiently trained, transfers could still be delayed.

With APAAR ID providing verified academic credentials, how will it help future employers make informed hiring decisions based on a candidate's cumulative academic performance?

Employers frequently struggle to confirm the authenticity of an applicant's degrees and certificates. A verified APAAR record could save time and resources, permitting legitimate validation of educational attainment. That said, privacy concerns arise when we discuss employers accessing a student's entire history – especially minors' details. The terms do not appear to address granular, consent-based data sharing beyond a binary approach (either you share your APAAR or you don't).

A nuanced structure where the student can share limited or relevant academic data would better align with privacy best practices. Also, while it's beneficial for employers, it might inadvertently expand employer data collection, raising questions about data minimisation and potential discrimination if old academic records (like primary and middleschool performance) are accessible. Is there a genuine need to centralize student data through the APAAR ID for improved academic management, or is this part of a broader government plan to centralise all data?

Centralisation can streamline academic management, but it also aligns with the government's general trajectory of "One Nation, One X" (e.g., Ration Card, Health ID). The APAAR terms do not explicitly limit data usage to academic purposes alone. For instance, it states the Ministry can "modify or discontinue... Services" and may share user data to comply with law enforcement requests, hinting at data usage beyond purely educational contexts. Such function creep is inherent to ID programmes such as Aadhaar. When data collected for one stated goal is gradually repurposed.

What are the potential implications of government access to students' personal data, such as academic credits, scorecards, mark sheets, diplomas, certificates, training details, and co-curricular accomplishments?

Significant personal data consolidation invariably raises surveillance concerns, particularly involving minors. The Privacy Policy references that the Ministry can collect, process, and store academic data but lacks detail on whether the data might be shared interdepartmentally without consent.Especially worrisome is the statement about "requests by law enforcement or other government agencies" leading to possible account suspension or data usage. Such broad wording fosters genuine apprehension on overreach and the creation of lifelong "profiles" on citizens starting from childhood. This can shape educational trajectories in ways that infringe upon autonomy.

With the introduction of APAAR ID and its hard-linking to Aadhaar, the Ministry of Education appears to have created a back-door or proxy mandate for capturing students' Aadhaar. Constitutionally speaking, Aadhaar is optional for school enrollment, as upheld by the Supreme Court's ruling in Justice (Retd.) K.S. Puttaswamy v. Union of India. What is your perspective on this?

From a constitutional standpoint, any intrusion into privacy must be legally justified, narrowly tailored, and proportionate to the goal (Puttaswamy, 2017). By linking your Aadhaar number to your APAAR account, you grant APAAR permission to use your unique identifier. While it may say it's "voluntary," the actual practice can still result in coercion, as local education offices push for 100% enrollment. This contravenes the Supreme Court's directive that the right to education for children in the ages of 6 - 14, is a constitutional right, and availing it cannot be curtailed by the Aadhaar Act, 2016 (Puttaswamy, 2019).

By making Aadhaar linkage a prerequisite for an APAAR ID — especially when APAAR is becoming the default repository for academic records — this effectively forces parents to surrender Aadhaar data. It's a textbook instance of the government circumventing a judicial ruling through administrative means. I see strong constitutional grounds to challenge this. The terms also give minimal insight into alternative ID acceptance, or an opt out. If Aadhaar is truly optional, the policy must provide a comparable method for non-Aadhaar holders to create APAAR IDs and also not be forced to take APAAR IDs itself, something that is conspicuously missing in the official documentation.

What are the potential concerns regarding the implementation of APAAR ID without statutory backing, and how might this affect the protection of personal data and compliance with privacy standards?

A fundamental principle from Puttaswamy (2017) is that any significant data-gathering exercise must have a legislative basis. APAAR currently operates via the terms and policy, which is an executive or administrative framework, not an Act of Parliament. That's a glaring gap. The terms do say that users consent to data collection and usage, but "consent" here is questionable — particularly for minors — and does not equate to a robust statutory mechanism. Without legislative oversight, rules around data retention, data sharing, and accountability measures can remain vaque.

One sees disclaimers about not being responsible for "Force Majeure" events and about indefinite modifications of service, but no robust mention of data erasure rights, independent audits, or statutory penalties for misuse. Such a key initiative, if truly in the public interest, demands parliamentary scrutiny and an explicit legal framework to ensure compliance with the Digital Personal Data Protection Act (DPDPA), 2023.Can you elaborate on the risks associated with data breaches and unauthorised access in the creation of a centralised database containing sensitive student information, including data of minors? Does India have a comprehensive data protection framework to prevent such breaches?

Given the scope and scale of APAAR, a breach could compromise millions of students' personal and academic records, leading to identity theft and long-term ramifications (especially if Aadhaar information is embedded). APAAR terms mention "industry-standard security measures", but fail to detail specifics: are third-party audits mandated? Is there a data breach notification protocol for impacted users?

India has the DPDPA but as I have often stated, it carries broad exemptions for certain government agencies and also is not yet in force while APAAR ID is being rolled out. The terms and policy do not articulate how they will enforce provisions of the DPDPA. For instance, if the basis of sharing any personal data is through a consent based framework then APAAR ID is already in violation.

Do students, or parents in the case of minors, have the option to withdraw their data from APAAR ID? If so, how can they opt out, and what happens to their data does it get deleted or removed?

The terms allow for "account deletion or suspension" by APAAR. Yet, critically, there is no explicit mention of a robust data erasure right for users themselves, especially if they no longer consent. Nor is there a clear process describing how to request deletion and guarantee that all personal data, including backups, are permanently removed.

For instance, the details of the point of contact which is the grievance officer are at present left blank. Moreover, the acceptance of terms clause and user registration mention that using or continuing to use the service indicates acceptance. This approach effectively locks students once they've started.Parents might not be fully aware of their ability to refuse, and, once enrolled, the terms are ambiguous about any meaningful opt-out or data deletion procedure. Indeed, one might interpret: if the Ministry or APAAR decides to terminate an account, that's on their terms, not the student. terms, not the student.

Do you believe the APAAR ID ensures equitable access for students from rural or underprivileged areas?

APAAR'S terms' scope of services and references to bridging educational gaps ring hollow if infrastructural disparities remain unaddressed. Many underprivileged regions have inadequate internet connectivity, insufficient school funding for IT equipment, and minimal digital literacy. While the policy states that students should "regularly" update their credentials via the nodal officer, the onus is on local institutions to facilitate these processes.

Data from the National Sample Survey Office (NSSO) consistently shows the urban-rural digital divide is stark. Without targeted interventions — such as government-funded connectivity for remote schools or comprehensive digital training — APAAR might end up being more accessible to urban, wealthier communities. This can widen existing disparities. Hence, while APAAR positions itself as a tool to ensure continuity and portability, ironically, it may sideline or penalise those who lack the resources or awareness to continuously update their IDs.

How cinema and the internet

Initially introduced in Parliament last year, the Bill was referred to a Joint Parliamentary Committee (JPC) chaired by BJP MP Jagdambika Pal for scrutiny. The committee submitted its report on February 13, 2025, receiving the Union Cabinet's approval six days later. However, Opposition MPs on the panel objected to the rejection of their proposed amendments and alleged that their dissenting notes had been redacted from the report without their consent. The new Bill, which was tabled along with repealing the 2024 version, seeks to amend the Waqf Act, 1995, which governs the administration of waqf properties in India. It proposes sweeping reforms that would expand the government's role in regulating waqf properties and adjudicating disputes related to them. A look at the key changes proposed in the revised Bill:Retention of 'waqf by user' doctrineThe original version of the Bill abolished the concept of "waqf by user" — a doctrine rooted in Islamic legal traditions that recognised properties as religious or charitable endowments based on their uninterrupted communal use, even in the absence of formal documentation. Historically, numerous mosques, graveyards, shrines, and other religious sites were established through oral declarations or customary practices, with their waqf status legitimised by continuous public usage over generations. The JPC report cautioned that dismantling this doctrine could destabilise the legal standing of such properties, many of which have been informally managed by local communities for decades.

Accordingly, the revised Bill now clarifies that "waqf by user" properties registered on or before the law's enactment will retain their status unless they are disputed or identified as government land. In effect, the government has retained the doctrine for historical cases while prohibiting its application to future land claims.Nevertheless, apprehensions persist regarding a provision mandating that individuals must "show or demonstrate that [they have] been practicing Islam for at least five years" to establish a waqf. Critics have argued that this requirement arbitrarily excludes potential donors, particularly recent converts who may wish to endow property for religious or charitable purposes.

The new Bill retains provisions allowing non-Muslims to be appointed to key waqf institutions, including the Central Waqf Council, State Waqf Boards, and waqf tribunals. It mandates that both the Central Waqf Council and State Waqf Boards include at least two non-Muslim members. Additionally, the requirement that a waqf board's chief executive officer must be a Muslim has been removed. In line with a recommendation from the JPC, the Bill now stipulates that the State government representative on the Waqf Board must be a Joint Secretary-level officer "dealing with waqf matters." Notably, non-Muslims will remain a minority in both the Council and the Waqf Boards.

The composition of waqf tribunals has also been revised, expanding them from a two-member to a three-member body. Each tribunal will now include a district judge, a joint secretary-level officer from the State government, and an expert in Muslim law and jurisprudence. The Bill also clarifies that tribunals constituted before the law's enactment will continue to function until the tenure of their chairperson and members expires.

There is an old truism that the most dangerous thing in the world is a bored young man. In the 21st century, we have discovered that the second most dangerous thing is a bored young man with an Internet connection. And so it begins with a boy, a laptop, and the algorithm. In Netflix's smash hit limited series Adolescence, a lonely teenager seems to find solace on the internet, only to be lured towards vitrioilic rhetoric, conspiracy-laden "truths," and a digital brotherhood that preys on his insecurities. In its brilliant third episode, we witness his temperament spiral deeper into this 'manosphere' — a loosely connected network of misogynistic influencers, incel forums, and self-proclaimed alpha males — watching on with mounting dread as his perception of reality is warped beyond recognition.

Adolescence is crafted as both a psychological thriller and a cautionary tale, tracing the way online extremism seeps into impressionable minds. Creators Jack Thorne and Stephen Graham explore the mechanics of radicalisation and the unnerving ease with which a child can become a soldier in a digital war against women, or the 'others'. The themes explored in Adolescence echo a long tradition of cinema examining the radicalisation of the young and the vulnerable. Shane Meadows' This Is England looks at how a rudderless youth, yearning for belonging, is seduced by the allure of camaraderie before realising too late that he's been recruited into something far uglier. Justin Kurzel's Snowtown paints an even bleaker picture — how abuse. poverty, and unchecked nihilism turn a boy into a monster. These films unpack this gradual metamorphosis for what it is: an entrapment, a corrosion of innocence. Gus Van Sant's Elephant and Lynne Ramsay's We Need to Talk About Kevin have burrowed into the psychology of troubled teens, depicting the slow boil and accumulation of resentment that eventually erupts in indiscriminate carnage. Yet, for some, these films have served as a kind of grim wish-fulfillment, a fantasy of ultimate retribution against a world that has failed to acknowledge them.

Perhaps the most unsettling realisation is also that this cycle of radicalisation is self-sustaining. A film like Fran Kranz's Mass, which grapples with the aftermath of school shootings by focusing on the parents of both the victim and the perpetrator, should serve as an antidote to the glorification of these figures. Instead, it's drowned out by more easily digestible, memeable content — Travis Bickle looking into the mirror, flexing his gun; the Joker dancing on the stairs; Patrick Bateman adjusting his tie.

As internet subcultures mutate, metastasising across YouTube recommendation algorithms and Discord servers, a certain brand of alienated, violently repressed mas-

saturated Instagram Reel edits and Twitter threads rife with Nietzschean self-mythologising. The sociopathic narcissism of American Psycho's Patrick Bateman is aspirational, Travis Bickle's psychotic unraveling in Taxi Driver is framed as a righteous crusade, and the grinning nihilism of Joker is a blueprint for emancipation rather than anything cautionary. The Internet's most jaded corners have idiotically reverse-engineered these films, turning critiques of masculinity into role models, and spawned a generation of disaffected men marinating in grievance, convinced the world owes them something and that the only way to claim it is through brute force. Cinema has become an inadvertent tool for recruitment. David Fincher's Fight Club remains one of the most misinterpreted films of all time, a satire of toxic masculinity that has instead become a Bible for men who mistake Tyler Durden's nihilistic manifesto for genuine wisdom. Martin Scorsese's The Wolf of Wall Street is another entry in the club. These films were meant to expose the arotesqueness of unchecked ego and ambition, yet they have been reclaimed by the very demographic they sought to critique.What makes Adolescence especially relevant, however, is its focus on the internet as the primary vehicle for indoctrination. Jamie's transformation isn't driven by a singular, Svengali-like figure or a shadowy cabal of internet misogynists whispering poison into his ear. Once a bov like Jamie shows interest in a single video about "sigma male grindsets" or the "truth about modern dating," the algorithm takes the wheel, steering him into darker, more radical waters

Platforms like Reddit, 4Chan, and QAnon operate as incubators for antipathy, where every perceived social slight rejection, loneliness, lack of success — is reframed as proof of a grand conspiracy against men. The pipeline is seamless: a lost teen stumbles onto a self-improvement forum, then drifts toward "red pill" ideology, then finds himself watching hour-long rants from self-styled masculinity gurus who peddle a cocktail of misogyny, nihilism, and barely disguised fascism. Whether they brand themselves as "sigma males," pickup artists, or political revolutionaries, these figures operate with the same cynical playbook: stoke resentment, validate insecurity, and then offer a solution that involves total emotional detachment and the rejection of all women as either obstacles or rewards. The rhetoric is deceptively empowering --- "Take control of vour life!" "Be the top dog!" - but the message is rotten at its core.

This is how the Internet turns into an accelerant. The kind of ideological radicalisation depicted in Tony Kaye's American History X, Daniel Ragussis' Imperium, and Spike Lee's BlacKkKlansman, is no longer limited to skinhead meetings in dingy basements. It's a process not unlike the pathways explored even in the Netflix doc, The Antisocial Network, streamlined for the digital age, where ideological extremism isn't confined to romanticised secret meetings or underground pamphlets — it's right there, nestled between gym vlogs and finance bros selling the illusion of control. And social media doesn't care if young men are developing mass shooter manifestos or just memorising Bateman or Bicklemonologues. It only cares that they stay

The buildup includes F-35 combat jets, which are joining B-2 bombers and Predator drones in the region, according to U.S. officials familiar with the planning. 
On Tuesday, the Houthis said they shot down a U.S. MQ-9 Reaper drone amid ongoing U.S. strikes in Yemen. The Pentagon was aware of the claim but declined to comment. Earlier this week, the Houthis launched missiles toward Israel, which were intercepted. In addition to threatening Iran with bombing if it doesn't negotiate a nuclear agreement, the White House has warned it will hold Tehran accountable if the Houthis fire at U.S. forces. Iran has provided arms and training to the Houthis. Talks between the U.S. and Iran on Tehran's nuclear program have yet to be arranged.

"The United States and its partners...are prepared to respond to any state or nonstate actor seeking to broaden or escalate conflict in the region," Pentagon spokesman Sean Parnell said in a statement Tuesday. "Should Iran or its proxies threaten American personnel and interests in the region, the United States will take decisive action to defend our people."Iranian Parliament Speaker Mohammad Qalibaf on Friday said Iran would retaliate against any U.S. strike on Iran by attacking American interests in the Middle East."If the Americans attack the sanctity of Iran, the entire region will blow up like a spark in an ammunition dump,' Qalibaf said in a speech in Tehran. An Iranian official said the response would be focused on U.S. bases in the Persian Gulf. "Each American soldier will be an individual target," he said. Some experts believe that Iran is wary of initiating a major conflict with Trump, who ordered the killing of Qassem Soleimani, the commander of the paramilitary Quds Force, in a January 2020 airstrike near the Baghdad airport.Army Gen. Michael "Erik" Kurilla, the head of the U.S. Central Command, which is responsible for military operations in the Middle East, has long advocated for a more forceful U.S. response to Houthi attacks on ships transiting the Red Sea and nearby sea lanes, which began shortly after Israel's war in Gaza began in 2023. The Houthis, who control large swaths of Yemen, stopped their attacks earlier this year after a brief cease-fire in Gaza, but said they would resume them once the deal collapsed and Israel relaunched its military operation.





Digital child abuse, the danger of AI-based exploitation



Recently, the Department for Science, Innovation and Technology of the British Government, along with the AI Safety Institute (now called the AI Security Institute), released the first-ever International AI Safety Report 2025 (updated February 18, 2025). It flags the imminent risk of the generation, the possession, and the dissemination of child sexual abuse material (CSAM) with the help of Artificial Intelligence (AI) tools. Additionally, the United Kingdom is making the first legislative attempt to target the threats posed by AI tools that can generate CSAM. CSAM refers to material (audio, video, and images) that depicts a sexually explicit portrayal of a child. In a similar vein, the World Economic Forum, in a 2023 paper, highlighted how generative AI can create life-like images, especially of children. Moreover, the Internet Watch Foundation, in its report released in October 2024, underscored the proliferation of CSAM on the open web. The Government of India must amend existing laws to address the emerging threats and ensure long-term effectiveness.

The upcoming U.K. legislation will make it illegal to possess, create, or distribute AI tools that can generate CSAM. Moreover, it will be illegal to possess paedophile manuals that may guide individuals in using AI tools to generate CSAM. This marks a progressive shift from an 'accused-centric' and 'act-centric' to a 'tool-centric' approach in dealing with these abhorrent crimes. The existing laws focus entirely on 'who' has done 'what', placing less or no emphasis on the 'tool/medium' used to commit the said 'act.' For instance, the Protection of Children Act 1978 criminalises taking, distributing, and possessing an indecent photograph or pseudo-photograph of a child. Furthermore, the Coroners and Justice Act 2009 criminalises the possession of a prohibited image of a child, including non-photographic materials. In contrast, the proposed law outlaws even the possession and use of such AI tools, making it deterrent and holistic. Second, it will enable enforcement authorities to apprehend offenders at the preparation stage itself. Third, it can curb the initial rippling effect caused by the spread of CSAM on the mental health of children. Fourth, it addresses the legislative gap concerning CSAM generated as purely

Al imagery, which was previously restricted to the images of an 'actual child.'On whether India is future readyAccording to the National Crime Records Bureau (NCRB) Report 2022, cybercrimes against children have substantially increased compared to the previous year's statistics. Moreover, the National Cyber Crime Reporting Portal (NCRP), under the aegis of the Cyber Crime Prevention against Women and Children (CCPWC) scheme, recorded 1.94 lakh child pornography incidents as of April 2024. In 2019, the NCRB signed a memorandum of understanding with the National Centre for Missing and Exploited Children (NCMEC), USA to receive tip-line reports on CSAM. As of March 2024, 69.05 lakh cyber tip-line reports have been shared with the States and Union Territories concerned. The statistics underscore the gravity of CSAM as a serious threat to a child's right to life and dignity in India. Presently, Section 67B of the IT Act 2000 punishes those who publish or transmit material in electronic form depicting children in sexually explicit acts. Furthermore, Sections 13, 14, and 15 of the Protection of Children from Sexual Offences Act, 2012 (POCSO) prohibit using children for pornographic purposes, storing child pornography in any form, and using a child for sexual gratification. Additionally, Section 294 of the Bharatiya Nyaya Sanhita penalises the sale, distribution, or public exhibition of obscene materials, while Section 295 makes it illegal to sell, distribute, or exhibit such obscene objects to children. However, the existing legislative framework lacks adequate safeguards to deal with the AI-generated CSAM.

The existing legislative and policy framework in India needs to adapt to futuristic challenges, by making suitable changes. First, as proposed by the NHRC Advisory in October 2023, the definition of 'child pornography' under the POCSO Act must be replaced with the phrase 'CSAM' to make it expansive. Second, the term 'sexually explicit' under Section 67B of the IT Act must be defined to enable the real-time identification and blocking of CSAM. Third, the definition of 'intermediary' under the IT Act must expressly include Virtual Private Networks, Virtual Private Servers, and Cloud Services to impose statutory liability on them to comply with the CSAM-related provisions in Indian laws. Fourth, statutory amendments are needed to integrate the risks arising from emerging technological advancements. Fifth, the Government of India must pursue the adoption of the UN Draft Convention on 'Countering the Use of Information and Communications Technology for Criminal Purposes' by the UN General Assembly. Notably, the Ministry of Electronics and Information Technology proposed the Digital India Act 2023, currently in pipeline, to replace the two-decade-old IT Act. Therefore, and lastly, the proposed Digital India Act must draw inspiration from the U.K.'s upcoming legislation to include the provisions specifically targeting AI-generated CSAM.

The reciprocal tariff dilemma

Under the 'Fair and Reciprocal Plan,' the Donald Trump administration is countering "non-reciprocal trading arrangements with trading partners by determining the equivalent of a reciprocal tariff with respect to each foreign trading partner". The non-reciprocal trading relationship is assessed based on tariffs, discriminatory taxes, non-tariff barriers (including subsidies and restrictive regulations), exchange rate manipulations, and any other practice deemed to limit U.S. market access or impede American firms from competing.

In 2010, countries across the world sent 12% of their total merchandise exports to American shores. By 2019, one year before the pandemic, the U.S. share of world exports had only risen to 13%. The share stood at 13.4% in 2022, the latest year for which internationally comparable data on merchandise exports are available for the largest sample of the world's trading economies. The class 1 age criteria: Impact on parents, schools and policy explained



The Kerala government recently announced that the age criteria for Class 1 admissions is raised from five to six years. In Karnataka, where the six-year age criterion was to be implemented 2025-26 academic year onwards, parents are waiting for the final announcement from the government even as school admissions have begun. A section of parents in Karnataka are demanding relaxation on this criterion. The Union Government in line with the NEP has been sending yearly reminders to all the States/UTs to ensure that the age of admission to Class one is six plus years. Currently, disparities exist in the prescribed age limit for school admission across and within states.

Parents often demand relaxation from the six-year criterion so their child can stay ahead in the race of competitive exams, government jobs, and promotions. Experts including child psychiatrists, educationists, and policy-makers however, warn of the negative impact of this rush towards early admissions. The Right to Free and Compulsory Education Act 2009 (RTE Act-2009) and the Rules, 2012, prescribes the age limit for enrolling a child to Class 1 as having compulsorily completed six years as of June 1. The National Education Policy (NEP-2020) has also mandated that the minimum age limit for admission to Class 1 should be six years as of June 1. Earlier, children in the age group of three to six were not covered in the 10+2 structure, as Class 1 began at age six. In the new 5+3+3+4 structure, a strong base of Early Childhood Care and Education (ECCE) from age three is also included, which is aimed at promoting better overall learning, development, and well-being. The NEP says that over 85% of a child's cumulative brain development occurs prior to the age of six, indicating the critical importance of appropriate care and stimulation of the brain in the early years to ensure healthy brain development and growth.Picture in different statesWhile the majority of State governments have agreed to align the admission age criteria to be at par with the NEP, some still allow Class 1 admissions at five years old. States trying to implement the six-year rule, however, face backlash from parents every year demanding relaxationIn Karnataka, the Department of School Education and Literacy made the rule mandatory from the 2023-24 academic year and issued an order on July 26, 2022. However, it created confusion and anxiety among parents, after which the Karnataka government gave a relaxation for two academic years. An amended order was issued by DSEL on November 15, 2022, stating that the six-year age completion rule will be implemented from the 2025-26 academic year.

This year, however, parents have demanded relaxation on the rule yet again. A letter by the Karnataka State Commission for Protection of Child Rights (KSCPCR) states, "As a result of admitting children to pre-KG (Kindergarten) as per the previous rules, this year, around five to six lakh students are facing difficulty in enrolling in Class 1 after completing UKG. Parents have requested to relax the age limit set for admitting children to Class 1 from the academic year of 2025-26". In Kerala, the Minister for General Education, V. Sivankutty, recently announced that the minimum age for Class 1 admission has been raised from five to six years. During the announcement, the Minister said, "Scientific studies suggest children are better prepared for formal education after turning six. That is why all countries with well-developed education systems set the age of entry for formal education at six years or above".In Maharashtra, the Early Childhood Association (ECA) complained of disparity in age criterion in school admissions last year. It stated that children are admitted to nursery schools when they are just two and a half years old. Mukund Kirdat, Aam Aadmi Party Parents union says that most parents in Maharashtra enroll their ward in Class one only once they turn six. Under RTE admissions, all the forms are now filled out online so no one can seek admission below the age of six years old. "For both SSC and CBSE boards, the Maharashtra act is in place, which requires age verification for school admission", he says.

schools. Maalathi K R, Founder and CEO, Auuro Educational Services says that in Tamil Nadu earlier preschool education would start at two years of age - Pre-KG at two years, LKG at three years, UKG at four years, and Class 1 at five. But this has further shifted recently. The pre-schools now take admissions for playgroup at 1.5 years, Pre-KG at 2.5 years, LKG at 3.5 years, UKG at 4.5 years, and Class 1 at 5.5 years. "If Class 1 criteria are set at six years, there is a six-month gap and parents find it challenging to enroll their ward in mainstream schools", she said.

What is the right age for enrolment?

Experts say that even though every child has their own pace of growing and achieving key developmental milestones, there is still a need to standardise appropriate age for school admissions. The book, 'Winning strategies for parents: Helping your child excel at home and school', by author and educationist, Gayatri Kalra Sehgal, talks about preschool readiness. It states that between ages three and five children acquire skills necessary for readiness for preschool.As attention span, memory, and language skills develop they become increasingly ready for preschool However, few understand that academic abilities are not the primary requisites for pre-schoolers. Childhood preschool readiness is individual personality and temperament and a combination of mental, physical, and emotional traits.Ms. Sehgal talks about around 15 developmental milestones, which include: physical development; personal social and emotional development; communications like listening and speaking development; pre-writing development; sensory development; self-help development; cognitive development; mathematical development, and more.Ms. Sehgal says that six is the appropriate age for certain development milestones that a child needs before entering Class 1. If the child is not ready even at the age of six, they get to develop at their own pace. If some of the 15 development milestones are not developed well, parents and teachers can use the strengths of a child to help them cope in areas they lack. "There is a lot of science behind why the Indian government is insistent on this age criteria. By the age of six a lot of children come at par to take on what is needed for school", said Ms. Sehgal.Bhooshan Shukla, a child psychiatrist said that some children can achieve developmental goals before they are six, but some may not. There is, however, a need to standardise age criteria for school admissions, like we have drawn a line for adulthood at 18.Mr. Shukla explains that when students are in Class 6, they are expected to sit in class for six hours with one short break, listen to their subject teachers, write, answer questions, and do homework. The education system depends a lot on cognitive abilities - understanding by listening, reading, doing things, logic, and more. "Most of the stuff required isn't achieved before six years. Children shouldn't start their Class 1 before their sixth birthday", said Mr. Shukla

Mr. Shukla says that enrolling a child early can negatively impact them in the long run. He says that if the youngest child in the class is five or five and a half years old, they are more likely to be labelled with psychiatric and behavioral problems like ADHD, and learning difficulties. "At that age, the difference of nine months of one year is 50% of a lifetime, it is like a 30-year-old working with a 40-year-old. There shouldn't be much gap", he says.Herambh Kulkarni, Director, Council for Creative Education, says earlier pre-primary education was not consolidated into primary education. But now that it has been incorporated, things should change for the better, since the curriculum is designed for each stage keeping in mind the one before. "Some pre-schools, though, teach Class 1 syllabus, instead of just conducting activities, which should not happen", he says.Ms. Maalathi says that five years is the right age for Class 1 admissions, it can be called the foundational stage. The six-year rule is from the time of RTE, preschool was not recognised at that time. "Brain development now happens in children at a much younger age, so it is okay to start at five", she said.The way

At the opposite end of the spectrum, 81 out of 160 countries, for which data were available from UN Comtrade for 2022, exported less than 5% of their total goods to the U.S. For 26 of these 81 countries (many from Africa), the U.S. share was less than 1%. The average U.S. share across the 160 countries was 11.4%, while the median was much lower at 4.7%. Less than a fifth of Indian, Chinese, and EU merchandise exports (18%, 16%, and 19%, respectively, in 2022) were destined for the U.S.

Now, let us look at the tariff picture and compare U.S. tariffs on partner exports vis-à-vis partner tariffs on U.S. exports. The latest tariff data available for this comparison are from UNCTAD TRAINS for 157 trading partners of the U.S., mostly for the year 2022. The European Union is considered a single partner given its common external tariff. The average import-weighted tariffs on U.S. exports in 27 partner countries are lower than the corresponding U.S. tariffs. Technically, the concept of reciprocal tariffs works as a threat and a bargaining tool only when U.S. tariffs are lower than those in the partner country. Considering only tariffs, this simple analysis thus rules out almost a fifth of all countries for which comparable tariff data are available from the 'Fair and Reciprocal Plan.' These countries include Canada, the EU, Japan, and the U.K. - among America's largest trading partners, which together accounted for half of total U.S. merchandise exports in 2022. In fact, U.S. commercial interests could be harmed if these countries imposed reciprocal tariffs on American merchandise exports instead.

Of the remaining 130 countries where the Trump administration perceives a tariff disadvantage, the magnitude of the tariff increase needed to nullify the disadvantage is less than 5% in 57 countries, including China and India. Moreover, in 15 of these 57 countries, the U.S. needs to increase its import-weighted tariffs by less than 1% to restore parity with partner tariffs. Thus, the threat of reciprocal tariffs may be more credible in the remaining 73 countries worldwide, where U.S. bilateral tariffs need to be raised by more than 5%.

Interestingly, however, the magnitude of the tariff hikes in these cases is positively correlated with the U.S. export shares in the partner countries. Put simply, pursuing the policy of reciprocal tariffs against partners where there is a significant tariff differential results in raising average import duties on exports from countries for whom the U.S. is an important destination market. There is extensive commentary on how tariffs are a self-defeating policy. The correlation above only compounds the self-inflicted harm that a policy of reciprocal tariffs brings to the U.S.This simple analysis is at the aggregate level, and more detailed product-level bilateral tariff and U.S. export share comparisons might be more revealing. However, based on this simple analysis, could partner countries be tempted to divert their exports to other countries in response to large reciprocal tariffs? After all, even today, 87% of global merchandise

costs to finding new export markets and trading partners, the experience during the pandemic has shown that firms adapt to external shocks quicker than governments. The best policy response to reciprocal tariffs is for impacted countries to remove barriers to doing business, both internally and with their non-U.S. trading partners. This is also the time to enhance regulatory cooperation and reduce regulatory bottlenecks to cross-border trade with the rest of the world, not just in goods but also in services. The World Bank and World Trade Organization reports show that exports of digitally delivered services have grown faster than those of all other services and goods during the last decade. My own research also shows that preferential trade agreements, which include provisions on regulatory behind-the-border issues, have the most positive effect on digital services trade. Instead of wasting scarce resources on retaliatory tariffs, countries will be much better served if policymakers focus on issues that matter. Chandrayaan's ChaSTE scores a first after taking moon's temperature

As the Vikram lander of Chandrayaan-3 touched down on the moon on August 23, 2023, a thermal probe tucked snugly in its panels, slowly worked itself free and stretched its arms. Its motors started to whir, sending the little probe into the soil. Once the probe reached its intended depth, it clicked in place with a latch. This is Chandra's Surface Thermophysical Experiment (ChaSTE) - the first instrument to measure temperatures in situ near the moon's south pole. Scientists used this data to report that water ice is more prevalent on the moon than expectChaSTE also became the first mission to successfully penetrate the soil of a celestial body to deploy a thermal probe after two previous missions had fallen short. The ChaSTE probe features 10 temperature sensors spaced about 1 cm apart along its length, near the nose-tip. It uses a rotation-based deployment mechanism. When its motor rotates, ChaSTE's probe needle pushes down until its tip touches the moon's surface. By monitoring the temperature from the sensor at the end of the probe, scientists can identify if it has touched the surface. As the probe continues to pierce, the soil offers more and more resistance. This requires the motor to exert greater force. That is how scientists confirm how far the probe has descended. ChaSTE tunnelled into the soil to a final depth of 10 cm, then collected measurements throughout the Chandrayaan-3 mission, until September 2, 2023.

Philae lander, hitchhiking on the Rosetta spacecraft, landed on comet 67P/Churyumov-Gerasimenko. But it bounced - twice. Its Multi-Purpose Sensors for Surface and Subsurface Science (MUPUS) instrument onboard was designed to measure temperature by digging into the terrain. However, scientists couldn't deploy it due to the awkward landing position Philae found itself in on that desolate icy rock, 500 million km away. The German-Polish team behind MUPUS got another chance when NASA's InSight robotic spacecraft landed on Mars on November 26, 2018. It carried a temperature-sensing instrument called the Heat Flow and Physical Properties Package (HP3). It consisted of a self-hammering nail, nicknamed "The Mole", designed to penetrate 5 m below Mars's surface. But the friction between the probe and the sand was too low for the mole to hammer itself down more than a few centimetres. After more than a year's action-packed struggle, the 35-cm Mole had finally descended fully into the Martian sand. But scientists couldn't get any temperature data. This was because HP3's temperature sensors were not on the mole. They were attached to a tether that was supposed to trail The Mole as it burrowed through the sand."While both the instruments [MUPUS and HP3] used a hammering device, the ChaSTE probe was pushed into the soil by a rotating device," Durga Prasad K., principal investigator of ChaSTE from the Physical Research Laboratory, Ahmedabad, said. It was the secret sauce that made all the difference.



New Delhi: Although India has, for a long time, battled the incidence of cancer, latest estimates pegs them to be rising at significantly higher rate. Once thought of as an old age disease, cancer is now a cause of concern also among the youth and children.National Cancer Awareness Day is observed every year on November 7 in India, to increase awareness about cancer prevention and the need for its early detection.

According to the Indian Council of Medical Research (ICMR), there will be an estimated 12 per cent rise in cancer cases in India in the next five years.

Longer life expectancy is a major contributor to the overall cancer incidence. As people grow old, their bodies have longer time to allow faults to build up and the body accumulates more of these faults in the genes, considerably increasing the risk of cancer.

"Larger proportion of older individuals is the first cause of increased cancer numbers. The higher the proportion of older age in the population, the higher is the chance of cancer," Wesley M Jose, Clinical Associate Professor, Medical Oncology, Amrita Hospital, Kochi, told IANS.


Further, males (52.4 per cent) are more prone to the risk of all cancer cases compared to females (47.4 per cent). Tobacco use is the major reason — comprising 48.7 per cent of cancers among males and 16.5 per cent among females.A recent report states that the number of cancers associated with tobacco use in 2025 would be 4.27.273 contributing to 27.2 per cent of India's total projected cancer cases. Initiation of tobacco, known to contain at least 69 cancer-causing agents, in the youth is a contributory factor

to the increased burden of cancers associated with tobacco use in India."Tobacco cessation will reduce the cancer burden by about 25 per cent. The major contributing factor being tobacco and ghutka consumption that directly accounts for 27 per cent of cancers in India," Murad E. Lala, Oncologist at P.D. Hinduja Hospital & MRC, Mahim, Mumbai, told IANS."We all know that oral and lung cancer that affects our male population to the maximum can be prevented by curbing smoking and tobacco consumption. We need to start thinking of some unhealthy foods similar to what we think about tobacco - unnecessary, addictive, and harmful," said Anil Heroor, Director-Advanced OncoSurgery Unit, Fortis Hospitals Mumbai. Apart from tobacco, alcohol, obesity, a sedentary lifestyle and environmental factors also contribute to the increase in cancers.

The overall living circumstances of the Indian population have improved and that have also led to a larger sedentary workforce, which has access to a high-calorie diet. These factors indirectly have affected the rise in numbers," Jose said."Nearly six types of cancers are linked to obesity and are slowly on the rise among people under 50. These are cancers of the colon or rectal, pancreas, kidney, gallbladder, uterine (also called endometrial cancer), and multiple myeloma. These Cancers are often not discovered in younger people until the disease is advanced and harder to treat," Heroor said.Childhood cancer is also seeing an increasing trend, mainly of leukemia and lymphomas. Childhood (0-14 years) cancers constitute 7.9 per cent of all cancers, according to ICMR.

"The common types of cancers in children are leukemias, lymphomas, CNS tumours, retinoblastomas and Wilm's tumours. While most of the childhood cancers are curable if detected early and treated appropriately, children in India have limited access to tertiary centres that treat childhood cancers. This delay in treatment causes the survival rate to drop," Jose said. The cancer burden in the country can be reduced by strengthening the government health systems, making universal health coverage, health education, treatment compliance, and early detection centres at the community level. Besides, vaccination for virus-related cancer like liver and cervix, and improved physical activity, stricter tobacco and alcohol laws can also help, the experts suggested.

New method for detecting adulterants in milk



New Delhi: Researchers at the Bengaluru-based Indian Institute of Science (IISc)have developed a low-cost and effective method to detect adulterants in milk, by merelyanalysing the deposition patterns after evaporation. The team used the method to test for the presence of urea and water, the most common adulterants, and suggest that thetechnique can be extended to other adulterants also.Adulteration of milk is a pressing concern in develop-

the periphery.

Current techniques such as lactometers look for changes in the freezing point of milk todetect the presence of water, but they have certain limitations. For instance, the freezingpoint technique can detect water only up to 3.5% of the total milk concentration. Inaddition, although biosensors with high sensitivity are available to test for urea, they areexpensive, and their accuracy tends to decrease with time. The IISc team, on the otherhand, was able to detect water concentrations as high as 30% and urea concentrations indiluted milk as low as 0.4% using pattern analysis. The technique was designed by Dr. Virkeshwar Kumar, a postdoctoral researcher, and

Susmita Dash, Assistant Professor in the Department of Mechanical Engineering at the

Institute. They have published a report on their work in the journal ACS Omega. The test does not require a laboratory or any other specialised process. "It can be done inany place. It can be easily adapted for use even in remo

Washington: A new research has found that women are less likely than men to ask for more time to complete projects with adjustable deadlines at work or school. The findings of the study were published in the journal 'Proceedings of the National Academy of Sciences'.Compared to men, women were more concerned that they would be burdening others by asking for an extension, and that they would be seen as incompetent, the study showed.

Prior research has shown that women feel more time stress than men do, and feeling uncomfortable about asking for more time to complete projects may be one important reason why, said Grant Donnelly, co-author of the study and assistant professor of marketing at The Ohio State University's Fisher College of Business."Women understandably feel like they have too many things to do and not enough time to do them. We found that not asking for more time to complete tasks undermines women's well-being and also their performance. But we also found a possible solution: Women were as likely to ask for deadline extensions as men when organisations had formal policies on making deadline extension requests," Donnelly said.Donnelly conducted the research with Ashley Whillans, Jaewon Yoon and Aurora Turek of the Harvard Business School. The research involved nine studies with more than 5,000 participants, including online panels of working adults and undergraduate students. Donnelly said that for him, one of the most compelling of the nine studies was one conducted in his own class. He assigned a discussion paper that was worth 20 per cent of the grade to 103 students in an undergraduate business course. All students were given one week to submit the paper but were told they could email Donnelly to request an extension without penalty.Male students were

more than twice as likely as female students to request an extension for the assignment (15 per cent of female vs. 36 per cent of male students).Not asking for an extension could hurt students, the findings showed. A teaching assistant who rated the papers gave better scores to those who had asked for an extension. (The assistant did not know who wrote the papers and whether they asked for extensions or the purpose of the study.) "What we found is that when students requested an extension, they made good use of that time and performed better on the task. Women may hurt themselves by not requesting additional time," Donnelly said.Several other of the nine studies by the researchers involving working adults showed that women's focus on other people and their needs played a big role in why they were uncomfortable asking for deadline extensions. In these studies, participants imagined they were assigned to submit a proposal for an upcoming event that was due the next day but needed more time. In this scenario, they could ask for an extension from their supervisor. Participants were asked a variety of questions about how asking for an extension might affect themselves and their team, and how it might affect how they were viewed by others. Results showed that women believed they would be seen as less competent if they asked for an extension. But that wasn't the main reason that women were reluctant to request more time."It was their concern about burdening their team and manager with more work that most strongly predicted women's discomfort with asking for more time on adjustable deadlines. Perceived burden and emotions like shame, embarrassment and guilt explained why women experienced more discomfort with asking for extensions than men did," Donnelly said.And these feelings have real-life implications.

Milk with and without water or urea showed very different evaporative patterns. In unadulterated milk, the evaporative pattern consisted of a central, irregular blob-likepattern. Water was found to cause distortion or complete loss of this distinctive pattern, depending on how much of it is added. Urea also completely erases the central pattern.Being a non-volatile substance, it does not evaporate but instead crystallises, starting at the interior of the milk drop and extending along

eas and rural places," said Dr KumarHe and Dr. Dash be lieve that this technique can potentially be extended to test foradulterants in other beverages and products too. "The pattern that you get is highlysensitive to what is added to it. So, I think this method can be used to detect impurities in volatile liquids. It will be interesting to take this method forward for products such as honey, which is often adulterated", Dr. Dash said. They noted that the simplicity of this method may also lend itself to easy automation, once the patterns for adulterants and their combinations are standardised. These could be fed into image analysis software, for example, which would compare a photo - even one taken with a mobile phone - of the sample's evaporative pattern with other standard patterns to accurately detect the adulterants present."The next step that we are looking at is to test for adulterants, such as oil and detergentsthat form an emulsion resembling milk. We plan to continue work in this direction, creating a repository of patterns corresponding to various concentrations of different adulterants," Dr Dash said.

Examining the power of modern interventions in alleviating symptoms of Parkinson's disease

Parkinson's disease is a progressive neurodegenerative disease that affects the areas in the brain that primarily regulate and fine-tune discrete movements. The motor system is affected in the initial stage of the disease, and as it advances, it also causes non-motor symptoms like reduced attention and cognitive problems. There is no cure for the disease, and all treatments only aim to reduce symptoms and improve the quality of life.

Affected patients have symptoms including tremors, slowness of activities, stiffness of limbs, walking difficulties, and postural instability. The exact etiology is unknown and believed to be multi-factorial in origin, involving the interplay of genetic factors, environmental toxins, and other unknown mechanisms. The disease causes a decrease in the population of dopamine-producing neurons in the brain circuits (Nigro-striatal pathway) that control body movements. Hence, other unwanted signals are not filtered, which disturbs intended body movements.

While pharmacological treatments like Levodopa are initially effective for some years in managing motor symptoms, their long-term use is associated with diminishing efficacy, increased dosage requirements, and side effects. As the drug's effect wanes, symptoms reappear immediately; this is called the 'on and off' phenomenon. Quality of life decreases, and patients become increasingly dependent on drugs. As the disease progresses, patients often experience motor fluctuations, dyskinesias, and wearingoff effects, necessitating more frequent and higher doses of medication. This can lead to a complex balance between symptom control and medication-induced side effects, significantly impacting the patient's quality of life.Surgical interventions have emerged as effective alternatives, particu-

larly for patients with advanced disease stages or medication-resistant symptoms. These procedures aim to modulate the abnormal neural activity in the basal ganglia-thalamocortical circuit, which is implicated in the pathophysiology of Parkinson's disease. Deep brain stimulation (DBS), introduced in the 1990s, has become a cornerstone in surgical treatment, offering superior control of motor symptoms without the motor fluctuations or on-and-off phenomena as seen with medications.DBS involves the precise placement of electrodes in specific brain regions, such as the subthalamic nucleus, globus pallidus interna, or ventral intermediate nucleus (VIM) of the thalamus. As the has technology advanced in recent decades, it allows the surgeon to place the electrodes precisely, deep inside the brain, with submillimeter accuracy. This is feasible because of advancements in neuroimaging, navigation tools, and robotic technologies. The electrodes are connected to a pulse generator implanted subcutaneously, which delivers continuous electrical stimulation to the target area, effectively modulating neural activity and improving motor function. Advancements in battery technology allow its lifespan to extend up to 15 years, and it can be recharged wirelessly. Other surgical options include minimally invasive techniques like stereotaxic-guided or navigation-guided lesioning procedures such as radiofrequency ablation (RFA), laser interstitial thermal therapy (LITT), and non-invasive techniques like MRIguided focused ultrasound (MRgFUS). These procedures create small, precise lesions in specific brain regions to disrupt abnormal neural activity associated with Parkinson's symptoms. Radiofrequency ablation uses heat generated by radio waves to create lesions, while LITT employs laser energy delivered through a small probe. MRgFUS, on the other hand

Trump's "Liberation Day" plan to impose sweeping new duties on trillions of dollars in imports shows that the White House wants goods sold to American consumers to be built in American factories—bringing down the curtain on U.S. support for the turbocharged globalization that powered the world economy for decades.

The new tariffs include a baseline duty of 10% on foreign imports and larger so-called reciprocal tariffs, with China facing total duties of 54%, Vietnam 46% and the European Union 20%. "Jobs and factories will come roaring back into our country, and you see it happening already," Trump said in a Rose Garden ceremony Wednesday. To any company or country that complains, he said: "If you want your tariff rate to be zero, then you build your product right here in America."Trump's Made-in-America ambitions mean that a gusher of investment that in recent years showered lowcost manufacturing destinations such as Vietnam, as well as U.S. allies such as South Korea and Japan, is set to dry up. Firms are reconsidering their options for where best to spend their investment dollars.

"The U.S. has been at the center of globalization," said Andre Sapir, a former EU official who is now economics professor at the Free University of Brussels. "Now the U.S., the center, wants to pull away."In the weeks since Trump took office, a flurry of new announcements by companies including iPhone maker Apple, South Korean car maker Hyundai and drug makers Johnson & Johnson and Eli Lilly signal that multinationals are gearing up to expand operations in the U.S. in response to Trump's tariffs.

Yet untangling the world's supply chains and relocating to the U.S. in the way Trump wants is a daunting task, given the costs involved. There is also the risk that Trump will lower tariffs if he can use them to wring concessions on trade from other countries, executives say. Economists warn the world could face a growth-sapping investment crunch as companies sit on the sidelines until the tradewar fog clears."Shifting things around is going to be quite complicated," said Derrick Kam, Asia economist at Morgan Stanley. That process will be slow, expensive and challenging, he said

What is the controversy over the Bodh Gaya temple? | Explained

The story so far: Beginning February, nearly 100 Buddhist monks under the All India Buddhist Forum (AIBF) have been protesting, first at the Bodh Gaya's Mahabodhi Temple or Mahavihara, and later a little down the road, demanding

The president's hope is that high tariff walls will usher in a golden age of plentiful manufacturing jobs and widespread prosperity as industrial production blossoms across the U.S. He blames predatory trade practices by China, the European Union and other American trade partners for sucking jobs and industries overseas, which he now wants to bring back.

The U.S.'s two largest trading partners, Mexico and Canada, were spared new tariffs Wednesday, with any goods compliant with their free-trade agreement still subject to no duties. But both countries still face 25% duties that Trump imposed on a large share of their exports not covered by the agreement, as well as the ongoing threat that the president could blow up the deal over non-trade issues such as drugs and migration. On Wednesday, Trump singled out China. It was the biggest beneficiary of the offshoring trend, over decades building out factories that started with toys and clothes and today make high-tech cars, machinery and electronics. Today, it dominates global manufacturing, with a trade surplus last year of \$1 trillion.A new 34% tariff on China announced Wednesday will be additive to previous duties imposed by the Trump administration, like the 20% tariff that Trump imposed over its role in the fentanyl trade. That means the base tariff rate on Chinese imports will be 54% after April 9.Job aspirants talking with a hiring agent outside the Foxconn factory, where workers assemble iPhones for Apple, in Sriperumbudur, India, last year. If Trump ends up imposing additional 25% tariffs on China for purchasing Venezuelan oil, then the tariff rate would bump up to 79%.

Driven by growing geopolitical tensions between Washington and Beijing and the trauma of the pandemic, multinationals have added new production bases outside of China to keep their operations running smoothly in the event of disruption from shipping delays, natural disasters, economic sanctions or conflict. Apple, for instance, began making some iPhones in India.At the same time, Chinese companies have built out their own overseas production facilities, in part to escape brutal competition in their cutthroat domestic market but also to keep serving multinational clients and to sidestep U.S. tariffs on Chinese imports. Mexico and Vietnam have been popular destinations, thanks to low costs and, in Mexico's case, tariff-free access to the U.S. market. For the U.S., the result has been a fall in the share of its imports coming from China but widening deficits with Vietnam, Mexico and other countries. The overall U.S. current-account deficit, a broad measure of trade and income from overseas, in 2024 reached \$1.1 trillion, underscoring to Trump and his allies the need to revamp global trade.

With his return to the White House, Trump has taken his trade war to adversaries and allies alike, whom he accuses of taking advantage of the global trading system the U.S. nurtured after World War II by pushing exports and restricting imports. Some analysts say such policies do indeed drive U.S. trade deficits, though most mainstream economists cite the U.S.'s persistent budget deficits and

low savings rate as the principal drivers of the yawning trade gap. There are signs Trump's strategy is having an effect. Around half of German engineering businesses want to boost U.S. investment, both as a result of the tariffs and the size of the market, according to a November survey by the German Mechanical Engineering Industry Association, or VDMA, a lobby group. Most members "look to the U.S. as a growth opportunity," said Andrew Adair, a VDMA official.

German engineering giant Siemens said last month it would increase by \$10 billion its investments in the U.S., its largest market. That includes new manufacturing facilities for electrical products in Fort Worth, Texas, and Pomona, Calif., creating over 900 skilled manufacturing jobs, the company said.

Taiwan Semiconductor Manufacturing said last month that it plans to invest at least \$100 billion more in chip-manufacturing plants in the U.S. over the next several years. On Wednesday, Trump said Taiwan would face 32% tariffs, though semiconductors would be exempted."We must be able to build the chips and semiconductors that we need right here in American factories with American skill and American labor, and that's exactly what we're doing," Trump said when announcing the deal alongside TSMC Chief Executive C.C. Wei in the White House. Taiwanese electronics companies Foxconn, Compal and Inventec have said they are seeking new investments in Texas, looking to secure land for AI-server manufacturing that could eventually rival the scale of their existing operations in Mexico.Mexico became a hub for manufacturing the servers needed by large U.S. tech companies to power artificial intelligence, with around 70% of the U.S. server imports arriving from the country and another 20% coming from Taiwan, according to a report by Taiwan's Ministry of Economic Affairs.

Yet, despite these pockets of activity, measures of business investment intentions published by the Federal Reserve suggest that across the economy corporate spending plans are being scaled back against the backdrop of tariff uncertainty. Another problem: U.S. manufacturing is geared towards advanced technology and doesn't have ready domestic supplies of basic materials and components that can be much more cheaply produced overseas. Already, U.S. manufacturers are struggling with the rising cost of screws, nuts and bolts, highlighting the need for easy access to global supply chains.

"You can't just put on tariffs and flip a switch and all of a sudden America is an industrial nation again," said Dan Digre, president and chief executive of Misco Speakers, a St. Paul, Minn.-based manufacturer of audio systems used amusement parks, medical devices and in spacecraft. Around half of Misco's production is in the U.S., but the company still depends on overseas factories for vibrating cones, copper voice coils and other essential loudspeaker components, many of them in China.Digre, who said his business has spent around \$14 million paying tariffs since 2018, said he has been scouring Vietnam and other parts of Asia for alternative suppliers. But with these sweeping new tariffs coming down the pike, "it's very hard to know what to do," he said. "There's no place that's safe.'

U.S. bans government personnel in China from having romantic or sexual relations with Chinese citizens



The U.S. Government has banned its personnel in China, as well as family members and contractors with security clearances, from any romantic or sexual relationships with Chinese citizens, The Associated Press has learned.Four people with direct knowledge of the matter told the AP about the policy, which was put into effect by departing U.S. Ambassador Nicholas Burns in January shortly before he left China. The people would speak only on condition of anonymity to discuss details of a confidential new directive.

Though some U.S. agencies already had strict rules on such relationships, a blanket "non-fraternisation" policy, as it is known, has been unheard of publicly since the Cold War. It's not uncommon for American diplomats in other countries to date locals and even marry them.A more limited version of the policy was enacted last summer prohibiting U.S. personnel from "romantic and sexual relations" with Chinese citizens working as guards and other support staff at the U.S. Embassy and five consulates in China. But Burns, the departing Ambassador, broadened it to a blanket ban on such relations with any Chinese citizen in China in January, days before President Donald Trump took office. The AP was unable to determine exactly how the policy defined the phrase "romantic or sexual relationship."

Two of the people with knowledge of the ban told the AP the new policy was first discussed last summer after members of Congress contacted Mr. Burns to express concern that restrictions on such relationships were not stringent enough. The House Select Committee on the Chinese Communist Party did not respond to a request for comment. The new policy covers U.S. missions in mainland China, including the embassy in Beijing and consulates in Guangzhou, Shanghai, Shenyang and Wuhan, as well as the American consulate in the semi-autonomous territory of Hong Kong. It does not apply to U.S. personnel stationed outside China."The only exception to the policy is U.S. personnel with pre-existing relations with Chinese citizens; they can apply for exemptions. If the exemption is denied, they must end the relationship or leave their position," the people said. Anyone who violates the policy will be ordered to leave China immediately.

The policy was communicated verbally and electronically to American personnel in China in January, but has not been publicly announced. The State Department said it does not comment on internal matters. The National Security Council referred questions to the State Department. Mr. Burns, the former Ambassador, did not reply to an AP request sent to his email address at The Cohen Group, a consultancy that he rejoined as vice chair in February.Intelligence services across the world have long used attractive men and women to obtain sensitive information, famously during the Cold War. The State Department and other agencies with offices in China have long had stringent reporting requirements on personal relationships for American personnel stationed there, as well as rivals considered high intelligence threats such as Russia or CubaDeclassified State Department documents show that in 1987, the U.S. Government barred personnel stationed in the Soviet bloc and China from befriending, dating or having sex with locals after a U.S. Marine in Moscow was seduced by a Soviet spy. Such restrictions were relaxed after the collapse of the Soviet Union in 1991, according to news reports at the time. In China, a blanket ban on such relations has not been in effect for many years. Until the new ban in January, U.S. personnel in China were required to report any intimate contact with Chinese citizens to their supervisors, but were not explicitly forbidden from sexual or romantic relationships.U.S. diplomats and intelligence experts say that Beijing continues to aggressively use so-called honeypots to access American secrets. In presentations before being stationed in China, U.S. personnel are briefed on case studies where Chinese intelligence services sent attractive women to seduce American diplomats, and warned that dozens of Chinese state security agents can be assigned to monitor any individual diplomat of interest.Little is known about the U.S Government's non-fraternisation policies elsewhere, as they are considered classified. It is unknown how restrictive such policies are in other countries. In recent years, tensions between Washington and Beijing have escalated over trade, technology and geopolitical competition. Peter Mattis, a former CIA analyst and president of The Jamestown Foundation, a Washington-based think tank, said there were at least two publicised cases in which Chinese agents seduced American diplomats stationed in China, though he hasn't heard of such a case in recent years.Mr. Mattis added that another issue is that Chinese state security doesn't gather intelligence just through spies, but also by pressing ordinary Chinese people for information, often through threats or intimidation. That, Mr. Mattis said, means any Chinese citizen who dates an American diplomat could be vulnerable to coercion."The MSS is willing to leverage any human connection that a target has to collect intelligence," Mr. Mattis said, using an acronym referring to China's Ministry of State Security. "This rule change suggests the MSS has gotten a lot more aggressive at trying to access the embassy and U.S. Government."The Chinese Foreign Ministry did not comment on the ban, saying in a faxed statement that it was "more appropriate to ask the U.S. about this question." China also has been tightening already strict controls on its personnel overseas, according to Chinese regulations, news reports and four people familiar with China's bureaucracy who spoke on condition of anonymity so they could discuss a sensitive topic. In recent years, Beijing began strictly enforcing regulations that bar promotions for Chinese civil servants with spouses who acquired foreign citizenship and restrict diplomats from spending an extended period of time in one country, forcing some to return to China. China's Foreign Ministry and many other government bodies bar their officials and staff from sexual or romantic relations with foreign citizens, while members of the Chinese military or police are generally barred from leaving China altogether without express approval from their supervisors.

New data keeps search for rare subatomic mystery going

a repeal of the Bodh Gaya Temple Act (BTA), 1949. The AIBF has support from prominent Buddhist bodies, and has submitted a memorandum to the Bihar government. The Bodh Gaya is one of the four sacred sites of Buddhism; the other three being Buddha's birthplace Lumbini, Sarnath where he gave his first sermon and Kusinagar where he attained parinirvana. Have there been protests before?

In November 2023, Buddhist monks held a rally in Gaya and submitted a memorandum to the Central and State governments. As it failed to have the desired effect, the monks scaled up the protest and held a rally in Patna last year to press for repealing the Act. Back in 2012, monks had filed a writ petition before the Supreme Court to repeal the Act. The petition is yet to be heard.

What is the Act?

The BTA established an eight-member management committee having equal number of Buddhists and Hindus. The Act made the local district magistrate an ex-officio chairperson of the committee. As the district magistrate hailed from the majority community, it translated to a Hindu majority on the committee, something which was resented by Buddhist bodies. Ever since then, various Buddhist bodies have been raising their voice intermittently for gaining autonomy over the Bodh Gaya temple, which they call the Bodh Gaya Mahavihara.

What do the annals say?

Noted poet Edwin Arnold in his well-known poem, 'The Light of Asia' talks about Gautam Siddharth's enlightenment under the Bodhi tree. Bodh Gaya was then described as the Mecca of Buddhism, and in many ways popularised Buddhism in the West. However, Bodh Gaya's claim to fame goes much further back in time. In the third century, Maurvan Emperor Ashoka worshipped the Bodhi tree and built the temple there. From the time of Ashoka to the Palas, the Bodhi temple continued to be a Buddhist place of worship and a site of pilgrimage. Chinese traveller Hiuen Tsang visited it in 629 AD during the reign of Harshavardhana. Incidentally, Hiuen Tsang called it a Buddhist site, and is said to have found only Buddhist relics here save for a statue of Avaloktishvara. Things changed with the invasion of Bakhtiyar Khilji in the 13th century. The invasion ended the Pala rule, and thus began the decline of Buddhism. During Akbar's reign, in 1590, a Hindu monk established the Bodh Gaya mutt. With this the temple lapsed into the hands of the Hindu community. Following Independence, the Bihar Assembly passed the BTA in 1949 and control of the temple was transferred from the Hindu head to the new management committee.

How has the government intervened?

The BTA was passed by the Bihar government to resolve a festering dispute between the Buddhist and Hindu heads of the Mahabodhi temple for control over the same. The Buddhist side was unhappy at the stipulation that the district magistrate, who was the ex-officio chairman, could only assume leadership if he was from the Hindu community. It changed in 2013 after the State government amended the rule and inserted a provision for the ex-officio chairman to be of any faith.

Last month, Microsoft announced a new quantum computing chip called Majorana 1 that it expected would "realise quantum computers capable of solving meaningful, industrial-scale problems in years, not decades". Independent scientists soon raised doubts about this claim - grandiose as it is - but also acknowledged Microsoft had taken on a great challenge to build such a chip and that its efforts in this direction couldn't or shouldn't be written off altogether.

Microsoft named the chip "Majorana 1" because it consists of Majorana particles, which is a particular type of subatomic particle with unusual properties. One is that a Majorana particle is its own anti-particle. The particles that make up matter, called fermions, have anti-particles with distinct identities. For example, the electron's anti-particle is a positron, not another electron. The proton's anti-particle is the anti-proton, not another proton. But uniquely among fermions, a Majorana particle's anti-particle is yet another Majorana particle. If two of them meet, they will annihilate each other in a flash of energy. One of the major open questions in contemporary physics is whether neutrinos are Majorana particles. Neutrinos are the second-most abundant subatomic particle in the universe, after photons, the particles of light. They were produced in copious amounts during the Big Bang event. They are produced in radioactive decay, when massive stars explode, and when cosmic rays strike the earth's atmosphere. They are also made during nuclear fusion: the sun alone is responsible for flooding every square centimetre on the earth with 60 billion neutrinos each second. These particles are also extraordinarily hard to catch because they interact very weakly and very rarely with matter.

Yet it is crucial physicists study them: neutrinos may just be the key to answering many of the open questions about our universe. Their tremendous numbers are a sign that they're involved in many, many subatomic processes. Thus a clear view of their properties will also afford physicists a clear view of these processes, and the as-yet unresolved questions they can answer.We don't know many things about neutrinos. Perhaps the biggest unknown is how much a neutrino weighs. We know neutrinos come in three flavours, or varieties, and we know the differences between the squares of their masses, but not the individual masses themselves. If neutrinos are found to be Majorana particles, the process that reveals them to be can be easily used to reveal their masses as well. This process is called neutrinoless double beta decay, or 0vBB for short. Chilling with beta decayEvery atom has some energy, which it bears in its particles and the forces acting between them. Sometimes an atom's nucleus may have too much energy, rendering it unstable and looking for opportunities to shed the excess. This notion of stability comes from the fact that for every set of protons and neutrons in the nucleus, there is a number that allows the particles to arrange themselves in a way that leaves the nucleus with the bare minimum of energy.For example, the nucleus of the actinium-227 atom contains 89 protons and 138 neutrons, forcing the nucleus to exist in a highly unstable configuration. To shed the 'excess energy', it undergoes a process called beta decay: it emits an electron and an anti-neutrino and changes to the



thorium-227 nucleus. Th-227 also isn't stable and decays further, but since the beta decay process releases energy, the nucleus is better off than it was before.

In nature, beta decay is a common way for an unstable nucleus to decay. It can happen in one of two forms depending on whether a nucleus has too many neutrons or too many protons. In the first case, a neutron is converted to a proton and releases an electron and an anti-neutrino. In the second, a proton is converted to a neutron and releases a positron and a neutrino. A third form exists where two beta decays happen simultaneously, i.e. two neutrons are simultaneously converted to two protons, emitting two electrons and two anti-neutrinos. The conversion ability stems from the weak interaction, which is one of the four ways in which subatomic particles can interact with each other. (The others are the strong, electromagnetic, and gravitational interactions.) The weak interaction is characterised by the appearance of particles called W or Z bosons. For example, during the Ac-227 beta decay, a neutron emits a W-boson and turns into a proton, and the W- boson decays to an electron and an anti-neutrino. A sign in the differenceAs common as beta decay is, scientists are currently on the hunt for an extremely rare variant: 0vBB. It may not even exist, but just in case it does, it would prove neutrinos are Majorana particles. In 0vBB, a nucleus emits two electrons instead of an electron and an anti-neutrino. This can happen only when the neutrino emitted by one neutron is absorbed as an antineutrino by the other neutron, which in turn can only happen if neutrinos and anti-neutrinos are the same thing. Each of the emitted electrons also has more energy because it 'includes' the energy of the missing anti-neutrino. Experiments looking for evidence of 0vBB can thus use this energy difference to tell whether a nucleus has undergone beta decay or 0vBB. This is precisely what the AMoRE experiment in South Korea has been doing, with sensitive particle detectors pointed at a crystal containing 3 kg of molybdenum-100 nuclei, cooled to fractions above absolute zero. Mo-100 nuclei are known to undergo double beta decay. In a paper published in Physical Review Letters on February 27, the AMoRE team reported it hadn't observed evidence of 0vßß. Because the process is already hypothesised to be rare, not observing it could just as easily mean we didn't look long enough. This is why the team reported in the paper that a population of Mo-100 nuclei would decay to half their number through 0vBB in no less than 1024 years. It could also mean 0vBB might show itself in a larger sample. In a future iteration of AMoRE, the physicists plan to look for it in 100 kg of Mo-100.Meanwhile, they've also estimated the mass of each neutrino would have to be lower than 0.22-0.65 billionths of a proton. This is an extremely low mass ceiling, but it's not the same as saying the neutrinos have zero mass. The distinction is crucial. The current theory of all subatomic particles, called the Standard Model of particle physics, says neutrinos should be massless.

Nicholas Pooran's incredible tale: from six months in wheelchair after traumatic car accident to smashing sixes in the IPL



When Rishabh Pant was battling physical pain and mental demons on his hospital bed after a near-fatal car accident two years ago, his Lucknow Supergiants colleague Nicholas Pooran would regularly text him with comforting messages. He was not his teammate then, but he could fully relate to the wars waging in Pant's head. "It's very challenging. It's one where no one understands. You go into a place where you're very depressed, and frustrated," Pooran would empathise with Pant years ago, on the highway near his home, Pooran, LSG's leading light this season, saw death screaming in front of his eyes like Pant did. Just 19, the buzz around him bubbling after a prolific Under-19 World Cup, he was driving home to Couva, from the training centre in Balmain, when he pulled away to the side so that a car by his side could overtake another and crashed into a sand heap

He dragged the car back onto the road, before another car knocked him down. "I woke up with the car smashed. Then the ambulance came. I was in so much pain, I just wanted them to knock me out," he recollected the ordeal to Daily Mail years later. When he regained consciousness, he was in the hospital. He tried moving his legs. He could not. They were wrapped in heavy casts. "They were numb. I couldn't feel them at all. I was on painkillers throughout the 12 days I was in hospital," he said.day, he asked a doctor whether he could play cricket again. He found his answer in the doctor's grim face. He asked whether he would run again. "Maybe", the answer came. His heart sinking, he asked whether could walk again. "Yes," the doctor said, "but without being able to bend the left leg fully." Any act in the game would require bending, he knows, and he was a wicket-keeper too (modelled on his idol MS Dhoni). His world crumbled.

As much as the bone-crushing pain on his legs—he had ruptured the patellar tendon on his left and fractured his right ankle—he worried about his future. His career was just blossoming, whispers were abound that he was in the mind of the national team's selectors, and T20 talent-hunters were scouting him. Twice he went under the surgeon's knife. A fortnight later he was discharged from the hospital on a wheelchair, his friend for six months. "It was the most difficult six months of life, but it made me a better person," he admitted. The phase taught him about the fickle nature of life. "I learned to take setbacks with the same composure as success, to take nothing in life for granted." he would treatment table.Once they were good enough to stand on both feet, they started going for long walks together, before running and gymming as their bodies healed. Pollard later introduced him to one of the most powerful sports agents around, Eddie Tolchard at Insignia Sports. A year after the accident, he was playing in the Bangladesh Premier League. The cricket board slapped a six-month ban. But Pooran's convictions remained firm. "You have to believe in your talents, and keep working," he kept telling himself.He has so much faith in his virtues that he sounds borderline arrogant when he talks about talent. A short, slender man, he generates immense power with his bat swing and transfer of weight, always getting under the ball when smashing the sixes, which he could all-park around. He shuttles between the classical and modern schools of Caribbean batting, gleaning elements from both. In his hands, the bat is both a shovel and paintbrush.Like all of the aforementioned legends, he is a happy six-hitter, the gift that had made him one of the most sought-after names in franchise cricket. This edition, no one has smoked as many sixes as him (15). None has struck the maximums so frequently either (once every 5.5 ball). Only Travis Head has found more fours than Pooran's 17. That is, he has found the fence or beyond once in every three balls (2.65). Last year, he was the highest six-hitter in T20s (170 in 74 innings) by a huge distance (next was Heinrich Klaassen (105 in 54). 

One of the most hardworking actors, Katrina Kaif. Because she was not a dancer. She wasn't trained as a dancer. And she was very tall and statuesque, a big built. How she's worked on her body! How she's worked on her dance! Commendable," said Terence.

In the interview with Pinkvilla, Terence recalled how he had a very different experience when he worked with her after Boom. "I remember her coming to my studio way back when Boom had just released. She was doing a diamond jewellery show. We were trying to teach her. She was also very young, fresh to India, very like 'What am I supposed to do?' Vijay Deverakonda predicts filmmakers from outside Mumbai will revive Hindi cinema; says Telugu industry fought for recognition

Many actors and filmmakers have spoken about the struggles of the Hindi film industry and its recent box office failures. Telugu actor Vijay Deverakonda recently weighed in on the topic, offering his perspective on why the South film industry is having a 'dream run' and predicting a resurgence in Hindi cinema with a new generation of filmmakers.

Speaking to News9, Vijay emphasised that the current phase of Hindi cinema is part of a larger cycle and not a cause for concern. "South film industry is having a dream run. It's a cycle. There was a time when you knew nothing about us. There was a time when India cinema was making solid noise and money, it had opened up international audience. It's a cycle. Now is the time when South cinema is being loved and watched. Five or 10 years later there will be some other changes," he said. Vijay predicted that Hindi cinema will undergo a creative reboot, with fresh storytellers emerging to steer it in a new direction. He said, "From this vacuum surely a new breed of filmmakers will emerge who wants to fix this. Hindi cinema will find big directors and new storytellers very soon and they will probably be from outside Mumbai. It is my prediction. They would probably be from heartland and they will start coming from other sections of Hindi-speaking areas. They will start making films in a different way and maybe even different from what South is making."Citing Baahubali as an example, the Arjun Reddy actor highlighted how director SS Rajamouli took a massive risk with the film, which ultimately put Telugu cinema on the global map. "Telugu cinema had to fight its way for bigger audience. For instance, when SS Rajamouli made



Baahubali. They spent so much on two actors that Hindi film industry might not have known and they went ahead and made such a big film. If it wouldn't have worked, it would have ended so many careers. The producers would have been in a lot of trouble. And the actors solely gave 5 years just for that one film. So the stakes were high for everyone. So you need to fight for your place, attention and love. I think they (Hindi film industry) will find their ways. It is part of life," he shared.

The following week, Triple H addressed the situation and said, "I will wrestle a broomstick for two hours, and that broomstick will give me a better match than half of the people out there on strike. Come hell or high water, I am giving you a show." Right after that, superstars John Cena, Sheamus and even CM Punk walked to the ring and declared their support for him.John Cena took digs at his previous bosses - Vince McMahon, Eric Bischoff and Vicky Guerrero and said, "I am not saying that you are my best friend, but you are my boss, and I am staying."
