Telangana HC upholds death penalty for five in 2013 Dilsuknagar bomb blasts case

Hyderabad: The Telangana High Court on Tuesday upheld the death sentence to five convicts, including the banned Indian Mujahideen's (IM) co-founder Yaseen Bhatkal and a Pakistani national, in the 2013 Hyderabad bomb blasts. A division bench of Justice K. Lakshman and Justice P. Sree Sudhha dismissed the appeals filed by the convicts challenging the order of a special NIA court pro-

Apart from Bhatkal alias Ahmed Siddibappa Zaraar and Pakistani national Zia ur Rehman alias Wagas, Asadullah Akhtar alias Haddi, Tahseen Akhtar alias Monu, and Aizaz Saeed Shaik alias Aijaz Shaikh were sentenced by the NIA court for offences, including waging war against the nation, criminal conspiracy and murder. The twin blasts in the Dilsukhnagar area of Hyderabad on February 21, 2013, killed 18 persons, including one unborn child in a mother's womb, and injured 131 othersAll five were convicted for offences, including waging war against the nation, criminal conspiracy and murderThe death sentence was pronounced under sections 302 A and 121 of the Indian Penal Code, section 3B Explosive Substance Act and section 16 of the Unlawful Activities Act. The counsel for one of the convicts, Aijaz Shaikh, said they would file an appeal in the Supreme Court. He said they would file an appeal after going through the High Court order.

Two of the convicts are lodged in Cherlapally Jail in Hyderabad, while others are lodged in other jails in the country as they are facing trial in other terror cases. Yaseen Bhatkal is brother of Riyaz Bhatkal, the brain behind the blasts and the main accused, who is absconding and suspected to be hiding in Pakistan. The NIA has already issued an Interpol Red Corner notice for him. Bhatkal brothers are from Bhatkal town of Karnataka, while Rehman is from Mustafabad of Pakistan's Punjab province, Asadullah Akhtar from Uttar Pradesh while Tahseen Akhtar and Aizaz

This comes shortly after it was revealed that the State posted zero per cent growth in GST collections for March 2025 compared to the same month last year. According to official figures, Telangana's total GST collections from April 2024 to March 2025 stood at Rs.62,987 crore. Central GST grew by a modest 6.6 percent while State GST saw a paltry 3.7 percent increase compared to last fiscal. T

Hyderabad: The writing on the wall is clear. Chief Minister A Revanth Reddy has his back against the wall, under attack from all sides and within the party too. The Kancha Gachibowli fiasco has seen Revanth Reddy facing one setback after the other, from the Supreme Court, from the High Court, from the public, from the opposition. Now, with the All India Congress Committee (AICC) too stepping in to take the reins of governance in the State, as seen from how Telangana in-charge Meenakshi Natarajan has been involved in the university issue over the last few days, Revanth Reddy is undoubtedly rattled. The situation has seen him resorting to yet another gimmick, that of invoking Telugu pride and self-respect in an effort to loosen the AICC strings that are tightening on him.Reports in media outlets feeding on leaks from the Revanth Reddy camp smack of desperate attempts to warn the AICC, by calling its actions self-destructive, that it was undermining the duly-elected Chief Minister and also dubbing Natarajan & Co as 'super bosses'. What was discussed in hushed tones in Gandhi Bhavan and in those media outlets is now out in the open after Natarajan showed that she meant business and that the final word was still with the high



command. She not only participated in the Committee of Ministers' meeting with University of Hyderabad Teachers Association and representatives of public organizations at the Secretariat, but also got Deputy Chief Minister Mallu Bhatti Vikramarka to issue orders to the police to withdraw cases registered against UoH students and even to withdraw the police from the campus.

This move, apparently seen as a retreat from the smouldering war zone by the government, has left not just Revanth Reddy, but the State leadership also jittery. Ministers are quietly saying that Natarajan should not have participated in the meeting or gone to the Secretariat, or in other words, that she should not have "meddled with administrative issues". However, insiders point out that the AICC had only tightened the strings that it already thrown around Revanth Reddy, citing how the high command had rejected his suggestions for the MLC elections, how actor-turned-politician Vijayashanthi came from literally nowhere and became an MLC, and how the Cabinet expansion has been kept on hold for a year now, despite Revanth Reddy's 40-odd visits to Delhi

KTR accuses Revanth govt of allowingTelangana water exploitation



Hyderabad, April 8: BRS party working president K Tarakarama Rao on Tuesday accused the Revanth Reddy government of allowing rampant exploitation of Telangana's rightful water share since coming to power. "Due to the State's negligence, our share of Godavari waters is going to waste," he said. He criticized the appointment of Adityanath Das, who argued against Telangana projects on behalf of Andhra Pradesh as the State's irrigation advisor and questioned if Andhra CM Chandrababu Naidu had influenced Revanth Reddy."The irrigation advisor is working solely for Andhra's interests. How can we stop their water exploitation in this situation?" KTR asked. The battle lines are set to harden as China has decided to red-flag US recipro al tariffs as a "new trade concern" at a WTO meeting o April 9. Beijing has signalled its intent to build a broad coali on to jointly oppose unilateralism and protectionism, and afeguard the international trading system.

The onus will be on othe nations to fall in line – how long they can hold out will de end on their ability to hit back. Hyderabad:Women in Sandwich Generation must take proactive steps to take charge of their financial planning including improving their financial know-how, said Edelweiss Life's Chief Distribution Officer Anup Seth. The company recently released a study which shows 50% women in this generation cite lack of understanding of various financial instruments as a challenge to wealth creation. 

Telangana to introduce slot booking system for registrations from April 10: Ponguleti



Hyderabad, April 8 (NSS): Ponguleti Srinivasa Reddy, the Minister for Revenue, Housing, Information and Public Relations, stated that the State government is enhancing the Sub-Registrar offices to deliver improved services to citizens throughout Telangana. The aim is to ensure these services are provided in an efficient, straightforward, quick, transparent, and corruption-free manner. To achieve this goal, the State government is launching a slot booking system that will allow the registration process to be completed in just 10 to 15 minutes, eliminating the need for long waits for document registration. This was announced by Ponguleti Srinivasa Reddy in a statement on Tuesday. The Minister mentioned that this slot booking system will be initially rolled out as a pilot program in 22 sub-registrar offices starting April 10, out of the 144 sub-registrar offices located throughout Telangana. The slot booking programme will be launched at a total of 22 places, including Azampura, Chikkadapalli in Hyderabad, Sadashivapet in Sangareddy district, Qutbullapur, Vallabh Nagar in Medchal district, Shamshabad in Rangareddy district, Saroor Nagar, Champapet, Ramagundam in Peddapalli district, Kusumanchi in Khammam district, Khammam (R.O), Medchal (R.O), Mahabubnagar (R.O), Jagtial, Nirmal, Warangal Fort, Warangal Rural, Kothagudem, Armur, Bhuvanagiri, Choutuppal, Nagar Kurnool, he said. In an effort to prevent delays from multiple document submissions for registration at the Sub-Registrar's office on the same day, the Minister announced that the office's working hours have been organised into 48 designated time slots. He explained that individuals can reserve a slot for a preferred date and time directly via the website "registration.telangana.gov.in." Visitors are encouraged to arrive at their scheduled time to complete the registration process and depart promptly.

The Minister further mentioned that for those without a prior booking, the office will accommodate five walk-in registrations daily between 5 PM and 6 PM for urgent cases. Walk-in applicants will be served on a first-come, first-served basis. To improve the slot booking experience, particularly in offices with high demand or where more than 48 slots are necessary, the Minister indicated that additional Sub-Registrars will be appointed alongside the existing staff. As part of a trial initiative, the Qutbullapur office in the Medchal Malkajgiri district has appointed two additional Sub-Registrars and an extra staff member, resulting in an increase of 144 available slots in the office, he reported.Ponguleti Srinivasa Reddy noted that daily complaints are being received from residents about the potential for their properties being registered multiple times. To address this issue, the State government plans to revise the law to prevent such double registrations. The Minister added that several other states have already modified their laws regarding this matter, and efforts are underway to amend the legislation in Telangana as well. He mentioned that a new section, 22-B, will be added through amendments to Section 22 of the Reg-

Hyderabad, April 8: The Muslim Joint Action Committee (JAC) of Telangana and Andhra Pradesh, under the banner of Tahreek Muslim Shabban, has announced a massive protest march in Hyderabad against the Centre's recently approved Waqf Amendment Bill. The 'Telangana March to Rollback Waqf Amendment Act-2025' will take place on April 26 at Dharna Chowk, starting 2 pm. The venue for the Telangana March was finalised during the core committee meeting of the JAC held on Monday evening at the head office of Tahreek Muslim Shabban in Azampura, Hyderabad. The meeting was attended by MBT spokesperson Md Amjedullah Khan Khaled, TPCC spokesperson Syed Nizamuddin, Minorities Finance Corporation former Chairman Akbar Hussain, Dr Toufeeq of Wahdat-e-Islami, TPCC Secretary Osman Mohammed Khan, Nazimuddin Faroogi of Muslim Chambers and other eminent personalities. The announcement was made by JAC convenor and

Tahreek Muslim Shabban president Mohammed Mushtaq Malik. He stated that people from all districts of Telangana would participate in the march, which aims to pressurise the Central government to withdraw the controversial legislation. Mushtaq Malik said the march would be bigger than the anti-CAA and NRC protests held in 2019, which were among the largest peaceful agitations in the country. "All political parties except the BJP, including the Congress, BRS, CPI, CPM, as well as leaders from religious institutions, educational bodies, and social organizations, are expected to join the march," he said. The main objectives of the Telangana March are to ensure the protection of mosques, dargahs, khanqahs, Ashoorkhanas, graveyards, Waqf properties, religious schools (madrasas), and Eidgahs, which protesters believe are under threat due to the amendment. Warning of grave consequences if the Muslim community remains silent, Malik said, "If we do not rise against this Act, all Waqf properties will be lost. Hindutva forces want to deprive Muslims of their rightful properties. Every Muslim must step out of their homes to resist this attempt. In the lead-up to the April 26 march, weekly peaceful protests will be held every Friday outside mosques across Telangana. Participants will wear black ribbons and wave black flags as a symbol of protest. Malik emphasised that the agitation would remain completely peaceful. The committee also plans to seek the support of key political leaders, including Chief Minister A Revanth Reddy, former CM and BRS president K. Chandrashekar Rao, BRS working president K.T. Rama Rao, TPCC president Mahesh Kumar Goud, and leaders from CPI and CPM.Responding to a question, Mushtaq Malik remarked that "those supporting the Waqf Amendment Act cannot be considered true Muslims." The protest is shaping up to be one of the largest demonstrations in recent times, with strong participation expected from both Muslims and non-Muslims, who believe in preserving constitutional and minority rights.

KTR on Party's silver jubilee celebrations

Increase cultivation area for horticultural crops in Telangana: Kodanda Reddy

Hyderabad, April 8 (NSS): M. Kodanda Reddy, the Chairman of the Telangana Agriculture and Farmers Welfare Commission, emphasised the need to expand the cultivation area for horticultural crops in Telangana. He recommended that officials implement measures to boost horticulture as part of a pilot project in three villages located in the Yacharam mandal of Rangareddy district. The meeting, chaired by the Commission Chairman Kodanda Reddy, was attended by Commission Members Gopal Reddy, Bhavani Reddy, Gadugu Gangadhar, Member Secretary Govindu, Agriculture, Horticulture, Marketing, NABARD officials, Commission DAO Sandhya Rani, Agriculture Officer Hari Venkata Prasad, and NGO representatives. During the meeting, officials stated that the villages of Gaddamallayya Gudem, Mondi Gourelli, and Chaudhary Guda in Yacharam mandal have been chosen for a pilot project aimed at expanding the horticultural crop cultivation area.

They indicated that the specific needs of farmers who grow vegetables and leafy greens in these villages have been recognised by the government.Kodanda Reddy emphasised that, due to the limited rainfall and water resources in Rangareddy district, officials should recommend that farmers focus on cultivating crops that require less water. Guidance should be provided to the farmers accordingly. In addition, officials need to devise plans to enhance the cultivation area for vegetables, greens, fruits, and flower gardens throughout the State.

AP govt to expand 'Zero Poverty P4' program

Chief Minister N. Chandrababu Naidu held a review meeting at the Secretariat on Tuesday regarding the establishment of the State-Level Society and the progress of the P4 program. Gurukulas to offer comprehensive coding courses for students' bright future

Hyderabad, April 8: In an era where technical proficiency is as crucial as academic knowledge, TGSWREIS (Telangana Social Welfare Residential Educational Institutions Society) is set to revolutionise education with the introduction of coding courses across its schools. Announcing this initiative on Tuesday, Dr. V.S. Alagu Varshini, Secretary of TGSWREIS, revealed that starting from the academic year 2025-26, coding training will be offered to students from Class 6 through to Intermediate in all 238 Gurukula schools across Telangana. Last year, coding training was offered only at the Moinaabad Gurukula school. However, following the success of the pilot programme, the decision has been made to expand this initiative statewide, she said. Alagu Varshini further stated that the training will be conducted in collaboration with the Raspberry Pi Foundation (RPF) from the United Kingdom, which has signed a Memorandum of Understanding (MoU) with TGSWREIS for a five-year partnership. The foundation will provide expert guidance in areas such as curriculum development, action plan monitoring, and pedagogy. The Telangana government has taken a significant step in integrating technology into the curriculum. The focus will be on Artificial Intelligence (AI), Coding, Machine Learning, Robotics, and Online Tools, all of which will be taught to students from the 6th class through Intermediate, she said. Alagu Varshini further explained that the pilot project, which involved selecting five students from each Gurukula school to engage in experimental coding training, yielded impressive results. Building on this success, the collaboration with the Raspberry Pi Foundation (RPF) is set to expand the initiative to all Gurukula schools in the upcoming academic year, ensuring that every student benefits from qualitative technical education. The goal is not only to teach coding but also to provide students with a comprehensive understanding of the digital world," she added. Under the new curriculum, approximately 1,52,000 students across Gurukula schools will be taught Computing as a regular subject. This includes two hours of classroom sessions focused on computing concepts, followed by two hours of

'Shiv Sena-style swagat hoga': Rahool Kanal to Kunal Kamra after Madras high court order, says 'not a threat'

Rahool Kanal of the Shiv Sena's Yuva Sena (Shinde faction) on Monday said the party would welcome stand-up comedian Kunal Kamra in "good Shiv Sena style" whenever he enters Maharashtra. Rahool Kanal, who was earlier arrested and granted bail along with 11 other Sena workers for vandalising Mumbai's Habitat studio where Kunal Kamra allegedly made a joke about Maharashtra deputy chief minister Eknath Shinde, asked the comedian, a permanent resident of Villupuram town in Tamil Nadu, to face the legal process in Mumbai.Kunal Kamra, known for his satirical comedy and outspoken views, has been facing legal trouble following complaints accusing him of making derogatory comments.

The FIRs have been registered in Maharashtra, prompting the comedian to seek legal protection from arrest while he prepares to contest the charges. On Friday,

the Madras high court granted interim anticipatory bail to Kunal Kamra on the condition that he execute a bond to the satisfaction of the judicial magistrate at Vanur in Villupuram district in Tamil Nadu. Kamra had submitted he moved to Tamil Nadu from Mumbai in 2021 and has been "ordinarily a resident of this State (Tamil Nadu) since then" and that he feared arrest by Mumbai Police. Reacting to Madras high court's decision, Rahool Kanal told news agency ANI, "We welcome the court's order that gives him relief, but it is only until April 7. He should come and face the law... No matter what protection he has there (in Tamil Nadu), whenever he comes to Mumbai, he will be welcomed in a good 'Shiv Sena style'."When asked if it threatened the comedian, the Shiv Sena Yuva Sena general secretary replied, "It's not a threat. Mumbai has this culture of 'Atithi Devo Bhava', and he considers himself a guest here (in Mumbai) now.

What is there to get scared of? He should face the law and follow the procedure. "Kanal emphasised that Yuva Sena members regularly visit the police station for attendance as per legal procedures. Meanwhile, Shiv Sena (UBT) leader Sanjay Raut claimed that the ministers in the Maharashtra state cabinet are threatening Kunal Kamra to be "shot and hanged immediately" over his controversial remarks about Shinde. During the press conference on Monday, Sanjay Raut addressed the security concerns for Kamra, stating that the cabinet ministers are allegedly demanding that Kamra be shot and hanged immediately. Raut also criticised Maharashtra CM Devendra Fadnavis for not taking any action against such "lawlessness" by the cabinet ministers."Ministers in state cabinet are threatening Kunal Kamra openly. They are demanding Kamra to be shot and hanged immediately.

RSS to pick Narendra Modi's successor, likely from Maharashtra, Sanjay Raut claims day after PM visits Sangh headquarters

A day after Prime Minister Narendra Modi visited the headquarters of the Rashtriya Swayamsevak Sangh (RSS) in Nagpur, Shiv Sena (UBT) MP Sanjay Raut claimed on Monday that the RSS is set to pick Modi's successor.Raut said it is clear that the PM will be made to retire at the age of 75, adding that Modi never visited the RSS headquarters in the last 11 years but he went on Sunday to inform that he was quitting.

"At this moment, it seems that the RSS will decide (the successor) and that is why Modi was called... The discussions of the Sangh take place behind closed doors and those discussions probably do not come out. Still, there are some indications, and those indications are clear. The next leader will be decided by the Sangh and he will most likely be from Maharashtra," Raut said. "Sarsanghchalak Mohan Bhagwat and the entire Sangh Parivar want a change in the country's leadership. Now Modi's term is over. The RSS now wants to have a presence in the country. It also wants a say in electing the BJP national president. Therefore, Modi went to the RSS headquarters to see off and say that he is leaving," the Sena (UBT) leader claimed. Raut also took a dig at PM Modi over his statement that the RSS was involved in India's freedom struggle. He said, "The RSS



was nowhere in the Indian freedom struggle. What was its contribution? Narendra Modi should take a briefing from us on this. What did the RSS do for breaking the shackles of slavery?""For 150 years, this country was bound by the shackles of slavery. From Mahatma Gandhi to Pandit Nehru, Sardar Patel, Savarkar, this struggle took place under the leadership of all of them and the shackles of slavery were broken," Raut added. The MP stated that until the attempt to project a false history is stopped, the mentality of the people will not improve. "You (BJP) are making people blind devotees and madmen. Therefore, this nation could be in the list of mad countries." he said.

Punjab Vigilance Bureau arrests SHO, ASI for demanding Rs 1.50 lakh bribe

The Punjab Vigilance Bureau Sunday arrested a sub-inspector posted as the station house officer (SHO) and his subordinate, an assistant sub-inspector (ASI), in the state's Hoshiarpur district for demanding a bribe of Rs 1.50 lakh. A Bureau spokesperson said Monday the arrests were made after an inquiry into an online complaint filed by a resident of the Asalpur village in the district on the Chief Minister's Anti-Corruption Action Line.

The complainant alleged that a First Information Report (FIR) was registered at the Bulowal Police Station against his nephew under the Narcotic Drugs and Psychotropic Substances Act (NDPS), and the two policemen were threatening to implicate his son in the case under Section 29 of the same Act. According to the complaint, the assistant sub-inspector initially demanded a bribe of Rs 1.59 lakh on behalf of the SHO to spare his son but reduced the amount to Rs 1 lakh after negotiations. The complainant recorded his conversations with the policemen in which they can be allegedly heard demanding a bribe, and submitted the audio evidence to the Bureau.

The Bureau spokesperson said after the its Hoshiarpur



unit verified the complaint, and obtained legal advice, a case was registered against both policemen under sections 7 and 7A of the Prevention of Corruption Act, Section 61(2) of the Bharatiya Nyaya Sanhita (BNS), and Section 59 of the NDPS Act at the VB Police Station under the Jalandhar Range. "Both accused have been arrested and would be produced before the competent court tomorrow. Further investigation is underway," said Harpreet Singh Mander, Senior Superintendent of Police, Vigilance Bureau (Jalandhar Range).

Ambedkar University revokes suspension of student activist, says decision taken keeping in mind student's future

The Delhi-based Dr B R Ambedkar University withdrew its decision to suspend a student activist on Friday, following days of protests by student bodies and rising tensions on campus. In a statement, the varsity said, "Dr. B.R. Ambedkar University remains committed to maintaining high academic standards and a disciplined university environment for the benefit of its students. Regarding the disciplinary action taken against student... the university followed all established norms and procedures. The student was given multiple opportunities to present her side of the matter. The Proctorial Board attempted to hear her twice, and she also appealed to the

"Taking her appeal into consideration, the Vice-Chancellor directed the Proctorial Board to review the matter once again. The board invited the student to present her case on April 3, 2025, but she did not appear. After thorough consideration of the appeal, the Vice-Chancellor directed the proctorial board to show some leniency in this specific case and then (the) board after due deliberations recommended to allow the student to continue her academic pursuit under

strict disciplinary guidelines. This decision was made while keeping in mind the university's integrity, academic environment, and the student's future," it added. The statement came more than two weeks after a student and member of the All India Students' Association (AISA) was suspended for six months for allegedly using the official university email to criticise the vice-chancellor's Republic Day speech. The suspension also barred her from entering the university premises during the period. Her suspension prompted a wave of student-led protests that questioned the university's handling of dissent and its approach to disciplining students.

The protests unfolded against the backdrop of a separate internal circular that raised concerns over increasing surveillance of student activities. Last week, an email from the Dean of Academic Affairs directed faculty members to report "disruptions" in classrooms, linking them to student collectives. "It has come to our attention that certain disruptions caused by students or student collectives have been affecting classroom instruction," the Dean wrote. "With immediate effect, faculty members are required to implement the following measure: In cases where such incidents occur, it is imperative that faculty members report that event promptly," he added. The email further instructed faculty to document the "date, time and location" of such incidents, including identifying details of students or groups involved and noting the actions taken to address the situation. These

'How will we hold classes, check Madhyamik scripts?': Heads of West Bengal schools face major crisis after SC order ousts 25,000 teachers

"My science faculty is almost entirely gone. How will we run classes?" said Kakoli Chowdhury, headmistress of Sailaja Memorial Girls High School in Lalgola, Murshidabad, where the employment of 18 out of 46 teachers is to be cancelled after a Supreme Court order nullified 25,752 school jobs in West Bengal. From holding classes and tests to checking answer scripts of Madhyamik (secondary board) examinations, hundreds of schools in West Bengal are facing a crisis after the order. Many state-run schools were already suffering from a dearth of teachers.

Notably, schools in West Bengal are yet to get an official notification in connection with the cancellations of recruitment, which came as the Supreme Court said the 2016 School Service Commission (SSC) recruitment process was "vitiated and tainted by fraud". Siddhartha Majumder, Chairman of Central School Service Commission of West Bengal, on Friday said, "We already got a letter from the state government regarding the Supreme Court order. We have started taking legal advice. We can say something only after making a decision. But the whole process cannot be completed within the three months.""We have 46 teachers out of a sanctioned strength of 60. Our school has 4,000 students. Now after the SC order, 18 teachers and a nonteaching staff will be gone. Most of the teachers teach biology, physics, chemistry and maths. Who will teach those subjects now?" said Chowdhury. "At present, the unit tests are on. How will we conduct the tests?" she said.

The thoughts were echoed by Jehangir Mian, a physics teacher at Lalgola M N Academy high school, where 11 teachers and one non-teaching staff will lose their jobs. "Last year, we started Al and data science classes in our school.

We had only one teacher for the subject. He lost his job How will the students study? The students can't even take tuitions since not a single teacher in that subject is available in the entire Lalgola block," said Mian. The school has more than 4,000 students. "Many teachers who lost their jobs were in the process of scrutinising answer sheets of the Madhyamik examination. What will happen to that? The answer scripts they scrutinised, will they be valid? Who will check the answer scripts that are still left to be scrutinised? We do not know how to teach students and manage such affairs. Will we reduce periods and stop teaching some subjects for the time being? I had contacted the secondary and higher secondary board officials. They are also in the dark," Mian claimed. At Orahar Girls High School in Bhagabangola Murshidabad, where there are around 2,000 students, eight of the 19 teachers have been ousted. Najmun Nahar, the headmistress said, "Today, we have our first summative (unit test). I have requested the teachers to stay since the notification is yet to come. But after the notification what will happen? I am not sure how we will run the school."

Though the Supreme Court has ordered fresh examinations through the West Bengal School Service Commission within three months, school administrations and teachers remain concerned about timely replacements. Sahin Saraf, headmaster of Sekhalipur high school in Lalgola, said the school will lose teachers for subjects like geography and physics. "We lost nine teachers, six of whom teach science subjects. One must understand that not only for teaching, but teachers operate data and work for various government schemes like Kanyashree. Everything will be affected.

Though the SC has ordered fresh examinations and a recruitment, whether it will happen on time and whether our school will get the requisite number of teachers is a question. It may take months." This school has around 5,000 students. In Arjunpur High School of the Farakka block of Murshidabad district, with 9,500 students, 36 of the 70 teachers will lose their jobs. "We haven't recruited since 2018. It will be a very tough time to continue running the school," said Faruk Abdullah, teacher and member of the School Organising committee. Basudeb Santra, headmaster of Salimabad High school in Jamalpur, Bardhaman district, which has 1,200 students, said the school will no longer have science or history teachers. The school has also lost a clerk. Kalna Kashra high school in the same district lost science, philosophy, and history teachers and a clerk.

Right to bodily autonomy: HC allows woman to terminate pregnancy with foetal anomalies

Mumbai, The Bombay High Court has granted a 32year-old woman's plea to terminate her 26-week pregnancy over foetal anomalies at a private hospital of her choice, emphasising her right to reproductive freedom, bodily autonomy, and the right to choice. A division bench comprising Justices Revati Mohite Dere and Neela Gokhale allowed the termination to be carried out at a private hospital of the woman's choosing, provided the hospital submits an affidavit affirming it meets all the requirements under the Medical Termination of Pregnancy Act. The provisions of the MTP Act don't allow termination of pregnancy beyond the 24week gestation to be conducted in private hospitals without the court's permission. "Conscious of the right of the petitioner to reproductive freedom, her autonomy over the body and her right to choice and having considered the medical condition of the petitioner, we permit the petitioner to terminate the pregnancy medically," the high court stated in its order dated March 28. The court's decision followed the woman's appeal to ensure that the procedure involved foetal heartbeat reduction to prevent the baby from being born alive. The bench, however, directed that the medical board at the state-run J J Hospital offer an opinion on the most suitable method to carry out the termination. The petitioner, a resident of Mumbai, said she wants to terminate the pregnancy at a hospital of her choice. Her lawyer Meenaz Kakalia said the procedure could be carried out if the requisite facilities under the Medical Termination of Pregnancy Rules were available at the private hospital. She had discovered a foetal anomaly during a Foetal Echo Cardiography at around 24 weeks of pregnancy, which revealed skeletal dysplasia—a condition likely to lead to severe morbid-



ity. A medical board at J J Hospital had given the green light for termination based on the foetal condition.Kakalia cited a guidance note issued by the Union of India under the MTP Act, which provides for the cessation of the foetal heartbeat to prevent a live birth. She said Maharashtra has adopted these guidelines. The high court bench stated that as per the Rules, the procedure to stop the foetal heart, whenever contemplated, needs to be clearly mentioned in the recommendation or report of the medical board. However, the court observed that the medical board's report did not recommend a specific method for the termination, particularly regarding foetal heartbeat reduction. In light of this, the court requested the J J Hospital medical board to provide its opinion within two days."Considering that the pregnancy is at an advanced stage, we deem it appropriate to request the medical board to give its opinion to the medical practitioner concerned within two days," the court said.

Only police inspectors, sub-inspectors with body cameras can issue traffic fines in Goa: CM Pramod Sawant

Announcing a slew of measures to curb harassment of both local residents and tourists in Goa, Chief Minister Pramod Sawant on Friday said only police inspectors with body cameras will now be authorized to issue challans (fines) for traffic violations during the day time. During the night time, either police inspectors or sub-inspectors with cameras installed on their uniform will be allowed to issue challans for traffic violations, he said, adding the new rule has come into effect from .The CM also warned that tourists who arrive in the state with gas stoves to cook on the road will face strict police action. Sawant was addressing a press conference at Mantralaya (secretariat) at Porvorim after chairing a meeting of high-ranking officials to review the implementation of new criminal laws (Bharatiya Nyaya Sanhita, Bharatiya Nagarik Suraksha Sanhita, and Bharatiya Sakshya Adhiniyam) in Goa. The chief minister, who holds the home portfolio, maintained only officers of the rank of police inspector with cameras installed on their uniform will be eligible to issue challans for traffic violations during the day time. He informed the state police will identify traffic violations through methods like dash cameras, digital cameras installed on the road side or other gadgets with Artificial Intelligence (AI). He clarified that no official of the rank of constable, head constable or assistant sub-inspector (ASI) will be eligible to issue challans.

"If anyone of that rank (constable, head constable or ASI) is found issuing challan, then citizens can click their pictures and send them to the police department. Such officials will be suspended from duty," Sawant warned. However, taluka nodal officers with body camera can issue challans, he said. "These measures will stop harassment of locals and tourists. They will also do away with

allegations levelled against police officers (of asking for bribes)," the CM emphasised. Warning travellers who prefer to carry their gas stoves and cook food at the roadside, the chief minister said all tourist vehicles entering the state will be checked thoroughly at the state border.

If they are found to be cooking at the roadside, their gas stoves and cylinders will be seized and their vehicles fined, Sawant insisted. The move is aimed at reducing roadside garbage, he said. In yet another announcement, the chief minister said activities of begging, massage on the beach and also touting will be completed banned. "Anyone found offering massage services or begging or touting will be immediately arrested by police," he cautioned.

For the eighth year running, the Whitefield Art Collective event is now being hosted at the Whitefield VR Mall in Bengaluru, with exhibits, paintings and sculptures on display in various corners of the mall. Backed by the Yuj Foundation, which conducts Public Art Festivals across the country, the Art Collective this year is on the theme 'The Future is Now'. The main event, which began on March 27, was preceded by a small film festival, hosted by the British Council

According to curator Sumi Gupta, the idea behind the festival is to create a space where people can freely express themselves, particularly in terms of identity, making it a diverse and inclusive platform. "As for the films we selected, this is actually a film festival hosted by the British Council, showcasing Five Films for Freedom. These films, created by global filmmakers, focus on themes of inclusivity, identity, and the need for a more accepting society," Gupta

The festival has largely collaborated with local artists for many of the exhibits. Gupta said that every festival is deeply rooted in the local community, with collaborations involving both local and global institutions. "The students working on the art installations are always from local schools. For example, in the Whitefield Art Collective, they come from institutions like the Bangalore School of Design and Chitrakala Parishath," the curator said. Among the major exhibits not to be missed are 'The Sunflower Series' by Chennai-based artist Gita Hudson and 'Through The Window' by Korean artist SoonYoung Yang. Other displays use existing objects as mediums of art - one of these is an auto-rickshaw made into an art display- created by an artist who is a rickshaw driver and art student by night. Vikhroli railway overbridge in Mumbai likely to be ready by July

Originally conceived in 1997, the bridge was proposed as an alternative to a level crossing that existed at Vikhroli. Commuters travelling in the east-west direction often used to trespass the crossing and in many cases, people had lost their lives. Following this, the authorities mooted a proposal to build Vikhroli bridge as an alternative. Even though the crossing was sealed during the early 2000s, the bridge still couldn't be built within a decade after its conceptualisation. It was only in 2018 that the tenders for the bridge were finally floated and work orders issued. The bridge will connect Eastern Express Highway in the east with Lal Bahadur Shastri (LBS) Marg in the west. Till date, there is no direct east-west link in Vikhroli and local residents have to either take the ROB from Ghatkopar or Kanjurmarg for their journey. The flyover will also provide pedestrians direct access to the platforms. Therefore, once operational the bridge will bring down commute time to seven minutes which today take at least 25-30 minutes or even more depending on the traffic movement. This bridge will be India's longest bridge having an open-web-girder system that will run above railway tracks. The total length of the girders will be 100 metres and will be made of stainless steel. The weight of each girder is around 1,100 metric tonnes. The total length of this bridge would be around 480 metres and it will have two carriageways for east-west vehicular movement. Alongside these, the bridge will also have footpaths for pedestrian movement.


After the work orders were issued, the deadline was fixed in 2020. However, the authorities failed to achieve this deadline and it was later postponed to 2022. Considering the delay in removing the encroachment, the delay was again



pushed twice by a year and the civic body had issued a final deadline in July. The initial cost of the project at the time of issuing work order stood at Rs 70 crore. However owing to multiple delays the cost now stands at Rs 180 crore.

"This bridge had initially met with a few hurdles. That's why the project got delayed by a few years. At present, the project is on track and work is ongoing at full pace. This bridge will bring down the traffic woes in the eastern suburbs by a significant level. One of the key features of this ROB is that this is the country's longest bridge that will pass above the railway tracks. Instead of opening it in phases we will be opening it in entirety for the traffic movement," Abhijit Bangar, Additional Municipal Commissioner, Projects, told.

'Foreign exchange violations involving over Rs 1,000 crore' behind ED raid at Empuraan producer's premises, officials claim

producer Gokulam Gopalan, empuraan, ed raid, indian expressProducer Gokulam Gopalan was seen largely distancing himself from the controversy and clarified that a movie with a political message was not his intentionThe Enforcement Directorate raids at the premises of producer Gokulam Gopalan, whose production house backed the Malayalam film L2: Empuraan, which faced criticism for its portrayal of the 2002 Gujarat riots, are linked to its probe into alleged foreign exchange violations involving over Rs 1,000 crore, agency sources claim.The Kerala wing of the ED launched a multi-state search operation in Tamil Nadu and Kerala on Friday against the businessman and film producer.

According to ED, the searches are "in (connection with) a FEMA (Foreign Exchange Management Act) case involving Gopalan and his company Sree Gokulam Chit and Finance Co Ltd". "Currently, five premises are covered (under the raids). The case relates to alleged violations of various FEMA provisions worth Rs 1,000 crore with NRIs and other unauthorised transactions. The ED is also verifying alleged cheating and forgery cases registered against the company under PMLA (Prevention of Money Laundering Act)," ED sources claimed. The searches began Friday morning, with at least 10 personnel arriving at the offices of Sree Gokulam Chit and Finance in Chennai's Kodambakkam area. Another team landed at Gopalan's farmhouse at Neelankarai in Chennai city.

The ED action comes just days after the release of Mohanlal-starrer Empuraan, which was co-produced by Gopalan along with Antony Perumbavoor, Mohanlal's close aide, and Lyca Productions' Subaskaran Allirajah. Gopalan was a late entrant into the production, at a time when the film's release was delayed over financial troubles faced by Lyca Productions. The film, a sequel to the 2019 blockbuster Lucifer and part of a trilogy directed by Prithviraj Sukumaran,

sparked controversy soon after its March 27 release. Rightwing groups, including sections of the RSS, accused the film of vilifying Hindus by depicting scenes from the 2002 Gujarat riots and using the names of individuals involved in cases related to the riots. The backlash prompted the producers to mute certain dialogues and remove scenes. This voluntary censorship involved about 24 cuts or a deletion of 2.08 minutes. Gopalan was seen largely distancing himself from the controversy and clarified that a movie with a political message was not his intention. Mohanlal also issued an apology and said that the contentious content had been removed. Gopalan, a Kerala-origin businessman with interests in hospitality, healthcare, education, media, cinema. logistics, and transport, and his company, Sree Gokulam Group, are widely known across South India, with its flagship chit fund operations servicing thousands of cus-

3 Delhi men detained for attempting Hindu rituals at Sambhal's Shahi Jama Masjid

GNS News Agency, April 8 Police detained three people from Delhi for allegedly attempting to perform Hindu rituals, including a havan and puja, at the Shahi Jama Masjid here, officials said. The administration had already deployed heavy security at the mosque due to Friday prayers. Superintendent of Police Krishna Kumar Bishnoi confirmed the detentions, stating, "Three individuals arrived by a car and were taken into custody near the disputed site. They have been sent to the police station, and action will be taken against them for disturbing public order. They will also be warned not to enter Sambhal in the future."One of the detained men, Sanatan Singh, claimed, "We came to perform a havan and yagna at the Vishnu Harihar temple, but the police arrested us. If namaz can be offered there, why can't we perform puja?" Another detainee, Veer Singh Yadav, said, "We came to conduct rituals at the Sambhal mosque, but the police stopped us." Anil Singh, the third detainee, added, "We were there for a havan at the Harihar temple when we were taken into custody." The police action follows heightened tensions over religious activities at the site in Mohalla Kot Garvi. Authorities have emphasised that any attempt to disrupt communal harmony will be dealt with strictly.

Mamnoor: Telangana's forgotten airfield and its glorious past

Sitting on a concrete bench in Mamnoor village in Telangana's Warangal district, 88-year-old Patwari Janardhan Reddy reminisces about the days when planes soaring through the sky were a common sight and their village was a part of India's aviation map.Back in 1932, the Nizam of Hyderabad, in coordination with the British, established what was then one of India's largest airfields—the Mamnoor airport. The airfield was used by the British in World War II, bombed by the Indian Air Force during Operation Polo, and played a strategically important role during the 1962 Indo-China War.

"Around 1900 acres of land was acquired from our village. Between 1952 and 1984, you could see a minimum of 40 aircraft here for training. From 1986, the agriculture department used it to store paddy for 7-8 years. Later, Hyderabad and Tirupati aircraft were operational from here. The airstrip was shut down in 1984," recalls Patwari Janardhan Reddy.Patwari Janardhan Reddy (L) at his village in Mamnoor. Patwari Janardhan Reddy (L) at his village in Mamnoor. Today, all that remains is a locked gate, overgrown grass, and a plaque that reads: "This was the biggest airfield in India during that time. It was built to cater to and catapult the paper industry business in the region." Operation Polo

The erstwhile princely state of Hyderabad comprised six present-day districts of the Marathwada region, three districts of the Kalyana-Karnataka region, and the Teluguspeaking regions of Telangana. As India gained Independence in 1947, the last Nizam, Mir Osman Ali Khan, sought to remain independent. However, on September 13, 1948, the Indian government launched 'Operation Polo', a fiveday military operation that led to the annexation of Hyderabad.In the neighbouring village of Bollikunta, Patwari's 91-year-old cousin Donthi Rami Reddy recalls the days when the Indian Air Force bombed the runway of the Mamnoor airstrip. "Around 27 people were arrested by the Nizam government and were lodged in the aerodrome's buildings. I used to take food to those people as our home was just a stone's throw away," he says. "However, there was excitement, not fear, among people," says Donthi, who was 11 years old at the time. On being asked about the history of the airfield, Donthi Rami Reddy's eyes light up like a young kid's and his memory serves as sharp as ever. "For many years, large aeroplanes were a daily sight, often flying over our villages. One day, we witnessed a large plane being chased by two smaller aircraft. Eventually, the larger plane returned and landed. Following this incident, for three days, the smaller planes dropped numerous bombs, severely damaging the runway. The resulting craters were as large as wells, and the explosions shook the villages," he says. Today, locals are optimistic about the revival of the airport, which was handed over to the Airports Authority of India in 1968.

Bollikunta Satheesh, a young auto driver from the nearby Bollikunta village, says they are hoping their business will pick up once the airport becomes operational, although concerns remain. "One key concern is the land acquisition for the airport. About 253 acres were required for further expansion of the runway. Not everyone is happy with the compensation offered, but at the end of it, everyone is happy about the revival of the airfield and Mamnoor's return to the aviation map of the country," he says.P Anuradha Reddy, historian and author of Aviation in the Hyderabad Dominions, however, cautions against limiting the state's aviation history to Operation Polo. Mamnoor was just one of the many airfields in the Nizam's Hyderabad State, she says. "Present-day Air Force stations of Begumpet, Hakimpet, Bidar, and Dundigal Air Force Academy, and the Chikkalthana airport in Aurangabad and airfields at Adilabad and Nadergul were all important airfields of the Nizam era, aiding industry, trade, and travel. The Kamareddy airstrip at Patarajapet was an important landing and refuelling station for the British aircraft flying between Ceylon and Delhi back in the day," she says.

In the early 1900s, Hyderabad had a coordinated system of air, road, and train services to ensure last-mile connectivity. This, she says, facilitated industrial development, trade, and transport across the region. "The British had their modern transport around Hyderabad and it was for their benefit that they suggested the Nizam to build a railway in the state as well. Thus, was born the Nizam State Railways in 1930, which later managed the aviation department as well."Deccan Airways, founded in 1945 by the Nizam of Hyderabad, was a pioneer in Indian aviation. The airline operated chartered flights to Quetta and Rangoon. In 1948, it became the first Indian airline to establish a dedicated Haj chartered fleet. "The Nizam 7th never set foot on a plane," and it was much later, as the Rajpramukh of Hyderabad, that he first boarded a plane. That was a trial flight for him before flying to Delhi for a meeting. He was so excited and anxious seeing his King Koti palace from the air that he imposed a no-fly zone over the palace," says Reddy.

In January 1911, Hyderabad State witnessed the first air-military reconnaissance operation when Bristol Boxkite, an early British aircraft, flew over Aurangabad cantonment during a military-cavalry movement. "This was the first such air-military joint operation in the world, and such things happened only due to the support of the rulers back then, who despite being unaware of the latest technology, understood and recognised the same as the technology of the future," she says. The Hyderabad State Aero Club, formed in 1934, started operations from Begumpet Airport. "During World War II, the British 'Hyderabad Squadron' prominently displayed the inscription, 'Presented by His Exalted Highness, the Nizam of Hyderabad,' on all its aircraft," Reddy notes.

ED seizes immovable assets worth Rs 22-crore of Kapurthala Congress MLAR G Singh-owned Rana Sugars

The Enforcement Directorate (ED) recently seized immovable properties worth Rs 22.02 crore belonging to Punjab-based Rana Sugars — owned by Kapurthala Congress MLA Rana Gurjit Singh, and his son and Sultanpur Lodhi MLA Inder Partap Singh — for the alleged violation of the Foreign Exchange Management Act (FEMA). "ED initiated investigation under the provisions of FEMA, 1999, against M/s Rana Sugars Ltd, its promoters, Directors & others in connection with (the) issuance of Global Depository Receipts (GDRs) and non-utilisation of entire GDR proceeds for its intended bona-fide purpose," the Central agency said in a statement Thursday.

"ED investigation revealed that out of total GDR receipts, M/s Rana Sugars Ltd did not repatriate (the) entire GDR proceeds to India and held GDR proceeds to the tune of \$2.56 Million (Rs 22.02 crore) outside India in contravention of Section 4 of FEMA,1999. Further investigation is



under progress," it added.Earlier, the Securities and Exchange Board of India (Sebi) imposed a penalty of Rs 63 crore on Rana Sugars for the alleged diversion of funds to its conduit and entities.

Tales of 3 chefs who experimented with exotic cuisines from Lucknow, Peru and Japan

Chef Qureshi comes from a long line of chefs, who have honed their skills in the kitchens of Nawab of Awadh in Lucknow. Thus, Qureshi, who showcases his art at the Chingari restaurant of Hotel Sheraton of Pune, says he brings with him skills that are influenced by a long line of masters and blended with his personal creations. The curator of the three categories of dishes - Riyaat (Traditional), Virasat (Modern) and Andaz (Contemporary) -, Qureshi says his aim is to make the delicate cuisine of Lucknow popular and with a twist. "Coming from a long line of chefs, I have literally learnt from the masters. My uncles were the one who introduced Nawabi cuisine to Delhi. Given how Delhi is the heartland of Mughal cuisine, making space for another North Indian cuisine must have been tough," he said. Unlike Mughlai food, Nawabi food goes easy on spices and instead brings about magic in terms of the blend of spices. "Unlike the Mughlai biryani, the Lucknowi biryani does not have any spice mix. Instead our biryani is made with lots of kewara and induced spices which make the Biriyani light yet fragrant," he said. When it comes to protein, most dishes are cooked over slow fire with a unique combination of spices. Developed when the Nawabs of Awadh gained power in the declining days of the Mughal Empire, the court of Lucknow tried to make up for the grandeur of the new empire. "Instead of excessive usage of fat, our cuisine is subtle - the magic lies in spices," he said. The new menu is a clever take on traditional dishes using modern techniques. "Our work is to ensure that our guest gets introduced to the rich heritage from the kitchens of Nawabs. At times we do get guests asking if the biryani would have masala. But over all our experience has been warm and gratifying," he said. Chef Barve, is one of the very rare ones in Pune who have specialised in Peruvian cuisine. "Along with Japanese, Mexican and Spanish cuisines, I decided to add this to my skill sets as it would help me introduce my guests to something new," he said. Developed along the heights of Andes, Barve said Peruvian cuisine is known for its usage of corn, seafood and fresh food. "The spread is very vibrant and plays on the taste buds,"

he said. Peruvian food, Barve said, is served to people who are actually familiar with it. Thus the chef and his team prepare the dishes only when guests place the order. "But through festivals and special counters we are trying to introduce this cuisine to Pune," he said. Ceviche is a type of seafood, which, according to Barve, has caught the fancy of foodies. Instead of using heat to cook seafood, ceviche uses acid from lime and sauces to 'cure' the dish before serving it in a palatable manner. "Food is about experimenting and this clean and colourful cuisine is the best to experiment with," he said. Before shifting to Pune, Barve had worked in Mumbai and had introduced Peruvian and other exotic cuisine to his guests there. In Pune, Barve wants to do the same and with the team of Westin with him, he says he would be able to do it well. Given the fact that the Peruvian cuisine is exotic, guests require some convincing to try out this at times. Barve, whose expertise lies in other cuisines also, is always ready to ask his guests to try this out. He says there are plans to make this more popular in

Recently, DoubleTree by Hilton, held a food festival where the main ingredient was mushroom. Chef Rakshe Jadhav, the executive sous chef, said the inspiration was from the rich umami flavours and versatility of mushrooms. "Mushroom, have been a staple in Japanese cuisine for centuries... through this festival, we wanted to showcase their unique texture and gourmet appeal through authentic Japanese preparation in a specially curated menu," he said. Working with mushrooms can be tricky, given their delicate flavour, their original flavour is often lost if the spices are too loud. The exotic ones like the shiitake mushrooms require delicate handling. Jadhav said they managed to do this by the right pairing of the mushrooms with spices. Jadhav said they used Japanese techniques with minimal seasoning. "Slow simmering in miso based broths, light tempura frying and teppanyaki grilling with soy and garlic butter allowed mushrooms to retain their textures and earthy notes," he said. Ponzu (a Japanese soy sauce), Mirin (sweet tangy rice wine), and tare sauce allowed the mushrooms to retain their original earthy taste

India imposes 'uniquely burdensome' certification requirements: White House

New York: India imposes its "own uniquely burdensome" testing and certification requirements in sectors such as chemicals, telecom products, and medical devices, making it "difficult or costly" for American companies to sell their products in the country, the White House said. In a fact sheet issued after US President Donald Trump announced sweeping reciprocal tariffs on countries that levy taxes on US goods, the White House stated that non-tariff barriers meant to limit the quantity of imports/exports and protect domestic industries — also deprive US manufacturers of reciprocal access to markets around the world. Citing the example of India, the White House fact sheet said: "India imposes its own uniquely burdensome and/or duplicative testing and certification requirements in sectors such as chemicals, telecom products, and medical devices that make it difficult or costly for American companies to sell their products in India. If these barriers were removed, it is estimated that US exports would increase by at least US\$ 5.3 billion annually."Trump announced a 26 per cent "discounted reciprocal tariff" on India, half of the 52 per cent levies imposed by the country on American goods, as he described India as "very, very tough.

The fact sheet, titled 'President Donald J Trump Declares National Emergency to Increase our Competitive Edge, Protect our Sovereignty, and Strengthen our National and Economic Security', noted that Trump has declared that foreign trade and economic practices have created a national emergency, and his order imposes responsive tariffs to strengthen the international economic position of the United States and protect American workers. On the issue

of addressing trade imbalances, the White House said that Trump is working to level the playing field for American businesses and workers by confronting the unfair tariff disparities and non-tariff barriers imposed by other countries. "For generations, countries have taken advantage of the United States, tariffing us at higher rates," it said, citing the example that the United States imposes a 2.5 per cent tariff on passenger vehicle imports (with internal combustion engines), while the European Union (10 per cent) and India (70 per cent) impose much higher duties on the same product. For networking switches and routers, the United States imposes a 0 per cent tariff, but India (10-20 per cent) levies higher rates. For rice in the husk, the US imposes a tariff of 2.7 per cent, while India (80 per cent), Malaysia (40 per cent), and Turkey (31 per cent) impose higher rates. Apples enter the United States duty-free, but not so in Turkey (60.3 per cent) and India (50 per cent).

"The United States has one of the lowest simple average most-favoured-nation (MFN) tariff rates in the world at 3.3 per cent, while many of our key trading partners, like Brazil (11.2 per cent), China (7.5 per cent), the European Union (5 per cent), India (17 per cent), and Vietnam (9.4 per cent), have simple average MFN tariff rates that are significantly higher," the White House fact sheet said. The White House stated in the fact sheet that China's non-market policies and practices have given China global dominance in key manufacturing industries, decimating US in-

As he announced the tariffs from the Rose Garden in the White House, Trump held up a chart showing the tariffs that countries such as India, China, the European Union, Japan, Taiwan, South Korea, Bangladesh, Sri Lanka, and Pakistan levy on US products and the reciprocal levies that these countries will now have to pay. On India, the chart showed that the country charged 52 per cent tariffs on the US "including currency manipulation and trade barriers," and America will now charge India "discounted reciprocal tariffs" of 26 per cent. "India, very, very tough. Very, very tough. The Prime Minister just left. He's a great friend of mine, but I said, 'You're a friend of mine, but you're not treating us right.' They charge us 52 per cent. You have to understand, we charge them almost nothing, for years and years and decades, and it was only seven years ago, when I came in, that we started with China and we took in hundreds of billions of dollars from China in tariffs," Trump said.

The Public Well Revival Movement wants people in Tamil Nadu to reconnect with the ancient sustainable source of drinking water

We trek up a trail, on a hillock composed of damp, loose rock that cuts into finger millet fields, to reach Giri's tile-roofed home. It is within the many folds of Erode district's Bargur hills of the Western Ghats in Tamil Nadu. He is not home, but his goats are. "Women walk up this stretch with a pot of water balanced on their hips up to 10 times a day." points out Madhu Manjari Selvaraj when we pause to catch our breaths near the goat shed. The world over, it is women who take it upon themselves to fetch water. It is no different in the mountain village of Solakanai. Here, women walk to a mountain stream for water every day. A few metres from the stream is their village well that, until a few months ago, was covered with boulders and sediment. It now brims with water and the promise of a new beginning after Manjari and her team from the Public Well Revival Movement took it into their fold. A handful of men used rocks sourced from the nearby hills to build a wall against the flow of the stream, after which the well was dredged, with a wall constructed around it. It was opened last month. The initiative, an offshoot of the Tamil Nadu-based Cuckoo Movement for Children, which strives to make childhood meaningful, has revived 15 defunct wells across the state over the past four years with crowd-funding. It is helmed by Manjari and her team that includes M. Mari Muthu, K. Rahuraman, V. Muthu, C. Bala Gurunathan, A. Arun Kumar and S. Mohan. Manjari, an architect, recently won the Doshi We Know Fellowship 2024-25 for her work. Architect Madhu Maniari Selvarai of the Public Well Revival Movement. "Wells become unusable for various reasons," says Manjari. "They may be closed due to conflicts arising out of caste tensions; due to sand or rock filling them up over the years or simply because people have forgotten their existence owing to piped water connections."But the earth remembers. Despite being forgotten, water continues to spring forth from a well. The Public Well Revival Movement identifies such wells, reminding people in the village or town of its existence. After necessary permissions from local authorities, citizen's collectives, and the Forest Department are sought, it sets out to revive them with help from the locals themselves. Wells, says Manjari, are sustainable sources of water. While waterbodies such as ponds and lakes provide surface water, wells store groundwater and are hence able to keep regenerating. "A well connects four to five aquifers," she points out. The first well the group dredged was in Puliyanur village near Tiruvannamalai. The team that usually camps in local government schools or temples spent belief that wells are akin to a mother's breast."



almost three months in Pulivanur. At the end of the first month, they saw the first traces of clear water. The sun's reflection gleamed gold in it: it was a moment that filled the team with immense faith in their movement. It soon filled up and the villagers came to it in droves, pots in hand, unable to believe their dilapidated well was alive. The team then took up a well in Dhuruvam village in Kallakurichi district. "Women there were walking up to seven kilometres to reach a quarry to fetch water," says Manjari. The team later headed to Naickanoor village in Krishnagiri district, where they spent four months dredging a 28-feet-deep well. "A 90-year-old resident of the village would sit on his haunches by the side to observe us at work every day," she recalls. "When we got to the 27th feet, he said we would reach water after exactly one more foot. He then told us his father had contributed to digging the well 40 years ago." Solakanai's is the movement's fifth well located in a mountain village. The terrain — there are no proper roads from Bargur to the village - makes it almost impossible to transport construction material. "It took us six days to bring a truck load of M-sand to the site," says Manjari. At Agnibaavi in Kongadai, Erode district, the team dredged a well that the people wanted to share with cattle and elephants from the surrounding forests. "We constructed an outer wall with room for elephants to dip their trunks inside to drink," says Manjari. The night before the well's opening, a herd of elephants stopped by for a drink, declaring it open long before people could use it. Watching wells come alive has left the team with fascinating insights into the interaction between people and nature. "The tribal community of Bejility mountain village in Erode calls water 'Gangai'," says Manjari. She recalls how once a little boy told her that children from their village do not hurl stones into wells. "They are being raised on the

Gains, losses, and politics in Andhra Pradesh

Ever since the Union government began discussing the delimitation exercise, Andhra Pradesh Chief Minister N. Chandrababu Naidu has made it clear that he supports the process, unlike his southern counterparts, led by Tamil Nadu Chief Minister M.K. Stalin. Supporting the NDA government's move, Mr. Naidu — who had earlier promoted family planning and spoken about population explosion said that he has changed his view on population and is now promoting population growth, arguing that India's biggest advantage over developed nations is its demographic dividend. He further stated that even South Indian States, including Andhra Pradesh, were also facing the ageing issue, compared to northern States. And that is why he is now promoting population growth. In the recently concluded Assembly Budget session, Mr. Naidu made it clear that once the delimitation process is completed after the 2026 Census, the share of women in the Assembly would increase to 75 seats as per women's reservation norms. After securing a landslide victory in the 2024 General and Assembly elections and forming the NDA coalition government in Andhra Pradesh, Mr. Naidu overturned a three-decade-old

rule that disqualified candidates with more than two children from contesting local body polls. Now the question is whether his support for delimitation will isolate him from the other Southern States. Notably, he did not attend the meeting convened by Mr. Stalin. Mr. Naidu's absence from the meeting was expected, as his party, the Telugu Desam Party (TDP), is part of the NDA, along with Pawan Kalyan's Jana Sena Party.Interestingly, Mr. Naidu is aware that if the delimitation process is done after the 2026 Census, Andhra Pradesh's representation in the Lok Sabha will not increase substantially, unlike States such as Bihar and Uttar Pradesh. However, he has no other choice. As the leader of the TDP, Mr. Naidu is unlikely to repeat his past mistake of differing or opposing the BJP, as he had done before the 2019 elections. He not only lost the election by walking out of the NDA over the issue of Special Category Status for Andhra Pradesh, but also invited the wrath of Prime Minister Narendra Modi and Home Minister Amit Shah. The coalition deal was inked only days before the 2024 elections, thanks to the efforts of Mr. Kalyan.It is also worth noting that Mr. Naidu first formed the government in 2014, after Andhra Pradesh's bifurcation, with the support of the NDA.

Kashmir's Pulwama takes a leap to meet India's over 20 lakh annual tulip bulbs demand

Scientists in Kashmir have embarked on an ambitious project to indigenise tulip bulbs to make India self-reliant and match the skill and production of Netherlands, a major global exporter that meets the annual demand of India's 20-25 lakh tulip bulbs and cut flowers annually. This will also pave the way for hosting more blooming tulip gardens across the country, especially capital New Delhi. To realise the goal, over a lakh tulips are already in full bloom at the research centre of the Council of Scientific and Industrial Research-Indian Institute of Integrative Medicine in Pulwams's Bonera

"The indigenisation of tulip bulb production in India is expected to bring significant changes to the country's floriculture sector. Currently, India imports around 20-25 lakh tulip bulbs and cut flowers annually, primarily from the Netherlands. By establishing sustainable production models for high-quality tulip bulbs, India will be able to meet its ever growing domestic demand while also creating opportunities to export tulip bulbs to international markets," Dr. Jitendra Singh, Minister of Science and technology and Earth Sciences, told The Hindu, in an online interview. Spread over 60 hectares at an altitude of 5,400 feet, Pulwama's Bonera station is emerging as the launching pad of the ambitious project that also aims to see new tulip blooming destinations adding to India's tourism map in

"The Ministry envisions establishing theme-based tulip gardens and production centers in regions with suitable agro-climatic conditions across the country. Given its temperate climate, J&K is poised to become a key hub for tulip

bulb production. In the coming years, the region is expected to match capabilities of the Netherlands in research and development on this novel floricultural crop, further strengthening India's position in the global floriculture industry," Mr. Singh said. The Union Minister said the Kashmir centre was developing "novel and elite varieties of high-value cut and bulbous crops, particularly tulips, to reduce import dependency and promote self-sufficiency in the sector". The Pulwama station already has eight varieties of tulips in its rows.Kashmir is home to the iconic Indira Gandhi Memorial Tulip Garden in Srinagar, which sees over 1.5 million flowers blooming every spring and attracts thousands of tourists from across the country. However, the region imports around 15 lakh bulbs every year from the Netherlands to curate Asia's biggest tulip garden. Over five lakh tulip bulbs were also planted in other parts of the country, mostly in New Delhi, officials said. The CSIR, however, felt the need to indigenise the bulbs. "India's floriculture industry has long faced economic and logistical challenges due to its heavy reliance on imported tulip bulbs. These imports are not only costly but also vulnerable to global market fluctuations, trade restrictions, and supply chain disruptions," Dr. Shahid Rasool, Senior Scientist and In-charge CSIR IIIM Field Station Pulwama, said. Terming the Pulwama centre as a "strategic intervention", Mr. Rasool said it will also create new economic avenues for growers within India's floriculture sector. The department is planning to create farmers' clusters to boost production of tulip bulbs. The CSIR IIM has been carrying out trials to evaluate floral characteristics and adaptability, optimizing agro-technological protocols for large-scale cultivation since 2022. "We have been assessing resilience against pests, diseases, and climatic stresses. By refining these scientific parameters, the initiative aims to develop robust tulip varieties suited to local conditions. This has the potential to position J&K as a major hub for tulip production," Mr. Rasool said. Tulip cultivation, according to the scientists, offers an alternative and profitable income stream, particularly in regions where traditional agriculture is constrained by climatic or environmental limitations. "The longterm objective of this initiative extends beyond self-sufficiency; it envisions positioning J&K as a key player in the global floriculture industry. J&K has the potential to export high-quality tulip bulbs to international markets, competing with established global producers such as the Netherlands,

China imposes 34% tariff on imports of all U.S. products starting April 10

China announced Friday (April 4, 2025) that it will impose a 34% tariff on imports of all U.S. products beginning April 10, part of a flurry of retaliatory measures following U.S. President Donald Trump's "Liberation Day" slate of double-digit tariffs. The new tariff matches the rate of the U.S. "reciprocal" tariff of 34% on Chinese exports Trump ordered this week. The Commerce Ministry in Beijing also said in a notice that it will impose more export controls on rare earths, which are materials used in high-tech products such as computer chips and electric vehicle batteries. Additionally, the Chinese government said it has added 27 firms to lists of companies subject to trade sanctions or export controls. Among them, 16 are subject to a ban on the export of "dual-use" goods. High Point Aerotechnologies, a defense tech company, and Universal Logistics Holding, a publicly traded transportation and logistics company, were among those listed.

Beijing also announced it filed a lawsuit with the World Trade Organization over the tariffs issue. "The United States' imposition of so-called 'reciprocal tariffs' seriously violates WTO rules, seriously damages the legitimate rights and interests of WTO members, and seriously undermines the rules-based multilateral trading system and international



economic and trade order," the Commerce Ministry said.

"It is a typical unilateral bullying practice that endangers the stability of the global economic and trade order. China firmly opposes this," it said. In February, China announced a 15% tariff on imports of coal and liquefied natural gas products from the U.S. It separately added a 10% tariff on crude oil, agricultural machinery and large-engine cars. The latest tariffs apply to all products made in the U.S., according to a statement from the Ministry of Finance's State Council Tariff Commission.

Bengaluru's Namma Metro: India's priciest transit

Mahindra Kumar, a daily metro rail commuter between Baiyappanahalli and Cubbon Park, used to pay ?19 earlier for a one-way ride. Now he pays ?28. "I am paying ?9 more for each trip, which adds up to ?18 daily and over ?500 a month. It may not seem like much to some, but for regular commuters like me, it's a burden," he says. Kumar's story is similar to that of lakhs of Namma Metro passengers who were in for more disappointment as the Karnataka High Court, on April 1, declined to intervene in the Bangalore Metro Rail Corporation Limited's decision to increase metro fares, dismissing a Public Interest Litigation petition that argued the hike amounted to a "breach of promise" as it exceeded previously stated limits.

The fare hike — the first revision in over seven years - has made Namma Metro the costliest transit service in India among the major cities with metro services. The revised fares, effective February 9, saw the maximum ticket price go up by 50%, from ?60 to ?90. The first fare revision since the metro began operations in Bengaluru in 2011 took place in 2017. The fare increase, implemented on February 9, in some cases, approached 100%. Amid public outrage, Karnataka Chief Minister Siddaramaiah intervened on February 13, instructing BMRCL Managing Director M. Maheshwar Rao to roll back "abnormal" fare hikes. Following this, BMRCL adjusted the increase, limiting the maximum stage-wise fare hike to 71%. However, the base fare and the highest ticket price remained unchanged at ?10 and ?90, respectively. Under the revised pricing, the maximum fare has gone up from ?60 to ?90, while the minimum fare for the shortest distance (0-2 km) has remained at ?10.

The fare for the 2-4 km distance increased from 15 to 20, while those travelling beyond 30 km now have to pay 90. The revised fares were implemented on February 14, with some commuters noticing reductions of 9 to 10 on certain routes.

Further aggravating commuter concerns, BMRCL discontinued QR code-based fare discounts, restricting them solely to smart card users. Even for them, the discount has been reduced to 5%. Additionally, the minimum balance required on smart cards was raised from 250 to 290. However, a 5% off-peak discount remains available, bringing the total discount to 10% for those travelling outside rush hours — before 8 a.m., between 12 p.m. and 4 p.m., and after 9 p.m. on weekdays. A flat 10% discount is also applicable on Sundays and national holidays.

The fare revision also affects tourist and group passes, with new rates set at 300 for a one-day pass, 600 for a

three-day pass, and ?800 for a five-day pass. The metro fare hike followed the Karnataka government's announcement of a 15% increase in bus fares. Chennai Metro provides a 20% discount for passengers using smart cards, National Common Mobility Cards, and online QR code tickets. The recent fare hike has made Bengaluru Metro the most expensive metro service in India. In contrast, Kolkata Metro, operated by Indian Railways, remains the most affordable, with fares starting at ?5 for short distances and going up to a maximum of 50 for longer routes.

In contrast, for journeys beyond 25 km, Namma Metro now charges ?90, whereas Delhi Metro's fare for distances over 32 km is ?60, and Chennai Metro's is 50. Meanwhile, in Kolkata, the fare for trips between 25 and 30 km is just 25. Unlike Bengaluru, most other metro systems continue to offer discounts for both QR code and smart card users. Many commuters argue that removing the QR code discount in India's tech hub contradicts the vision of Digital India. Metro operators in Chennai and Kochi still offer a 20% discount on smart cards, QR codes, and WhatsApp tickets.BMRCL has also raised the minimum balance requirement for smart cards from ?50 to 90, a policy not seen in any other metro service in India. Since its launch in 2011. BMRCL has issued around one crore smart cards. Additionally, the cost of daily and multi-day passes has increased significantly, with the one-day pass rising from ?150 to 300, the three-day pass from 350 to 600, and the five-day pass from 550 to 800. It has also reduced discounts on smart cards and QR code tickets, while other metro systems across India continue to offer significant fare benefits. For instance, Delhi Metro provides multiple discounts to encourage ridership and affordability. Smart card users receive a 10% discount on every journey, with an additional 10% off during off-peak hours to promote staggered travel. Delhi Metro also offers discounted fares on Sundays and national holidays. Similarly, Chennai Metro provides a 20% discount for passengers using smart cards, National Common Mobility Cards, and online QR code tickets. Hyderabad Metro offers student passes where students get 10 free trips for every 20 trips purchased while Kochi Metro offers student passes, including the "Vidya" pass, with options for daily, 30-day, and 45-day travel, — an initiative that Bengaluru

Meanwhile, in Hyderabad, metro authorities are considering a fare hike, and a fare fixation committee has been appointed. The previous government had not allowed any fare increase due to the Assembly elections. L&T Metro Rail Hyderabad, which built and operates the project under a public-private partnership. has now jumped from 120 to ?180, making shared cabs or autos a more economical choice for families travelling together. With the High Court on March 2 directing aggregators to stop bike taxis, it will soon no longer be an option. Those using personal vehicles must also bear the added expense of parking fees at metro stations.

Since the fare hike, commuters have expressed their discontent online and through on-ground protests, including demonstrations inside metro trains. Many have voiced concerns that the increased costs are making public transport unaffordable, pushing people toward private vehicles instead. Ridership data for Namma Metro indicates a sharp decline following the fare hike on February 9. Before the increase (February 2-7), the average daily boardings stood at 8,44,899, peaking at 8,70,687 on February 7. However, post-hike (February 9-14), average daily ridership dropped to 7,51,560, with a drastic dip on February 9 (6,23,123), the lowest recorded during this period. This suggests an immediate impact, as many commuters may have switched to alternative transport options due to higher fares.

Why it is most expensiveBMRCL stated that the fare hike was based on recommendations from a fare fixation committee (FFC) appointed by the Union government on September 7, 2024. The committee, chaired by a former High Court judge, submitted its report on December 16, suggesting a fare revision after considering operational costs, passenger feedback, and expert consultations.

BMRCL Managing Director M. Maheshwar Rao explained that the FFC had recommended fare increases of up to 105.15%, resulting in an average hike of 51.5% (6.87%) per year). However, the final revision was lower than the 14.02% annual increase initially proposed by BMRCL. Passengers argued that the increased fares would force low-income commuters to revert to private vehicles, further worsening Bengaluru's already severe traffic congestion — an issue the metro was meant to alleviate. Critics also highlighted that despite the Namma Metro covering only 76 km, it now has a maximum fare of ?90, whereas the 353 km-long Delhi Metro charges just ?60 for trips ex-

tions and Maintenance (O&M) Act, 2002, which states that FFC recommendations are binding. However, critics pointed to Tamil Nadu's 2021 decision, when the then Chief Minister, Edappadi K. Palaniswami, reduced Chennai Metro fares despite similar recommendations. Rao admitted that technical errors had impacted the fare calculations and announced corrections to the pricing structure. "This revision aligns with the spirit of the Fare Fixation Committee's recommendations while addressing commuter concerns," he said.Political showdownThe fare hike has sparked a political showdown between the ruling Congress and the opposition BJP. BJP leaders submitted a memorandum to BMRCL demanding a rollback, accusing the Congress government of burdening citizens with higher fares.

The Congress, however, shifted the blame to the BJPled Central government. Karnataka Transport Minister Ramalinga Reddy stated, "BMRCL revised fares based on recommendations from the fare fixation committee constituted by the BJP-led Centre. Let the BJP explain who is truly responsible."Under mounting pressure, Chief Minister Siddaramaiah intervened on February 13, directing BMRCL to reverse the "abnormal" fare increases. "The way BMRCL has implemented the fare revision has led to anomalies, with fares more than doubling in some sections," he wrote on social media platform X. "I have asked the MD of BMRCL to urgently address these issues and reduce fares where increases are abnormal."

This statement contradicted his earlier stance that the Karnataka government had no control over BMRCL's fare decisions, as the metro operates autonomously under a 50:50 partnership between the State and Centre.

Reasons for higher costWhen asked why and how fares remain lower in Kolkata and other cities but not in Bengaluru, a BMRCL official explained that Kolkata Metro is operated by Indian Railways, which heavily subsidises passenger fares. In Delhi, the Union government covers the cost of CISF security, whereas, in Bengaluru, a significant portion of revenue is allocated to staff salaries.

Shot dead at 19, how Jyoti Hemla went from being an ashram school girl to a Maoist



It was a grim police handout photograph — eyes closed, a trickle of dried blood on the left side of her temple. "Unidentified Maoist," read the description in the note released on February 9, after one of the biggest anti-Maoist operations in Chhattisgarh. Police later identified the girl in the photograph as Jyoti Hemla, one of the 31 Maoists killed that day in the forests of the Indravati National Park in Bijapur. How did a 19-21-year old who until a few years ago studied in a government school in Bijapur end up in the forests of Indravati? It's a question Jyoti's family has been grappling with since the encounter., as the family waited for hours at the district hospital to take her body home after the post-mortem procedure, her uncle Bhadru Hemla had burst into tears. "Bahut hi achi bachhi thi, sir. Yahan Bijapur ke porta cabin me padti thi (She was a very good girl. She used to study in a portacabin school in Bijapur," he said.

Portacabin schools were introduced by the Chhattisgarh government in 2010 for children in Naxal-affected areas of the state to tackle the loss of education as Maoists destroyed several school buildings. The portacabin schools continue till date, housing 28,000 children in BijapurAt the portacabin in Bijapur where Jyoti studied, the teachers said they were new and refused to share records of past students. When asked about Jyoti, Bijapur SP Jitendra Yadav directed The Indian Express to the press release issued a day after the encounter in which Jyoti was identified as a member of the banned Communist Party of India (Maoist) with a bounty of Rs 2 lakh on her head. The note also said that among the 31 killed were six 21-yearolds, including Jyoti, and eight 20-year-olds. The Indian Express visited Sawnar, a village in Bijapur district, to track Jyoti's journey — from the portacabin school that is few kilometres away from the Bijapur Collectorate and the police headquarters, to dropping out in while in Class 3, and finally joining the Maoist ranks in 2021 at the age of 16. A village nearly 30 kilometers from the district headquarters in Bijapur, Sawnar falls in Gangaloor, an area that is known to be a recruitment, training and high-level meeting centre of Maoists. Top police sources said that many of the Maoist cadres gunned down over the last few decades in Chhattisgarh as well as neighbouring states were from Gangloor. At Sawnar, only her minor sister was home, picking mahua flowers from a tree in their compound. Her mother had gone deep into the jungles with other women to gather mahua, while her father and a brother had gone to Telangana to "pluck chillies". Her two other brothers studied in an ashram school in Bijapur while her married elder sister lived in another village. Jyoti's uncle Laxman Hemla, 40, and her 17-year-old cousin, both speaking on the phone, and her childhood friend and neighbour (name withheld) spoke about all that had gone wrong.Laxman said, "Jyoti was born in 2005, sometime in May or June. Though barely anyone in our village has a birth certificate, I vividly remember her

birth year as she was born around the time the Salwa Judum was set up."Like most other children from Gangaloor, Jyoti and her childhood friend joined the portacabin school in Bijapur. While the friend stayed on, Jyoti dropped out in Class 3 to help her parents with household work and to collect forest produce.

"I last met her in 2023, after she joined the Sangathan (Maoists). She came to the village with a couple of Maoists. She asked me about my studies and what they teach in school. She said she missed school. I asked her why she had dropped out and she said that she had no time for studies now that she was with the Sangathan. She loved mangoes and took some with her when she went back. She didn't ask me to join the Sangathan but when I asked her to leave, she said they wouldn't let her," the friend said.Her uncle Laxman says Jyoti joined the Maoists years after she dropped out of the portacabin school and, like most other child recruits, was influenced by the Chaitya Natya Mandal (CNM), a cultural wing of the Maoists. Police sources said Jyoti joined the Jantana Sarkar school run by the Maoists in Sawnar before becoming a part of the CNM. Jyoti's uncle Laxman said, "They took her away by the end of 2021. I told her to guit the movement many times but she would simply look down and say no. She would say, 'Dinesh bhaiya (Dinesh Mudiyam, a Divisional Committee Member) ne bola hai kitna bhi bolenge toh bhi chodna nahi hai (people will keep asking you to quit but do not leave the organisation)."

Incidentally, earlier this month, Dinesh — who has 26 murder cases to his name and who was allegedly involved in two attacks on security forces, in 2005 and 2017, killing seven jawans — surrendered to the police along with his wife. Police sources said the 26 cases against him are likely to be closed Police sources admit that the recruitment of children remains a concern, especially in Bijapur villages beyond the Indravati River and the Indravati National Park, where there is little presence of the State. "The villagers have no choice. The Maoists force them to send at least one child from their family to join the Maoist organisation," said Inspector General of Police for Bastar Range, Sundarraj P.Though police say many Maoists from Gangaloor have been surrendering over the last two years, their influence was evident when a 45-kg command Improvised Explosive Device (IED) was planted on the Palnar road near a police camp on Friday, March 28, a week after 26 Maoists were gunned down in south Gangaloor on March 20.

The Public Well Revival Movement wants people in Tamil Nadu to reconnect with the ancient sustainable source of drinking water



We trek up a trail, on a hillock composed of damp, loose rock that cuts into finger millet fields, to reach Giri's tile-roofed home. It is within the many folds of Erode district's Bargur hills of the Western Ghats in Tamil Nadu. He is not home, but his goats are. "Women walk up this stretch with a pot of water balanced on their hips up to 10 times a day. points out Madhu Manjari Selvaraj when we pause to catch our breaths near the goat shed. The world over, it is women who take it upon themselves to fetch water. It is no different in the mountain village of Solakanai

Here, women walk to a mountain stream for water every day. A few metres from the stream is their village well that, until a few months ago, was covered with boulders and sediment. It now brims with water and the promise of a new beginning after Manjari and her team from the Public Well Revival Movement took it into their fold. A handful of men used rocks sourced from the nearby hills to build a wall against the flow of the stream, after which the well was dredged, with a wall constructed around it. It was opened last month. The initiative, an off-shoot of the Tamil Nadubased Cuckoo Movement for Children, which strives to make childhood meaningful, has revived 15 defunct wells across the state over the past four years with crowd-funding. It is helmed by Manjari and her team that includes M. Mari Muthu, K. Rahuraman, V. Muthu, C. Bala Gurunathan, A. Arun Kumar and S. Mohan. Manjari, an architect, recently won the Doshi We Know Fellowship 2024-25 for her

"Wells become unusable for various reasons," says

Manjari. "They may be closed due to conflicts arising out of caste tensions; due to sand or rock filling them up over the years or simply because people have forgotten their existence owing to piped water connections."But the earth remembers. Despite being forgotten, water continues to spring forth from a well. The Public Well Revival Movement identifies such wells, reminding people in the village or town of its existence. After necessary permissions from local authorities, citizen's collectives, and the Forest Department are sought, it sets out to revive them with help from the locals themselves. Wells, says Manjari, are sustainable sources of water. While waterbodies such as ponds and lakes provide surface water, wells store groundwater and are hence able to keep regenerating. "A well connects four to five aquifers," she points out. The first well the group dredged was in Puliyanur village near Tiruvannamalai. The team that usually camps in local government schools or temples spent almost three months in Puliyanur. At the end of the first month, they saw the first traces of clear water. The sun's reflection gleamed gold in it: it was a moment that filled the team with immense faith in their movement. It soon filled up and the villagers came to it in droves, pots in hand, unable to believe their dilapidated well was alive. The team then took up a well in Dhuruvam village in Kallakurichi district. "Women there were walking up to seven kilometres to reach a quarry to fetch water," says Manjari. The team later headed to Naickanoor village in Krishnagiri district, where they spent four months dredging a 28-feet-deep well. "A 90-year-old resident of the village would sit on his haunches by the side to observe us at work every day," she recalls. "When we got to the 27th feet, he said we would reach water after exactly one more foot. He then told us his father had contributed to digging the well 40 years ago."

Solakanai's is the movement's fifth well located in a mountain village. The terrain — there are no proper roads from Bargur to the village — makes it almost impossible to transport construction material. "It took us six days to bring a truck load of M-sand to the site," says Manjari.At Agnibaavi in Kongadai, Erode district, the team dredged a well that the people wanted to share with cattle and elephants from the surrounding forests. "We constructed an outer wall with room for elephants to dip their trunks inside to drink," says Manjari. The night before the well's opening, a herd of

The power of 'not' | Notes from the 10th Symposium in the Literary Activism Series

Prefixing any straitjacketed definition with a defiant "not" can produce startling results. Much like Kabir's 'ulatbansi' (upside-down sayings) or the Advaita philosophy of 'neti neti' (not this, not that), it is a stream of consciousness that moves beyond the blindspots of binary thought, resisting convenient categorisation. Only fitting then that modernist writer Virginia Woolf was the toast of the 10th Symposium in the Literary Activism Series in New Delhi last week, centred on 'the non-peer reviewed essay', a work that is more spontaneous, imaginative, intellectual, "essayistic" and, more importantly, immune to slaughter at the conformist hands of "peer review". Jon Cook, Emeritus Professor of Literature at the University of East Anglia, said that the essay stemmed from a festering "self-doubt" when imperialist forces started digging their feet in foreign lands. For it to develop dialogue between the "philosophical eye" and "conversable crowd", it needs the firm footedness of "experience". He further quoted from a Woolf essay to describe the "transition, the invention of self", that the form of the essay might facilitate. Interesting assumptions, each one intersecting with, and adding to, what an essay can (not) entail, emerged from the two-day event, helmed by scholar-

writer Amit Chaudhari. One panellist compared the Hindi variant 'nibandh' (one without any 'boundation' as he puts it) with its Bengali or Odia counterpart 'prabandh' (one with form). Poet-professor Sumana Roy believed the essay to be a way of 'genre-defiance', genre being a very masculine, rigid entity, while Yale University's Cynthia Zarin thought it to be a container to hold discursive thoughts. Dwelling on his decade-long engagement with the series, Chaudhari said the aim was to zoom in on intelligent, thoughtful, playful exchanges, to listen to them and learn from them. The extension of the symposium into a full-fledged online magazine, as well as a dedicated imprint which doesn't bow down to market forces, are his ways of engaging with and chronicling these ongoing conversations. In the coming years, Chaudhari wishes for the symposium to move to Kolkata and other parts of the country, to "democratise knowledge and rescue these conversations from the stranglehold of academia". 'Trust the tale, not the genre'ls non-fiction only based on verifiable facts, and is fiction its made-up version? Is non-fiction (non) fiction, a dry and drab fact sheet sans narrative and storytelling, the two central tenets of creative writing? How do these forms interact and intersect

with each other in a world dominated by free market capitalism? Chaudhari chose the cinematic equivalent of nonfiction — the documentary — to illustrate his point. In focus was Anand Patwardhan's "bold and perspicacious" Ram Ke Naam (In the Name of God), based on the 1992 demolition of Babri Masjid in Ayodhya. Chaudhari seemed least concerned with the historicity of the events; the quotidian shots of a milestone, an empty stretch of road, and two chatting farmers piquing his interest instead. These marginal people or objects, simultaneously in and out of the narrative, he said, offer a "looseness, unfinishedness, and distractedness to narrative" making the tale take a flight of its own, without the constrictions of genre, so that we, as viewers "trust the tale, and not the genre". Author Saikat Majumdar made a convincing case for the public essay at a time when emotion is animating public conscience. Underlining the Hobbesian theory that pits 'public sphere' as a corrective space against the excesses of state, he stressed on the need for an effective emotion — a co-mingling of the 'rational' and 'emotional' — for effective dissemination of information. While the turnout at the symposium remained lower than one expected, it was exciting to see specialists from various fields in attendance.

For Nimisha Priya, Indian nurse on death row for murder in Yemen, hope hangs by a thread — a pardon from victim's family



With Yemen President Rashad al-Alimi approving the death sentence for 37-year-old Indian nurse Nimisha Priya, for her family in Kerala, any hope of reprieve now hangs by a thread – a pardon from the family of Talal Abdo Mehdi, the Yemeni citizen whose murder she has been convicted of.According to the prosecution's case, Nimisha, who worked as a nurse in Yemen, allegedly murdered Talal in July 2017 by "injecting him with sedatives to get her passport that was in his possession".

Samuel Jerome Baskaran, a social worker who is currently involved in the negotiations with government officials in Yemen and Talal's family, told The Indian Express that the President's order reached the prosecutor on Monday, December 30. "The key to Nimisha's life now rests with the family of Talal. She will live if they forgive her. Our job is to convince the family to do that," he toldSamuel, however, said the negotiators were chasing a very tight deadline. "We had an excellent first phase of mediation. We established contact with Talal's family, but the mediation did not continue because the Save Nimisha Priva International Action Council (set up in 2020 to raise the required funds for negotiations) did not send the second installment of funds. Our immediate task is to resume the negotiations and hopefully, get Talal's family to forgive her, because all legal options have been exhausted. We have barely four weeks left with us," he said. Advocate Deepa Joseph, Vice-Chairperson of the Save Nimisha Action Council, said an amount of \$40,000 was required for the negotiations and the legal process. "Earlier, we had paid \$20,000 via the Indian mission to the lawyer in Yemen. Due to some confusion within the Action Council, the remaining amount could not be transferred. We have now transferred the second installment of the negotiation amount through the Indian mission in capital Sanaa," she said.On December 31, the Ministry of External Affairs said it would extend "all possible help" to Nimisha. Since April, Nimisha's mother Prema Kumari, a domestic worker in Kochi, has been camping in Yemen. In December last year, Kumari had approached the Delhi High Court to secure an exemption from the travel ban to conflict-ridden Yemen. Since her arrival in Sanaa, Kumari has had a few meetings with Nimisha in prison, Samuel said. A busi-

Raised by a single mother, Nimisha was in her 20s when she left for Yemen to work as a nurse at a health centre outside Yemen's capital city of Sanaa. In 2011, she returned to Kerala to marry Tomy Thomas, then a driver in Qatar, before returning to Yemen with him. Thomas told The Indian Express that in mid-2014, he returned to Kerala with their infant daughter since Nimisha wanted to open a

clinic of her own and he hoped to raise funds from well-wishers back home. His departure was followed by the civil war in Yemen in September 2014, after which India imposed travel restrictions to the conflict-ridden country. Three years later, Nimisha was arrested for murdering 24-year-old Talal. In an open letter released by Nimisha after her arrest, she accused Talal of mental, physical and financial abuse. The 2017 letter and accounts shared by Nimisha with her mother and husband paint a picture of how her business plans in Yemen went all wrong. Talal Talal Abdo Mehdi, the Yemeni citizen whose murder Nimisha has been convicted of.

According to Nimisha's letter, it was around October 2014 that she met Talal, whose family frequented the clinic where she worked. During a conversation with Nimisha, Talal is said to have expressed his desire to see India, while she shared with him her plan to open her own clinic. Since Yemeni laws require local partnership in ventures started by foreigners, Nimisha, the letter said, sought help from Talal in completing the paperwork for the proposed clinic. The letter stated, "I gave Talal the money (6 lakh Yemen riyal) to pay the building owner and complete the paperwork for the clinic."Accompanied by Talal, her family said, Nimisha arrived in Kerala for her daughter's baptism in January 2015. She returned to Yemen a month later with the funds Thomas had raised. "Then the war in Yemen got worse and India issued a travel ban. That was the last time my daughter and I saw Nimisha," Thomas had told The Indian Express last year. Nimisha, meanwhile, proceeded with her business plan with Talal's help.nimisha Raised by a single mother, Nimisha was in her 20s when she left for Yemen to work as a nurse at a health centre outside Yemen's capital city of Sanaa. According to the letter, following the launch of her clinic on April 17, 2015, Talal allegedly got fake papers claiming a 33 per cent share in the business. Nimisha also accused him of torturing her for money, taking away her passport and other documents and getting a fake marriage certificate made to show them as a couple. She filed a police complaint against Talal in Sanaa, but the dispute landed both of them in jail. According to a court order dated February 16, 2016, Talal returned to Nimisha the documents related to the clinic and property. While both of them were released from jail, Talal went back to jail in another cheating case. According to her letter, Nimisha, meanwhile, kept visiting Talal in jail to persuade him to return her passport and get him to sign on the divorce papers. In July 2017, during one of those visits, Nimisha allegedly injected Talal with sedatives, leading to his death.

In 2020, a trial court awarded Nimisha three death sentences. The appeal court expunged one of these death sentences, a verdict which was upheld by the Supreme Court of Yemen. A family's agonising waitNimisha's mother Prema Kumari said they learnt about her troubles through the media. "It was through others that Tomy (Nimisha's husband Tomy Thomas) got to know that Nimisha was in jail. I came to know about the incident only through newspaper reports of her conviction on May 5, 2018," Prema Kumari had told earlier. Back in Kerala, Thomas, an auto driver, shifted his 13-year-old daughter to a residential school to keep the news of her mother's death sentence from her. "We have told her that her mother is in jail due to some trouble. I delete all messages related to the case before giving her my phone. At school, the teachers have been told not to talk about the case. If Nimisha makes it to the news, I call the school to ensure the newspaper is kept away from students that day."

The year of the 'sakhi'

2024 was the year the International Olympic Committee voted for numerical gender parity. A revolutionary mandate. There was equal representation of men and women at the world's most elite and most celebrated sports event of the year, the Paris Olympics.India kept pace — at least in cinema. In 2024, quite a few films passed the Bechdel Test. An unofficial invention by American cartoonist Alison Bechdel in 1985 in her comic strip Dykes To Watch Out For, it goes so: For any given work of fiction to pass the Bechdel Test, it must 1) have at least two women in it 2) talk to each other, about 3) something other than a man. A blunt and basic measure of gender equality in a book/film/show

Indian women directors and screenwriters sliced up the clutter of big-budget, star-fuelled spectacles with huge dollops of novelty. Their narratives draw on their experiences and their gaze on the human condition: Payal Kapadia's All We Imagine As Light, the most celebrated around the world: Shuchi Talati's Girls Will Be Girls: Kiran Rao's Laapataa Ladies; Lakshmipriya Devi's Boong, set entirely in Manipur, which had its world premiere at the 2024 Toronto International Film Festival under the 'Discovery' section; Sandhya Suri's Santosh, UK's official entry to the Oscars; Rima Das's Village Rockstars 2, a rare indie sequel; Nishtha Jain's immersive documentary Farming the Revolution, set in the farmers' protests of 2023, which won Best International Feature at Hot Docs 2024. Nothing prepared movie lovers, critics and curators for the staggering response Kapadia's All We Imagine As Light received on the international stage from May onwards. A film written and directed by an Indian woman in her mid-30s, with a cast that included actresses from Malayalam cinema and Marathi/Hindi cinema, in three Indian languages, about three women working in the lower rungs of a medium-sized medical establishment, about inter-faith love, and female camaraderie and resistance, won the Cannes Grand Prix. The Cannes feed showed the four women, Kapadia, Malavalam actresses Kani Kusruti and Divya Prabha, and Marathi/Hindi actress Chhaya Kadam accept the honours for their work flaunting Indian glamour, quiet confidence and Cheshire Cat grins. Actresses Kani Kusruti and Chhaya Kadam are each in two of these films — Kusruti in All We Imagine As Light, as well as Girls Will Be Girls, and Chaya Kadam in All We Imagine As Light as well as Laapataa Ladies. Both primarily act in regional language films — Malayalam and Marathi. Both are what every groomed, branded, radiant star actress in Indian films is not. Kusruti was born in rural Kerala to social activist and rationalist parents, who had dropped their last names to erase the social hierarchy marker that comes with last names in India. At 15, she invented her last name 'Kusruti' (meaning 'mischievous' in Malayalam) to fill in a requirement in her class 10th exam application. She studied physical theatre in Kerala and Paris before acting in Malayalam films. Kadam, also with a formidable background in Marathi theatre, is known for her roles in Nagrai Maniule films, Fandry, Sairat, and Jhund, which demand her to engage with social realities as much as with acting craft.

Kapadia's three lead characters in the film, Prabha (Kusruti), Anu (Prabha) and Parvaty (Kadam) could be characters from any great film by Satyajit Ray or Shyam Benegal — attuned to feelings of drift, up against a system unfriendly to them and yet deeply rooted in a sense of place and to their work. In the film's most revelatory moments, Prabha's



melancholic-eyed wisdom about life and Anu's determination to experience joy don't clash; they harmonise. As it does also in Rao's Laapataa Ladies, which was India's official entry to the Oscars for 2024. Friendship, these two films remind us, can be a profound act of resistance. For each other, Prabha, Anu, Paravaty, or Manju Maai and Phool in Laapataa Ladies, or for Mira and Anila in Girls Will Be Girls, are like family (you need, or hate, or can't forsake them), a beloved (you are jealous, and you are so sensitive to their slights) and also an alternative self, all squashed into one.

In Rao's splendid social comedy, the astute and cyni-

cal street brio of Manju Maai (Kadam), a chai-seller at a railway junction and Phool (Nitanshi Goel), simmers hope in the young, just married (and separated from her husband because of a bizarre and entirely believable twist in the plot) Phool like she makes chai: always on a boil, always ready to be stirred, always on survival mode. Hope is a balm, respite as well as a propeller also in Kapadia's film — when Prabha sinks to the floor of her kitchen one rainy night and folds her husband's gift in a silent, wrenching embrace as if the red rice cooker contains her every last grain of her hope; when the three friends embrace the youngest's inter-faith love, shooting the sea breeze at a village beach shack in rural Ratnagiri, hope is the emotion, accented by their beautiful sense of surrender to camaraderie, and to be beside each other. The climactic moment in All We Imagine As Light is sublime in its quiet resistance to the crushing pressure of living with so less of visibility in society, and so much of traditional binds. Talati's Girls Will Be Girls is about a mother and a daughter, and here too, the intangible becomes a resolution—for the plot as well as for the characters. Mira the daughter (Preeti Panigrahi) and Anila the mom (Kusruti) don't end up cementing their frenemy tugs that puncture almost the entire film. They can never break each other; in contrast, the film ends with a quiet sense of possibility and hope. Even as the mom-daughter relationship grows more fraught, their interdependence more complicated, there is the unspoken sense, through a scene where the daughter is oiling her mother's hair, that they are emotionally and psychologically conjoined. And this is what's interesting about friendship as the basis for all these stories: Their elasticity. Romance lends itself to declarations, defining events, hurdles and societal preconditions to accept or fight, but friendship eludes these things. These films, and a mainstream OTT film, Crew (Kareena Kapoor Khan, Tabu and Kriti Sanon as air hostesses) reclaim the female friendship narrative like no other time in Indian film history. A toppling of the saasbahu canon, a new gaze on how women exist for each other and the world, a serum to cure the normalised anti-individual staples of womanhood in Indian movies —

In Chennai, two concerts showed Carnatic music has a place for T M Krishna and his right-wing critics



The 2024 edition of the December music "season" in Chennai crested with two contrasting recitals bookending Christmas Day. At 9 am, the curtain rose on T M Krishna at the Music Academy to cheers and applause that would not have been out of place at a rock concert. At 6 pm that evening, Krishna's fiercest critics, the sisters Ranjani and Gayatri (RaGa to their fans), who had refused to participate in the Music Academy's festival, held their audience spell-bound at the Narada Gana Sabha, barely half a kilometre from the Academy. Between them, the two kutcheris showed how the Carnatic tradition can move on, and even thrive, after nearly a year of acrimony.

Krishna had stopped singing at the Music Academy and other Chennai sabhas about a decade ago, accusing them of Brahmin elitism. No community in the world is as closely associated with a high-brow cultural tradition as Tamil Brahmins are with Carnatic music (and its dance sibling Bharatanatyam) and the Music Academy has been their unrivalled bastion. Only Germanic Jews with Western classical music come close. Therefore, when the Music Academy decided to award Krishna its highest honour of Sangeeta Kalanidhi in March 2024, it caused a kerfuffle. Conservative rasikas accused the institution of pandering to a "woke" leftist who had tarnished the tradition by accusing revered icons — the composer Thyagaraja and the vocalist MS Subbulakshmi — of casteism and undermining its Hindu devotional roots by singing in praise of Allah and Jesus Christ. Carnatic stars such as RaGa and the Trichur Brothers announced that they would not perform at the Academy's December festival. Behind all this was the politics of Hindutva ('Hindutva, music and the elite', IE, March 27, 2024) provoked by Krishna's mockery of the Ram temple in Ayodhya and his endorsement of Periyar, the Dravidian movement founder known for his anti-Brahmin rhetoric.

Krishna's Christmas morning performance was therefore a homecoming of sorts (he had sung at the Academy at a lower profile event last year). He had insisted that it be a free concert, in keeping with his campaign for Carnatic music to be more inclusive. Free entry, of course, ensured the hall was packed (unlike on previous days of this "season" when many of the usual rasikas kept away, likely put off by the controversy). They were rewarded by a trademark unconventional performance. For two-and-a-half hours, Krishna sang, seated cross-legged in a twin-toned lungi, slightly turned towards his violinist. As someone observed, this was rather like Roger Federer turning up at Wimbledon in striped shorts and serving from the middle of the baseline (Carnatic vocalists typically sit at right angles to their main accompanists, clad, if male, in crisp white veshtis). Krishna served up many more breaks with concert convention: Opening his recital with an extended 22-minute-long exposition of Thyagaraja's "Karubaru" (rather than a brisk varnam or krithi), starting the next song, "Lavanya Rama", with the middle verse and then returning to the opening pallavi to improvise upon it, rendering three pieces, including a se-

ping a ragam-tanam-pallavi, the highpoint of a Carnatic concert and de rigeur at the Academy.

Krishna's political leanings also featured in rousing lyrics espousing freedom of expression, by the Tamil writer Perumal Murugan. For his closing pieces, he chose a song on the travails of a Dalit devotee of Siva and a composition by Narayana Guru, the late 19th and early 20th century social reformer from Kerala, which referred to Buddha, Christ and the Prophet Mohammed, alongside Hindu deities, while probing the identity of the divine. But it was Krishna's command of the classical idiom that shone through, not least in the three Thyagaraja krithis that he sang, and in his main piece in Kalyani by Swathi Tirunal. Carnatic's enfant terrible, extended an olive branch to his critics by concluding his kutcheri with "Dhava Vibho", a Marathi bhajan that M S had popularised; Krishna had also pointedly praised MS in his Academy address a few days earlier. The standing ovation that greeted him at the end suggested that he had made his point: Carnatic music can innovate and be more inclusive without compromising its classicism. The RaGa sisters' nearly three-hour concert to a mostly-packed (and ticketed) house was as steeped in tradition as Krishna's was unconventional. Resplendent in their yellow-and-black Kanjeevaram silks and wearing jasmine flowers in their hair, RaGa looked straight from Carnatic central casting. However, while they stuck to convention in their concert format and musical form, their content was just as political as

Gayatri set the tone at the very outset with her assertion that Carnatic music is inextricably intertwined with bhakti and the programme was replete with pieces ingrained with Hindu devotionalism. And what glorious music this was, even to my irreligious ear! But no Christ, the Prophet, or even the Buddha figured in their verses — indeed, they sang praising our nation as the land of Rama, Krishna, and Vittala. Their sublime ragam-tanam-pallavi in Jaunpuri had as its pallavi (equivalent to the bandish in Hindustani) a Tamil line celebrating Bharat as an upholder of dharma since time immemorial.RaGa's uncritical nationalism tinged with Hindu revivalist sentiments made me cringe but it was hard not to be moved by their stirring patriotic composition in Desh, sung in Sanskrit, Tamil, Brijbhasha and Marathi. The choice of Desh, and Jaunpuri earlier — both ragas derived from Hindustani music — and the multilingual renditions underlined Carnatic's catholicism and relative lack of parochiality In one sense, RaGa may actually have been more inclusive than Krishna. They made it a point to announce each of their pieces while Krishna uncharacteristically stuck with the elitist practice of seldom naming his song or its raga.

most readThese two performances demonstrated that Carnatic music is capacious enough to accommodate both a "left wing" Krishna and the "right wing" RaGa sisters. No classical art form can remain relevant without constantly evolving. While bhakti is undeniably foundational to Carnatic, the tradition also has more recent strands that espouse reform and protest, and celebrate other faiths. Likewise, the current Carnatic concert format, while only a century old, already feels stale in certain aspects. Krishna is only the latest artist to push its boundaries; indeed, others have done so without being sanctimonious, as he has sometimes been. The Music Academy has a crucial role to play in ensuring that Carnatic music thrives. Its leadership showed courage in honouring Krishna for his stellar musicianship, despite him being out of favour with the BJP and the adherents of Hindutva. Now, perhaps, it can reinforce its commitment to musical excellence by naming the equally deserving RaGa sisters as its next Sangita Kalanidhis, despite their public diatribe against the institution for honouring Krishna. Would such magnanimity be too much to ask for?

A WhatsApp group, a network of doctors, and thousands of lives saved: How Kashmir is curbing heart attack deaths

In 2016, a 35-year-old pilgrim undertaking the long trek to the Amarnath cave suffered a heart attack in the Baltal area of Jammu and Kashmir's Ganderbal district. As he was brought into the makeshift medical bay set up for pilgrims, a young doctor — unsure of administering drugs to thrombolyse the patient — called his senior, cardiologist Dr Imran Hafeez, for assistance."He was a bit unsure, but I told him to stay on the call and administer the drug. Once the pain settled, the patient was brought over to the Sher-e-Kashmir Institute of Medical Sciences (SKIMS) in Srinagar and saved just in time," Dr Hafeez told .The incident was the spark that led to the creation of a network of doctors across J&K that has been working on ensuring that patients on the peripheries of the state's healthcare infrastructure get the required treatment within the "golden hour" — the first 60 minutes after a heart attack, during which proper treatment can significantly improve chances of survival.

The network, Save Heart Foundation, connects over 1,200 doctors from 130 hospitals across J&K over WhatsApp, allowing even those with little cardiology experience to provide life-saving treatment to patients at makeshift medical camps and primary health centres by tapping into the expertise of senior cardiologists. According to its members, over 6,000 lives have been saved through early intervention via their WhatsApp group since the network started in 2017. Currently, the network covers nearly all hospitals in Kashmir, large parts of Jammu and some areas of Ladakh.

Every few minutes, Dr Hafeez's phone lights up as his colleagues interact on the WhatsApp group, uploading ECGs and seeking the expertise of cardiologists on the platform. "In remote corners, say at a primary health centre, the set-up includes a medical officer and consultants. So, when a patient with heart complications comes in, whether or not the person on duty is a cardiologist, they upload the ECG on our WhatsApp group and the cardiologist available at the time responds and guides the doctor on further treatment before they are referred to SKIMS or a district hospital if required," he said. SKIMS is the Valley's premier health institute and caters to a majority of Kashmir's patient load. Dr Hafeez, who has been a cardiologist here for 20 years, said, "In cardiology, time is muscle. So, ideally, the sooner a patient reaches us, the better the chance we have to save the heart. With our topography and the distances involved, a patient can sometimes take even four hours before reaching the hospital.'

In places like Kupwara and Kulgam, which have remote villages that often face issues of connectivity, the expertise of the cardiologists on the group has helped save several lives. Dr Aijaz Ahmad Bhat, posted at the Sub-District Hospital in Kupwara, said that while he has been posted at the hospital for the last 19 years, he first conducted thrombolysis on a patient with assistance from doctors on the group in 2017 and since then, "thousands of patients have been saved through early intervention of the doctors on the group". He said, "ECG facilities are available in every hospi-

tal, drugs are available everywhere, so in case of cardiac emergencies – even as far as Machhil or Keran – we upload the ECG and the patient is immediately treated."Dr Bhat emphasised that this has reduced referrals to tertiary care, and the key benefit is that they are able to treat the patients in time – within the "golden hour".In Kulgam, Dr Irfan Dar, posted at the district hospital for the last four years, said that in this period, at least 350 patients who came to the hospital have benefitted from the early diagnosis of heart diseases

"What happens is that sometimes, people available at the hospital do not know how to read or even conduct ECGs. But with this network, they are administering medicine to thrombolyse a patient. This has been an excellent collaboration," he said. "Even a young doctor with little cardiac experience can get assistance on the group and help patients."Though the group started in 2017, the internet shutdown in 2019 following the abrogation of J&K's special status under Article 370 of the Constitution took a toll on the effort. During the Covid-19 pandemic, the group again served as an asset, with doctors already connected through WhatsApp.Dr Hafeez also credited the J&K Health Department for providing drugs required for pharmacological interventions at primary health centres and training for doctors where necessary. As per data collected by the collective, nearly 64 per cent of cardiac emergencies in the Valley come from peripheral regions where the average time between diagnosis and treatment had been about 250 minutes. In many cases where there has been a delay in treatment, the reason has been misdiagnosis at the primary level. Easy to criticise consumer internet startups: Zepto CEO cites firm's contributions after Goyal's jibe



zepto ceo cites, startups, FDI, internet consumers, jobsThe Zepto co-founder statement comes after Goyal on Thursday asked the Indian startup community to shift their focus from grocery delivery and ice cream making to high tech sector like semiconductor Commerce Minister Piyush Goyal's scathing remarks on Indian startup ecosystem and its innovation priorities have drawn sharp reaction from the industry, with Zepto CEO Aadit Palicha putting up a strong defence citing the company's contribution to jobs, FDI and terming it a "miracle in Indian innovation".

Underlining the role played by consumer internet companies in pushing technology-led innovation, Palicha - one of the most recognised faces in the startup circles, and the co-founder of quick commerce company Zepto - argued that the startup ecosystem, the government, and the owners of large pools of Indian capital need to actively support the creation of these local champions, "not pull down the teams that are trying hard to get there". "It is easy to criticise consumer internet startups in India, especially when you compare them to the deep technical excellence being built in US/China. Using our example, the reality is this: there are almost 1.5 Lakh real people who are earning livelihoods on Zepto today – a company that did not exist 3.5 years ago," Palicha said in a LinkedIn post. The Zepto co-founder statement comes after Goyal on Thursday asked the Indian startup community to shift their focus from grocery delivery and ice cream making to high tech sector like semiconductor, machine learning, robotics, and artificial intelligence. "Are we going to be happy being delivery boys and girls... Is that the destiny of India... this is not a startup, this is entrepreneurship... What other side is doing — robotics, machine learning, 3D manufacturing and next generation factories," Goyal said on Thursday, comparing the nature of Indian startups with that of Chinese.

Palicha went on to count many other economic contributions, and placed many arguments. Rs 1,000 plus crores of tax contribution to the government per year, over a billion dollars of FDI brought into the country and hundreds of crores invested in organising India's back-end supply chains (especially for fresh fruits and vegetables). If that isn't a miracle in Indian innovation, I honestly don't know what is," he wrote.

Why doesn't India have its own large-scale foundational Al model, he quipped, then added "It's because we still haven't built great internet companies". "Most technology-led innovation over the past 2 decades has originated from consumer internet companies. Who scaled cloud computing? Amazon (originally a consumer internet company). Who are the big players in Al today? Facebook, Google, Alibaba, Tencent etc. (all started as consumer internet companies)," he said. Consumer internet companies drive innovation because they have the best data, talent, and capital to put behind it. We need to build great local champions in the internet that are generating hundreds of millions of dollars in free cash flow (FCF) first if we ever want to get a piece of great technology revolutions. The startup ecosystem, the government, and the owners of large pools of Indian capital need to actively support the creation of these local champions, not pull down the teams that are trying hard to get there," he argued. Zepto, he said, is still far away from being a great Internet company that can hold a candle to the global best, but is "executing day in and day out to get there". "I can promise that any capital we generate from this business (and it honestly looks like we will) will be invested towards long-term innovation and value creation in India. That is essentially what I am dedicating the next few decades of my life to try to do: create dynamism in the Indian economy and our capital markets, in the same way the Americans have for decades. We have the talent and capital; we just need the execution," he further said.

Trump tariffs singe India Inc: TCS, Infy to Tata Motors and metal firms in turmoil

Top Indian companies are facing a major challenge following US President Donald Trump's announcement to raise tariffs. This move is expected to affect directly or indirectly many Indian corporates, including IT giants TCS and Infosys, automobile firms like Tata Motors, pharmaceutical companies such as Sun Pharma and Cipla — which are now set to be brought under the reciprocal tariff policy — and National Aluminium and Tata Steel.

The stock market has already started feeling the heat, with stocks of pharma, automobile, IT, aluminium, steel companies and even Reliance Industries experiencing a significant decline over the last two days, taking the benchmark indices down by 1.22 per cent on Friday.

The tariff increase is expected to disrupt India's export-oriented industries, potentially leading to job losses, profit margins and revenue declines. As the situation unfolds, Indian corporates are gearing up to mitigate the effects of the tariff hike and explore alternative strategies to maintain their competitiveness in the global market. "Our analysis suggests that India's direct export loss from higher tariffs could be limited to around \$9-13 billion, which is 0.2-0.3 per cent of its GDP. India's domestically driven economy may offer some resilience," CareEdge Ratings said in a report. The Trump blow has come at a time when the rise in input costs and moderation in urban consumption slowed down corporate performance in the quarter ended December 2024 and companies listed on the stock exchanges set to report a lacklustre performance in profits and sales during the quarter ended March 2025, reflecting th1e challenging business environment. There's uncertainty over the corporate performance and GDP growth in the first quarter of FY2025-26 in the wake of the tariff changes. Tremors created by the Trump tariffs are expected to impact the entire industrial spectrum.

Hit by the tariff hike, shares of TCS, India's largest IT firm, fell another 3.07 per cent and Infosys plunged by three per cent on the stock exchanges on Friday amid worries that US firms will cut down IT spending. "Higher tariffs may result in higher inflation (versus the 2 per cent target of the US Fed) and may impact the FED's rate cut decision which is not conducive for the IT sector, in general," said Sumit Pokharna, VP-Fundamental Research, Kotak Securities. Indian IT companies get almost 70 per cent of their export revenue from the US. Any imposition of retaliatory tariffs on US exports by the US's trading partners could add to global inflation, which had turned benign. Tata Motors, a leading vehicle manufacturer, fell by 6.15 per cent on Friday after US has imposed 25 per cent tariffs on imported cars, light trucks and select auto parts sourced from outside of North America. Over 30 per cent of Tata Motorsowned JLR's revenue is from the US

Further, almost 150 auto parts will face tariffs at similar rate. This move could result into increase in car prices in the US and cost pressure for component suppliers. In the event of car prices going up, the US car market may witness a steep volume decline and that can impact rev-



enue for component players supplying parts to the US car/light truck industry, according to Arun Agarwal, VP (Fundamental Research – Automobiles), Kotak Securities.

Bharat Forge which exports 20 per cent of its auto components to the US fell by 8.46 per cent on the stock exchanges. However, auto makers like Maruti Suzuki and Mahindra & Mahindra have largely escaped as they are unlikely to get hit in a significant way. Sun Pharma and other pharma majors in the country are also set to face Trump tariff policy as the US has planned to include pharmaceuticals in the reciprocal tariffs in the next stage. Sun Pharma plunged by 3.43 per cent and Cipla by 5.32 per cent on the exchanges on Friday. India exported \$ 8 billion of pharma products to USA in fiscal 2024, its largest export destination, and supplies 40 per cent of generics consumed in the USA and any hike in tariff by the US Administration is likely to impact pharma exports.

India has more than 650 manufacturing facilities approved by the US Food and Drugs Administration (USFDA), the second-highest number outside the US. They account for a quarter of all such certified facilities outside the US, Crisil said. Steel and aluminium companies are also bracing for tough times as they fear dumping from other Asian countries following the Trump tariff. National Aluminium and Tata Steel shares plummeted by 8.6 per cent each as there could be pressure on their margins in the coming quarters, analysts said. Though textile firms like Arvind and Raymond declined on the stock markets in line with the subdued trend, they are likely to be beneficiaries. This is because the US administration has levied 27 per cent reciprocal tariff on home textiles and readymade garments from India. This is lower than the levies on other major textile exporting countries — China (54 per cent), Vietnam (46 per cent), Bangladesh (37 per cent) and Pakistan (30 per cent) — and could enhance India's relative competitiveness and present an opportunity to increase its share of textile exports to the US. For Arvind, the US is a key destination for its products. Higher tariffs are likely to be passed through to consumers to an extent, leading to an increase in the prices of end products, which could dampen the demand over the medium term. This, along with any potential reversal in tariffs imposed on India and the competing nations, will remain a key monitorable,

Taj Mahal top earning ASI monument in last five years

New Delhi: Mughal-era mausoleum Taj Mahal was the top earning ASI-protected monument through ticket sales, generating a revenue of Rs 297 crore in the last five years, according to data shared by the government.

Union Culture Minister Gajendra Singh Shekhawat shared the data in a written response to a query in the Rajya Sabha on Thursday. In FY23-24, Qutub Minar and Red Fort of Delhi were in the second and third positions generating a revenue of Rs 23,80,16,983 and Rs 18,08,90,825 respectively. He was asked the amount that the Archaeological Survey of India (ASI) has received from selling entry tickets to various monuments in the last five years, yearwise and monument-wise; and the monuments that have received the highest income through sale of entry tickets in the last five years. In his response, the Minister shared the data in a tabular form for cycles of financial years ranging from FY19-20 to FY23-24. According to the data, Taj Mahal earned the top slot for all five years. The Taj Mahal was commissioned by Emperor Shah Jahan in the 17th century and



it is considered one of the most beautiful buildings in the world. In FY19-20, the Agra Fort in Agra and Qutub Minar in Delhi were in the second and third positions. In FY20-21, the Group of Monuments Mamallapuram in Tamil Nadu and Sun Temple, Konark were in the second and third positions. In FY23-24, Qutub Minar and Red Fort of Delhi were in the second and third positions.

WTO, IMF raise alarm over Trump's reciprocal tariffs; Economists predict weaker Indian growth prospects



Key multilateral agencies, the World Trade Organisation (WTO) and the International Monetary Fund (IMF), on Friday raised alarm over higher-than-expected US reciprocal tariffs, which are set to upend the global trade order and trigger a potentially long-drawn trade war between large trading blocs such as China and the European Union. This could, they warn,ultimately hurting global goods trade volumes. The WTO's initial estimates suggest that US tariff measures introduced on April 2, along with those imposed since the beginning of the year, could lead to an overall contraction of around 1 per cent in global merchandise trade volumes this year. This represents a "downward revision of nearly four percentage points" from previous projections, WTO Director-General Ngozi Okonjo-Iweala said in a statement

Meanwhile, the IMF warned that the new US tariffs have heightened the risk of sluggish global growth and urged the US to ease trade tensions. "We are still assessing the macroeconomic implications of the announced tariff measures, but they clearly represent a significant risk to the global outlook at a time of sluggish growth. It is important to avoid steps that could further harm the world economy. We appeal to the United States and its trading partners to work constructively to resolve trade tensions and reduce uncertainty," IMF Managing Director Kristalina Georgieva said.

Okonjo-Iweala further emphasised that the recent US announcements will have substantial implications for global trade and economic growth prospects. "I'm deeply concerned about this decline and the potential for escalation into a tariff war with a cycle of retaliatory measures that lead to further declines in trade. It is important to remember that, despite these new measures, the vast majority of global trade still flows under the WTO's Most-Favoured-Nation (MFN) terms. Our estimates now indicate that this share currently stands at 74 per cent, down from around 80 per

cent at the beginning of the year. WTO members must stand together to safeguard these gains," she said, as per Reuters. The WTO was established precisely for moments like this—as a platform for dialogue to prevent trade conflicts from escalating and to support an open and predictable trading environment, Okonjo-Iweala added, encouraging members to use WTO forums to engage constructively and seek cooperative solutions.

Goldman Sachs, in its report, estimated a 30-basispoint drag on India's GDP growth for the current year, given India's 4 per cent share in US final demand. The investment banking firm further stated that it expects no retaliation from India and believes some announced tariffs will likely be negotiated lower over time during the ongoing trade deal negotiations.HDFC Bank Research warned that FY26 growth estimates could see a "significant downward revision" due to potential trade wars and the absence of a strong domestic demand recovery, exacerbated by weather-related disruptions, the risk of heatwaves, increased financial market volatility, inflation spikes, and a more severe downturn in the global economy. Sakshi Gupta, Principal Economist at HDFC Bank, stated in a report that the across-theboard reciprocal tariffs imposed by the US are much more extreme than initially anticipated, posing a downside risk to India's GDP growth forecast of around 30 basis points. "We must admit that there continues to be a significant level of tentativeness in this forecast, which hinges on several 'unknowns'-whether other countries like the EU and China would retaliate, or whether the US will eventually reduce tariffs through successful bilateral negotiations," the report

Furthermore, HDFC Bank's research report warned that a sharp global growth slowdown, particularly in the US (with recession odds now rising to 40 per cent), could reduce India's total export volumes—not just in goods but also in services."We believe this is the biggest risk to India's GDP growth (estimated at 0.3-0.4 percentage points for a 0.8-1 per cent drop in global growth), more so from the direct impact of US tariffs. Moreover, with tariffs of over 50 per cent on China, the risk of oversupply flowing into India and hurting domestic manufacturing remains high," the report noted. Gupta added that the impact on India could be softened if it secures some concessions under the ongoing bilateral talks with the US. However, she cautioned that the potential benefits could be weaker than expected if other countries choose to absorb some of the tariff hikes by reducing prices, negotiate lower tariffs with the US, or engineer currency depreciation to offset the impact of tariffs

How India may gain from relatively lower tariff rate: Foreign inflows likely to rise

US President Donald Trump's announcement to impose lower reciprocal tariffs on India compared to other Asian countries will give India a competitive advantage over its peers and attract higher foreign inflows into the domestic market, experts say. On Wednesday, President Trump announced sweeping reciprocal tariffs on its trading partners. In the case of India, the tariff imposed is 27 per cent. This rate is much lower than 34 per cent imposed on China, 46 per cent on Vietnam, 37 per cent on Bangladesh and 36 per cent on Thailand.

"Exporters are going to benefit given the preferred tariff rates for India vis-a-vis the other economies of the globe, especially Asia Pacific. Now, India is going to have a better advantage in terms of exporting at a lower cost, and that will tantamount to better profitability, and earnings growth cycle in the country. This, in turn, will attract further investments into India, especially from foreign investors," said Akhil Puri, partner, financial advisory, Forvis Mazars in India. All export-oriented sectors, such as auto, textile and minerals, are going to reap the benefits.

"In the textile segment, our major competitor is Bangladesh. After the political upheaval in Bangladesh, customers are looking at India. Now, with higher tariffs on Bangladesh, India is better placed," said an analyst.Lower tariffs directly reduce the cost of doing business, making Indian markets more attractive than high-tariff economies. This competitive edge encourages FIIs to invest larger capital amounts, anticipating higher returns in a lower-barrier trade environment, he saidA favorable tariff structure also signals a business-friendly climate, leading to immediate foreign capital influx and increased investor confidence. Puri said. "Over the medium to long term, sustaining these (FIIs) inflows will depend on stable trade policies and investorfriendly regulations. If India maintains a predictable policy environment, lower tariffs could ensure a steady and stable stream of FII investments," he said. India has been in talks with the US for a trade agreement and both sides are soon



expected to arrive at a common ground.

After incessantly selling for months, foreign portfolio investors changed their strategy and became buyers of domestic stocks. The modest buying by FPI was visible in the week ending March 21, which further increased in the week ended March 28.Big buying by FPIs during the last several days of March substantially reduced the total FPI selling in the month to Rs 6,027 crore. Since FPIs invested Rs 2,055 crore through the primary market, the net FPI sell figure for March is down at only Rs 3,973 crore.

The re-emergence of FIIs as buyers contributed to nearly six per cent recovery in Nifty. The factors that resulted in recent buying by foreign investors included valuation in the domestic market turning attractive, recent appreciation in the rupee and improvement in India's macros such as gross domestic product (GDP), IIP and CPI inflation, according to VK Vijayakumar, Chief Investment Strategist, Geojit Investments Ltd.The real GDP picked up pace sequentially to grow at 6.2 per cent in October-December 2024 (Q3 of 2024-25 or FY25) compared with 5.6 per cent in July-September 2024 (Q2) quarter. Consumer price inflation (CPI), or retail inflation eased to a seven-month low of 3.61 per cent in February, compared to 4.26 per cent in January

Electronics manufacturers remain cautiously optimistic post Trump tariff hit — but see some immediate risks

As US President Donald Trump announced "retaliatory" tariffs on a slew of countries, demolishing an over 75-year-old global trading system with the imposition of an across-the-board baseline levy, electronics manufacturers that are producing and exporting from India acknowledged that while it could result in a cost barrier, the measure could also offer some advantage to India owing to higher levies imposed on its competitors. Immediate risks, however, arise from countries like Brazil, Saudi Arabia and the United Arab Emirates (UAE).

As part of Trump's diktat, India is receiving a 27 per cent tariff on exports to the US. Its key Asian competitors in electronics manufacturing, China and Vietnam, have fared much worse. The reciprocal tariff on China is 34 per cent, plus the existing 20 per cent rate which Trump had imposed on the country in early days of his administration, bringing the total rate to 54 per cent. Vietnam will be hit with a 46 per cent levy. However, some countries - with similar ambitions as India in deepening their electronics supply chain - may have received a more favourable levy than New Delhi. Key among them is Brazil, which will be subjected to the baseline 10 per cent levy, and as a result could draw away some investments from India. Similarly, Saudi Arabia and UAE, too have gotten away with just the baseline levy, and Philippines has been charged with a lower rate than India at 18 per cent. Although, it is worth noting that the tariff-setting mechanism by the US appears to correlate primarily with bilateral trade imbalances rather than purely tariff rates or non-tariff barriers. Clarity on the precise calculation methodology remains limited, introducing uncertainty into future negotiations. "Saudi Arabia and UAE represent near-term threats to India's electronics exports due to their SEZs, competitive manufacturing environments, and potential labour-cost advantages. Brazil's favourable tariff treatment, despite historical trade barriers, adds to strategic ambiguity and warrants careful monitoring," electronics lobby group India Cellular & Electronics Association (ICEA), said in a statement. The group represents companies including Apple, Google, Vivo, Oppo, and Dixon among others.

According to the Economic Survey 2024-25, the domestic production of electronic goods in India increased from Rs 1.9 lakh crore in FY15 to Rs 9.52 lakh crore in FY24, growing at a compounded annual growth rate of 17.5 per cent. However, the country has made limited progress in localising electronics design and component manufacturing. It has recently announced a Rs 23,000 subsidy scheme to boost the latter. One key company in focus is Apple. Its stock was down more than 7 per cent in after hours trading post Trump's measure as many of its key production hubs - China, Vietnam and India - were hit by tariffs. In India, the company assembles around 10 per cent of its iPhones through its contract manufacturers Foxconn and Tata Electronics, and is the prime beneficiary of New Delhi's production linked incentive (PLI) scheme for smartphones. Apple's business in India is considered crucial in the power corridors of New Delhi, as the company is seen as a flagbearer for the manufacturing narrative it wants to project, while drawing in more marquee names. Calling for a comprehensive trade agreement between India

De Bruyne will leave City with at least 16 major trophies to his name, given the club fails to add any more to their cabinet this season. De Bruyne will end his City career with the most number of Premier League titles for an active player. He is tied on six trophies with several City teammates, including Phil Foden, Nathan Ake, Ederson and John Stones.

Delhi HC expresses concern over infighting in sporting federations

The Delhi High Court on Wednesday (April 2, 2025) expressed concerns over the "infighting" and "disputes" in sporting federations in the country, saying such an environment was not conducive for sports. A Bench of Chief Justice D.K. Upadhyaya and Justice Tushar Rao Gedela made the observation while hearing an appeal by the Boxing Federation of India (BFI) against a single judge Bench's order over its election process. Counsel appearing for the secretary and treasurer of the federation said the appeal was not duly filed as it was instituted by the BFI president

without any authority.

The BFI's counsel, however, said the secretary and the treasurer were suspended. The court asked the parties to "resolve" the dispute and said every sporting federation in the country was embroiled in litigation and "inter se disputes" came in the way of "interest of sports". "Every sports federation has some dispute. Your function affects the entire nation. Why this kind of infighting? These kinds of things pave the way for where you can be disqualified by the international body. Sports internationally is governed by international Olympic charter. The charter says the (national) body has to be autonomous. Autonomy is being compromised by litigation," the court said, Judge said, "such kind of infighting I can't understand. Every single sports federation is in litigation." The court posted the matter for further hearing on April 7. The BFI plea challenged a March 19 order of a single judge Bench, which stayed the federation's March 7 decision to allow only elected members of its affiliated State units to represent their respective States in the upcoming elections in the sporting body. The single judge Bench's order came on a plea of Delhi Amateur Boxing Association and held the process of election should continue along with the declaration of results but it was subject to the petition's final outcome.

Rahi Sarnobat eyes Olympic comeback after battling health scare

Hyderabad: Two-time Olympian and shooter Rahi Sarnobat, who staged a stunning comeback from serious health issues to win the gold in the women's 25m air pistol in the National Games in Dehradun this year, says that her goal now is to focus on herself to realise her Olympic dream. "This dream has been planted in my system for a reason. This is not about proving to the world. I am more courageous as there is nothing to lose. I want to be remembered as a person who made things happen," Rahi said in a House of Glory podcast, an initiative by Hyderabadi and London Olympics bronze medallist Gagan Narang Sports Foundation. The 32-year-old Maharashtra shooter had health issues in 2022 and found herself facing hot flashes and nerve pain. After weeks of feeling sensations all over her body,

causing her tremendous pain, Rahi found herself being on bed rest, unable to find a diagnosis. "We did not know which doctors to go to – we did ECG, cardio testing, routine tests – but everything was fine. Still, I was feeling terrible. I started feeling my neck pain, that I could not lie on bed and I had to sit and sleep for months. My medical team suggested consulting a neurologist," Rahi revealed .After weeks of neurological testing, Rahi was diagnosed with neuropathic pain. "Neuropathic pain syndrome has no fixed pattern and no fixed line of treatment. It depends on case-to-case, and the medical history of every person. It makes it even more scary," the pistol shooter said. "I was sleeping for 17-20 hours for months. I was just staring at the ceiling for months. I could not live my normal life. I felt fear about being uncer-

Impact Player — a tussle between evolution and a level-playing field

Followers of the Indian Premier League will identify Vikram Solanki as the Director of Cricket with Gujarat Titans, the champions on debut in 2022. The Udaipur-born Solanki, who celebrated his 49th birthday on Tuesday, played 51 ODIs and three T20Is for England between 2000 and 2007 with modest returns, but he will go down in history books as the first 'Super Sub' in international cricket. The Super Sub was introduced in One-Day International cricket in July 2005, sending hordes of statisticians, mainly, and scorers across the world into a tizzy. Cricket was always supposed to be 11 versus 11; the Super Sub would make it 12 vs 12 or, in many instances 12 vs 11. How was this cricket?

As an experiment, the Super Sub idea lasted only eight months. Fundamentally flawed because it magnified rather than neutralised the effect of the toss, it met its logical denouement in March 2006 with numerous luminaries, among them then Australian captain Ricky Ponting, exhorting a rollback to the original 11 vs 11 faceoff. Because the Super Sub had to be named before the toss, it negated the advantage for the captain who lost the toss and conferred a distinct edge to the side that hit it lucky with the coin. The decision makers within the International Cricket Council acted swiftly, though had they been a little more prudent in the lead-up to the unleashing of the Super Sub, it might not have been the worst idea, never mind if the scoring/statistician community was up in arms.

More than a decade later, the concussion sub came into the picture, in 2019. The catalyst for this move was undoubtedly the tragic incident involving Phil Hughes in a Sheffield Shield encounter towards the end of 2014. The prime example of a concussion sub emerging as one of the leading batters for his country is Marnus Labuschagne, the first such player in Test cricket when he came on to replace an injured Steve Smith, who was struck on his helmet by Jofra Archer in the Lord's Test of August 2019. Labuschagne made 59 in his first hit in Test cricket, and despite his recent travails, averages 46.76 from 57 Tests.

The concussion sub is a permanent feature now, used – sometimes misused or abused, one might say -- in all formats across all levels but a novelty that the IPL sprung on the game is yet to catch on. In a more nuanced variant of the discarded Super Sub, the IPL permitted the use of an Impact Player from the 2023 edition onwards. Outside of the designated 11, each side can nominate five reserves, from whom the Impact Player can be summoned at any stage. Because this was delinked from the outcome of the toss – any of the five could be used in that capacity, so long as only four overseas players were part of the 12 – it provided a greater level-playing field compared to the Super Sub, though the bowling community might hold a dim view on this development.

Ironically, while the Impact Player has freed up the minds of batting groups and spawned a dramatic increase in the rate of scoring and team totals, the thinking behind this innovation was to bolster bowling depth. In theory, teams could swap a batter for a specialist bowler when they defended a target, thereby precluding the need to rely on the infamous 'bits-and-pieces' players. In reality, it has triggered a in mindeate and attitudge from a tive. The Impact Player might not always make an impact, but the luxury of being able to call up an additional batting resource in the event of a collapse has emboldened teams to shed conservatism and concentrate on all-out attack. That the top five scores of all time in the IPL have come since the start of the 2024 edition is no coincidence. The once-preferred approach of beginning carefully and then exploding in the second half has now been emphatically thrown out the window. There are no more sighters even if the new ball is swinging or nipping around. No one has benefitted from this more than Sunrisers Hyderabad, who have produced scores of 287, 286 and 277 in the last season and a quarter, taking aggression to ridiculously new heights and marrying it with a consistency that makes them comfortably the most feared batting unit of the competition.

When an Impact Player delivers, it sends a frisson of excitement and satisfaction in the support staff that works out match-ups and the rest and decides who is best suited for that role. Already this season, a slew of such players has made a telling difference, none more so than Ashutosh Sharma, against Lucknow Super Giants.Rishabh Pant's men had amassed 209 for eight in their 20 overs and Delhi Capitals were reeling at 65 for five after 6.4 overs when Ashutosh strode in to join Tristan Stubbs, the exciting young South African. The Capitals needed 145 more in 80 deliveries but were fast running out of batters. Among those already back in the hut were skipper Axar Patel and Faf du Plessis, the South African who had captained Royal Challengers Bengaluru for the preceding three years.

Ashutosh started slowly, steadying the chase with stands of 48 and 55 respectively with Stubbs and the relatively unknown Vipraj Nigam. Because Stubbs had taken only 22 balls for his 34 and Nigam had scored even more furiously – 39 off just 15, at a strike-rate of 260 – Ashutosh was able to play himself in without feeling the need to score rapidly. Perhaps he had an inkling of what was to come, of how much responsibility he'd have to shoulder. Perhaps he believed that there would come a time when it would all be up to him and therefore it made no sense to take a chance or three early on and throw it all away. When the Nigam show ended, the Capitals required 42 in 23 deliveries with three wickets in hand; that became 39 in 17 with two wickets remaining when Mitchell Starc ate up five balls in making two before falling to leg-spinner Ravi Bishnoi. Only Kuldeep Yadav and Mohit Sharma were left. The former is no mug with the bat but not exactly a power-hitter while the latter averages 7.34 at a strike-rate of 94.94 in 166 T20s. It was now entirely in Ashutosh's hands, the fate of the match. At one point 20 off 20, the powerful right-hander positively exploded towards the closing stages. Pant and his team believed all they needed was one false stroke, but none was forthcoming. Targeting his areas, mainly straight down the ground, the 26-year-old smashed five fours and as many sixes so that his last 11 deliveries produced a remarkable 46 runs. Despite having their backs to the wall, despite the required rate mounting and the wickets tumbling, the Capitals won by one wicket with three deliveries to spare. A massive half an hour. Extraordinary doesn't even begin to do justice to the carnage at the gob-smacked ACA-VDCA Stadium in Visakhapatnam, the Capitals' temporary home at the start of their campaign.

Ashutosh is the most visible but not the only Impact Player to make a difference at this early stage of this year's skirmishes. As recently as on Tuesday, but under far less pressure, Nehal Wadhera justified his introduction with a 25-ball 43 not out in Punjab Kings' eight-wicket rout of, well, Lucknow Super Giants again. Maybe they, more than anyone else, will have deep reservations about the Impact Player, considering how adversely that has impacted their fortunes and left them languishing at sixth in the table a fifth of the way into the league phase.

The Impact Player hasn't been discussed on a global platform and no other major T20 league has followed in the IPL's footsteps. Indeed, there was a concerted push from many captains for the scrapping of this rule ahead of this season; among those who have spoken out against this are Rohit Sharma, Virat Kohli and AB de Villiers. But the IPL has gone ahead and extended this concept to the next three seasons, sparking genuine fears that what might be good for the most visible franchise-based league in the world might not necessarily be good for Indian cricket because it will, as it already has, stymie the unearthing of genuine Indian all-rounders."It brings an added excitement, clearly, for the audience," Mo Bobat, RCB's Director of Cricket, observes. "It also makes sure that games stay live for longer. which is useful. And I think that also is relevant here (at the M Chinnaswamy Stadium in Bengaluru), where games stay live for longer because you can chase quite a lot in the end. So, in many ways, it makes it very exciting for people."Bobat's loyalty is to RCB, as it must be, and he isn't particularly fussed about how the Impact clause affects Indian cricket per se. Hence, it was no surprise to hear him say, "If you were someone who was particularly bothered about Indian cricket's future, you might ask a few questions around what it's done to the all-rounder. But me in this position right now, that isn't a major concern. It's a case of us trying to make sure that we use it to our advan-

The IPL's insistence on the Impact Player, yet to surge into international consciousness, hasn't adversely impacted the national team's fortunes. India remained unbeaten at the T20 World Cup last year on their way to the title and are unbeaten in their last nine bilateral series. Maybe we are overstating the adverse effect on the Indian all-rounder. Or maybe, just maybe, we are being clairvoyant?





SS Rajamouli-Mahesh Babu project to be a singlepart filmSSMB 29, starring Mahesh Babu, is expected to be a globe-trotting action adventure Even thought sequels and franchise films were dime-a-dozen in Indian cinema SS Rajamouli's Baahubali films became the blueprint of sorts for every big-ticket film that followed. Almost every big star had two-part films, and in some cases like Mohanlal-Prithviraj Sukumaran's Lucifer franchise, even three films. However, after Baahubali, Rajamouli is yet to make a two-parter or a franchise film. His RRR was a standalone film that starred Ram Charan and Jr. NTR and became a global success of epic proportions. Even as there were speculations about his next with Mahesh Babu, tentatively titled SSMB 29, might take Rajamouli back to his Baahubali days, newer reports have surfaced giving clarity to the same.

According to a Pinkvilla report, the film, which will hit the screens in 2027, is said to be a single-part film. The globe-trotting adventure, which also features Privanka Chopra-Jonas and Prithviraj Sukumaran, will reportedly be Rajamouli's longest film. A Minecraft Movie review: Dwayne Johnson, Jack Black keep the jokes going in predictable film



Guess when you are "the best-selling video game of all time", "with over 300 million copies sold" as per Wikipedia, you don't have to stress more than calling yourself 'A Minecraft Movie'. Guess when you have signed Momoa and Black on, you may also think you don't need to stress more than throwing them together. A Minecraft Movie does that, again and again – having the two actors

with a fairly good comic presence go at each other head to head. It's not funny, particularly when you can't escape the quantities of unwashed hair on their heads. Still, Momoa and Black, who hold little of themselves back in this video game enterprise, are the best part of A Minecraft Movie.

Strangely, for a gaming enterprise that prides itself on its emphasis on creativity – differentiating it from the others – the film hardly has any time for those aspects of Minecraft. Henry (Hansen) is the sort of child genius who can get there, under the guidance of Steve (Black), but there is no method to his madness in hurling blocks around to "create" things – nor is the film interested in showing you the method. We have fights, flights, swines, wolves, orbs, crystals, red minerals, diamonds, castles, towers, lava-cooked chicken, good people, bad people, real world, Overworld, and lots and lots of screaming. And then we have Jennifer Coolidge, doing her thing. As a waiter at a hotel asks her and her partner, "Are you finished?" She replies, "No, I think he is Swedish."

"When the audience sings along, sometimes there could be leakage in the in-ear monitors. This is a technical aspect. Because of that leakage, they might not have been able to hear their own voice. Either they weren't getting proper pads or the stage monitors weren't working properly. When you perform live, there are many technical aspects that matter," he noted. "I am not trying to save anyone, nor am I trying to hide anyone's mistakes. I feel that when I am in my 60s or 70s, my aim will be to sing in tune. The feel of singing is a game-changer; not every person



can think like an engineer. If everything's so perfect, then a song could be immediately recorded and released without any mix or mastering. 'The singer has recorded it and that's it, everything is perfect' — that's not how it works. The whole team works together. And we should also think a little more humanely. Kisi ko 'besura' kehne se pehle samajhna chahiye ki besura hona kya hota hai (Before calling someone 'out of tune', we should understand what it means to be out of tune," he added.

Ravikumar, noted Malayalam and Tamil actor known for his lead and villain roles, passes away

Renowned actor Ravikumar, known for his performances in several Malayalam and Tamil movies, has passed away. He was 71 and reportedly succumbed to his battle with cancer at a private hospital in Chennai, Tamil Nadu, on Friday morning. The holder of a prolific career spanning over 100 Malayalam films, several Tamil movies and a handful of television serials, Ravikumar hailed from Thrissur in Kerala but had been living in Chennai for many years

Following his purported acting debut in Indhulekha (1967), Ravikumar rose to prominence in the 1970s and 1980s by playing both lead and villain roles. Although he appeared in movies such as Ullaasayaathra (1975), Neelasaari (1976) and Ayalkkaari (1976), it was his performance in director M Krishnan Nair's Amma (1976), starring Madhu and Srividya, that earned him his first bout of recognition.

His other notable films include Avargal (1977), Avalude Ravukal (1978), Padakkuthira (1978), Lisa (1978), Neelathamara (1979), Allauddinum Albhutha Vilakkum (1979), Anupallavi (1979), Sarppam (1979), Pagalil Oru Iravu (1979), Angadi (1980), Theekkadal (1980), Sphodanam (1981), Rojavanam (1999), Vanna Thamizh Pattu (2000), Youth (2002) and Sivaji (2007). He was last



seen in films such as director B Unnikrishnan's Mohanlal-starrer Aaraattu (2022), K Madhu's Mammootty-led CBI 5: The Brain (2022) and Veetla Vishesham (2022), a Tamil comedy drama featuring RJ Balaji, Sathyaraj and UrvashiThe son of KMK Menon and R Bharathi, Ravikumar's mortal remains will be taken to his residence at Valasaravakkam in Chennai, as reported by OnManorama, and his funeral will be held there on Saturday.

Nani on bringing back 'relatable Chiranjeevi' with Srikanth Odela project: 'We forgot why we loved Chiru garu'

Actor-filmmaker Nani has never minced words in his admiration for Megastar Chiranjeevi. Throughout his career, Nani has often spoken very highly of Chiranjeevi, and waxed eloquently about the impact of the Megastar's films in his life. That's why, when it was announced that Nani was presenting Srikanth Odela's next with Chiranjeevi, it was almost like life came a full circle. When asked in an interview with The Hollywood Reporter if the larger-than-life persona of Chiranjeevi impacts the way the project will be made, Nani simply said, "I don't want to have that idea at all."

Elaborating on how placing such pressure on himself, and on Chiranjeevi isn't doing any good at all. "When people start thinking that way, we stop understanding what made Chiranjeevi garu so relatable to generations," said Nani, who fished out an example from his own life. "In my childhood, when I walked into the theatre to watch Chiru garu on the screen, I could see him immediately transform into whatever role he was playing. He made us cry, he made us smile, and of course, there were exciting fights too, but what really stood him apart was the immense relatability."

Nani, who is fondly called the "Natural Star" is someone who has made a career out of being relatable to his audience. Since he made his debut in 2008, Nani has always gravitated towards the script featuring the everyman as the hero, and picked scripts that endeared him to the masses. "

We are not understanding the power of relatability. We do these big action films, the big spectacles where the focus is on the technique, music, and the huge action setpieces. Imagine we do all that but with a strong grasp of relatability... the emotions are magnified by ten times. That used to happen when we saw Chiru garu's films," said Nani, who pointed out how theatre viewing has undergone a drastic change in today's digital era.

"We used to be in complete awe while watching a film. Now, we are having conversations, looking at our phones, etc... First, let's bring back that brand of cinema. Of course, Chiru garu is larger-than-life, but let us remind ourselves as to why we loved him in the first place. Some say he is good with dance or he is good with action or he is good in this or that... But he is more than all of that. We always saw him as a member of our family, and we seem to have forgotten that now," said Nani, who is presenting Srikanth's film under his banner of Wall Poster Cinema.
