## Telangana may experience respite from severe heat in the form of thunderstorms till May 7 in public view

Hyderabad: People in Hyderabad and districts can expect respite from intense heat wave-like conditions for the next five days. The Hyderabad MET department on Friday in its forecast has indicated widespread thundershowers along with gusty winds in 29 districts of Telangana State till Wednesday, May 7.

The weather department issued an orange alert of severe thunderstorms accompanied by gusty winds of 40 to 50 kmph on Saturday for several districts such as Jayashankar Bhupalapally, Mulugu, Bhadradri Kothagudem, Khammam, Nalgonda, Suryapet, Mahabubabad, Warangal, Hanamkonda and Jangaon.

# Youth brutally murdered in public view in Falaknuma

Hyderabad: Unidentified persons brutally murdered a youth in full public view at Bibi-ka-Chasma in Falaknuma in the old city on Friday. A previous enmity is suspected to have led to the murder. As per available information, the assailants approached the victim identified as Mohd Majid (27), who runs a pan shop near Metro Bakery and reportedly after an argument, attacked him with knives and other sharp weapons. He suffered multiple grievous bleeding injuries. Those who noticed the attack immediately rushed to his rescue and shifted him to the hospital, where the doctors declared him dead. Delhi Court Issues Notice to

Herald Money Laundering Case

New Delhi: A Delhi court issued notices to Congress leaders Sonia Gandhi and Rahul Gandhi in connection with the ongoing National Herald money laundering case. The development came during the second hearing at the Rouse Avenue Court, with the next hearing scheduled for May 8.

This marks a shift from the court's earlier stance on April 25, when it declined to issue notices to the Congress leaders. At that time, the court directed the Enforcement Directorate (ED) to submit additional relevant documents and rectify deficiencies in its filing. The case stems from a chargesheet filed by the ED in the Rouse Avenue Court, in which Sonia Gandhi, former Congress president, and Rahul Gandhi, Leader of the Opposition in the Lok Sabha, have been named as accused. Other individuals mentioned in the chargesheet include senior Congress leaders Sam Pitroda and Suman Dubey.

The roots of the case trace back to the National Herald newspaper, established in 1938 by India's first Prime Minister, Jawaharlal Nehru. Once a symbol of the country's freedom struggle, the paper was published by Associated Journals Limited (AJL) but ceased operations in 2008 due to financial difficulties. Subsequently, in 2010, a new company—Young India Private Limited (YIL)—was formed, with Sonia Gandhi and Rahul Gandhi reportedly holding a 38% stake each. In 2012, BJP leader Subramanian Swamy alleged that YIL had fraudulently acquired AJL's assets, valued at over ?2,000 crore, for a mere ?50 lakh. He termed the transaction a case of fraud and money laundering, prompting a prolonged legal and investigative process.

# Political undercurrents mark Vizhinjam port inauguration by PM

The official commissioning of the Vizhinjam International Seaport by Prime Minister Narendra Modi on Friday (May 2, 2025) appeared marked by national and provincial politics. Mr. Modi, who dedicated the facility to the nation, seemed to take an oblique dig at the Congress' national leadership by observing that two prominent INDIA bloc leaders - Kerala Chief Minister Pinarayi Vijayan and Shashi Tharoor, MP, - shared the high-profile stage with him."It might make some quarters uncomfortable," Mr. Modi quipped. The Prime Minister also joked about the translator missing the political punchline.Mr. Modi also satirically seized on State Fish-Minister V.N. eries Vasavan's words for political point-scoring. Mr. Vasavan said the Kerala government had "found a partner" in Adani Ports to make Vizhinjam a reality.Mr. Modi said he saw some novelty in a Communist government reckoning a private sector entity as a reliable partner in a flagship infrastructure development project. "Privategovernment partnership is crucial to the country's development", he noted. Mr. Modi appeared to have used the moment to indirectly dispel Congress' criticism that the Central government



favoured the Adani Group. Mr. Modi commenced his speech by stating he was "fortunate to step on Padmanabhan's land", referring to the landmark Sree Padmanabhaswamy temple in Thiruvananthapuram.He noted that the country observed May 2 as Adi Sankara Jayanthi, an eighth-century Hindu seer believed to have been born in Kalady in Kerala. Mr. Modi paid homage to the late Pope Francis in the predominantly Latin Catholic locality. He remembered St Thomas, one of the 12 Apostles, who Christians believe had arrived in Kerala in 52 BC.Mr. Modi saluted the crowd by stating 'Jai Bharath and Jai Keralam', signalling that the Centre was "in lockstep with the State" on welfare and development issues. Meanwhile, Mr. Vijayan sought to make a political point by underscoring that Kerala had borne 60% of the project cost. He noted that the Centre had limited itself to (a relatively less and repayable)

viability gap funding. Mr. Vijayan appeared to leverage the national stage to counter the Bharatiya Janata Party (BJP) and the Congress' assertion that the Left Democratic Front (LDF) government was falsely taking credit for a Central scheme. He also highlighted the challenges the LDF had overcome to make Vizhinjam a reality.Tourism Minister P.A. Mohamed Riyas stated that the presence of BJP State president Rajeev Chandrasekhar on stage at the behest of the Prime Minister's Office was "undemocratic." Mr. Riyas accused Mr. Chandrasekhar of political impropriety by allegedly attempting to turn the State function into "a BJP political event."Mr. Riyas asked journalists to turn their television cameras towards the stage where Mr. Chandrasekhar had seated himself well ahead of the function's commencement, raising his fist occasionally in support of BJP workers' loud sloganeering."

### continuation of past government's schemes

Hyderabad: After abolishing the KCR Kits, KCR Nutritional Kits, Bathukamma sarees, and several other schemes, Chief Minister A Revanth Reddy has been making claims about continuing the previous government's welfare initiatives, while also inflating loan repayment figures within a month. To promote institutional deliveries,

the previous government had implemented the KCR Kits and KCR Nutritional Kits. Apart from providing essential items like baby soap, powder, handbags, towels, and diapers, pregnant women received financial assistance of Rs 12,000 in three phases. In the case of a girl child's birth, an additional Rs 1,000 was given.Similarly, women were gifted sarees annually during the Bathukamma festivities. All these schemes



have now been discontinued by the Congress government.Although selfhelp group (SHG) women were promised two sarees annually, the scheme is yet to take off. Likewise, during the Assembly elections, the Congress party had pledged to offer one tola of gold along with Rs 1,00,116 under the Kalyana Lakshmi scheme.

Over the last 16 months, the Congress government has been distributing Kalyana Lakshmi cheques, albeit with significant delays and to a limited number of beneficiaries. Yet, during the May Day celebrations at Ravindra Bharathi, the Chief Minister claimed that all welfare schemes, including the crop loan waiver, Kalyana Lakshmi, and Rythu Bharosa were being continued.However, the reality remains that these schemes are being implemented partially, not comprehensively.

Under Rythu Bharosa, the Congress had promised Rs 15,000 per acre annually

to farmers. However, this has been reduced to Rs 12,000 per acre. Furthermore, it was assured that the amount would be deposited in farmers' accounts before March 31 this year. Even this reduced assistance has not been extended to all farmers and is restricted to one village per mandal across the State.At the Rythu Mahotsavam programme on April 22 in Nizamabad, Minister Agriculture Tummala Nageswara Rao publicly apologised to farmers for the delay in releasing the Rythu Bharosa assistance. This incident underscores the Congress government's current stance on farmers' welfare.Similarly, under the crop loan waiver scheme, farmers were promised that loans up to Rs 2 lakh would be waived by August 15, 2024. Even after nine months, many farmers are still struggling to get their loans waived.

Another key factor is the tussle over BR Ambedkar's egacy. No party can afford to adopt a half-hearted approach to fulfilling his grand dream of social justice, least of all the BJP. The importance of a nationwide caste count cannot be overemphasised. It will help policymakers taior welfare schemes according to the specific needs of communities rather than persisting with a one-size-fits-all strategy. Transparent collection and meaningful use of lata can go a long way in addressing social inequalities. As of now, it is vital to fix a timeline for the exercise as the census has already got inordinately delayed.

Dr Reddy also highlighted the State's efforts in promoting women entrepreneurship through Mahilashakti Industrial Hubs in every district and emphasized Telangana's growing role as a circular economy leader. Responding to concerns raised by Anil Reddy Vennam, Senior Vice President of the All India Plastics Manufacturers' Association (AIPMA), regarding skyrocketing land prices, Dr Reddy assured that land rates in plastic parks are being frozen until 50% occupancy is achieved. To support MSMES, he announced the rollout of

flatted factory sheds and plug-and-play facilities at subsidised rates, with three such units ready for occupation. Dr Reddy also announced Telangana's first dry port at Manoharabad, which will be developed as a multi-modal logistics hub under a PPP model, with two more dry ports in the pipeline. Anil Reddy Vennam, Sr VP, AIPMA, pointed out that although the polymer industry should ideally mirror or outpace GDP growth, it has seen inconsistent performance. "Polymer consumption in 2024-25 stood at 20.4 million metric tonnes, reflecting just 4% growth over the previous year. Prices remain lower than pre-COVID levels, and domestic raw material producers are not adequately supporting local players," he noted. He further appealed to the government for the establishment of a dedicated plastics recycling park and allocation of 500 acres for TAAPMAled development. In his welcome address, Narendra Baldwa, President, TAAPMA, stressed the importance of innovation focused on sustainability, circularity, and advanced materials, while recognizing Telangana's industryfriendly policies. Shiv Kumar Gupta, Conference Chair, noted that environment and sustainability are now at the forefront of industry transformation

"Telangana's forest cover of 24% is well above the national average of 21.71% — this is a significant ecological advantage," he said. # AP to dedicate 'Quantum Valley' on Jan 1, 2026 to Nation; MoUs signed with IBM, TCS & L&T



Amaravati, May 2 : In a historic step toward India's technological future, Chief Minister N. Chandrababu Naidu today announced that the State's pioneering Quantum Valley will be dedicated to the nation on January 1, 2026.

The announcement was made at a landmark event held at the Chief Minister's residence in Undavalli, where the Government of Andhra Pradesh signed MoUs with IBM, Tata Consultancy Services (TCS), and Larsen & Toubro (L&T). These partnerships aim to establish India's most advanced and first-of-its-kind Quantum Valley Tech Park in Amaravati, anchored by IBM's cutting-edge 156-qubit Quantum System Two — the largest quantum computing system to be installed in the country. In his remarks, CM Chandrababu Naidu pointed out that just as Andhra Pradesh played a central role in India's IT revolution of the 1990s, it will now lead the global quantum computing revolution. He recounted his early initiatives like computerizing seven lakh government records, launching AP Online, and now advancing to "WhatsApp governance" where services can be delivered through voice commands.

"This is a historic day, not just for Andhra Pradesh but for India," he declared. "Now no one can stop quantum computing - it is the foundation for next-generation governance and innovation." Stressing the need to include academia, start-ups, and global partners, he called for a model akin to Silicon Valley, backed by real-time analytics and inclusive public policy. "We are analysing 1.7 crore families under P4, and TCS is already supporting us with vital data," he noted. He reiterated that financial constraints are not a hurdle and urged for an aggressive, time-bound approach to build a scalable, replicable ecosystem that serves as a national benchmark. The Chief Minister highlighted the importance of involving the Government of India and announced that he would soon brief Prime Minister Narendra Modi, who has shown great enthusiasm for the project. "Among all politicians, Modi Ji and I speak tech," he said. Referring to Andhra Pradesh's past success in building Hyderabad's HITEC City in 15 months, he expressed confidence that Quantum Valley could be constructed even faster. He confirmed that the site has been shown to L&T and directed simultaneous development of the main quantum facility and its innovation ecosystem. Two committees will be constituted to fast-track execution: one focusing on infrastructure and another on ecosystem building. Jay Gambetta, Vice President of IBM Quantum, through a release expressed enthusiasm about deploying IBM's Quantum System Two in Amaravati, calling it a pivotal step for India's quantum journey. He emphasised that the collaboration with TCS and Andhra Pradesh would accelerate quantum algorithm development and bring the vision of "quantum advantage" closer to realityDr Harrick Vin, CTO of Tata Consultancy Services, outlined TCS's hybrid computing strategy that integrates quantum with classical systems like CPUs and GPUs. "Quantum will catalyze breakthroughs in life sciences, materials, cryptography and more. This is a defining moment," he added.

V. Rajanna and C.V. Sridhar of TCS underscored their company's commitment to public innovation. Rajanna noted that under CM Naidu's leadership, TCS pioneered digital governance in the state, and that the Quantum Valley will now enable future-focused R&D. Sridhar added that TCS's COIN (Co-Innovation Network) and seven years of quantum research will now empower 43 research centers across 17 Indian states to work on real-world quantum use cases, ranging from cybersecurity to rust detection and supply chain resilience.

Scott Crowder, IBM's VP for Quantum Adoption, described the global significance of this partnership. He highlighted that quantum computing is the "second quantum revolution," and its applications — from EV batteries to anomaly detection in financial systems — will define the next era of industrial and scientific innovation. With more than 75 quantum systems already deployed worldwide and eight centers in operation, IBM's latest investment in India reflects the country's strong capabilities in both software and emerging tech. Katamaneni Bhaskar, Secretary of IT & RTGS, described the signing of MoUs with IBM, TCS and L&T as the beginning of a great transition — "from traditional to quantum computing." He noted that Andhra Pradesh is no longer a follower in tech but a leader shaping the nation's future.

L&T, tasked with construction, will begin immediate development of the main block and supporting infrastructure. The Government of Andhra Pradesh also plans to appoint global experts, develop quantum-enabled public services such as GST optimization and real-time census modeling, and create India's first quantum governance framework. The Quantum Valley Tech Park will act as a launchpad for high-end job creation, talent development, and global investment inflows into India's emerging quantum industry. With the dedication of Quantum Valley set for January 1, 2026, Andhra Pradesh has taken a decisive step toward becoming a global hub for quantum computing, research, and innovation — putting India firmly on the quantum map.

# Caste census in Telangana became a national model, forced Centre to Act: Shabbir Ali

Kamareddy, May 2 Senior Congress leader and Government Advisor Mohammed Ali Shabbir on Friday claimed that the caste census conducted by the Congress Government in Telangana has become a national model, compelling the BJP-led Central government to follow suit. He said the credit for this significant policy shift goes to Leader of Opposition in Lok Sabha Rahul Gandhi, who consistently championed the demand for a nationwide caste census as a tool for ensuring social justice. Shabbir Ali was speaking at a district-level meeting of the Congress party in Kamareddy, held as part of the nationwide 'Jai Bapu, Jai Bheem, Jai Samvidhan' campaign. The initiative aims to uphold constitutional values, fight for social equality, and mobilise grassroots workers across the country. Referring to the Centre's recent announcement to include caste data in the national census the first such enumeration since 1931 - Shabbir Ali said, "While Union Ministers are claiming credit for empowering marginalised communities, the truth is this decision was a direct outcome of the relentless efforts by the Congress party and the bold example set by Telangana. Without Rahul Gandhi's persistent advocacy and the pressure created through movements like Bharat Jodo Yatra, this shift would not have happened."

"Projects that required just Rs 300 crore were inflated to Rs 3,000 crore to benefit contractors," he said. He also highlighted the Congress government's Indramma housing scheme, under which 3,500 houses are being sanctioned per constituency, with plans to increase the number to 10,000. "We will provide houses to every eligible poor family without any discrimination," he assureCalling for wider outreach of the 'Jai Bapu, Jai Bheem, Jai Samvidhan' campaign, Shabbir urged party workers to take its message to every village. "It is our collective responsibility to strengthen the party. There should be no divide between old and new members. Every committed worker will have a place and a role." he said.

# Mumbai's Rani Baug zoo to revamp space left behind after elephant Anarkali's death



#### GNS News Agency, May 2

With the demise of the city's last elephant, Anarkali, in November last year leaving behind a vacuum of sorts at Veermata Jijabai Bhosale Vanaspati Udyan and Zoo in Rani Baug, the Mumbai civic body is planning to revamp the area spread over 4,000 sq m to accommodate new animal exhibits. The zoo authorities have written to a Thailand-based firm to create a new layout for the land parcel. After elephant Laxmi's death in 2020, the city's lone remaining elephant Anarkali breathed her last on November 10, 2024, bringing the curtains down on Mumbai's decades-old relationship with the gentle giants. Anarkali was 58 years old and had lived in the zoo for nearly five decades.

Senior officials of the Brihanmumbai Municipal Corporation (BMC) said the Byculla zoo will no longer house

elephants as Central Zoo Authority (CZA) guidelines now prohibit it.Last month, the zoo authorities wrote to HKS Consultants seeking new designs for the space, "We already have a list of approved animals from the CZA. The new proposal will be designed to accommodate species from this list. Since smaller species require much less space, the plan may look at redeveloping the elephant enclosure into a space that can house several species of animals. According to the design proposal, we will take further decisions and submit it to the CZA for approval," a BMC official told The Indian Express.

Currently, the zoo authorities are awaiting a response from the consultants. "They are finalising the terms of the tender for the upcoming exotic zone, spanning over 10 acres. Following this, they are expected to take up work on the redevelopment designs," an official added. The tender for the separate exotic zone, which lies adjacent to the existing 53-acre facility, is expected to be floated in the coming weeks. It will house animals such as cheetahs and white lions.Redevelopment plans are being drawn up for the 162year-old Rani Baug facility after footfall and revenue at the zoo dipped to a three-year low. The visitor count has seen a drop of nearly 21 per cent in a year. While over 28.97 lakh people flocked to the zoo during the 2023-2024 financial year, it dropped to 23.57 lakh during 2024-25. This marks a significant decline from 2022-2023 when nearly 30 lakh people had arrived at the zoo, raking in a revenue of Rs 11.59 crore. Senior officials attributed the dip to the lack of

# Vehicle approaching expiry, get it scrapped from registered centre: Chandigarh admin

#### GNS News Agency, May 2

If your vehicle is approaching expiry and you plan to get it scrapped, then you can visit the authorised RVSF (registered cehicle scrapping facility) centre in Chandigarh, "Select Technical Services", at plot number-182/65, Industrial Area, Phase I, Chandigarh.

The Chandigarh Administration has fixed the concession in the Motor Vehicle Tax in Chandigarh in case the vehicle is registered against submission of "Certificate of Deposit", issued by the RVSF to the owner of a vehicle. When he/she deposits the vehicle with the RVSF for scrapping, there will be a concession of 25 per cent in the registration of non-transport vehicle and 15 per cent in the registration of the transport vehicle.

As per Gopal Krishan, owner of RVSF in Chandigarh, when the vehicle owner approaches their authorised centre, the form for scrapping the vehicle is filled through the Vahan application. An OTP (one time password) will be received on the mobile number of the owner which is linked with the Aadhaar card. The application will be logged in then and the form will be filled further. The value of the vehicle is assessed. The scrap value is assessed by the weight of the car, 90 per cent of the weight and then 10 per cent valuation varies as if the car has some alloy wheels or has a CNG kit. After this process is completed, the payment is



made online to the vehicle owner. Also, in the whole process, a COD (certificate of deposit) is generated to the owner of the vehicle, which confirms that the vehicle has been deposited at the scrapping centre of RVSF. Then the RC status turns from active to scrapping under process. The vehicle is then scrapped, and the chassis number is updated on Vahan application. The owner of the vehicle gets a message that the vehicle has been scrapped. The COD can be used by the owner of the vehicle at the time of buying another new vehicle. One must get the vehicle scrapped through the RVSF, so that the vehicle is not misused further, said Gopal Krishan.

# Be available on cellphone 24×7, Punjab Govt tells officers and employees

The Punjab government Sunday asked all its officers and employees not to switch off their mobile phones after office hours, on weekends, and holidays, and to be available for work even after office hours. In the order signed by the special secretary (Personnel), the Punjab Government said that if an official or employee is not available on the phone, it becomes a hindrance in completing essential administrative work and providing services and facilities to the general public. "It has come to the notice that many officials are not available on their mobile phones after office hours. Their phones are either switched off, are in flight mode, out of coverage area or even on call diversion. Some works related to administration require immediate indulgence of the government. Hence, the availability of officers related to these works becomes necessary," said the order."All Special Chief Secretaries, Additional Chief Secretaries, Financial Commissioners, Principal Secretaries and Secretaries are directed to ensure that all officers of your department are available on cell phones after office hours and on holidays to complete essential office administrative work so that these works can be completed in a timely manner," it added, A similar order was passed by former chief minister Amarinder Singh in the first year of his term in 2017. At that time, the government said the phone bills of employees are paid or reimbursed to ensure that they are available for 24 hours. The employees' phone bill has always been a bone



# MMRDA triples its non-fare revenue to Rs 122 crore through strategic efforts

The Mumbai Metropolitan Region Development Authority (MMRDA) has almost tripled its non-fare box revenue (NFBR) – income generated from sources other than passenger fares – to Rs 122 crore in FY 2024-25 from Rs 42.5 crore the previous year. According to MMRDA, the 187 per cent hike indicates a healthy move towards developing a financially sustainable and commuter-centric metro rail system in Mumbai. The total operating revenue, comprising fare and non-fare revenue, increased from Rs 190 crore during FY 2023–24 to Rs 292 crore this fiscal, well above the Rs 200-crore target set at the start of the fiscal. The increase was mainly possible through licensing of optical fibre cables (Rs 61.72 crore), advertisements at stations (Rs 23.95 crore), advertisements on trains (Rs 7.47 crore), retail shops and kiosks (Rs 8.22 crore), and naming and branding of stations (Rs 9.76 crore). Manpower deployment, telecom infrastructure, and small promotional activities contributed the rest.

Authorities stated that the major increase in NFBR highlights MMRDA's efforts to diversify revenues without burdening commuters. Revenue from fares also increased by 15.6 per cent, from Rs 147 crore to Rs 170 crore.MMRDA Chairman and Deputy Chief Minister Eknath Shinde said, "The three-fold growth in non-fare revenue isn't just a financial success, it is a testament to our vision for a successful, contemporary Metro system. It reinforces MMRDA's absolute dedication to constructing strong infrastructure that enables economic development and better urban life for all Mumbaikars."Dr Sanjay Mukherjee, Metropolitan Commissioner, MMRDA, attributed the achievement to their strategic planning. "This unprecedented revenue success was brought about through a well-planned NFBR strategy, facilitated by robust state government support. We exceeded our Rs 200 crore revenue target and reached Rs 292 crore, while maintaining Metro fares reasonable for the citizens," he said. In the future, Maha Mumbai Metro, operating Metro Lines 2A and 7, will also explore new revenue streams, including pillar ads, F&B space monetisation, and production shoot rentals across its 30 stations.

# Fire breaks out in Nature Park, reduces trees to ashes

A sudden fire erupted in a pile of dried leaves in Mohali's Nature Park in Sector 62 which engulfed several trees. Multiple fire brigade vehicles rushed to the scene to contain the flames. The fire started around 3 pm and was contained about 6 pm. The authorities have yet to determine whether the fire was accidental. Mayor Amajit Singh Jitti Sidhu and Deputy Mayor Kuljeet Singh Bedi visited the site and demanded an investigation. "At first glance, it appears to be a case of arson. Drug addicts frequently gather here, and they may be responsible for this act. It's unfortunate as trees have been destroyed," the mayor said, urging the Greater Mohali Area Development Authority (GMADA) to designate a specific storage site for fallen leaves to prevent future incidents.

Reports suggest that while the Mohali Municipal Corporation has resource management centres (RMCs), the current contractor refuses to handle the seasonal influx of dried leaves. A newly built RMC at Jagatpura village intended for green waste remains underutilised, with leaf piles left unattended.Mechanical sweeping contractors collect leaves from roadsides, but without assigned dumping grounds, they discard them in vacant plots. Locals allege that the fire originated from one such pile. "Leaves were



dumped here haphazardly. They can self-ignite in rising temperatures or be set ablaze by miscreants," said Makhan Singh, a resident of phase 7.R S Baidwan, general secretary of the Environment Protection Society, demanded immediate action, including proper leaf disposal systems, to prevent future disasters and safeguard air quality. The fire has polluted Mohali's air, with toxic smoke posing health risks. A similar blaze on Saturday broke out at the Mauli village light point on Airport Road, requiring over 30 fire tenders to control it.

# Mohali's Phase 6 bus stand remains underutilised, adds to commuters' pain

A state-of-the-art inter-state bus terminus (ISBT) in Phase 6, constructed at a cost of crores of rupees, stands eerily deserted as buses continue to bypass the facility and instead picking up and dropping passengers haphazardly on the main road. Even the bus terminal fees are being collected by Punjab Roadways staff stationed roadside, bypassing the designated infrastructure.

A visit by The Indian Express revealed that the company responsible for building the ISBT has converted the bus bays into paid parking zones, forcing drivers to avoid entering the terminus. As a result, buses halt arbitrarily on the main road, triggering traffic snarls and leaving commuters scrambling to board. Daily scenes of passengers sprinting toward moving buses have become a norm, raising serious safety concerns. The chaos often leads to accidents, while pedestrians and motorists face constant inconvenience.Molronically, hundreds of commuters continue to wait inside the swanky, air-conditioned ISBT, unaware that buses bypass the terminal entirely. "I wait here daily, but buses never stop here. We end up running to catch the bus," said Rajinder Singh, a Phase 5 resident who commutes to Ludhiana. Deepak, a municipal inspector from Phagwara, echoed the frustration: "The buses' refusal to use the terminal disrupts my daily commute. Authorities must enforce strict entry protocols". When contacted, Punjab



Roadways Manager Shiv Kumar acknowledged the issue: "The matter is under active consideration, and steps are being taken to resolve it," he said. However, commuters demand urgent action as the arrival of monsoon rains will exacerbate the daily struggle.

Built during the previous Badal government and touted as former Deputy CM Sukhbir Singh Badal's "dream project", the ISBT now languishes in neglect. Despite its modern amenities, buses either skirt the terminal or halt near the old Phase 8 stand, leaving the new facility obsolete. Even the incumbent AAP government, in power for three years, has failed to address Mohali's public transport woes. There are six grades of security cover: X, Y, Y Plus, Z, Z Plus, and the Special Protection Group (SPG). The SPG is exclusively for the prime minister and immediate family. The other security categories can be assigned to anyone for whom the Central or state governments have received intelligence regarding a potential threat.

Chief Minister Rekha Gupta and Minister for Environment, Forest and Wildlife Manjinder Singh Sirsa are the two other ministers with 'Z' category security in the Delhi Cabinet.Sachdeva, 55, has been active in politics since 1988 and has held several roles, including party general secretary and vice president, a position he was appointed to in 2020. He was appointed as the Delhi BJP president in March 2023. Earlier, he had stepped in as the party's working president following its defeat in the Municipal Corporation of Delhi (MCD) polls in 2022.

Sachdeva belongs to a Punjabi family that came to India after Partition. He was raised in Old Delhi's Chandni Chowk and has strong support from his community, as well as among traders in the capital.During the Assembly elections in February, Sachdeva led the BJP's campaign to corner the Aam Aadmi Party (AAP). The BJP won 48 seats in the 70-seat Assembly, unseating the AAP and forming the government in the capital after 27 years.

# Punjab minister Hardeep Singh Mundian's gunman 'shoots self' at woman's house, dies

A 32-year-old Punjab Police constable, who was posted as a gunman with state minister Hardeep Singh Mundian, allegedly shot himself with his service weapon at the residence of a woman in a village in the Ludhiana district late Sunday. According to the Punjab Police, prima facie, Gurkirat Singh was in a "one-sided love affair" with the woman who got married around four years ago. The Khanna police said Singh, who was unmarried, shot himself in his chest in a fit of rage.Jyoti Yadav, Senior Superintendent of Police (SSP), Khanna, said Singh was a native of Rampur village, and was posted with the Ludhiana police commissionerate."Prima facie, the constable reached the house of the woman whom he had liked some years ago. The woman got married four years ago. He asked for the woman's number from her mother, but she refused to provide it to him, following which he shot himself with his carbine weapon," said Yadav.Inspector Akash Dutt, Station House Officer, Doraha police station, said a First Information Report (FIR) has been registered on the statement of the deceased's family for abetment to suicide against the woman, her mother, and brother for allegedly harassing the constable. "According to his family, the woman's family used to harass him and even extort money from him for letting him speak to the woman over the phone. We have booked the woman, her brother, and her mother under Section 108 of BNS [Bharatiya Nyaya Sanhita]. Further probe is on," said Dutt.

# Lab grown skin gives robots the ability to smile

Hyderabad: A living skin developed in a laboratory is attached to the face of a humanoid robot, enabling it to smile and even give human-like expressions! This is not a movie scene from a sci-fi movie, but a reality. Scientists from the University of Tokyo, Japan, have created a human-like fleshy skin in a laboratory, enabling a humanoid robot to smile and give expressions. They have found a way to bind the engineered skin tissue to the complex forms of humanoid robots. The research by Japanese engineers, published in the prestigious journal Cell Reports Physical Sciences (July 2024), means that in the near future, whenever a humanoid robot gets injured, the skin can self-heal, will have sensing abilities and increasingly will look 'life-like' and not like a life-less robot

Taking inspiration from human skin ligaments, the team, led by Professor Shoji Takeuchi of the University of

Tokyo, included special perforations in a robot face, which helped a layer of skin take hold. Their research could also be useful in the cosmetics industry and to help train plastic surgeons. Takeuchi's lab, the Biohybrid Systems Laboratory, has also created mini robots that walk using biological muscle tissue, 3D printed lab-grown meat, engineered skin that can heal, and more. It was during research on the last of these items that Takeuchi felt the need to take the idea of robotic skin further to improve its properties and capabilities, the University of Tokyo press release said."During previous research on a finger-shaped robot covered in engineered skin tissue we grew in our lab, I felt the need for better adhesion between the robotic features and the subcutaneous structure of the skin," said Takeuchi."By mimicking human skin-ligament structures and by using specially made V-shaped perforations in solid materials, we found a way to bind skin to complex structures. The natural flexibility of the skin and the strong method of adhesion mean the skin can move with the mechanical components of the robot without tearing or peeling away."According to the research scientists, this research will have long-term applications in several areas of medical research."The idea of an organ-on-a-chip is not especially new, and finds use in things like drug development, but something like a face-ona-chip could be useful in research into skin aging, cosmetics, surgical procedures, plastic surgery and more. Also, if sensors can be embedded, robots may be endowed with better environmental awareness and improved interactive capabilities," the researchers added.

# After encounter, Delhi Police arrest man named in 33 cases, including sexual assault

The police said they received information that Javed would come to Wazirabad Saturday, and a team laid a trap in the area to arrest him. Javed was spotted getting off his motorcycle at the Jagatpur Pusta road. and was asked to verify his identity. Instead of complying, the police said, Javed took out a pistol and shot at Head Constable Vikas, missing his ears by a whisker.

"Vikas caught hold of the accused Javed. Both got into a scuffle and then fell on the ground. Javed couldn't fire again and was then arrested," Harsh Indora, Deputy Commissioner of Police (Crime) said. According to the police, Javed raped his friend's wife at gunpoint in the Nabi Karim area in December 2024. "The lady filed a complaint in January 2025, saying that in May 2024, she came into contact with a man. She got pregnant with his child, but the man



beat her, leading to a miscarriage. In December 2024, Javed came to her. He carried a pistol with him and raped her on gun point." Indora said

Javed's friend was arrested in the case, but he was on the run, the police said. The police said Javed joined his father's garment in Chandni Chowk after dropping out in Class 5. After marrying a Hindu girl in 2013, Javed separated from his family, and committed his first crime in the same year, a robbery in Rajouri Garden. It would be the first of 33 cases lodged against him. "In 2021, he, along with his associates, committed a dacoity at gunpoint in a house in the Uttam Nagar area. He came out of jail in December 2024, and got married the second time in January 2025," Indora said.

# Another Nitish Kumar of Bihar rises this time in JNU as its Student Union President

According to a statement released by the United Left panel, "Nitish Kumar carries with him the lived experiences of India's oppressed communities."Hailing from a humble OBC family in Sheikhpura of Bihar's Araria district, Kumar grew up amid the agricultural hardships of rural India — his father is a farmer, and his mother a homemaker. # **JNUSU elections: ABVP shatters decade**long drought with historic gains

This victory is emblematic of ABVP's stellar performance, as it clinched an impressive 23 out of 42 councillor seats across 16 schools and special centres - a record-breaking achievement for any student body.

Amit Malviya, the BJP's National Information and Technology Department In-charge and Co-incharge for West Bengal, celebrated this victory on his X handle: "Jawaharlal Nehru University Students' Union (JNUSU) conquered: Akhil Bharatiya Vidyarthi Parishad (ABVP) candidate Vaibhav Meena has been elected as Joint Secretary. And it doesn't stop there. ABVP has delivered an unprecedented performance in the JNUSU elections, winning 23 out of 42 councillor seats across 16 schools and special centres the highest number of seats won by any student organization."Throughout the vote-counting process, ABVP candidates showcased remarkable dominance, leading in all four central panel positions and mounting a formidable

challenge to the university's entrenched Left-leaning political dominance. Although the ABVP fell short in securing the posts of President, Vice-President, and General Secretary, the narrow margins of defeat underscored a palpable shift in the campus dynamics. Vaibhav Meena's victory as Joint Secretary was secured with an impressive tally of 1,518 votes.

Manisha secured 1,150 votes, while Munteha Fatima's win further solidified DSF's presence in the central panel by securing 1,520 votes. The ABVP fielded a comprehensive panel, with Shikha Swaraj, Nittu Goutham, Kunal Rai, and Vaibhav Meena contesting for the positions of President, Vice-President, General Secretary, and Joint Secretary, respectively. Their campaign reflected a strategic and determined effort to reshape the political narrative on campus. The elections, held on April 25 after delays caused by campus unrest, witnessed an enthusiastic voter turnout of nearly 70 per cent, with approximately 5,500 students casting their ballots. The multi-cornered contest was marked by intense competition among strategic alliances: the All India Students Association (AISA) allied with the Democratic Students' Federation (DSF), while the Students' Federation of India (SFI) joined forces with the Birsa Ambedkar Phule Students' Association (BAPSA), the All India Students' Federation (AISF), and the Progressive Students' Association. This year's turnout of 68.3 per cent, though slightly lower than the record-breaking 73 per cent participation in the 2024 elections, still reflected robust engagement. Of the 7,906 registered voters, 5,400 exercised their franchise on election day. Polling was conducted in two sessions, from 9 a.m. to 1 p.m. and 2:30 p.m. to 5:30 p.m., across 17 booths on the JNU campus on April 25. The counting of votes commenced late on Friday night, with the results officially declared on Monday (April 28).

# **Himachal Pradesh raises** stipends of medical specialists

Medical-Specialists-Stipend-HikeApart from upgrading medical infrastructure and adopting modern technologies, the government has announced a substantial hike in stipends for senior residents, specialists, and super specialists. In a push to improve healthcare facilities across Himachal Pradesh, the state government has introduced landmark measures to attract and retain specialist doctors.Apart from upgrading medical infrastructure and adopting modern technologies, thegovernment has announced a substantial hike in stipends for senior residents, specialists, and super specialists.

A government spokesperson said, "The monthly stipend for senior residents and tutor specialists has been increased from Rs 60,000-65,000 to Rs 1 lakh, while for super specialists and senior residents, it has been enhanced to Rs 1.30 lakh-marking an increase of 50 to 170 per cent. Himachal Pradesh has six medical colleges and one super-specialty hospital. Institutions such as IGMC Shimla and Dr Rajendra Prasad Government Medical College, Tanda, have been providing critical healthcare services with the support of Postgraduate Super Specialists and Senior Resident doctors. However, of the 751 sanctioned posts across the state's medical colleges, only 375 are filled, with



376 posts lying vacant, severely impacting healthcare delivery.

The state is also working to implement international standards for doctor-nurse-patient ratios and is expediting recruitment to meet these benchmarks. According to the health department, 9.5 lakh patients travel outside the state annually for treatment, causing a Rs 1350 crore loss to the state GDP.Strengthening in-state healthcare services is projected to save Rs 550 crore annually and offer timely care to patients

Mandir in Forbesganj, he "first witnessed and understood the sinister nature of communal fascism penetrating educational spaces."After completing his BA in Political Science from Banaras Hindu University (BHU), Kumar joined JNU in 2020 for a Master's degree. ## **Once ashram of power whisperer Dhirendra** Bramhachari, now home to the penniless in Gurgaon

Yoga classes by the district administration, a cricket ground for locals, a shelter for people with nowhere else to stay, and a haunt of dealers in scrap and second-hand furniture. This is what is spread across the 30-acre land in Gurgaon's Sector 30, which once held the Aparna Ashram of the late Dhirendra Brahmachari, the jet-setting yoga guru to the country's mightiest - and which the Haryana government has now moved formally to take over, passing a Bill that awaits the President's approval. With the then Prime Minister Indira Gandhi among Brahma-chari's disciples, the ashram had flourished. Central grants over time helped it purchase this prime plot, now reportedly worth several hundred crores. Since Brahmachari's demise in 1994, though, the ashram has been at the centre of constant litigation, with competing sides laying claim to it. The only sign now of what is at stake is two constables posted at the site, from the Sector 40 Police Station, who guard the 5-acre section of the property that is already under state government ownership. This is the site where yoga classes are held in the open, and where the demolished remnants of the ashram's main building, including a former helipad, lie. Refusing to be identified, one of the constables says: "We have been here for two months now, but police have been guarding this place since February 2023, when the (ashram) building was demolished. The yoga classes started a month after that."A small tin shed built for the constables to stay on the property 24×7 means the encroachers have stayed away from these five acres. "Even if there is only one of us, no one will dare trespass," says the constable. Inspector Lalit Kumar, Station House Officer of the Sector 40 Police Station, says they have not received any complaints or had any issues relating to any attempted encroachments on the land where



the two policemen are stationed."They have been deployed as a precautionary measure," Kumar says, adding that they had not received any fresh instruction from the district administration as regards the land, given the passage of the Bill. Away from the constables' eyes, on the other side of the disputed property, a settlement ironically called 'Indira Vikas Colony' is watching in apprehension as the construction of a boundary wall demarcating the former ashram land indicates the government's resolve to take over the premises. Afraid of inviting action, the residents talk only on the condition of anonymity.A group of scrap dealers, who have been staying and working out of this area since the start of the year, say they have not received any notices so far and are waiting and watching."We have not faced any hassle. If any notice comes, we will see," says one of the scrap dealers. Their neighbours include three old furniture dealers from Uttar Pradesh, who say the notices have come to them. As a precaution, they have moved their shop from one site within the property to another.

# In Central Delhi, Ayushman Aarogya Mandir opens doors to public. What does it offer?

The walls are freshly painted in yellow with murals Inderpuri. This is part of the Centre's flagship Pradhan Mantri showing a doctor treating a child and assisting a pregnant woman, while the entrance sports newly installed railings, an iron gate and a board: This is the new Urban Ayushman Arogya Mandir (UAAM) in F Block, Central Delhi's Inderpuri, which has opened its doors to residents.Until recently, it was a mohalla clinic. Gone are posters of former Delhi Chief Minister Arvind Kejriwal and former Health Minister Satyendar Jain. In fact, every sign identifying this clinic with the previous Aam Aadmi Party government's flagship scheme has been erased. The Delhi government has readied at least four such clinics — one each in Todapur, Bhanwar Singh Camp in Vasant Vihar, Mayapuri and

Ayushman Bharat Health Infrastructure Mission scheme (PM-ABHIM), which has been implemented in the Capital.A total of 13 staff members, including a medical officer, will be appointed to the Inderpuri facility, as per an official order. Other staff members include a pharmacist, four auxiliary nurse midwives, a lab technician, a DOTS lab technician (for management of tuberculosis patients), a data entry operator, and a cleaner. The facility is supposed to maintain an essential drug list of 256 medicines. In-house tests will be made available for blood sugar, haemoglobin, blood group, urine, pregnancy, among others. Ninety other tests will be outsourced to Agilus Lab. While the coat of paint is new, as is the board, change will take time. For now, residents who frequent the facility said it's the same as before.Sitting on a bench outside the clinic were two local residents, Amit Kumar and Sagar Mandal. "We live in the neighbourhood," said Kumar, a Delhi government employee. "This still seems like a mohalla clinic... Medicines, tests and consultation... everything is free so far," he added.On April 17, the clinic was locked because the doctor was on leave. "Whenever the doctor is on leave, the entire staff also takes off," Kumar claimed. "This is how mohalla clinics also functioned."Mandal added, "The staff register patients on their tabs and notebooks just like before."Saroj Devi, 65, who runs a grocery shop nearby, said, 'jaise pehle

tha waise ab bhi hai (It is providing the same services as earlier)'.After winning the Delhi elections, the BJP government had announced that it would convert 250 mohalla clinics running from rented accommodations to Ayushman Arogya Mandirs. State Health Minister Pankaj Singh had said, "We will also establish the centres near JJ clusters to ensure free primary healthcare for all residents in these areas."On April 16, the Delhi Health Department issued directions to the chief engineer of the Public Works Department to complete construction of 70 Ayushman Arogya Mandirs and make them functional by May 31.Last week, Chief Minister Rekha Gupta announced that a total of 1,139 Arogya Mandirs will be established across Delhi.

# At least nine killed in Vancouver after vehicle plows into Filipino festival

VANCOUVER, GNS News Agency, May 2, At least nine people were killed when a man drove through a crowd at a Filipino community festival in the western Canadian city of Vancouver on Saturday evening, police said in an X post.Police said they had arrested a 30-year-old Vancouver man, who was "known" to them, at the scene. The suspect was initially chased down and held by festival-goers until police arrived, witnesses said. One witness told CTV News he saw a black vehicle driving erratically in the area of the festival just before the crowd was struck."At this time, we are confident that this incident was not an act of terrorism," Vancouver police said in an X post.The incident happened shortly after 8 p.m. (0300 GMT) near East 41st Avenue and Fraser Street, where the Lapu-Lapu Day Block Party, celebrating a Philippine national hero, was taking place.Canadian Prime Minister Mark Carney said on X: "I am devastated to hear about the horrific events at the Lapu-Lapu festival in Vancouver earlier this evening."

Canada's federal election takes place on Monday. Officials from Carney's Liberal Party said the prime minister's campaign movements would be delayed on Sunday morning and that Carney would make a statement.Philippine President Ferdinand Marcos Jr said he was "shattered to hear about the terrible incident" and extended his "deepest sympathies to the families of the victims and to the strong and thriving Filipino community in Canada."'HORRIFIC'Jagmeet Singh, leader of Canada's New Democratic Party, was among the attendees at the event, but left minutes before the vehicle arrived, he told reporters.Item 1 of 7 The suspect vehicle is seen with the driver's door open, as bodies of victims lie covered on the ground, after it drove into a crowd at a Lapu Lapu day block party, in which police say multiple people were killed and injured, in Vancouver,"We don't know the motives, we don't know any of the details, but ultimately this is something that targeted the Filipino community," he said.

"I was there, and I just imagined the faces of the kids I saw smiling and dancing. It's horrific," he said. Another witness, who did not wish to be identified, said he had seen about 15 people lying on the ground after the dark SUV plunged into the crowd. The witness said the driver had tried to run but was chased down and held against a fence for



about 10 minutes until police arrived. The festival, celebrated especially in the central Philippines, honors Datu Lapu-Lapu, a Filipino chieftain who defeated Spanish forces led by Ferdinand Magellan in the Battle of Mactan in 1521. The government of British Columbia officially recognised April 27 as Lapu-Lapu Day in 2023, acknowledging the cultural contributions of the Filipino-Canadian community, one of the largest immigrant groups in the province.King Charles, Canada's head of state, said in a statement: "Both my wife and I were profoundly saddened to learn of the dreadful attack and utterly tragic loss of life in Vancouver, which took place as the Filipino community came together to mark the celebration of one of their most special festivals."The centerpiece of the festival in Vancouver is a multi-block street party in the Sunset neighborhood featuring Filipino food and traditions, live performances and cultural displays.

"I didn't get to see the driver, all I heard was an engine rev," Yoseb Vardeh, co-owner of food truck Bao Buns, said in an interview with Postmedia."I got outside my food truck, I looked down the road and there's just bodies everywhere," said Vardeh, his voice breaking with emotion. "He went through the whole block, he went straight down the middle."Vancouver city councillor Peter Fry told CTV News he had also been at the event earlier in the day."This was a great day. A wonderful event. Huge community event. # Trump's next 100 days to feature trade deals, peace talks, 'torpedoes,' officials say

WASHINGTON, GNS News Agency, May 2 President Donald Trump and his administration this week will highlight the accomplishments of his first 100 days in office, while looking toward the next 100 days with a focus on trade deals and peace talks, White House officials said. After a pace of changes that have thrilled allies and stunned adversaries, including in social policy areas such as transgender rights, one official said Trump has "torpedoes" in store but did not explain what those were. Trump has enacted sweeping changes on a wide range of U.S. domestic and foreign policy priorities since taking office on January 20. He has upended the world economic order with tariffs, slashed the federal government with job cuts and done away with diversity programs in the public and private sector. He has also attacked academia, law firms and courts.

This week, Trump plans to travel to Michigan for a rally to commemorate the 100-day milestone. The White House intends to highlight his economic vision, ejection of undocumented immigrants, changes to foreign policy, and rk by billionaire Elon Musk's Department of Government Efficiency to purge the federal bureaucracy and cut what it sees as waste. Celebrating those moves will be part of a broad victory lap around Trump's second-term launch that the official, speaking on condition of anonymity, described to reporters as a conservative's fantasy."Every morning I wake up, it's like living in a dreamscape," he said. While Trump officials laud the speed and breadth of his efforts to remake American society, critics say Trump has trampled on the rights of citizens and non-citizens, alienated allies and threatened U.S. supremacy in the world. The president has withheld funding from universities for what his administration considers tolerance of anti-Semitic behavior; cut back on transgender rights; and done away with diversity, equity and inclusion (DEI) programs in the federal government and with federal contractors. # America First president is overturning the world order

WASHINGTON/TOKYO/BRUSSELS, GNS News Agency, May 2, He has launched an unprecedented global tariff war and slashed U.S. foreign aid. He has disparaged NATO allies and embraced Russia's narrative about its invasion of Ukraine. And he has spoken about annexing Greenland, retaking the Panama Canal and making Canada the 51st state. In the chaotic first 100 days since President Donald Trump returned to office, he has waged an often unpredictable campaign that has upended parts of the rulesbased world order that Washington helped build from the ashes of World War II.

Sign up here."Trump is much more radical now than he was eight years ago," said Elliott Abrams, a conservative who served under Presidents Ronald Reagan and George W. Bush before being appointed U.S. special envoy on Iran and Venezuela in Trump's first term. "I have been surprised."Trump's second-term "America First" agenda has alienated friends and emboldened adversaries while raising questions about how far he is prepared to go. His actions, coupled with that uncertainty, have so unnerved some governments that they are responding in ways that could be difficult to undo, even if a more traditional U.S. president is elected in 2028.

All this comes amid what the Republican president's critics see as signs of democratic backsliding at home that have raised concerns abroad. These include verbal attacks on judges, a pressure campaign against universities and the transfer of migrants to a notorious El Salvador prison as part of a broader deportation drive."What we're seeing is a huge disruption in world affairs," said Dennis Ross, a former Middle East negotiator for Democratic and Republican administrations. "No one is certain at this point what to make of what's happening or what will come next."

This assessment of Trump's shakeup of the global system comes from Reuters interviews with more than a dozen current and former government officials, foreign diplomats and independent analysts in Washington and capitals around the world. Many say that while some of the damage already done could be long-lasting, the situation may not be beyond repair if Trump softens his approach. He has already backtracked on some issues, including the timing and severity of his tariffs. But they see little chance of a dramatic shift by Trump and instead expect many countries to make lasting changes in their relationships with the U.S. to safeguard against his erratic policy-making.

Some European allies, for instance, are looking to boost their own defense industries to reduce reliance on U.S. weapons. Debate has intensified in South Korea about developing its own nuclear arsenal. And speculation has grown that deteriorating relations could prompt U.S. partners to move closer to China, at least economically.

The White House rejects the notion that Trump has hurt U.S. credibility, citing instead the need to clean up after what it calls former President Joe Biden's "feckless leadership" on the world stage."President Trump is taking swift action to address challenges by bringing both Ukraine and Russia to the negotiating table to end their war, stemming the flow of fentanyl and protecting American workers by holding China accountable, getting Iran to the negotiating table by reimposing Maximum Pressure," White House National Security Council spokesman Brian Hughes said in a statement. He said Trump was also "making the Houthis pay for their terrorism ... and securing our southern border that was open to invasion for four years."More than half of Americans, including one in four Republicans, think Trump is "too closely aligned" with Russia, and the American public has little appetite for the expansionist agenda he has laid out, according to a Reuters/Ipsos poll released on March 13.At stake, say experts, is the future of a global system

that has taken shape over the past eight decades largely under U.S. primacy. It has come to be based on free trade, rule of law and respect for territorial integrity.But under Trump, who has been scornful of multilateral organizations and often views global affairs through the transactional lens of a former real estate developer, that world order is being shaken up. Accusing trading partners of "ripping off" the U.S. for decades, Trump has set in motion a sweeping tariffs policy that has roiled financial markets, weakened the dollar and triggered warnings of a slowdown in worldwide economic output and increased risk of recession. Trump has called the tariffs necessary "medicine" but his objectives remain unclear even as his administration works to negotiate separate deals with dozens of countries.At the same time, he has all but reversed U.S. policy on Russia's threeyear-old war in Ukraine and engaged in an Oval Office shouting match with Ukrainian President Volodymyr Zelenskiy in late February. He has warmed to Moscow and stirred fears that he will force NATO-backed Kyiv to accept the loss of territory while he prioritizes improved relations with Russian President Vladimir Putin.

The administration's belittling of Europe and NATO long the central pillar of transatlantic security but accused by Trump and his aides of freeloading off the U.S., has caused deep unease.German Chancellor Friedrich Merz, after winning February's election, expressed concern about European relations with the United States, saying it would be difficult if those who put "America First" actually made their motto "America Alone". "This really is five minutes to midnight for Europe," Merz said. In a further blow to Washington's global image, Trump has employed expansionist rhetoric long avoided by modern-day presidents, which some analysts say could be used by China as justification if it decides to invade self-governed Taiwan.With his blustery style, he has insisted that the U.S. will "get" Greenland, a semi-autonomous Danish island. He has angered Canada by saying it has little reason to exist and should become part of the U.S. He has threatened to seize the Panama Canal, which was handed over to Panama in 1999. And he has proposed that Washington take over warravaged Gaza and transform the Palestinian enclave into a Riviera-style resort. Some analysts say Trump may be seeking to resurrect a Cold War-style global structure in which big powers carve up geographic spheres of influence. Even so, he has offered no details on how the U.S. could acquire more territory, and some experts suggest he may be assuming extreme and even over-the-top positions as bargaining ploys."When you demand to take over a part of the Kingdom of Denmark's territory, when we are met by pressure and by threats from our closest ally, what are we to believe in about the country that we have admired for so many years?" Danish Prime Minister Mette Frederiksen told a news conference in Greenland in early April. "This is about the world order that we have built together across the Atlantic over generations."



# Death toll from blast at Iran's Bandar Abbas port rises to 28

DUBAI, GNS News Agency, May 2, The death toll from a powerful explosion at Iran's biggest port of Bandar Abbas has risen to at least 28, with more than 700 people injured, state media reported on Sunday, as firefighters worked to fully extinguish the fire.Saturday's blast took place in the Shahid Rajaee section of the port, Iran's biggest container hub, shattering windows for several kilometres around, tearing metal strips off shipping containers and badly damaging goods inside, state media said

The incident occurred as Iran held a third round of nuclear talks with the United States in Oman. Chemicals at the port were suspected to have fuelled the explosion, but the exact cause was not clear and Iran's Defence Ministry denied international media reports that the blast may be linked to the mishandling of solid fuel used for missiles.A spokesperson for the ministry told state TV the reports were "aligned with enemy psyops", saying that the blast-hit area did not contain any military cargo. The Associated Press cited British security firm Ambrey as saying the port received in March sodium perchlorate, which is used to propel ballistic missiles and whose mishandling could have led to the explosion. The Financial Times newspaper reported in January the shipment of two Iranian vessels from China containing enough of the ingredient to propel as many as 260 mid-range missiles, helping Tehran to replenish its stocks following its direct missile attacks on its arch-foe Israel in 2024.

Plumes of black smoke rose above the site on Sunday and pieces of twisted metal and debris lay scattered across the blast site.By early afternoon, the head of Iran's



Red Crescent Society told state media the fire was 90% extinguished and officials said port activities had resumed in unaffected parts of Shahid Rajaee.Iran's crisis management organisation said that of the 752 people who had received treatment for their injuries, 190 were still being treated in medical centres early .A spokesperson for the country's crisis management organisation appeared on Saturday to blame the explosion on poor storage of chemicals in containers at Shahid Rajaee, adding that earlier warnings had highlighted potential safety risks.Government spokesperson Fatemeh Mohajerani cautioned against "premature speculation", saying final assessments would be shared after investigations.Negligence has often been blamed in a series of deadly incidents that have hit Iranian energy and industrial infrastructure in recent years.

## Russia files terrorism charges against suspect in car bomb killing of army officer

Russian investigators have filed terrorism charges against a Ukrainian citizen suspected of killing a senior Russian military officer near Moscow, Interfax news agency reported The Kremlin has blamed Kyiv for Friday's car bomb that killed 59-year-old Yaroslav Moskalik, the latest in a series of Russian military officers and pro-war figures to be assassinated since the start of the war in Ukraine.Ukraine has not commented on the incident.Interfax, citing Russia's Investigative Committee, said the suspect, Ignat Kuzin, had pleaded guilty to killing Moskalik and had said he was recruited by Ukraine's security services.

Moskalik, who was deputy head of the Main Operations Directorate of Russia's General Staff, was killed on Friday in the town of Balashikha, hours before U.S. President Donald Trump's envoy Steve Witkoff was due to hold talks with President Vladimir Putin in Moscow on ending the Ukraine war. The Investigative Committee said Russian authorities were trying to identify others who might have been involved in the killing of Moskalik. Russian war bloggers described Moskalik as a rising star. He had participated in several high-level Russian delegations that have met Western officials to try to negotiate a settlement to the conflict in Ukraine. He also dealt with Syria, presenting a report on



military-technical cooperation in Africa and the Middle East at a security forum in Moscow in 2021.

# **China seizes disputed reef near key Philippine military outpost: report**

The Chinese Coast Guard has seized control of a disputed reef near a major Philippine military outpost in the South China Sea, according to Beijing's state media, adding to longstanding territorial tensions with Manila.Beijing claims sovereignty over almost all of the South China Sea and has waved away competing assertions from other regional countries as well as an international ruling that its position has no legal basis. China and the Philippines have engaged in months of confrontations in the contested waters, and Manila is currently taking part in sweeping joint military drills with the United States that Beijing has slammed as destabilising. The Chinese Coast Guard "implemented maritime control" over the Tiexian Reef, also known as Sandy Cay, during the middle of April, state broadcaster CCTV reported The tiny sandbank, part of the Spratly Islands, lies near Thitu Island, also called Pag-asa and the site of a Philippine military facility.CCTV said the Coast Guard landed on Sandy Cay to "exercise sovereignty and jurisdiction" over the reef, carry out an "inspection" and "collect video evidence regarding the illegal activities of the Philippine side".

The broadcaster published a photograph of five blackclad people standing on the uninhabited reef as a dark inflatable boat bobbed in the nearby water. Another shot showed four Coast Guard officials posing with a national flag on the reef's white surface, in what CCTV described as a "vow of sovereignty". The group also "cleaned up leftover plastic bottles, wooden sticks and other debris and garbage on the reef", the broadcaster said. The Financial Times reported an unnamed Philippine maritime official as saying that the Chinese Coast Guard had left after unfurling the flag. There do not appear to be any signs that China has permanently occupied the reef or has built a structure on it.In recent months, Beijing and Manila have blamed each other for causing what they describe as the ecological degradation of several disputed landforms in the South China Sea. China's state news agency Xinhua on Friday (April 25, 2025) cited a report from the natural resources ministry that it said "debunked" Manila's allegations that Beijing's land reclamation projects had harmed the local environment. Philippine forces are present on Thitu Island and Manila inaugurated a Coast Guard monitoring base there in 2023 in an effort to counter what it describes as Chinese aggression.





# Why is UPI seeing frequent downtimes? | Explained



The story so far: In March and April, the Unified Payments Interface (UPI) system went down three times, causing significant disruptions in payments on apps like GPay and PhonePe, which rely on the system. One of the downtimes was caused by individual banks flooding the National Payments Corporation of India's (NPCI) systems with transaction status checks.

How does UPI work?

UPI payments work based on an architecture that was inherited from the Immediate Payment Service (IMPS). For UPI payments to work, a bank is required to join the UPI system and allow users to access their own accounts through a linked phone number, on a Payment Service Provider (PSP)'s app, like PhonePe or GPay. Practically every commercial bank, public or private, is on the UPI system.UPI is designed as an interoperable system, allowing any bank's account holders to sign up for the service on any app, and even multiple apps at the same time. This resembles a peer-to-peer system, where individual banks are all talking to each other, but in reality, practically every transaction is routed through the systems of the NPCI. "The NPCI is essential in this process," said Srikanth Lakshmanan, a member of the Cashless Consumer project, as it encrypts the PIN information - which only the bank knows — and sends the payment information forward to a payer's bank, which then executes the transaction. "So if there's a downtime in the NPCI, there's no way your bank would get your PIN. This is where it is a single point of failure.

#### Why did the NPCI have several outages?

The NPCI as an organisation is structured as a collective of banks, with public sector banks holding the bulk of its shareholding. This, Mr. Lakshmanan said, is because of the Payment and Settlement Systems Act, 2007, which mandates that organisations involved in clearing transactions in bulk have to be majority-owned by public sector banks. Led as it is by banks, the implementation too is largely left to them, though the NPCI has played a big role in designing and presiding over the UPI system. In the last few weeks, individual banks reportedly flooded the UPI system with "check transaction" requests, which payer banks use to verify that a payment has been completed. That hit the single point of failure at NPCI, and took the system offline briefly. To reduce the impact of downtime like this, the NPCI has created something called UPI Lite, which allows users to set aside up to ?2,000 for payments without having to punch in a PIN. But even such payments go through the NPCI's systems. "You don't do a PIN authentication, but other communication still goes through NPCI," Mr. Lakshmanan said. "The NPCI has to say this transaction originated from your device and so on. This is why even though UPI Lite doesn't involve the PIN entry and decryption, it is still routed through NPCI since it's fundamentally an interoperable system. While UPI Lite is light, it still requires NPCI to be in the middle."

#### Why are banks peeved?

Banks have historically had a rocky relationship with UPI. While the system has revolutionised payments in India - just on Friday, there were over 58 crore transactions worth over ?73,000 crore - they are largely unable to collect any significant fees on transactions, even though there are costs attached to each of these. The RBI estimated that banks incur a cost of ?0.80 per transaction, due to SMS notification costs (which telecom operators collect for commercial messages), and the costs incurred in maintaining and updating records of each payment. However, they are not able to charge a Merchant Discount Rate (MDR) for these services, leaving them with few incentives to keep to rigorous uptime standards. Individual banks go down far more frequently than the NPCI as a whole, and these outages result in increased payment decline events. Systemwide downtimes are far fewer and shorter on commercial card networks like MasterCard and Visa. Mr. Lakshmanan said, as there is robust monitoring and service level agreements to enforce performance standards. However, he said, the Ministry of Electronics and Information Technology has tried a "carrot and stick" approach, with its annual UPI incentive programme for banks, which comes attached with conditions that penalise banks whose performance suffers over the course of a year. The subsidy scheme compensates banks for their current inability to charge an MDR. "If you're at the bottom [in terms of uptime], you get nothing,' Mr. Lakshmanan said.

# India and remaking of the global supply chain

iphoneThe doubling down by the US tech major on its India operations — the company recently exported 600 tons of phones from India "to ensure sufficient inventory" in the US — sends an important signal about the country as an export hub, more so during these uncertain times.

As per reports, Apple is now looking to make all its iPhones for the US market in India by 2026, as it attempts to bring down its reliance on China as an export base. If these plans fructify — the tech giant currently sells in excess of 60 million iPhones in the US — it would imply that roughly a quarter of all iPhones sold globally could be from India.

This doubling down by the US tech major on its India operations - the company recently exported 600 tons of phones from India "to ensure sufficient inventory" in the US - sends an important signal about the country as an export hub, more so during these uncertain times. Other companies with production facilities in countries such as Vietnam — the Southeast Asian nation has been slapped with a reciprocal tariff of 46 per cent - are also said to be exploring a similar move. This would be a significant development. Alongside these shifts, a strengthening of the supplier ecosystem in the country - for instance, a significant number of Apple's vendors and suppliers currently manufacture in mainland China — would ensure that the country captures a greater portion of the value added. India was not a big beneficiary during the first round of supply chain reconfigurations. As per a report from OCBC, a Singaporean banking and financial services firm, "The ASEAN-6 region (Indonesia, Malaysia, Philippines, Thailand, Singapore and Vietnam) has benefited from a diversification of global and regional supply chains as well as the adoption of 'China+1' strategies." FDI flows into these countries rose to a staggering \$236 billion in 2023, up from an average of around \$190 billion in 2020-22. The question, now, is: Can India grab a bigger share this time around? Can the gains in the mobile space be replicated across labour intensive segments such as apparel, footwear, toys and furniture? Can India use the uncertainty in the global economy to its advantage? The current economic environment is indeed quite challenging. In its recent World Economic Outlook, the International Monetary Fund cut its forecast for global growth to 2.8 per cent, down 50 basis points. The outlook for both advanced as well as emerging market and developing economies has been slashed by 50 basis points each. Alongside, the Fund also lowered its projection of global trade by almost half. As per its assessment, it is the emerging market and developing economies that are likely to be affected the most. This slowdown in global growth comes at a time when the Indian economy is also showing signs of weakness. Household consumption is weighed down by the combination of subdued real income growth and high indebtedness. Private sector investments remain muted as companies await greater clarity over demand and remain watchful of a possible surge in exports from countries that will face difficulty in accessing the American market. Alongside, the Union government has committed to the path of fiscal consolidation, implying a contractionary pulse to the economy. The outlook for exports is also marred by uncertainty. However, as Shoumitro Chatterjee has argued (IE, April 4, 'How to Trump tariffs'), the country's priority "should be to grow its global market share — regardless of whether global trade itself is expanding." At a time when other countries are turning their back on globalisation, India's focus should be to emerge as a safe haven, a country that offers predictability of policy, and embraces openness and freer trade, not protectionism. Signing a deal with the US will send the right signal. An editorial in this paper (IE, April 25, '<strong>Seal the deal') noted that it will "help the country avoid reciprocal tariffs, and reduce uncertainty, providing clarity to both global and domestic firms." However, this alone is not enough. There is no room for complacency. India must push ahead with similar agreements with the EU and the UK and reexamine its position on Asia-centric trade deals such as RCEP. Further, as another editorial in this paper argued (IE, April



4, 'After the tariffs'), "the Indian government must also pursue a more ambitious and broader agenda for trade reform."But, even as companies step up diversification of supply chains, and India tries to emerge as a major global export hub, the criticality of China to the global trading system cannot be understated. As an editorial in this paper noted (IE, April 23, 'New give & take'), "China is at the centre of global manufacturing supply chains. In 2023-24, the India-China bilateral trade stood at a staggering \$118.4 billion." Moreover, companies looking to shift their production out of China are also likely to face some pushback. Reportedly, the plans of a fast-fashion company to relocate some of its production out of the country are being met with opposition from the Chinese government. These rapidly evolving trade dynamics, as an editorial in this paper noted (IE, April 23, 'New give & take'), will "require deft handling".

# Save the children': Guide who helped tourists escape recalls those terrifying 10 minutes at Pahalgam meadow



Over the sound of gunshots ringing across Baisaran, Chhattisgarh resident Lucky Parashar, his face on the ground, cried out to tour guide Nazakat Ahmad Shah for help. The firing in the Pahalgam meadow started just short of 2 pm on April 22. In barely 10 minutes, "three terrorists in dark clothes" shot dead 26 people, including a local pony ride operator, and injured several others. As cries of pain, shock and grief broke out, the terrorists melted into the forest nearby. Earlier that day, four couples and three children, including Lucky's family, had travelled with 31-year-old Nazakat to sightsee around Pahalgam, a one-day stop in their Kashmir itinerary. At the ticket counter, the guide greeted his cousin — 30-year-old Syed Adil Hussain Shah, the ill-fated pony operator — before entering the park.

Nazakat, who has been working as a tour guide since 2010, has known Parashar's family for years. For four months each year, his family sells shawls and other Kashmiri goods in Chhattisgarh. Two of his brothers, too, are involved in the tourism sector, helping yatris traverse the Amarnath route every year. At around 2 pm, Nazakat approached Lucky, who was near one end of the zipline that runs through the park, to ask if his family was ready to move to the next spot."I wanted to take them to 'ABC' — Aru Valley, Betaab Valley and Chandanwari (in Pahalgam). Lucky said the children really loved Baisaran and wanted to stay there a while longer," says Nazakat, recalling how the three children in the group shrieked with joy as they ran all over the meadow.

As the gunshots grew louder, Nazakat knew he had to get out if he wanted to stay alive. In the middle of his exchange with Lucky, he remembers the echo of a loud 'crack'. It was followed by another. And then a volley of shots. "It took me a minute to realise what was happening. This place is so remote, so peaceful that even a local like me did not immediately realise that we were under attack," he says.

As soon as he realised the danger, Nazakat grabbed the youngest child in the group, a boy aged two, followed by the other two. Holding them close, he lay flat on the ground, just like the others lying prone nearby. While Lucky lay next to him, his wife and the rest of the group were elsewhere in the park.Chhattisgarh BJP youth wing worker Arvind Agrawal, who was also part of the group, had told The Indian Express earlier that his four-year-old daughter was among those Nazakat had shielded. As the gunshots grew louder, Nazakat knew he had to get out. The ticket gate was too far. As he looked around for another way out, Nazakat spotted a gap in the fence."Lucky told me, 'whatever happens, save the kids'. I have two daughters myself, he did not have to explain. I had spotted three people in dark clothes walking in the meadow earlier.... I had to think about the children first," he says. Pahalgam guide 'hugged my children, saving their lives': Chhattisgarh BJP worker whose family had narrow escape Arvind Agrawal with NazakatAmid the gunshots, Nazakat called up the driver he had hired to ferry the family, instructing him to take a different route and meet him "near the spring that flows close to the park". A split second later, he grabbed the three children, and, with Lucky, made a beeline for the gap in the fence."The taxi driver had heard the gunshots too. He also took a while to realise that it was the sound of bullets," says Nazakat.

Running along the spring, Nazakat, the children and Lucky reached the car 10 minutes later. Once the children were inside, Nazakat turned around - back towards the meadow and the gunshots - to track down the remainder of his group. The gate near the ticket counter was open, he recalls, allowing those on the park's periphery to get away. At the fence, he saw pony wallahs rushing panicked tourists down the slope on ponies even as shots continued to ring. "It had rained two days ago. The path was still extremely slippery," he says. Despite the chaos, Nazakat managed to locate all seven remaining members of his group. He says he took the stunned tourists back to their hotel in Pahalgam. The next day, April 23, he accompanied them to Srinagar airport, nearly 80 km from Pahalgam. "They were scared. They wanted to leave Srinagar. I knew that no matter what I said, they would not stay back if they could leave." he savs

Srinagar airport was overrun with victims, their families, panicked tourists and VIPs. Lucky's family failed to get a flight out. "They were scheduled to leave on April 24 anyway. They ended up taking the same flight," he says. It was on his way to Srinagar on April 23 that Nazakat found out about his cousin succumbing to the bullet injuries he had sustained during the attack. Adil, too, was attempting to save some tourists in the park when he was shot. "It struck me then that in my rush to get the guests out, I had forgotten to check on Adil," he says. On Friday, April 25, three days after the attack, Nazakat was still in Pahalgam, still answering calls from "customers who are now friends" "They have been checking on my well-being since Tuesday. Many tourists who I've travelled with earlier have been calling too to check on me and my family."Before answering yet another "wellness check" from one of his "friends", Nazakat says: "People in the centre of the bowl (at the park) bore the brunt of the attack. I don't know how I would have lived with myself had one of my guests been injured or worse.

# Amid Waqf hearing in SC, a 400-year-old mosque near Delhi HC finds itself in the spotlight

## Government bans manufacture, sale of 35 fixed-dose combination drugs

New Delhi: Apex drugs regulatory body CDSCO has directed drug controllers of all states and Union territories to stop manufacture, sale and distribution of unapproved 35 fixed-dose combination drugs that include painkillers, nutrition supplements and anti-diabetics.

They have also been asked to review their approval process for such fixed dose combination drugs (FDC) and ensure strict compliance of the provisions of the Drugs and Cosmetics Act 1940 and rules.FDC drugs are those which contain a combination of two or more active pharmaceutical ingredients (APIs) in a fixed ratio.

The regulator issued the directions after it found that certain FDC drugs have been licensed for manufacture, sale, and distribution without prior evaluation of safety and efficacy, posing a serious risk to public health and safety.In a communication sent on April 11, Drugs Controller General of India (DCGI) Dr Rajeev Raghuvanshi referred to the letter issued by his office on January 2013 where concerns were raised regarding the grant of manufacturing licenses for sale of FDC drugs that fall under the definition of a "New Drug" in the country without due approval from DCGI.The same concern has been raised from time to time and multiple letters have been issued to the respective state licensing authorities that granted permission for manufacturing and marketing of unapproved FDCs. The most recent such letter was issued in February this year."It has come to the notice of this directorate that certain FDC drugs have been licensed for manufacture, sale, and distribution without prior evaluation of safety and efficacy as per the provision of NDCT Rules 2019 under the Drugs and Cosmetics Act 1940. This poses a serious risk to public health and safety," the letter stated. The approval of such unapproved FDCs compromises patient safety and may lead to adverse drug reactions, drug interactions, and other health hazards due to the absence of scientific validation, the letter underlined.Upon issuance of show cause notices to the manufacturers, they have stated that these licenses were granted by the respective drug licensing authorities and have not violated any rules, it said.

Two years before Gautam's 2015 plea, in 2013, a group of lawyers had sought the court's intervention on construction activity being undertaken at the masjid. On December 27, 2013, the Delhi High Court had directed that construction activity at the mosque be stopped and status quo be maintained. Mobin Akhtar, a member of the mosque's managing committee and an advocate, says, "Around 2013, the mosque committee decided to renovate and repair the masjid, which was in a shambles at the time. This resulted in the plea before the High Court."He adds, "The mosque is not on the Delhi High Court premises. In fact, the Delhi High Court is located around the mosque."Senior Advocate Anil Soni, who had appeared as the Centre's standing counsel in the 2015 case, told The Indian Express, "Construction (at the mosque) had started around December 2013. There was a plan to expand the mosque's boundary and construct minarets around it. There was also an objection to outsiders coming inside the High Court premises to pray. The High Court's administrative committee back then had intervened, deciding not to escalate the matter. Ultimately it was seen that the masjid was on Waqf land. The High Court had opined that it cannot issue directions or regulate Waqf land."Established in 1966 through the Delhi High Court Act, the court's main building was declared open on September 25, 1976, by then President Fakhruddin Ali Ahmed.









# NIMHANS study identifies blood-based biomarkers for early detection of postpartum depressive symptoms

A study by researchers from NIMHANS has identified a panel of novel DNA methylation makers that can help predict the risk of postpartum depressive symptoms in early stages of pregnancy. The study was published in the Journal of Affective Disorders on April 24.Perinatal depression, which includes both prenatal (during pregnancy) and postpartum (after childbirth) depression, affects a substantial proportion of women and can have long-lasting effects on both mother and child. It often manifests as persistent sadness, low energy, anxiety, and disrupted sleep and appetite patterns.

The study, led by Kuppan Gokulakrishnan, Associate Professor of Neurochemistry at NIMHANS, is a collaborative effort with researchers from the Madras Diabetes Research Foundation (MDRF), Seethapathy Clinic & Hospital in Chennai, and the University of Warwick in the United Kingdom. The team focused on epigenetic changes, specifically DNA methylation (a biological process by which methyl groups are added to the DNA molecule - the levels of which help predict diseases) as potential early indicators of depressive symptoms. This study was funded by the DBT-Wellcome Trust India Alliance.Postpartum depression or

postnatal depression is different from the baby blues. It usually occurs two to eight weeks after giving birth but can happen up to a year after the baby is born. Feelings of intense anxiety are also a common feature of postpartum depression.Dr. Gokulakrishnan said there are currently no blood-based biomarkers available to identify postpartum depressive symptoms at an early stage of pregnancy. "Therefore, our discovery allows for earlier intervention, which can help reduce the harmful effects of depression. Our findings open up the possibility of a simple blood test during early pregnancy that could help identify women at risk, allowing for timely intervention and support," he said. Early detection could lead to personalised, preventive strategies in maternal mental health care and reduce the long-term emotional and developmental toll on both mothers and children, he said. The study involved 201 pregnant women with no prior history of depressive disorders, recruited from the STratification of Risk of Diabetes in Early Pregnancy (STRiDE) study. "Participants were screened for antenatal depressive symptoms, and blood samples were analysed using the advanced Infinium Methylation EPIC array. This revealed 591 methylation markers significantly associated with antenatal depressive symptoms. From this data, a panel of seven methylation markers was identified using machine learning as a robust biomarker panel capable of distinguishing depressed women from controls with high sensitivity and specificity," the author explained."Remarkably, this same panel was also able to predict postpartum depressive symptoms with impressive accuracy. The predictive power increased further when combined with patient-reported data. This is a significant leap forward in our understanding of the biologi cal underpinnings of perinatal depression," said Dr. Gokulakrishnan. Pointing out that further studies with larger and more diverse samples are warranted to improve the robustness of the model, he said, "Additional analysis of the associated methylation patterns pointed to biological pathways such as inositol phosphate metabolism, notch, and calcium signalling pathways already known to play roles in mood regulation."Chinnasamy Thirumoorthy, who is one of the authors of the study, said the team is currently working on validating the findings in other Indian cohorts. "Our goal is to develop a point-ofcare diagnostic tool based on these epigenetic

#### India's AI compute conundrum offered may cap private demand at what is avai the reduced prices. The end-user policy for AI s



The Ministry of Electronics and Information Technology announced the launch of a continuous empanelment process for Al compute providers, which allows firms to apply on an ongoing basis to supply Al compute and related services. While this may seem like a good move in the short term, the process impedes market dynamics and creates bureaucratic hurdles for both providers and users of compute infrastructure. Allowing markets to function freely and offer services that meet consumer needs is necessary for long-term sustainability.

The IndiaAl compute mission follows a bidding process where empanelled vendors must match the lowest bid price for the AI compute and services. Some vendors undercut the market price by as much as 89% by "doing things that were never done before to reduce operational costs", as one vendor put it. In addition, the IndiaAl mission will subsidise up to 40% of the compute costs for eligible users addressing priority use cases such as healthcare and education. The government's move to empanel private compute providers and offer additional subsidies stimulates demand in the near term. This might support the development of India-based compute providers. In addition, if done well, the continuous empanelment process could prevent cartelisation among compute providers and allow newer providers to enter the market. However, it is worth asking if the bidding process that requires matching the lowest bid price is sustainable and how effectively it addresses the goals of developing sovereign computing infrastructure and encouraging innovation in priority areas.

The lowest bid tendering process creates incentives to compromise on the quality of service as operational costs need to be kept to a bare minimum. Slim profit margins will also leave little room for investments in research and development.Furthermore, the fact that many of the providers agreed to the lowest price seems to be a sign of low private market demand for AI compute in India. Yotta, an empanelled vendor providing a majority of the compute under the IndiaAI mission, claims that just 25% of the demand for their Nvidia H100 chips is from India. While government intervention might stimulate demand in the near term, the below-market prices and the additional subsidy

offered may cap private demand at what is available at the reduced prices. The end-user policy for AI services under the IndiaAI compute mission has several requirements to apply for the compute that create hurdles for users. This involves meeting various qualification criteria and a project and subsidy evaluation process. For instance, a startup applying for compute needs to be registered with Startup India or recognised by the Department for Promotion of Industry and Internal Trade. It will also need to demonstrate experience in AI/Machine Learning and have an annual revenue of ?50 lakh-?200 lakh or funding above ?100 lakh. The monitoring and evaluation team would then evaluate the project and, based on several criteria, approve the allocation and any subsidy requested.Such a process is necessary to ensure accountability and due diligence, but it adds too much friction, which will hinder innovation. DeepSeek has been disruptive in building AI models comparable to frontier models developed by OpenAI at a fraction of the cost Some reasons for its success were that it was incubated from a hedge fund, ran its own data centre, and had no business model. This allowed engineers to experiment without navigating through bureaucratic processes or internal coordination to get compute resources.India's choice to build its sovereign computing infrastructure may seem like a good move in the short term, as it provides ownership of computing resources and supports the development of a domestic infrastructure-as-a-service market. However, some concerns remain. To create a sustainable market, providers must compete for market share by offering solutions that meet consumer needs instead of just undercutting prices. In addition, the ?4,500 crore earmarked for the IndiaAl compute pillar over five years will fund only the subsidy component for eligible projects. It is interesting to explore whether there is enough demand for projects that qualify for the subsidy. If not, a significant part of the budget allocation might remain unutilised. Finally, India's current compute capacity at ~19,000 GPUs pales compared to investments in compute in the U.S., EU, or China. Meta alone is building \$10 billion in a data centre. This seems to imply that India's focus is not on building the most capable AI models but rather on addressing Indian use cases, which is a practical choice. Concerns that must be prioritised include scaling up energy infrastructure as demands are likely to grow as compute utilisation grows. Further, any hurdles to importing compute infrastructure can also be an area that can be streamlined through government intervention. Market trends indicate that compute usage is moving from training to inference time, which requires different kinds of AI chips. As the hype settles down and competitors to Nvidia emerge, chip costs may also go down. Government interventions should leave the market as agile as possible to adapt to these shifts. Allowing private players to function freely will enable the market to keep pace with future developments and also provide a pathway for the transition after the IndiaAI mission sunsets.

# Smoking is a major risk factor for rheumatoid arthritis

Emphasising that delayed diagnosis of arthritis can lead to permanent joint damage and deformities in individuals, senior rheumatologists on Sunday urged people to seek early intervention as it helps slow down its progress. Speaking at a webinar on "Understanding Arthritis", they pointed out that smoking is a strong risk factor for rheumatoid arthritis and advocated lifestyle changes, exercises, yoga, and a healthy diet that is low on carbohydrate and sugar but rich in fibre and protein. The webinar was held as part of the ongoing "Healthy India Happy India" initiative of Naruvi Hospitals, Vellore, in association with The Hindu. Sunday's edition was the ninth in the series on the theme "Prevent Illness, Promote Wellness".

N. Raja, senior consultant in rheumatology, Naruvi Hospitals, Vellore, spoke on the importance of correct diagnosis of symptoms and timely treatment. He said arthritis was a grossly misunderstood clinical sign. "It does not denote a disease but is an inflammation of joints, including the knee, hip, wrist, shoulder, ankle, elbow and manifests as pain or swelling and stiffness that limits movements and affects daily activities," he explained, adding that the systemic condition could lead to eye inflammation, spinal fusion, and chronic deformities.

Dr. Kavitha said there was no single test to diagnose arthritis. A combination of clinical history, physical examination, blood investigations, and imaging such as X-ray, MRI, PET and bone scan help in confirming the diagnosis and monitoring disease progression.S. Sham from Kauvery Hospital, Alwarpet, spoke about how treatment protocols had changed, and steroids and painkillers were not the main treatment for rheumatoid arthritis. "Disease-modifying agents entail different levels and combinations of drugs and take 8-12 weeks to start acting," Dr. Sham said. The doctors reiterated the importance of patient education and reminded that once arthritis sets in, it cannot be cured but can go into remission with regular follow-up, comprehensive approach to treatment, including diet, exercise, and psychological support.

Yet, you are still experiencing very real and disabling symptoms.Unfortunately, this is the experience of many people with functional neurological disorder. Even worse, some are blamed and reprimanded for exaggerating or faking their symptoms.

# Assessing temperature-related deaths in urban heat islands



Cities having higher ambient temperatures than rural surroundings (known as the urban heat island effect) could offset some of the negative effects of increased heat-related mortality by reducing the number of deaths associated with cold exposure in some global cities, according to a study in Nature Climate Change. These findings highlight the importance of developing region- and season-specific strategies to mitigate the urban heat island effect. The urban heat island effect contributes to an increase in human heat exposure and subsequent death globally during hotter seasons. However, this phenomenon could also impact the rate of cold-related deaths in cooler conditions. This dual impact could vary across regions and seasons, but previous research has often focused on the effect at the local scale. In the context of climate change and rapid urbanisation, it is important to understand the broader impact of the urban heat island effect on both heat- and coldrelated deaths for urban heat mitigation strategies

Dr. Wenfeng Zhan from Nanjing University, Nanjing, China and others analysed multiple data sources, including remote sensing data and climate and socioeconomic factors (such as Gross Domestic Product), to establish mortality-temperature relationships across more than 3,000 cities worldwide. They found that the reduction in cold-related mortality under the urban heat island effect is 4.4 times greater than the increase in heat-related mortality in 2018.

The authors further observed that cities at high latitudes saw an even higher reduction - Moscow, for example, saw a reduction in cold-related deaths that was 11.5 times greater than those associated with heat. The authors further analysed the role of increasing vegetation and the reflectivity of buildings (albedo), which are current strategies to mitigate the urban heat island effect. They found that these strategies could result in an increase in cold-related deaths that surpasses heat-related deaths globally depending on the magnitude of the intervention and the season in which it is implemented. The authors emphasise that their findings should not be interpreted as downplaying the negative health outcomes of the urban heat island effect but instead offer crucial insights into the specifics of its impact across seasons. They further suggest that cities must take a seasonal approach to mitigating the urban heat island effect.

What is functional neurological disorder?

Neurological disorders are conditions that affect how the nervous system works. The nervous system sends and receives messages between the brain and other parts of your body to regulate a wide range of functions, such as movement, speaking, vision, thinking and digestion. To the untrained eye, functional neurological disorder can resemble other conditions such as stroke, multiple sclerosis or epilepsy.But, unlike these conditions, functional neurological symptoms aren't due to damage or a disease process affecting the nervous system. This means the disorder doesn't appear on routine brain imaging and other tests.Functional symptoms are, instead, due to dysfunction in the processing of information between several brain networks. Simply put, it's a problem of the brain's software, not the hardware.

#### What are the symptoms?

Functional neurological disorder can produce a kaleidoscope of diverse and changing symptoms. This often adds to confusion for patients and make diagnosis more challenging.Symptoms may include paralysis or abnormal movements such as tremors, jerks and tics. This often leads to difficulty walking or coordinating movements.Sensory symptoms may involve numbness, tingling or loss of vision.Dissociative symptoms, such as functional seizures and blackouts, are also common.Some people experience cognitive symptoms including brain fog or problems finding the right words. Fatigue and chronic pain frequently coexist with these symptoms.

These symptoms can be severe and distressing and, without treatment, can persist for years. For example, some people with functional neurological disorder cannot walk and must use a wheelchair for decades.Diagnosis involves identifying established diagnostic signs and ensuring no other diagnoses are missed. This process is best carried out by an experienced neurologist or neuropsychiatrist.

#### How common is it?

Functional neurological disorder is one of the most common medical conditions seen in emergency care and in outpatient neurology clinics. It affects around 10–22 people per 100,000 per year. This makes it more common than multiple sclerosis. Despite this, it is often under-recognised and misunderstood by health-care professionals. This leads to delays in diagnosis and treatment. This lack of awareness also contributes to the perception that it's rare, when it's actually common among neurological disorders.

Who does functional neurological disorder affect? This condition can affect anyone, although it is more common in women and younger people. Around two thirds of patients are female, but this gender disparity reduces with age.

Understanding of the disorder has developed significantly over the past few decades, but there's still more to learn. Several biological, psychological, and social factors can predispose people.Genetics, traumatic life experiences, anxiety and depression can increase the risk. Stressful life events, illness, or physical injuries can trigger or worsen

existing symptoms.But not everyone with the disorder has experienced significant trauma or stress.

#### How is it treated?

If left untreated, about half the people with this condition will remain the same or their symptoms will worsen. However, with the help of experienced clinicians, many people can make rapid recoveries when treatment starts early. There are no specific medications for functional neurological disorder but personalised rehabilitation guided by experienced clinicians is recommended. Some people may need a team of multidisciplinary clinicians that may include physiotherapists, occupational therapists, speech therapists, psychologists and doctors.People also need accurate information about their condition, because understanding and beliefs about the disorder play an important role in recovery. Accurate information helps patients to develop more realistic expectations, reduces anxiety and can empower people to be more active in their recovery. Treating common co-existing conditions, such as anxiety or depression, can also be helpful. The origins of the disorder are deeply rooted in the sexist history of its pre-scientific ancestor - hysteria. The legacy of hysteria has cast a long shadow, contributing to a misogynistic bias in perception and treatment. This historical context has led to ongoing stigma, where symptoms were often labelled as psychological and not warranting treatment.

Women with functional symptoms often face scepticism and dismissal. In some cases, significant harm occurs through stigmatisation, inadequate care and poor management. Modern medicine has attempted to address these biases by recognising functional neurological disorder as a legitimate condition. A lack of education for medical professionals likely contributes to stigma. Many clinicians report low confidence and knowledge about their ability to manage the disorder.

#### A bright future?

Fortunately, awareness, research and interest has grown over the past decade. Many treatment approaches are being trialled, including specialist physiotherapy, psychological therapies and non-invasive brain stimulation.Patient-led organisations and support networks are making headway advocating for improvements in health systems, research and education. The goal is to unite patients, their families, clinicians, and researchers to advance a new standard of care across the world.

# AI to reboot UAE's skyscraping tech ambitions, away from fossil fuels

Dubai, the gleaming metropolis on the edge of the Arabian desert known for its shiny high-rises, fast life and limitless ambitions, epitomises the UAE's towering tech-fuelled aspirations in more ways than one. It is no secret that the Emiratis want to lead the world in artificial intelligence (AI), as they seek to pivot their economy away from fossil fuels. And as part of its intensifying technological ambitions, the Emirates have heralded plans to become the first nation in the world to deploy AI to help write new laws and amend existing ones — a move expected to accelerate its lawmaking process by up to 70 per cent, but one that has also raised some concerns among technologists.

This novel "AI-driven regulation" system, to be overseen by the newly-created Regulatory Intelligence Office, a unit tasked with managing the AI's integration into its lawmaking process that will change how laws are created, making the process faster and more precise, according to Sheikh Mohammad bin Rashid AI Maktoum, the UAE's Vice President, Prime Minister, and the ruler of Dubai.The AI system, announced just weeks ago, is expected to comb through a comprehensive database of federal laws, court rulings, and government services, and come up proactively with legal updates.

Al's role, said UAE officials attending the third edition of the Machines Can See Summit in Dubai over the weekend — touted as the largest computer vision event and a leading AI gathering in the Gulf region — goes beyond just drafting; the system will track the real-world impact of new laws on the Emirates' population and economy, allowing the administration to adapt legislation in real time. The plan, though, has raised concerns among researchers and technologists, who have flagged the propensity of AI models to produce unreliable outputs, hallucinate and its potential shortcomings with legal interpretations.

These risks notwithstanding, the UAE has made AI a national priority, pumping in billions into the sector through its new sovereign wealth vehicle, MGX. While its fascination with tech is not new, it is the scale of the Emirates' plan, alongside that of neighbouring Saudi Arabia, that is key. The UAE's centralised government structure is a facilitator of this kind of rapid technological experimentation, something that could be difficult to achieve in other countries."Humans usually like to speak, to discuss, to get options and also to negotiate. And this is what the machine is (now) doing. We are going to a more human-centric approach. In Dubai, we are designing a multi AI agent, where a single AI can talk to one or multi AI agent in order either to perform tasks or execute commands or get a notification in order to finish a service. So what we'll see in the future, and I think this is one of the most complicated things that we'll see, we'll see more AI working with the digital tool. So each one of us will have a digital tool," Hamad Obaid Al Mansoori, Director General of Digital Dubai, said at the first day of the Machines Can See summit here on April 23. Mansoori said the provincial administration is gearing for a future where AI agents or virtual 'Metaverse-type' avatars of citizens could be potentially designated to carry out tasks on behalf of citizens, such as applying for a licence or a business permit. That is the level of crystal ball gazing that the UAE administration is willing to do in its pursuit of AI leadership.

Within the Emirates, Dubai has taken a lead in AI, and policymakers hope to keep it that way, Omar Sultan AI Olama, head of the UAE Ministry of State for Artificial Intel-



ligence, Digital Economy and Remote Work Applications, said at the event that the administration is following a wholeof-government approach to keep that lead. "There is a saying... Every morning in Africa, a gazelle wakes up. It knows it must run faster than the fastest lion or it will be killed. Every morning a lion wakes up. It knows it must outrun the slowest gazelle or it will starve to death. It doesn't matter who you are, when the sun comes up in Dubai, you'd better be running," Olama said in his opening keynote.

The approach is backed by action. In March 2024, the UAE floated MGX, a tech-investment company by two stateowned entities – global investment fund Mubadala and an artificial intelligence firm G42 — with a target size of \$100 billion that will invest in Al infrastructure, including data centres and chip-making facilities. It has also set up a \$10 billion Al venture-capital fund.Earlier in 2023, the Technology Innovation Institute, a state-owned research body, unveiled Falcon, a large language model or LLM, and is currently working on new, smaller models. As part of these efforts, G42 had unveiled Nanda, a Hindi LLM while Mubadala had earlier invested in Anthropic, a top global Al startup.

Countries such as India have been slower to get started. On Saturday, the Indian government said it had selected a Bengaluru-based start-up Sarvam to build the country's first indigenous Al large language model. The startup, chosen from among 67 applicants, will receive support from the Union government in terms of compute resources to build the model from scratch and is the first to get approved for sops under the ambitious Rs 10.370 crore IndiaAl Mission to build its own LLM model. In the Emirates, non-AI companies are simultaneously being roped in to prep up the region's infrastructure to match its AI projections. E&, an Emirati telecom company, has been roped in as part of a project to build a 45,000-km long undersea cable that makes its way around south Asia, Africa to the UK. Khazna, an arm of G42, is also building peripheral infrastructure, all part of a concerted plan.Last August Mubadala invested in Yondr, an American data-centre developer. The UAE is also reported to be in talks with TSMC, the world's largest chipmaker, to build a semiconductor foundry in the Emirates.A big concern, though, is the worsening relation between America and China, analysts attending the conference told The Indian Express. Companies from the UAE are reliant on American companies for technological and capital support, even as most of them have heavy exposure to multiple Chinese players for hardware and software requirements. Having to pick sides would be an emergent risk for the tech-focused administrators sitting in Abu Dhabi, as will be the case for those in other capitals around the world

# In the US-China trade war: India has enough weight to avoid being forced to make the choice... Should avoid making (an) outright choice, says Martin Wolf

According to Martin Wolf, chief economics commentator at the Financial Times, London, China is likely to come out better than America in their escalating trade war. And it might be advisable for countries such as India to walk the middle path, like it has done in the Russia-Ukraine conflict, he said in an interview with Anil Sasi.When Donald Trump was inaugurated in January, the general impression was that he might pander to the MAGA base for a while and then get back to business. There was a feeling that all this tariff talk could just be transitory. Now it does not seem like that. How do you read the situation?

I think what's changed between his first term as president and the second term is that the last time he didn't know what to do. He was almost a classic example of the famous story of the dog that catches the car and then doesn't know what to do after that. He became president the first time around, and I don't think he really expected to become president. He didn't know who to appoint... The area where he was probably most radical was trade policy even then, but he had a US trade representative Robert Lighthizer, who was very professional. He was very conservative, and I disagree with him on most things, but he was a professional trade negotiator.So (now) MAGA moved from being a slogan to being a cult, and there were a lot of people, many of them associated with the Heritage Foundation, who developed a detailed plan for what they would do when they were in government. A lot of that is happening so it's a very different administration with a man at the head who feels both vindicated and vengeful.

I think that's sort of the description of what we've got and there are very few people in this administration, I think Scott Bessant is probably one of them, Marco Rubio is another, who would be plausible candidates to be in the administration of a Republican president before Trump himself. Nobody else in this administration, as far as I can see. would have been appointed, even by Trump 1.0, let alone George W. Bush or George Herbert Walker Bush.So this is a new administration. Now, tariff is the one thing he really feels (strongly) about, thinks about, and he feels that all this should be rectified by having bilateral balances. China move to issue a fairly open threat that countries that are negotiating for a deal of some sort with the US will be slapped with some sort of retaliatory tariffs of their own. Now this is an escalation of the kind that was probably not expected earlier. Are we in some way now reaching a point of no return?

Well I think it's very plausible. I mean, it seems to me the (most) probable outcome... With Europe interestingly in the middle. There are three major trading powers. The EU is not of course a major power, but it's a very much a major trading power and it looks to me as though it's certain that what the US will say to all the other trading partners is we won't impose these reciprocal tariffs on you that we have temporarily waived if you put a prohibitive tariff on China.I assume that's what's going on. And completely predictably, China is saying, well, if you do that, we're going to retaliate against you. Of course they are! So, the countries will have to choose, it seems to me, whether they're going to be in a bloc with the US or in a bloc with China. And that's going to be a very, very difficult choice for many countries who have extremely important trading relations with both. And more importantly, relations for the Europeans, for example, America is its principal ally; for Southeast Asian countries well China's right there next door; it's a huge military power rising power they have to consider not only their trade relations with China, which are very very important to them, but the potential geopolitical consequences of being seen by China as an enemy and they have to wonder, well, will



ing that is you can make (it) very clear there are obliga tions, you have to live up to those obligations, and everybody in the world that matters agrees on this, and we're going to act collectively. And I think it could have been done within the WTO (World Trade Organization), and if it couldn't have been done within the WTO, you could have tried, you could have done it, as it were, cooperatively among the rest of the world...What Trump is trying to do (now) is quite clearly an act of war against China. It's trying to break China. It's trying to impoverish China. And it's doing so in a way that inevitably, and perfectly understandably, will be viewed as humiliating by China. And China is a proud, ancient nation. It's enormous. It has made enormous progress. And it feels very bitterly the impact of Western colonialism in the 19th century. So behaving like this is going to turn China and the Chinese into an enemy. And my view is a world in which the US and China are actually at war, even if it's a Cold War, is going to be very dangerous and very difficult and very unpredictable. Any sane strategy would have tried to avoid that outcome. So my view is (that) there were legitimate issues. They should have been taken out in the most multilateral way possible. The Americans could have provided the leadership, they didn't for a whole host of rea-

They never created a coalition with other interested powers like the Europeans on this. We are now moving into a world in which there will be a complete breakdown of relationships and the division of the world in a sort of Cold War way. And I'm not at all sure that the US is going to come out the winner in this. China is a vastly more powerful enemy than the Soviet Union ever was. It has tremendous resources, human capital as well. It has lots of countries that are highly dependent on it, which will not, and this is crucial, trust Donald Trump's America, because Donald Trump's America is really not very trustworthy, as the Europeans have been discovering. I actually feel, more than usual, very unwilling to advise India in such a difficult situation, because it's a very difficult situation and the Indian policymakers have historically been fairly good at managing situations like this... I think India has weight! After the three great economic powers, India is clearly, leave aside Russia which is all on its own now and that's a sui generis, India is the country that sort of matters most by far, clearly. Because of its size and potential economic dynamism. So both sides will want it to align with them. And it has enough weight, it seems to me, to avoid being forced to make a choice. Or at least if I were India, I would try to avoid making a choice in the sense that, of course, there are natural reasons to want to be close to the US and the West. They're very important trading partners, economic partners and potentially security partners. You want them to balance, to some extent, the power of China, which is very close to you, obviously. So you want to preserve that. But I do think that India will always be a neighbour of China. China is always going to be an important country and you don't want to turn it into an outright enemy... So I think if I were, God forbid, advising Indian policymakers, I would say you probably have enough weight to avoid being forced to make the choice. And if you can use that weight to avoid making an outright choice, then you should try and avoid making that outright choice and being sort of a bit in the middle, as you have been over the Ukraine war, to give an example... I wish you weren't, but I fully understand why you have been... And I think that's what you should try to do here. Because it is quite possible the next President of the United States, I'm not predicting it, will have quite a different policy. He will try to reconcile, to open up again somewhat at least to China. And China won't forgive. And your relation, China will not forget. China has very long memories. And your relationships with China might be poisoned for a very long time. I realise it would be very, very difficult and it might be very difficult to avoid making a choice, even if you would rather not. Theoretically, in terms of staying power, isn't China better placed to weather this tariff storm because they can do what they've not done so far: push domestic consumption. Beijing also has the fiscal power firepower. President Xi doesn't have to face midterms, unlike Trump and the Republicans. Isn't China better placed than the US to see this through? My instinct is exactly as yours that at the very least, the Americans will have to be much cleverer than they've been so far. I mean, much cleverer to avoid eventually losing. They cannot close China out of the world completely. I don't think that's in any way a realistic bet, given China's economic and military size. It now has a very formidable military establishment, given its proximity to such an economically powerful and dynamic region with countries that are very closely intertwined with it. It has, as you say, huge degrees of freedom. It can generate domestic demand, reduce its export dependency, create more demand for other countries to sell things into China. It's shown remarkable innovative capacity.So, of course, America can stop it from getting access to certain technologies, there's a limit to how effective that seems to be. And so China has tremendous room for maneuver. America, on the other hand, as you say, it's politically fragile. The economy looks somewhat fragile now.

HDFC net profit, CSR law, CSR committee, unspent CSR funds, ease of doing business, Indian expressThe CSR law, which came into force in April 2014, mandates companies, subject to the provisions of the Act, to invest two per cent of their net profit in CSR projects.

Aided by a surge in profits, funds spent by listed companies on Corporate Social Responsibility (CSR) rose by 16 per cent to Rs 17,967 crore during the year ended March 2024 as compared to Rs 15,524 crore spent in 2022-23, says a report. HDFC Bank topped the list with a CSR spend of Rs 945.31 crore, followed by Reliance Industries Rs 900 crore, TCS at Rs 827 crore and ONGC Rs 634.57 crore.

The rise was due to an 18 per cent rise in average net profit (in the preceding 3 years) of these companies, two per cent of which needs to be spent on CSR activities as per regulatory requirements, and followed three years of flattish spends, from Rs 14,751 crore in 2019-20 to just Rs 15,524 crore in 2022-23, says a PRIME Database report. The CSR law, which came into force in April 2014, mandates companies, subject to the provisions of the Act, to invest two per cent of their net profit in CSR projects. Companies with net worth of Rs 500 crore and above or revenue of Rs 1,000 crore and above or net profit of Rs 5 crore and above have to spend two per cent of average net profits of last three years.

According to Primeinfobase.com, the average net profit of 1,394 companies over last three years was Rs 9.62 lakh crore, up from Rs 8.14 lakh crore in 2022-23. As per CSR requirements, the amount required to be spent by them was Rs 18,309 crore (2022-23: Rs 15,713 crore), against which they spent a slightly lower Rs 17,967 crore (2022-23: Rs 15,524 crore). The shortfall can be explained by the increase in amount which remained unspent which was transferred by companies to Unspent CSR Account Rs 2,329 crore) for use in future years, it said. According to Pranav Haldea, MD, PRIME Database, it is also now time that the Government considers revising these thresholds upwards given the passage of time and "ease of doing business". As a case in point, the average 3-year net profit of companies listed on NSE has more than doubled from Rs 4.18 lakh crore in 2014-15, the first year of this regulation, to Rs 9.62 lakh crore in 2023-24. The CSR thresholds may now be revised upwards to keep the relatively smaller companies out of the purview of this regulation, which was the original intent as well, he said.

In line with the previous years, education received the maximum spend Rs 1,104 crore) followed by healthcare Rs 720 crore). On the other hand, areas such as slum development, armed force veterans and disaster management saw lower and negligible spends. In comparison to previous year (only considering data of 440 companies for which project details were available for both years), spends on environmental sustainability increased the most (54 per cent) followed by spends on national heritage (5 per cent). On the other hand, contribution to slum development fell the most (72 per cent) followed by spends on rural development (59 per cent) and armed force veterans (52 per cent).

The number of companies which spent on CSR went up to 1,367 (98 per cent of the 1,394 companies) in 2023-24 from 1,272 (98 per cent) in 2022-23. The balance 27 companies, despite being mandated, did not spend anything. While 418 companies (30 per cent) spent as much as prescribed, there were 681 companies (49 per cent) which exceeded their prescribed spending. On the other hand, there were 259 companies which missed the mandatory spending of two per cent of net profit (249 in 2022-23). This was primarily due to companies undertaking multiyear projects and thus transferring the unspent amount to their 'Unspent CSR Account' for utilisation in the next three financial years. In case the amount remains unspent even after the end of the three financial years, it needs to be transferred to any fund specified under the CSR Act such as PM National Relief fund, PM CARES fund etc.PSU spending saw an increase of 19 per cent from previous year - 66 PSUs spent Rs 3,717 crore in 2023-24, up from Rs 3,136 crore spent by 56 PSUs in 2022-23. The CSR Act also mandates companies to appoint a CSR committee comprising at least three members of the board of which at least one should be independent, in case the CSR spend is more than Rs 50 lakh. While 1,028 companies spent more than Rs 50 lakh, 990 companies had such a CSR committee in place. Several companies also went beyond the requirement of having 3 members with as many as 503 companies appointing more than 3 members.

America protect us, under Trump... So it seems very clear to me that there are some very, very difficult choices and I would assume if this is what's happening, and I haven't seen absolutely explicit stories on this, but I think it's pretty plausible that this sort of choice will also apply, in some respects, to India.

Now, I assume India will choose America for obvious reasons, but it will still be a very difficult choice. And having outright hostile relations with China in economics, as well as on security issues, the Himalayas and so forth, will be a very big issue, I imagine, for India, it's a terrible situation, and should never have been allowed to happen. But this looks to me what is going on. And the whole host of countries, Australia, for example, are going to find all this very, very difficult to handle. Now if we were to discount the hamhanded manner in which the Trump administration has pursued this tariff agenda, doesn't the world economy not have a China problem: the way Chinese manufacturing had been allowed to grow unabated for over two decades. At what level is some of what Trump is doing now justified in some manner, if this onslaught were solely an attack only on China?

Well, it's what I suppose is what he (Trump) tried to do the last time. And he did play hardball with China. He did get a deal, which they obviously concluded that it didn't work.It didn't work partly because, of course, Trump lost power and so the Chinese felt that they didn't need to worry about this anymore. My view, for what it's worth, is that it was perfectly legitimate to form a coalition of countries around the world, that certainly would have included Europe... I imagine it would include India, who would tell China (that) you have to change the way you run your external economic policies on a number of dimensions. You can't go on pretending you're a developing country, you have to accept the rules of the game, as we accept them. First, and most important to me is macroeconomic policy, the constant huge current account surpluses and trade surpluses. But there are also issues about industrial policy, the openness of the Chinese economy, although I think it's much more open than many people suppose, but it's still not open in the way that the US or the Europeans have been open, and that we would expect you to do this, and if you don't, we are going to retaliate against you. and US India Strategic Partnership Forum (USISPF), Washington DC on April 25. "Our strong domestic demand and relatively lower dependence on exports cushions the Indian economy from external spillovers," he said. # Triathlon Paris Olympics gold medallist finishes 14th at London Marathon, enduring 'dark moments'

Alex Yee, the Londoner who won the triathlon gold medal at Paris Olympics decided to fulfill a childhood dream when he entered to compete at the London Marathon on Sunday. But he said he endured more "dark moments" on his 42.195 km run debut than during his Olympic triathlontitle in Paris.He still declared it an experience of a lifetime, after ending 14th amongst elite athletes and second amongst British athletes, behind Maha met Mahamet.

The 27-year-old Londoner completed the race in two hours, 11 minutes and eight seconds. "It was seriously tough," said Yee, "but probably one of the best moments in my life. Just the feeling of everyone, that experience, I can't really put into words. The experience of running into London, the crowds," he said of the highs. However it was a

testing run. "Definitely a lot more dark moments, I'd say, more than Paris, today. Once I got to 32, 33k there's a lot of pain there. My legs are cramping and I just had to keep fighting through that. And yeah, (I'm) pretty proud to get to the finish line," he added. Yee told the media he has a "hard reset" in February, when he returns to triathlon ahead of the 2028 Olympics in Los Angeles. "Hopefully I will evolve as a person, as an athlete. I wanted to do that in a unique way. I wanted to do this race all my life, the opportunity fell to do it, and I couldn't say no," he said of the effort less than a year after winning Olympic gold in the triathlon."It was was probably one of the best experiences of my life if I'm being honest. I expected the crowd to be good but they were another level. I am so proud to have completed the marathon," he reiterated."An amazing experience but it was hard at the end. I am just proud to have done it. Emotions about time will come afterwards, but the main thing for me today was to enjoy it, do something unknown and embrace it. I did that to my best of my ability. I feel like I gave 100%

This is bigger than running. It's an amazing day and I wanted to be a part of it. This was the perfect opportunity."There is curiosity over whether he will go easy on the three event triathlon for the more soul nourishing marathons. "Definitely not," he told BBC. "I am still hoping for LA Olympics. This is just an experiment really to help me improve my run. I've worked hard over the years to improve my bike and swim to get to that level so it's nice to be able to work on this now," he said.

# Who is Jan Louda, the Czech badminton player who nicked a men's singles win off Korea at Sudirman Cup

Jan Louda caused quite the stir at the Sudirman Cup when he gave Czech Republic a 1-0 lead against perennial team Championship powerhouse Korea, on Sunday. The 25-year-old saw his team go down 4-1 to the former champions, but he had nicked a point after beating Cho Geonyop 21-16, 21-16. While doubles is Korea's strongest suit always, new coach Park Joo Bong might've taken Czechia a tad lightly fielding Cho, ranked 142 against Jan, ranked 103. Jan has a career high of 39. "I used to go with him on the bus to the hall," he told BWF."Four years ago when I started to become a better player and started to be more competitive at the international level, I was beating players who had participated in the Olympics, so I felt I can be the same. If I can beat them, I can also be there."The hyper bouncy player known to ambush unsuspecting opponents with his energy, has had to pay for that hoppity style with injuries. "I face injuries, so that was the hardest part, but I'm glad I could get through. I had an infection in my Achilles last summer (2023), it took two months and I couldn't prepare well for the World Championships. But that's part of sport, so I tried to be positive. It was after some good tournaments I had, so I felt OK, I could afford these two months and come back and I didn't feel it would affect qualification," he told BWF after making the Paris cut.Jan spends most of his training time in Czechia working with a Spanish coach. The men's doubles, both 21, and barely entering Top 50, will learn their lessons fast. But for India's Top 20 shuttlers, this plummeting of fortunes will be tough to swallow.India has never won a Sudirman Cup medal - probably the toughest team event that tests a country's capability (top range, not depth) in each of the five disciplines. But Sunday made it plain that not much was going to change with the available set of players, with Satwik-Chirag and Treesa-Gayatri not travelling due to injuries. Tanisha and Dhruv Kapila were declared team captains, but the freshly minted Top 20s got a swatting reminder of what Top 10s in mixed doubles is. Playing Danish World No 7s Jesper Toft and Amalie Magelund, the Indians ranked No.17, were never the favourites. But the young duo will need to learn to compose their nerves guickly, and hit the road running in any tournament. Defensively tentative, and overwhelmed by the stage, the top pairing which has been making some headway on the circuit, could not stem the flow of points as the Danes, got cracking quickly and never took the foot off the pedal in a 21-13, 21-14 win in 33 minutes.

# How Arne Slot's men conquered Premier League for their coveted 20th English title

As Liverpool's season unfolded, summiting in their 20th league triumph at a canter with a 5-1 win against Tottenham on Sunday, the songs celebrating former Jurgen Klopp grew feebler. His face faded a little from the flags fluttering in the stands. Not that the faithful cruelly forgot the man who reacquainted the institution with success after decades of pain, turned them from a nostalgia brand to a genuine force. But they were fully embracing his successor Arne Slot, knee sunk in the raptures of an unforeseen march to the title, and dancing to the tunes of a bashful Dutchman who rarely moves on the touchline.On the day of their coronation, Liverpool barely flinched as Spurs landed the first punch. Instead of panicking, the Reds just turned on the afterburners to thrash their woeful North London opponents with an alarming efficiency.


It was not meant to be the year of Liverpool or Slot. Premier League success tends to conform to a pattern. A new manager comes, feels, instills his ideals, builds and rebuilds, stumbles and staggers, before – if the owners are generous – they scale the promised land. The holy quartet of managers in the Premier League—Sir Alex Ferguson, Arsene Wenger, Pep Guardiola and Klopp—barely caught a glimpse of the trophy in their first season. Only four have ever enjoyed beginner's luck. Slot is the fifth, and arguably the least celebrated of the group that features luminaries such as Jose Mourinho, Carlo Ancelotti, Manuel Pellegrini,

Claudio Ranieri, and Antonio Conte. Thus, Slot and his merry men have effortlessly debunked the prevailing myths in the Premier League. Rather, in many ways, Liverpool's triumph was a contradiction of the accepted wisdom in winning the league.

He demonstrated that a new coach doesn't needlessly rebuild for the sake of it. Klopp had to because the team he inherited was a shocking mess. The Liverpool that Klopp bequeathed to Slot was ageing but an assemblage of highlyskilled talents. The squad had its flaws-among them a nonscoring centre forward, absence of a genuine holding midfielder, an accomplice for centre back Virgil van Dijk, and a bunch of injury-prone midfielders. But not an awful lot that required a makeover. How he stiffened out the perceivable cracks reveals his undemonstrative genius. To fill the holding midfield void, he retooled a No 8 into a No 6, harnessing the best of two worlds. Ryan Gravenberch has been one of his unsung heroes. He combined his supreme passing range, robust physicality, dazzling half-turns and technical prowess to perform the role of midfield duct, functioning as both the defensive screen and the back-line-midfieldforward-like link. He was the centre of Liverpool's universe, others revolving around him like obliging planets, with frictionless control. Halfway through the season, he became such an integral block of Slot's scheme that senior midfielders Alexis Mac Allister, Dominik Szoboszlai and Curtis Jones donned second-act roles.

It's been eight years since he left. But I still hear him-like the sea inside a shell-not because it speaks, but because I am stitched together with memories that stir whenever someone whispers his name. When he died, it was like the way stars vanish when the sun risesquietly, unapologetically-as if even the light had grown tired of pretending.

Your closest friend?

Yes, I regret not looking into his eyes, not holding his hand as he melted into the abyss of time. Some debts can never be paid. As a dear writer friend once said, "Insaaan apne karz chuka sakta hai, lekin ehsaan nahi." His generosity watered my parched life, and made me live again.

Vinod Khanna starred in your first commercial film? I carry the fondest memories of Lahu Ke Do Rang. Those days when we shot in Hong Kong, they still nourish me. Just the other day, my domestic help-a young woman from Darjeeling-smiled and said she had been a little girl when we filmed the Bappi Lahiri-composed song "Pyaar Pyaar Pyaar" there. Her words threw me back-back into those enchanted, golden times.

Later the two of you went separate ways?

Later, life took us down stranger paths. After his mother's death shook him, he began searching for answers. And I, broken by my own failures, took him to Bhagwan Rajneesh's ashram in Pune. He would still call sometimes, usually late at night. His voice softened by a few drinks, still warm, still reaching across the years. Time had taken its toll. Distance had crept in. But the bond endured. And then-just like that came the bad news, as it often does these days. A journalist's voice on the phone: "Vinod has passed away." It hit me like a ton of bricks. Now, eight years later, what remains is not his fame, not the applause, but his silence, his charm, his lionhearted generosity.

You sound very emotional?

He was truly one of a kind. It was a privilege to have known him, to have walked some of life's road with him. And I can say with absolute certainty-I would not have been who I am without having encountered a man as large


